

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to <https://klaconsultsnow.com/>, and KLA Consults Now LLC and governs data collection and usage. The KLA Consults website is an informational and educational site. By using the KLA Consults website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, KLA Consults may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase KLA Consults' products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. These may include: (a) registering for an account; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services. We also may gather additional personal or non-personal information in the future.

Use of your Personal Information

KLA Consults collects and uses your personal information to operate and deliver the services you have requested.

KLA Consults may also use your personally identifiable information to inform you of other products or services available from KLA Consults and its affiliates.

Sharing Information with Third Parties

KLA Consults does not sell, rent or lease its customer lists to third parties.

KLA Consults may, from time to time, contact you on behalf of external business partners about a

particular offering that may be of interest to you. In those cases, your unique personally identifiable

information (e-mail, name, address, telephone number) is not transferred to the third party. KLA Consults may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to KLA Consults, and they are required to maintain the confidentiality of your information.

Tracking User Behavior

KLA Consults may keep track of the websites and pages our users visit within KLA Consults, in order to determine what KLA Consults services are the most popular. Automatically Collected Information

Information about your computer hardware and software may be automatically collected by KLA Consults. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the KLA Consults website.

Use of Cookies

The KLA Consults website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.

- SSL Protocol

Right to Deletion

Subject to certain exceptions set out below, on receipt of a verifiable request from you, we will:

- Delete your personal information from our records; and

- Complete the transaction for which the personal information was collected, fulfill the terms of a written warranty or product recall conducted in accordance with federal law, provide a good or service requested by you, or reasonably anticipated within the context of our ongoing business relationship with you, or otherwise perform a contract between you and us
- Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity; or prosecute those responsible for that activity
- Debug to identify and repair errors that impair existing intended functionality
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided by law
- Comply with the California Electronic Communications Privacy Act
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information

Children Under Sixteen

KLA Consults does not knowingly collect personally identifiable information from children under the age of sixteen. If you are under the age of sixteen, you must ask your parent or guardian for permission to use the website.
