Brooks: For me, a boss is someone who handles their business. Some-

one who isn't dependent on others to push them through. A boss can juggle things, get back on track, and most importantly, can lose it all and get it right back-because they understand that being a boss isn't about the things you have. It's the mindset that, no matter the situation, you're still you.

Collins:

So, Jackiea, you've already accomplished many goals-becoming a nurse, a profession that many people strive for. But even after establishing yourself as a nurse, you pursued a second career as a writer, where you've also been very successful. What keeps you going?

Brooks:

Pain.

Collins:

Can you break that down for us?

Brooks:

you asked, what's the highlight of your life? And most people think the best highlight is success. But for me, my success came from pain. I don't want to get emotional, but... being a teenage mom at

I'm laughing because we had a conversation earlier where

16, I heard people say, Jay, you're not going to do this. You won't be successful. And for me, I had two choices-either depend on someone, or be the person people depended on.

So, I worked three jobs—serving, waitressing, bartending while paying for school out of pocket. At one point, I failed my LPN program one week before graduation. I had to send my kids to live with their dads so I could try again. That was the hardest decision of my life, but I knew I had to do it.

I went back, paid my tuition, and graduated. Then, I went on to my RN program, commuting from Port Norris to Trenton. But the stress of being away from my kids turned what was supposed to be a 15-month program into two and a half years.

Through it all, I kept going. Because pain shaped me.

Collins:

It makes a lot of sense. So, I've met some very dynamic women throughout my journey, and many of them were single moms. Many were teenage moms. But yet, through perseverance, they made it. What words of encouragement would you give to a teenage mom or someone who's about to become a teenage mom about not giving up?

Brooks:

Don't focus on the people doubting you. Focus on whatever mission you feel is meant for you. Because regardless of what happens, you're always going to meet people who have a problem with something. You're always going to meet people who will tell you that you're not capable, that you can't do it-but you can.

The main thing I'm going to say is this: trust your gut. If you truly feel it and if you truly want it, it doesn't matter how many times you get knocked down. Because I've been through it all—nothing in life is ever just a straight path. It's always a fight. But the fight is what makes you who you are.

Meeting me, you would have never guessed my struggles. You've never seen me upset, you've never seen me angry, you've never seen me complain. You've always seen me happy-go-lucky. But I always tell people the same thing: You can't judge a person by what you see.

Don't judge a person by their circumstances. Because successful people go through a lot. And when a person is finally winning, they earned that. So, keep going.

Collins:

What words do you have for the general public who tells a teen mother that she'll never be anything?

Brooks:

Wow. That right there... I feel like people have to stop being so judgmental. A lot of times, when people see a young girl with a belly, their first reaction is, whoa, why did she do that? What does she have going on?

Instead of reacting like that, people should open their arms and say, It's okay. You can do it. Whatever her dream is, instead of telling her she can't do something, give her a resource. Say, hey, do you know about this program that can help you? Not to promote dependency on a system, but to show her that there are opportunities.

Collins: a writer? **Brooks:**

Tell us about motherhood. Has that inspired you to become

I think being a mom, to be completely transparent with you, has given me the most motivation to do everything that I do in life. And it's because of sacrifice. As a parent, you sacrifice. And for me, every sacrifice I made came with both success and pain. So yes.

Collins:

Now, let's talk about your book Shift Your Focus. Tell us about the title and why you chose it.

Brooks:

May 29th of this past year, my grandmother passed away, which was the day before my birthday. Shift Your Focus came from that experience. She was diagnosed with cancer three months prior, and she went from being independent to dependent.

For me, as an entrepreneur, a nurse, and someone always on the go-traveling back and forth between New Jersey and Georgia, constantly in a mindset of being ready—I went from that to not wanting to show up at all. I wasn't going to work, wasn't operating my businesses, I wasn't posting, I wasn't doing events. I just couldn't physically do it because of what was happening with my family.

So, Shift Your Focus came from that. After everything happened and she passed away, within a week or so, I would talk to my friends, and they'd say things like, oh, you got to get over it. You got to push forward. And while people genuinely try to be there for you, when you're going through something that heavy, it's hard to just pick up the pieces when your life feels shattered.

However, life is still going on, even when you don't know how to push forward. So, Shift Your Focus came from me saying, instead of talking to people, I'll talk to God. I'll write. I started using my phone to write every day. That's where the 30 days came from-each day reflecting what I was going through at that moment.

For example, I had a friend say to me, oh, you don't value yourself. You don't love yourself-all because I was dealing with a certain situation. But at the time, it wasn't that I didn't love myself. I just had so much on my mind that I couldn't even focus on that.

I always tell people—you realize who's genuinely there for you by how they treat you at your lowest. And at that point, I was at my lowest. I wasn't able to be me.

So, Shift Your Focus was born from that. I told myself, Jay, you have to shift, regardless of what's going on around you. You have to shift. You have to show up.

The 30 days came from asking, how can you shift? What steps can you take? The book guides you through exactly what I wrote and felt during that time-to help somebody else get through their own struggles without being weighed down by people, places, or things.

Collins:

Okay. And yes, your book is titled Shift Your Focus: 30 Days to Changing Your Mindset Like a Boss. You wrote that this book is not designed to be read straight through but to be completed one day at a time with work exercises for the reader. Why did you structure it that way, and what can people expect when they read Shift Your Focus?

Brooks:

I structured it as a 30-day process because when it comes to habits, it's easy to create them but hard to break them.

For example, you can go to the gym and work out for a month, but it only takes one day to fall back into old patterns. So, for me, it was like, okay, you do Day 1. You look at the exercise, you write about it, you figure out what you need to change about yourself.

What am I allowing? What am I focusing on? What am I not focusing on?

Then, after another 30 days, if I realize I'm still here, I ask myself, what do I need to shift about myself to get to the next level? To get back into my boss mentality?

Collins:

And let's talk about boss. Is that an acronym for something, or what do you mean when you say like a boss?

Brooks:

I used to talk to people because I mentor sometimes on the side, and through talking to other women, sharing experiences while being at work, I said to myself, you know what? I've been through certain things, and I'm giving people my knowledge for free, my past for free; so why not put it in a book and share it with people to see?

Like, hey, listen, have you been through this too? And if so, let me help you. That book actually did really well in sales on Amazon. Then I was like, you know what? I can do this again. So, I wrote another book—not to be a victim of my past, but to use my past as a tool to help other people.

There are programs that will help not only her but also her baby. When I was younger, there was this program called Robin's Nest for troubled teens. They would sit down and talk to you-What are you going through? How are you feeling mentally? Where are you?

So, for me, I believe in giving young moms tools like that. Or better yet, be a mentor to them. This is how I see things: if you haven't been through something, you shouldn't speak on it. It's like trying to mentor an alcoholic when you've never been one yourself. You have to meet people where they are.

Collins:





Lead-based paint in buildings poses serious health risks, particularly for children who may ingest paint chips or inhale lead-contaminated dust. The New Jersey Lead Remediation and Abatement program (LRAP), funded by a \$180 million. federal grant, aims to address this issue by supporting the removal of lead-based hazards from low- to moderate-income

Households with incomes at or below 80% of the area median income for the County in which the municipality is situated, residing in one to four family residential properties constructed prior to 1978, are eligible.

ICYMI: Our Value Proposition & Co-Existence in New Jersey

As Black History Month winds down, I think about the efforts of so many of my ancestors and leaders who went to great lengths to demonstrate that black people could meet the standard(s) if the playing field were level, and the terms of engagement fully disclosed. When Dr. Carter G. Woodson established Negro History Week in 1926 it was all about showcasing Black Excellence in Math, Health, Science, Engineering, Technology, Industry, Innovation, Culinary, Sports and Entertainment.

It was people like Robert Smalls and Frederick Douglass who negotiated with President Lincoln to draft 170,000 black slaves into the Army to claim victory in the Civil War in exchange for the liberation of blacks from slavery through the passage of the Emancipation Proclamation. Fast forward 37 years when Booker T. Washington, established the Negro Business League (NBL) which introduced black entrepreneurs to free enterprise and capitalistic activities. The NBL started with 40 chambers between Maryland and Texas and grew to over 300 chambers, largely throughout the south. Notwithstanding the tumult that my people in the south encounter, black businesses today in Florida, Texas, Georgia, North Carolina, Virginia, and Maryland are outpacing black businesses in New Jersey today. Perhaps this is because they, and those who are collaborating with them, have not forgotten the price paid historically by blacks. (States with the largest number of black businesses by ranking: Florida (1), Texas (2), Georgia (3), North Carolina (8), Viginia (9), Maryland (10), New Jersey (13). Perhaps this is because they, and those who are collaborating with them, have not forgotten the price paid historically by blacks.

Later, in 1912, President Taft founded the United States Chamber of Commerce, the largest business federation in the world and I am honored to serve on its board of trustees.

There is no doubt in my mind that success is within the DNA of black people, passed on by our ancestors. Here are a few examples; slaves produced cotton and many of the ancillary devices that led to mass production and exports to Europe, created enormous wealth for those who leveraged this free labor; and when these enterprising businessmen needed capital for expansion, they used my ancestors as collateral.

Blacks contributed in several ways that led to bustling industries which created generational wealth. For example, Lous Lattimore created the carbon filament which enabled Thomas Edison's light bulb to stay illuminated, in addition, he improved the toilet systems on railroad cars and created an air conditioning system. Gladys West is a Historically Black College (HBCU) graduate whose efforts led to a GPS Map-

Katherine Johnson provided the mathematical formula that enabled spacecraft to successfully take flights; where would Elon Musk's flights in space be today, without the contribution of Ms. Johnson?

Fred McKinley Jones created refrigeration systems that enabled perishables to be transported by trucks, planes, cargo ships and trains.

Dr. Daniel Hale Williams performed the first heart surgery.

The Tuskegee Airmen flew escort missions in War World II and had the lowest loss records of all escort groups. In the last four football games, of the 2024-2025 National Football League (NFL) season, 3 of the 4 quarterbacks were black, two of which played against each one another in the Super Bowl for the second time.

Dr. King sacrificed his life to move the consciousness of America and to encourage us to value people for their abilities and not their skin color. He laid the foundation for Barack Obama to successfully run and win two terms as the President of the United States.

Unfortunately, today, a zero-sum game is the playbook, executed with total disregard for the sacrifices that have propelled this nation and New Jersey to greatness.

As millions watched the recent hockey match between the USA and Canada, both countries rooted for their respective teams while the players demonstrated pride and professionalism. During that match we shouted from our homes, within the stadium, or at our local taverns in support of the players representing the United States.

However, today, in our state of New Jersey, our leadership appears to be supportive whenever it is expedient. In late 2023, the results of New Jersey's Disparity Study demonstrated systematic exclusion of blacks for equitable participation in public contracting opportunities despite their ability to provide value. While there is a lot of conversation about what is going on in Washington, the African American Chamber of Commerce of New Jersey is laser focused on the inequities in which the 1.2 million black New Jerseyans and the over 88,000 black businesses must navigate to survive their coexistence. Poverty, unemployment, and net worth for blacks are well below other groups in New Jersey.

Deflection is an often-used strategy to redirect the focus while keeping the aggrieved party engaged with a residual return while the real leader accomplishes their larger selfserving objective(s). This is an old play that has been run successfully repeatedly. Notwithstanding how one feels after they have fallen victim, while arguing within themselves, they become num, complacent and proceed to go along to get along.

This has been the story for many blacks in our state, however, as we look at this upcoming gubernatorial race, I am hopeful that the next governor and state legislators will work to address disparities while collectively establishing an agenda that lifts all boats equitably.

FINANCIAL FOCUS **Consider Tax-Smart Charitable Gifts**

As we enter the annual season of giving, you might be thinking of charities you wish to support. But you also might be wondering how to gain some tax benefits from your gifts.

It used to be pretty straightforward: You wrote a check to a charity and then deducted the amount of the gift, within limits, from your taxes. But a few years ago, as part of tax law changes, the standard deduction was raised significantly, so fewer people were able to itemize deductions. Consequently, there was less financial incentive to make charitable gifts.

Of course, this didn't entirely stop people from making them. And it's still possible to gain some tax advantages, too.

Here are a few tax-smart charitable giving strategies:

- · Bunch your charitable gifts into one year. If you combine a few years' worth of charitable gifts in a single year, you could surpass the standard deduction amount and then itemize deductions for that year. In the years following, you could revert to taking the standard deduction.
- Make qualified charitable distributions. Once you turn 73 (or 75 if you were born in 1960 or later), you must start taking withdrawals from your traditional or inherited IRA. These withdrawals — technically called required minimum distributions, or RMDs — are taxable at your personal income tax rate, so, if the amounts are large enough, they could push you into a higher tax bracket or cause you to pay larger Medicare premiums.

But if you donate these RMDs directly to a qualified charity, you can avoid the taxes. And because these donations, known as qualified charitable distributions (QCDs), will reduce the balance on your IRA, you may have lower RMDs in the future.


Of course, if you need some or all your RMDs to help sustain yourself in retirement, the use of QCDs may not be of interest to you. Keep in mind, though, that you can start making QCDs at 701/2, even before you must start taking RMDs. QCDs up to \$105,000 can be taken in 2024.

 Consider a donor-advised fund. If you're interested in a long-term charitable giving arrangement, you might want to consider establishing a donor-advised fund. You can put many types of assets into this fund, and then direct it to make grants periodically to the charities you've chosen. You get an immediate tax deduction for your contribution, and, if you donate appreciated assets, such as stocks, you'll avoid the capital gains taxes you would have incurred if you simply sold the stocks and then gave the money to the charities. One note of caution, though — your contributions to a donor-advised fund are irrevocable, and once the assets are in the fund, you can't use them for anything except charitable giving.

These strategies — QCDs and donor-advised funds in particular - can be complex and involve several issues of which you should be aware. So, you should consult your tax advisor before taking action. But if any of these techniques are appropriate for your situation, give them some thought - because helping a charitable group and getting tax benefits for doing so is a "win" for everyone.

Camden to Benefit from \$2.5 Million Infrastructure Investment by New Jersey American Water

CAMDEN, N.J. – March 13, 2025 – New Jersey American Water will replace approximately 6,900 feet of aging water main in Camden starting next week. The company will upgrade the aging water lines that were installed as far back as the 1900s with new 8-inch and 12-inch ductile iron main along the following streets:

- •Howell Street from High Street to North 27th Street
- •Stewart Avenue from County Route 601 to Howell Street
- North 21st Street, North 22nd Street, North 23rd Street, North 24th Street, North 25th Street, and North 26th each from High Street to Howell Street
- Saunders Street from North 26th Street to North 27th Street
 High Street from Howell Street to North 21st Street

"New Jersey American Water is proud to continue investing in Camden's water infrastructure to support the city's growth and long-term success," stated Mark McDonough, President, New Jersey American Water. "Through these essential upgrades, we are significantly enhancing service reliability to help ensure that life keeps flowing smoothly for residents. Camden is a city on the rise, and we remain committed to working closely with local leaders and the community to support its continued growth through our infrastructure investments."

The project also includes replacing fire hydrants and utilityowned service lines along the pipeline route. Additionally, New Jersey American Water will replace any customerowned service line that has been identified as lead or galvanized as part of a statewide initiative to remove all lead and galvanized service lines by 2031.

New Jersey American Water Signs Agreement to Purchase South Orange Village Water System

New Jersey American Water to Invest \$50 Million in First 10 Years

CAMDEN, N.J. – March 6, 2025 – New Jersey American Water announced today it signed an agreement to acquire the water system in South Orange Village for \$19.7 million. This announcement follows a referendum vote in November of 2024 in which 62% of South Orange voters approved the sale of the system. The South Orange water system serves approximately 5,000 customer connections.

"On behalf of New Jersey American Water, I want to thank the residents of South Orange for entrusting us with their water system," said New Jersey American Water President Mark McDonough. "Through existing operations and maintenance and bulk water contracts, we have been serving South Orange for many years and are proud of the relationships we've built within the community. Our familiarity with the water system will allow us to make needed system improvements quickly, specifically removing all lead and galvanized service lines. We look forward to providing safe, reliable and affordable water service to South Orange residents."

As part of the agreement, New Jersey American Water will invest \$50 million in infrastructure improvements within the first 10 years of ownership. Anticipated improvements to the system — which is over 100 years old in some areas — include:

- Identification and replacement of all utility-owned and customer-owned lead and galvanized steel service lines by 2031;
- Replacing all four-inch water mains and associated fire hydrants;
- · Replacing the Crest Drive Standpipe; and
- Rehabilitating the Main Reservoir and the Newstead Watersphere.

Additional improvements will be identified through a comprehensive analysis of the system which New Jersey American Water will conduct upon taking ownership.

"After careful consideration and the extensive work of the water utility task force, our Village Council, our Village administrative staff, Village residents and outside financial consultants, I am fully confident that the sale of our water system to New Jersey American Water is in the best interest of South Orange residents," said South Orange Village Mayor Sheena Collum. "This agreement ensures that our community will receive the investment needed to modernize our water infrastructure and eliminate lead and galvanized service lines, while also providing the expertise and resources of a trusted, regulated utility. WHAT TO EXPECT


When crews are in the area, you may experience a drop in water pressure or discolored water. If discolored water occurs, let the **cold water** run until it is clear.

ICYMI: Murphy Administration Surges Resources to Reduce Veterans Homelessness to Functional Zero

Bringing Veterans Home Initiative Seeks to House All New Jersey Veterans by July 1, 2026

SEA GIRT, NJ – The New Jersey Department of Community Affairs (NJDCA) and the New Jersey Department of Military and Veterans Affairs (NJDMAVA) yesterday began a two-day training session at the National Guard Training Center in Sea Girt highlighting New Jersey's Bringing Veterans Home initiative to reduce veterans' homelessness to functional zero. The Bringing Veterans Home initiative seeks to house all homeless veterans in the state by July 1, 2026, while strengthening the State's homelessness prevention system so that any newly homeless veteran can be placed in stable housing within one month.

"Our veterans have sacrificed so much to uphold our nation's freedom and deserve our deepest gratitude and respect for their service," said Governor Murphy. "Our Administration is committed to providing the many veterans who call the Garden State home the support and resources they need to thrive. I am grateful to Commissioner Suárez and Brigadier General Mays for their continued efforts to ensure every veteran in New Jersey has a safe and dignified place to call home."

"The Bringing Veterans Home initiative formally unites federal, state, and veteran service organizations throughout the state in the fight against unsheltered veteran homelessness," said NJDCA Commissioner Jacquelyn A. Suárez. "Using this collaborative approach, we will be sheltering our homeless veterans this year and next, while creating a strategic framework that will carry momentum long into the future."

"Bringing Veterans Home represents a groundbreaking step toward ensuring that no Veteran endures the hardship of homelessness." said Brig. Gen. Yvonne L. Mays, Commissioner of the NJDMAVA and the Adjutant General of New Jersey. "Thanks to Governor Murphy, the Legislature, the NJDCA and NJDMAVA teams and so many passionate volunteers throughout the entire state, we are in a position to effectively end veteran homelessness.

The Bringing Veterans Home initiative coordinates efforts between DCA's Office of Homelessness Prevention, NJD-MAVA, federal partners at the U.S. Department of Veterans Affairs and U.S. Department of Housing and Urban Development, and multiple veterans service organizations. This combined effort will ensure the State can reach its goal to house 300 veterans within the next 180 days and reach functional zero by July 1, 2026.

More than \$30 million in State and federal funds have been committed to support these services and interventions over the span of two years, to place more than 1,000 homeless New Jersey veterans into stable housing. Services and interventions include Veterans Affairs Supported Housing (VASH) vouchers and other rental assistance, the State's Veterans Haven transitional housing facilities, and Supportive Services for Veterans and Families (SSVF) programs.

Additionally, the initiative will expand homelessness diversion, rapid rehousing, street outreach, emergency sheltering, and permanent housing voucher programs to more rapidly achieve housing stabilization for all program-eligible veterans.

"Success requires collaboration," said Michael Callahan, Director of the Office of Homelessness Prevention at the New Jersey Department of Community Affairs. "This training event shared key insights on veteran homelessness through data analysis and interviews with people who've experienced it firsthand. This knowledge sharing helps us meet our goal."

"We appreciate the support from all community partners involved in this effort in ending Veteran homelessness," said Wilmington VA Medical Center Interim Director, Dr. Matt Morris. "One homeless Veteran is one to many, we want to make sure all Veterans are receiving the VA services they've earned."

NJDMAVA provides highly trained, professional, and ready forces - prepared for rapid response to various civil and military operations - while providing exemplary services to New Jersey Service Members, Veterans, and their families.

DCA offers a wide range of programs and services, including local government management and finance, affordable housing production, fire safety, building safety, community planning and development, disaster recovery and mitigation, historic preservation, and information privacy.

Governor Murphy Signs Legislation Requiring Public Universities and Colleges to Readmit Students Who Withdrew Due to Military Service

Readmission to Be Granted Upon Written Request by the Returning Student, With No Associated Fees

TRENTON, NJ – Governor Phil Murphy today signed legislation requiring New Jersey's public universities and colleges to readmit students whose enrollment was interrupted due to military service. This includes service in the Armed Forces or as a member of the National Guard or Reserve – whether on active duty, active duty for training, or full-time National Guard duty under federal or State authority.

Under the bill, the institution of higher education is required to readmit the student with the same academic status the student had before withdrawing. Readmission is to be granted upon written request by the student with no associated fees.

"We are committed to doing everything we can in New Jersey to support our service members and veterans, including ensuring that the brave men and women who selflessly put their studies on hold to answer the call to serve can pick up their college education exactly where they left off," said Governor Murphy. "With today's bill signing, we are underscoring our support for New Jersey's active-duty service members and veterans by removing barriers to securing a college education."

"New Jersey is committed to helping every student complete their degree, including those who have paused their education to serve our country," said Secretary of Higher Education Brian Bridges. "With this law, it will be easier for service members to return to college with the same academic standing they had before their military service and without the financial burden of application fees. I want to thank the sponsors for their leadership in championing this important legislation. Together, we reaffirm New Jersey's commitment to fostering inclusive higher education opportunities, ensuring that all residents have clear paths to finishing their education and advancing their careers."

"Calls to service from our state and country can happen at any moment, no matter what is going on in the lives of our service members. When they answer those calls, disruption to their pursuit of academic degrees is one of the sacrifices they frequently make," said Brig. Gen. Yvonne Mays, DMAVA Commissioner and The Adjutant General of New Jersey. "This legislation ensures that those who answered the call to serve are afforded the opportunity to succeed and advance their educational careers when they return from duty."

Sponsors of the legislation (S1445/A3803) include Senator Troy Singleton, Senator Kristin Corrado, Assemblywoman Verlina Reynolds-Jackson, Assemblywoman Cleopatra Tucker, and then Assemblyman, now U.S. Representative Herb Conaway.

"Colleges and universities should not be penalizing students who have their education interrupted to serve our country by forcing them to retake classes and spend more," said Senator Troy Singleton. "We should do everything we can to support veterans when they return, and I thank the Governor for signing this legislation to ensure that these students are able to pick up right where they left off without penalties."

"Every veteran in the state deserves the opportunity to pursue their higher education goals," said Senator Kristin Corrado. "With the Governor's signature, we will make certain that public colleges and universities have policies in place to provide special accommodations for veterans, and help our brave men and women in uniform transition back into civilian life more easily than ever before."

"We owe it to our service members to ensure they have a seamless transition back to college," said Assemblywoman Verlina Reynolds-Jackson. "Through A3803, we not only honor their commitment to this country but also make higher education more accessible."

"Service members sacrifice so much for our country, and it is only right we make it as easy as possible for them to pursue their educational aspirations upon their return," said Assemblywoman Cleopatra Tucker. "This bill is a small token of our appreciation for their service."

"I am pleased to learn that Governor Murphy has formally signed S1445/A3803 into law—the new NJ bill designed to enhance support and benefits for the veterans who call New Jersey home. This measure represents a vital step toward ensuring that every veteran receives the care, recognition, and educational opportunities they deserve," said Luddie H. Austin, Commander, Dept. of NJ VFW. "On behalf of the Veterans of Foreign Wars, I extend my sincere appreciation to Governor Murphy for his steadfast commitment to our community and our heroes."

"The bill (S1445/A3803) that the Governor has signed is another helpful tool to support our veterans to continue the education needed to support their families and to give them a larger sense of being a viable part of our ever-changing society," said Charles Andy Jackson, Dept. Commander NJ, American Legion. "We, the American Legion members, are grateful for his continued support of furthering the educational needs of our Veterans. A student that has their pursuit of a higher education degree interrupted by military service, whether by service in the Armed Forces, Reserves or National Guard, on active duty or for training, should not be penalized," said George R. Schnepf, Jr., Adjutant, DAV Dept. of NJ. "It is only fitting that the student be readmitted at the same academic status the student held when they last attended the institution. Education opportunities should be encouraged by military service. This bill will be helpful in those transitioning back to civilian life after service."

"The NJVN is excited about S1445/A3803 being signed by the Governor," said Michael D. Boll, President, New Jersey Veteran Network. "This bill is a great step forward in supporting our veteran college students during their studies by removing stressors and potential disruptions. Also, this will allow veterans to focus on their education and future."

Norcross, Costa, Fitzpatrick Introduce Seizure Awareness and Preparedness Act

WASHINGTON, DC – Today, Representatives Donald Norcross (NJ-01), Jim Costa (CA-21), and Brian Fitzpatrick (PA-01) introduced the Seizure Awareness and Preparedness Act to create a grant program to support students who have epilepsy or a seizure disorder. Based on a New Jersey law, the Seizure Awareness and Preparedness Act would authorize funding to ensure all students nationwide are surrounded by trained and prepared individuals in the event of a seizure. Senator Cory Booker (D-NJ) introduced companion legislation in the Senate.

"I'm honored to introduce the Seizure Awareness and Preparedness Act to build on the progress we've made in New Jersey with Paul's Law and ensure school staff members across the nation are prepared if a student has a seizure in the classroom," said Congressman Norcross, Member of the House Committee on Education and Workforce. "We know that about 470,000 children and teenagers live with epilepsy in the United States, and all our schools must know how to keep them safe."

"This legislation is crucial for creating a safer school environment for children with epilepsy and seizure disorders. By funding response training, we ensure school staff are prepared to act, providing every child the support they need to succeed," said Congressman Costa.

"Medical emergencies like seizures demand immediate action from school personnel to ensure the safety of all individuals," said Congressman Brian Fitzpatrick (PA-1). "Our primary duty is to protect our children, and the Seizure Awareness and Preparedness Act is key to fostering safer learning environments and providing families with much-needed peace of mind. I am championing this bipartisan effort to ensure that no child facing a medical crisis is left without the care they need."

"Nearly half of America has followed in New Jersey's footsteps and passed legislation to create safer environments for children with epilepsy," said Senator Booker. "It's now time we take action at the federal level, which is why I'm pleased to stand alongside my colleagues in the New Jersey delegation to reintroduce the Seizure Awareness and Preparedness Act. This legislation will equip our schools with the resources they need so school personnel are trained and prepared in the event that someone has a seizure."

In 2020, New Jersey Governor Phil Murphy signed "Paul's Law" into law, the first-of-its-kind in New Jersey named in honor of Paul St. Pierre, a New Jersey teenager with epilepsy. The legislation authorized the development of individualized health care plans for students with seizure disorders or epilepsy and mandates that school personnel are trained on how to care for students with such conditions.

About half of the states in the country have passed similar legislation to mandate or encourage seizure recognition and first aid training of school personnel, as well as other provisions to help ensure students with epilepsy are safe and supported in the school environment. The Seizure Awareness and Preparedness Act would continue this momentum by authorizing funding to help ensure all students nationwide are surrounded by trained and prepared individuals, including:

- Training of school personnel to administer or assist with the administration of seizure medications.
- Training and education of students on seizure awareness and preparedness.
- Recruiting, hiring, and retaining compliance staff who are responsible for ensuring that all training and program requirements related to seizure awareness, preparedness, and management are consistently met.

Rep. Norcross Co-Sponsors Richard L. Trumka Protecting the Right to Organize Act

WASHINGTON, DC – Today, U.S. Congressman Donald Norcross (D-NJ) joined congressional leaders, labor leaders, and workers to introduce the Richard L. Trumka Protecting the Right to Organize Act. Rep. Norcross, a cofounder of the Congressional Labor Caucus, is a union electrician by trade, a former union organizer, and was president of an AFL-CIO regional labor council for nearly two decades.

"I know how important it is to give workers a voice and protect them from unfair labor practices because I lived it," said Congressman Norcross. "At its core, the PRO Act carries Rich's legacy forward by promoting worker solidarity, giving hardworking women and men a voice in their workplace, and holding accountable corporate bosses who violate workers' rights. I first met Rich back in the 80s at a union hall in Cherry Hill, where he was collecting donations to support striking coal miners. The PRO Act strengthens union protections, and I can think of no better person to name this critical piece of legislation after than Rich."

The PRO Act increases protections for workers engaging in union or other collective bargaining activities, expanding unfair labor practices to prohibitions on the replacement of, or discrimination against, workers who participate in strikes. The bill also makes it an unfair labor practice to require or coerce employees to attend employer meetings designed to discourage union membership.

The PRO Act protects the basic right to join a union by:

1. Holding employers accountable for violating workers' rights by authorizing meaningful penalties, facilitating initial collective bargaining agreements, and closing loopholes that allow employers to misclassify their employees as supervisors and independent contractors.

- 2. Empowering workers to exercise their right to organize by strengthening support for workers who suffer retaliation for exercising their rights, protecting workers' right to support secondary boycotts, ensuring workers can collect "fair share" fees, and authorizing a private right of action for violation of workers' rights.
- Securing free, fair, and safe union elections by preventing employers from interfering in union elections, prohibiting captive audience meetings, and requiring employers to be transparent with their workers.






