## **Tuition & Fees 2025-2026**

#### **Our Mission**

The AIS Vienna General Assembly determines the fees payable for each student attending the school for each school year. The fee amounts for the 2025-2026 school year are listed below.

#### **New Students**

Application Fee	€700	The non-refundable Application Fee must be paid to initiate the processing of completed admissions applications. This fee also covers the administration of admissions testing/screening and application review, leading to an admissions decision. This fee is valid for two years.	
Reservation Fee	€3,000*	The non-refundable Reservation Fee is a deposit that must be paid within 10 days of the enrollment offer to secure the student's place at AIS Vienna. Without timely payment, the family may forfeit the student's enrollment at Vienna.  *This fee is credited to the total annual tuition fee amount.	
Enrollment Fee	€3,300	The one-time Enrollment Fee must be paid to complete AIS Vienna enrollment for all new students entering Kindergarten - Grade 12 (excluding Pre-Kindergarten) and all re-enrolling students entering Kindergarten. This fee is invoiced with the initial tuition payment.	
Capital Assessment Fee - New Students	€7,000	The one-time Capital Assessment Fee for New Students must be paid for all new students entering Kindergarten - Grade 12 (excluding Pre-Kindergarten) and all re-enrolling students entering Kindergarten. Capital Assessment Fees help pay for buildings and other long-term projects. This fee is invoiced with the initial tuition payment.	

## **Re-Enrolling Students**

Reservation Fee	€3,000*	The Reservation Fee is a deposit that must be paid by March 1 to reserve a re-enrolling student's place for the following year. This payment is refundable until April 1. Re-enrollment after April 1 is subject to space availability, is not guaranteed, and is not refundable.  *This fee is credited to the total annual tuition fee amount.	
Capital Assessment Fee - Re-Enrolling Students	€1,500	The Capital Assessment Fee must be paid for all re-enrolling students entering Grades 1-12 and is payable for each subsequent year of enrollmen at AIS Vienna. Capital Assessment Fees help pay for buildings and other long-term projects. This fee is invoiced with the initial tuition payment and non-refundable after June 14.	

#### **Leaves of Absence**

Leave of Absence Fee	€3,000	If requested by the family and approved by the school before March 1 of the current school year, AIS Vienna may agree to prioritize enrollment for a qualified student who is leaving the school but expects to return within one year. Should the student return at the start of the following school year this fee guarantees a place and the regular fee rates for Re-Enrolling Students (see above). The Leave of Absence Fee is not prorated or refunded under any circumstance. A Leave of Absence may not be extended beyond one year. Approval must first be obtained through the Admissions Office at <a href="mailto:admissions@ais.at">admissions@ais.at</a> .
		During the school year of the Leave of Absence, the family must adhere to the regular re-enrollment timelines and fees for the following school year in order to secure the student's return to AIS Vienna.

## **Returning Students After Withdrawal**

**Return Within 1 Year:** The regular fees for Re-Enrolling Students (see above) apply for students who withdraw from AIS Vienna but are re-enrolled within 1 year, with or without a Leave of Absence Fee guarantee.

**Return After More Than 1 Year:** The fees for New Students (see above) apply for students who withdraw from AIS Vienna but are re-enrolled after more than 1 year, with or without a Leave of Absence Fee guarantee.

## **Payment Of School Fees**

#### Option 1 - Payment In Full

Tuition and fees are due and payable by August 31, 2025 for students re-enrolling or entering in Quarter 1, or upon receipt of invoice.

#### Option 2 - Installments

Installment payments are applicable for tuition fees only; the Enrollment and Capital Assessment Fees are invoiced with the first installment.

Payers wishing to pay in 3 installments must sign a payment agreement and pay an additional €970 financing charge (€630 for Pre-Kindergarten). The amount of each installment and the date when each of the installments is due and payable are stated in the schedule of tuition fees.

If an installment is not paid on the respective due date, the installment payment agreement is nullified (breach of contract) without further notice and disqualifies non-payers from future installment arrangements. In such cases, the total outstanding amount has to be paid immediately.

Installment payments may be granted upon written request to the AIS Vienna Business Office. Requests for installment payments must be submitted by October 15, 2025 at the latest. No installment payments may be granted after the deadline.

## **Mid-Year Enrollment / Late Arrivals**

In the 2025-2026 school year, the fiscal guarters end on the following dates:

• Quarter 1: October 17, 2025

• Quarter 2: January 16, 2026

• Quarter 3: March 27, 2026

• Quarter 4: June 12, 2026

#### **Proration of Fees for Mid-Year Enrollment**

Annual tuition fees for mid-year enrollment are payable according to the following schedule:

Refunds of school fees are based on the date of notification via completion of the <u>Student Withdrawal Form</u> and the schedules below.

Fees for a given student may not be transferred nor applied to another student's account. Refunds will be made after the withdrawal of the student within 30 business days.

#### **Late Payment**

In the event of late payment of any amounts due to AIS Vienna for more than 2 weeks, arrears interest at the rate of 1% per month calculated from the day following the due date until the date when the outstanding amount has been credited to the AIS Vienna bank account.

If a late payment continues for more than 1 month, the AIS Vienna Director may, at his/her discretion, terminate the schooling contract and disenroll the student by way of a notice in writing to the parent/guardian. In all other respects, the Tuition & Fees Refund Policy applies correspondingly. Legal costs incurred by AIS Vienna in the recovery of outstanding fees will be borne by the parent/guardian. In case of continued non-payment AIS Vienna will forward the open amount to a debt collector.

## **Third Party Payment**

Parents/guardians may inform AIS Vienna that a specific third party will pay the school fees on their behalf. It is, however, the responsibility of the parents/guardians to assure that the third-party payments are made according to the school's payment terms, and parents/guardians are liable for any outstanding balances of school fees including charges for late payments.

## **Payment Method For Tuition And Fees**

Payment can be made in € (EURO) only. Bank handling charges are to be borne in full by the remitter.
