




RETURN TO WORK (LAST 12 MOS.)





ACTIVE UI CLAIMANTS BY MONTH BORDERPLEX REGION






UNEMPLOYMENT INSURANCE CLAIMANT DATA

ACTIVE UI CLAIMANTS BY WEEK BORDERPLEX REGION 11/1 TO 11/30













COST OF LIVING COMPARISON (2024)






MEDIAN VS LIVING WAGE (FY2025 VS 2022)






LABOR FORCE PARTICIPATION RATE (2023)
