# **CLASS 43 WRAPS UP WITH APPLIED LEADERSHIP SEMINAR**

The class gathered in Spokane for their final seminar including giving their public policy project presentations, guided reflection, and visioning.

Steve Robinson, Craig Nelson (27), and Gretchen Lech (36) served as panelists for the policy projects providing insightful feedback and posing questions to each group to ensure class members captured lessons learned from the process. The evaluators emphasized that the journey is more important than the destination and in their individual reflections, class members expressed confidence and readiness to engage in policy discussions and process in the future.

The last day of the seminar included a "what's next?" by Jordan McDevitt (38) sharing his leadership journey since AgForestry. Then the class was guided by Holly Henning, Curriculum Advisor, in an exercise to map their leadership futures. Lastly, Jaime Pinkham (9) provided an inspirational send off with the call to action, "what difference will you make?".

## **CLASS 45 SELECTION IN PROCESS**

<u>The Issue:</u> The nationwide shortage of commercial truck drivers is affecting everyone.

Washington state agriculture and timber industries heavily rely on trucking to move materials, equipment, crops, animals, and get supplies to farms. The significant shortage of truck drivers is creating a competitive environment. The higher cost of trucking is affecting prices of supplies, fertilizer, feed, fuel and at the end consumers.

<u>The Issue:</u> Young, beginning, small, and historically underserved producers face barriers to entry into agriculture, specifically access to education and extension.

The Issue: Washington's agriculture, food, and livestock fiber industries face increasing economic risks associated with pest and disease outbreaks, which have increased across the state in frequency and severity due in part to global trade flows and changing climate patterns. The Washington State Department of Agriculture currently lacks readily available funds to prepare for, prevent, detect, and respond in a timely manner to pest and disease outbreaks that impact agricultural producers, the overall economy, and our state's food system.
