## **Challenges**

A regional healthcare facility with multiple locations recognized the need to digitize their outdated POTS lines, as traditional copper lines were being phased out and repairs were becoming unreliable. This posed a critical risk: outages could result in lost revenue and life-threatening situations.

Each facility relied on POTS for essential services, including fire alarms, elevators, security systems, and modems for management. They also required HIPAA-compliant fax services to avoid legal risks associated with transmitting protected health information (PHI) electronically.

Additionally, with new construction underway, sticking with POTS lines would lead to vendor delays and costly permits. The facility needed to transition away from POTS in both existing and new buildings without disrupting operations.
