GDP GROWTH RATE ROBUST GDP GROWTH

Guyana's GDP growth rate has seen a dramatic increase since the discovery and extraction of offshore oil reserves in 2019. The most significant growth occurred in 2020 with a 43.5% increase, followed by an even higher surge of 62.3% in 2022, 57.8% in 2023, and a projected rate of 47.5 in 2024. This rapid growth is attributed to the burgeoning oil industry

OPPORTURIES

IN SEVERAL SECTORS

Oil and Gas Industry: Recent discoveries in the Stabroek Block, with estimated reserves of over 11 billion barrels.

Agriculture: Expansive arable land suitable for diverse crops, especially rice and sugarcane.

Mining: Rich deposits of gold, diamonds, rare earths, and bauxite.

Tourism: 3rd largest export sector. Rated as the world's #1 Eco-Tourism destination and the best in Sustainable Tourism. Guyana with its' 83,000 sq mi of pristine forest, dozens of waterfalls, and unique bio-diversity, makes it a wealth of tourism investment opportunities.

Infrastructure Development: Government incentives for development in transportation, housing, and renewable energy initiatives. This investment by the government in this sector now being the largest portion of the national budget.

ICT: Information, communication, and technology are now in the infancy stage in Guyana. Additional technical expertise would bolster the development of this sector.

MORKFORCE

AVAILABLE WORKFORCE

LITERACY RATE OF 90.03% PERSONS 15+

The workforce unemployment rate peaked in 2020 at 15.7%, likely due to the economic disruptions caused by the COVID-19 pandemic. Since then, it has gradually decreased, with a forecasted rate of 10.3% in 2024, reflecting improvements in the labor market as the economy expands. With Guyana's robust growth, it is projected that approximately 60,000 additional individuals will be needed to boost Guyana's further development



FOREIGN DIRECT INVESTMENT

PROJECTIONS for 2023 >= USD 4.32 BILLION exact figures for 2023 are not yet fully reported

FDI as a percentage of GDP has increased significantly since the onset of oil production. The FDI rate jumped from 8.3% in 2019 to 30.0% in 2021, 35.0% in 2022, peaking at 51% in 2023. This influx is largely driven by investments in the oil sector and related infrastructure.
