

Green Hydrogen

So why this sudden change of mindset, to understand first let us understand what is Green Hydrogen.

Green Hydrogen is a carrier of energy, it is not produced using Methane or coal but by the use of Renewable energy (Solar Photovoltaic). The process to obtain this Green Hydrogen is called "Electrolysis".

Now to explain why the mindset has changed. The reason why Green Hydrogen has become such a valuable source now and why was it not used before is because the cost to assemble this renewable energy like solar was \$359 in 2009 whereas Coal was just \$111, but now this has changed the rate of solar has decreased drastically up to just \$40 in 2019 whereas coal is \$155.

Green Hydrogen was always considered an expensive alternative to fossil fuels and was always dodged, but for the first time in human history, this mindset can be changed.

Nitin Gadkari Minister of Road Transport and Highway stated that Green Hydrogen is the future of automobiles. Mukesh Ambani has invested about \$75 Billion into Blue and Green Hydrogen to make India a Hydrogen Hub. Adani Group also invested about \$70 Billion in Renewable to produce the cheapest energy hydrogen, he aims to become the World's largest Renewable energy Company. Tata Motors is planning to build Hydrogen Buses for India.



GREEN HYDROGEN

A whopping 89% decrease and in the next 10 years, this cost is expected to drop further from \$40 to maybe even less than \$5. This is the reason why Electrolysis looks like a feasible and cheaper process than Fossil Fuels.

Why India is so aggressive about Renewable Energy (the source of green hydrogen)?

India for the past few years has been keen towards the improvisation of renewable energy. Why? There are 3 Reasons they are,

- India is extremely dependent on the Middle East for Oil which makes India vulnerable to situations like Geo Political Situations for example the Russia-Ukraine War. So, if India manages to produce Green Hydrogen, then it can act as a replacement for oil and thus the import of oil can be decreased.
- World Leaders realized that climate change is real so India and 193 other Nations signed the Paris Agreement. In this Paris Agreement India is aiming to cut down 50% of the Green House Emission by 2030.
- Three of the most important industries in India and the World itself are Steel, Transportation, and chemicals. These Industries produce a lot of Fossil Fuel Emissions and they do not have a viable energy substitute. So, in the long run, due to the formation of the Paris Agreement these industries cannot run profitably. Green Hydrogen can be the best alternative to fossil fuels as it is the cleanest form of energy because it has no carbon by-product at all.

This means whosoever manages to crack the code of renewable energy will go on to become the net exporter of renewable energy, and eventually, they will go on to command extraordinary power in global politics, in short being an exporter of Green Hydrogen is a fast track into the big leagues of Geopolitics.

So, for now, we can be happy that India has become aware of this treasure and let us hope that this source of energy will be used to our country's advantage.

HOW RBI'S STRATEGY WILL KILL THE US DOLLAR DOMINANCE IN THE WORLD ECONOMY?


This wouldn't kill the dollar as mentioned in the title. Don't forget that currency dominance depends on the demand for the currency. India would need to export stuff to create that demand.



The new generation of virtual reality (VR) headsets is the portal to the metaverse. Head-mounted VR displays engulf the senses and offer an unrivalled sense of embodied presence. Users can move freely through a 3D scenario and interact with the world around them with their hands, just like in real life. An internet connection is not even necessary for single-player sessions.

VR engages the brain's motor system and builds muscle memory. Just like a flight simulator prepares pilots for emergency landings, VR can train anything, from farming skills to firefighting. Skills that play to the unique strengths of the metaverse include spatial training, such as involving the hands and body for tasks that are too dangerous, expensive, inconvenient, or simply impossible to practice in real life. Other examples include simulating scenarios for routine and abnormal operations, emergency response, stressful workplace situations, necessary procedures, and high-consequence events—all in a safe and controlled environment that can then be repeated until it becomes second nature.

What is Metaverse?



In futurism and science fiction, the metaverse is a hypothetical iteration of the Internet as a single, universal and immersive virtual world that is facilitated by the use of virtual reality and augmented reality headsets. In colloquial use, a metaverse is a network of 3D virtual worlds focused on social connection.

6 Ways the Metaverse Can Positively Impact Learning and Capability Building

1. Learn and connect in an immersive virtual campus.


Before and during COVID-19, learning had already begun to move from physical classrooms to more virtual and blended spaces. The metaverse facilitates an immersive campus life, where learners wearing VR headsets enter the virtual campus or University to learn, explore, and socialize. In this digital space, for example, learners can delve into different learning pods, visit libraries and breakout rooms, meet coaches and counsellors, and hang out with peers. These digital experiences can truly democratize education, by bringing individuals from geographically dispersed locations and varied economic backgrounds together to learn, in a cost-effective, flexible, and quicker duration. For example, in September 2023, the planned Kenya-KAIST virtual campus located 60 kilometres from the capital city of Nairobi will allow the institution to extend its reach across continents, allowing students to learn together on cutting-edge topics without having to leave their home countries.

2. Enhance real-world skilling in Virtual and Hybrid environments

The metaverse provides experiential, embodied skilling opportunities using real-world scenarios and high-pressure situations, where you can make mistakes without consequence. When well-designed, it combines VR with data science and spatial design to improve learner engagement, confidence, and application. Some examples of the benefits of training in the metaverse include:

- Experiential learning. Pharmaceutical leader Novartis trains lifesaving lab skills with high-fidelity, multiplayer VR simulation. Students step into a virtual lab to interact with instructors and practice welding tubes, removing bag caps, and labelling bags with unlimited do-overs.
- Deliberate practice. The metaverse provides intense practice and feedback loops, where learners practice many variations of a concept to hone skills. Walmart's Spark City game is different every time the game is played. If customers appear within 10 feet, players have to ask if they can help, but not before they've addressed spills and other safety hazards.






Visualization and storytelling are two hallmarks of a metaverse learning experience and are much needed today after the profusion of boring Zoom experiences during COVID-19. Through VR technology, learners can step into an entirely different world or another person's shoes. For example, healthcare leader DaVita builds patient empathy by using an interactive, multi-sensory first-person story.

Stepping into meta worlds facilitates visualization of scenarios, including complex development challenges. For example, a learner can use a VR headset to examine a street transformation in South Asia or explore life in a green Smart City. Through bite-sized 360-degree stories, virtual tours, and visualizations, learners "enter" crucial global development challenges, including climate change, education, gender, urban development, international trade, and public health.

4. Build human capabilities in interpersonal or difficult situations

Training staff for soft skills, such as communication, leadership, listening, and empathy is hard to achieve and also measure. The metaverse facilitates this by immersing learners in real-world conflicts and allows them to practice their soft skills in a safe environment, for example, by having sensitive or difficult conversations with employees or customers.





An immersive learning experience

Education through the metaverse can engage students in a 3D world of imagination where they can view and interact with their peers and the 3D objects around them, just like in a physical classroom. Whether it is about the prehistoric stone age or the modern age, metaverse learning can virtually transport students to various historical periods, eliminating the need for imagination. Wouldn't it be amazing to learn about the voyages of Columbus by sailing on his ship and discovering 15th-century America?

Gamification

Although students can be taught statically or passively and actively in an engaging way, the latter is the most effective as it can teach concepts better. Metaverse does the same for students through gamification, which is the process of integrating something with game elements to encourage user participation. Gamification in a metaverse combines both entertainment and learning to increase student participation and engagement where they have to complete fun tasks. This motivates students to keep learning and finish their assignments on time.

Hands-on practice

The metaverse is redefining the conventional means of education by engaging students in handson practices, which can otherwise be risky and difficult to do in a real-world setting. It helps students better understand theories and refine their skills to prepare them for real-life endeavours. Students can do complex surgeries or conduct unsafe explosive experiments within a metaverse without putting someone's life on the line.



Life-like learning

Unlike the conventional education system that hardly promotes active communication and engagement among students, metaverse classrooms offer life-like ecosystems that motivate students to interact with their surroundings and peers. In a metaverse, educators can take students to various life-like scenarios where they can participate in activities after which they can discuss their learnings and findings.

Improved learning speed

According to a research conducted by PwC, employees in VRenabled courses learned four times faster than in the classroom environment. The metaverse's immersive experience brought on by gamification, engrossing hands-on practices, 3D elements and fun activities can keep learners a step ahead. Moreover, metaverse learners feel less distracted, as they can comprehend subject topics bet

Conclusion

The term metaverse has been able to draw massive attention ever since Facebook was rebranded to Meta. It has stoked the interest of top brands and businesses already investing in several metaverse projects. Although the metaverse concept is also creeping into the academic field, its possibilities in the education sector are yet to be fully unlocked. "Security Analysis" is indeed a book that speaks for its glory, being the only book about investment which has its value at the top position throughout the years.

The core focus of this book is its guidance and valuable advice which shows the way for anybody who wishes to be a successful individual investor. It has the most reliable financial advice - this is concluded based on the fact that; the authors have survived and understood several financial instabilities such as the Great Depression and world war 2.

"But investing isn't about beating others at their game. It's about controlling yourself at your own game."

Benjamin Graham, The Intelligent Investor As a first-time reader, the book acquaints us with the basics of value investment and profit making.

Graham has precisely laid out a margin of safety principle that can be used to obtain profit. It reveals how particular stocks can be bought when their market price is below the original value and earn Back the profit when their true value returns.

He has given a clear definition that any investment is like an operation which upon complete analysis will promise us the safety of principal and an adequate return. If the investment doesn't meet these requirements then it should be speculative.

In a nutshell: Investment must keep the principal safe and must deliver a return. If it doesn't meet the two conditions it's only a speculation.

This book proved to be revolutionary as it promoted investors to take a different approach by viewing the value of the business that lies behind security.

This set a whole new benchmark in the field of investment. The authors introduced terms like margin of safety for the first time



The industries with the highest turnover rates have included hospitality, healthcare, and education.



INTRODUCTION



Despite its revocation by the Indian Constitution in 1948, it's needless to say that we still have a long road ahead of us to eliminate it from our nation.

Caste Discrimination just like a lot of other issues of action in our nation has had a reputation of being seen in the light of being just a social issue rather than something that hinders development, growth, corporate decisions and the entire economy as a whole. This article will focus on this very relation and how we, as the younger generation could make an impact.

Organizations and Companies

With the advent of labour laws and labour rights groups, discrimination based on caste is highly refuted by most organizations. But while the policy looks good on paper, acting upon it exposed organisations to their failure to adhere to these policies.





In 2021, the class four workers Oil Corporation from the Indian Limited (IOCL) in Jaipur belonged to the scheduled caste community were prohibited from using the restrooms inside despite being the ones that were given the responsibility of cleaning them in the first place. They were also not allowed to use other facilities in the organization like the lift or the facility. This is just canteen example out of the hundreds of similar cases that takes place almost every day in our nation.

The National Education Policy (2020) clearly orders all higher educational institutions to "strictly enforce all nodiscrimination and anti-harassment rules". But the cases of Dalit students being beaten up by their teachers and students suicide due to harassment faced in their settings, otherwise. say classroom (Example: Case of Nikhil Kumar of Auraiya). The COVID-19 pandemic and the subsequent shift to online classes along with rampant unemployment have worsened the accessibility for students from the community. According UNICEF, the drop-out rates secondary schools especially female students have skyrocketed in the past year. This widening gap in education is opportunities limiting for underrepresented communities thereby hindering economic development.

- Work with Non-Profit organizations specializing in caste discrimination to further understand gaps in income, housing and other basic facilities.
