As we welcome the beginning of the new year, I wanted to take this opportunity to tell you about my experience this past Veterans Day. While on "holiday" in Australia on November 11, I was fortunate to observe the respect and reverence our valued "Aussie" Allies bestowed upon their heroes "down under".

My wife and I were enjoying a tour through the Daintree Rainforest in Queensland, Australia, when we drove past a coastal roadside Veteran's Memorial overlooking the Great Barrier Reef. We sped past, but not before I noticed several locals setting up flags and chairs in front of it for their Remembrance Day observance. Our guide informed us that we would briefly stop just before 11:00 a.m. so we could observe a minute of silence at the 11th hour, of the 11th day, of the 11th month, to honor his country's Veterans. I can honestly say that I did not realize what day it was as my mind was still on this side of the International Date Line.

As promised, our guide pulled over, as did every vehicle that I could see in front or behind us, at approximately two minutes before 11:00, shut down the bus and respectfully asked us to remain silent until 11:01. To say that I was moved was an understatement. In the 50 plus years that I can remember, including my 24 years of active duty service and my time with the VFW, I do not recall a time, outside of 9/11, when the **population** of this country, stopped what they were doing, and remembered the Veterans who have fought to secure the freedoms they cherish. Don't get me wrong, I know we conduct numerous ceremonies, wreath layings and speeches. In fact, every year my Post 7308 participates in a Veterans Day ceremony held by the Village of Pleasant Prairie. However, as the ceremony is going on, cars and trucks speed by without giving any consideration to what we are doing.

My point is this: how amazing is it to have everyone across a country, stopping everything they are doing, for just one minute, to remember the men and women of their nation who have served in the Armed Forces? Since then, I have done some reading regarding how our Allies down under "take care" of their

At the most recent VFW National Convention, the membership approved the wearing of an **alternative baseball-style cap** when serving in an official capacity. This newly authorized cap is intended for wear during Post meetings, official functions, community events, and other occasions where members represent the Veterans of Foreign Wars.

The alternative cap is designed to serve as an option to the traditional overseas cap, offering increased comfort and a different appearance while continuing to clearly represent the VFW organization. The design features the Cross of Malta on the front; the Post number or Department on the right side; title and years of service (if applicable) on the left side; and "Veterans of Foreign Wars" on the back, with an option to add "Life Member" or "Legacy Life Member." Caps are available with **Post, District, or Department-colored bill trim** [Gold, Green or Red respectively].

Discussion at the National Convention centered on the need for a cap that clearly displays who we are as an organization and can be worn more broadly in the community. The approval reflects an effort to adapt to changes in membership demographics while maintaining the professionalism and identity of the VFW.

Greetings fellow Wisconsinites,
I hope all are doing well, coming up to the half way point of the Command year. As of this writing, 38 Posts have met or exceeded the 101% Membership Goal already, with 28 Posts at 100%, knocking on the door to the Goal. That is crazy for only being half way – let's keep up the momentum.

Traveling around with the Command Team visiting Posts and doing Special Events, along with doing my District Inspections, I have been noticing a trend that I feel needs some attention. We are all doing great work at the Post level but we are not taking credit for it. Looking at the Department's Check List on the State Web site there are too many zeroes next to the Community Activity Reports.

Commanders: you need to make sure you or a member of the Post is logging the activities the Post is doing. Following the criteria on the Online Report Form found in the **Members Only Section** you should find a topic that fits mostly everything we do as a Veterans Service Organization. One of our main pillars is Community Service which we all do well, let's take the credit for it so our Department has the ability to have the numbers to back up our mission.

NOTE: The Mid-Winter hotel portal is still active on the state website - see page 6 of this issue, so get your reservation in. Also see the Tentative Agenda in this paper. Come out and support our Students and Teachers at the Banquet as we announce the winners in Voice of Democracy, Patriot's Pen and Teacher of the Year.

Ty's Commander shirts are still available up on the State site, again in the Members Only section. If you don't have access you can reach out to me directly. Thank you for all you continue do to "Make it Count".

Commanders and Quartermasters:

Now's a good time of year to take a close look at your Post rosters and pay particular attention to any member whose information is in **red**.

Red designates that the address on file at National HQ is **undeliverable** and it is likely that mailings from National, Department and maybe your Post, are not getting to your member. There are a number of reasons for this to occur.

The first is that your member moved and didn't update their address with the Post or National. A second reason may be that they are snowbirds and spend winters in a much warmer climate and didn't inform the VFW of their temporary address change. Lastly, it is possible that they may have passed away, and no one noticed.

At any rate, members who are undeliverable are not being served properly by the VFW since there is an information void that prevents mailings from reaching them. All the above situations are easy for Quartermasters to fix using the **VFW Online Membership System** (OMS) to complete an update. The difficult part is getting updated information from the member.

I recently got my own Post's roster squared away, and I was curious what was going on at other Posts. I was a little bit concerned at what I found. In District 9 for example, I counted 156 undeliverable addresses out of 2,842 members. That's 5.5% of the District's membership. I feel that the percentages in other Wisconsin Districts will be about the same. This is **not** actually a **District** problem. Posts can easily see the bad addresses on their roster and contact their member for an update. Larger Posts

appear to have more bad addresses. In one case, a large Post had 57 bad addresses, which is 10% of their membership. This would be a lot of work for one person to take on so the Post Membership Committee should be asked to help get the updates needed.

National HQ told me that undeliverable Life Members stay on your roster, waiting to be corrected. A correction can be as simple as adding an apartment number to the street address, or as difficult as tracking down someone who moved to another state or passed away.

Post Quartermasters should constantly review their Post rosters and take action quickly to update address information, as well as any other information that may be incorrect such as e-mails and phone numbers. Start by trying to call or e-mail the member or contacting a relative or neighbor. Maybe a short road trip and "Buddy Check" is needed to get the information.

I hope that every District Quartermaster discusses this issue with Posts at their next District meeting so that the VFW can "Make it Count" for every member.

or participating in local VFW or community programs can maintain strength and

mobility. Equally important is mental health: staying connected with fellow Veterans,

attending Post meetings, or reaching out when stress feels overwhelming.

Wisconsin Veterans also have access to a wide range of resources, including VA health

care; Whole Health programs; Mental Health Services and community-based support. These

programs are designed to treat the whole person, mind, body, and spirit, not just a diagnosis.

This New Year, let's encourage one another to make health a priority. Supporting

our fellow Veterans, checking in on those who may be struggling, and taking proactive

steps for our own well-being honors the service we've already given, and strengthens

To update all of the happenings at your friendly neighborhood Service Office:

The Government shutdown did throw a big old wrench in the whole Service Office operation. This was the first time the Service Officers could not work outside of the office, which is not an ideal situation. However, we were able to keep representing our clients by working with our partner agency "VetsNet", the Wisconsin Veterans Network. They were gracious enough to let us work out of their office, which meant there was little to no lack of services from us. Though it did make it a lot harder to deal with our case load, and it took a lot longer for us to get back to people and respond.

Now that the shutdown is behind us, there are new things learned about what is needed to keep making these types of "curve balls" less of an issue in the future.

In other news, if you have any questions regarding the new Post Benefits Advisor (PBA), I plan on setting up some training at the State Convention in June. Please make sure your Post and Districts let us know who would like to participate in that training.

DID YOU KNOW...?
VA Non-Service Connected Pension (NSC Pension)
• What it is:

A needs-based, tax-free monthly benefit for low-income wartime Veterans.

• Who's eligible:

Wartime Vets with honorable service, 90+ days active duty (one day during a wartime period), meeting age/disability (permanent and total) and income/net worth limits.

• Purpose:

Helps offset catastrophic medical costs when unreimbursed expenses exceed income, especially for older Vets.

• How to apply:

Use VA Form 21P-527EZ.

STATE OFFICERS

Hello,

I am hoping you all made it through the Holiday Season! It got cold early this year, maybe that means we will have an early Spring. The next scheduled events we have coming up are our State Mid-Winter Conference in Appleton and the National Washington, DC Conference.

Two notes from National Commander Carol Whitmore - General Orders No. 4:

1. Commanders on all levels are reminded that according to Section 105 of the National Bylaws, a member whose dues are unpaid after their anniversary date ceases to be a member in good standing and loses all rights of membership in the Veterans of Foreign Wars. They shall not attend meetings or Conventions and shall not participate in Post, County Council, District, Department or National functions.

2. The attention of Department, District, County Council and Post Commanders is directed to Section 103 of the Manual of Procedure, which prescribes the manner in which applications for membership will be handled. In Combat in Korea Eighteen Veterans Remember the War

small town in Wisconsin. Who as a sixteen-year-old High School Sophomore, heard a teacher preach that "The Korean War was the first war America had lost". Recalling his Great-Uncle Smokey's and his Grandfather Sonny's rare and sparse words about their Korean War experiences, Ryan rebuffed his teacher who laughed and challenged the student to get the facts from his relatives. Ryan's father warned him, "Don't get your grandpa started with something said by a liberal teacher. He'll be off on a rant and never stop." Grandpa's exact response (nearly): "You tell that goddamned liberal pinko communist teacher he doesn't know what the f*** he's talking about. Ask him if they teach you that our machine gun barrels would melt."

From there, Ryan learned all he could about the Korean War, and then in 2022, this self-described "blue collar electrician and valve technician", took on a mission to ensure this war, in which his grandfather and great-uncle fought,

would be remembered. Taking overnight drives across the United States, he interviewed Korean War Veterans who recounted the most terrifying times of their lives. Walkowski and author Ed Gruber, a Navy and Korean War Veteran, sought to present these stories of battles in frigid and monsoon conditions, of fierce warfare in rugged mountains and muddy paddies, of bugle-blaring enemies attacking in waves.

Blunt, profane, hesitant, and tearful, these firsthand accounts of vicious hand-to-hand fighting and other harrowing

experiences provide a stark reminder of the immense devastation that was the Korean War. Ryan gently and mindfully interviewed these Veterans, letting each speak in his own way, at his own pace, and in his own words.




The location of our Washington, D.C. office allows us to monitor all legislation affecting Veterans, alert VFW membership to key legislation under consideration and to actively lobby Congress and the administration on Veterans' issues. By testifying at Congressional Committee hearings and interacting with Congressional members, the VFW has played an instrumental role in nearly every piece of Veterans' legislation passed since the beginning of the 20th century.

Everything we do on Capitol Hill is with the VFW's Priority Goals and Veterans' well-being in mind. With the strength of the more than 1.4 million members of the VFW and its Auxiliary, our voice on Capitol Hill cannot be ignored!"

Our 2026 Priority Goals are:

- Budget
- Disability Assistance and Memorial Affairs
- Education, Employment and Transition Assistance
- Health Care
- Military Readiness
- National Security, Foreign Affairs and POW/MIA.

Budget

To fully fund relevant programs for veterans, service members and their families, Congress must:

- Hold leaders accountable to "Honor the Contract" and uphold their end of the military service contract by opposing any effort to cut or reduce veteran benefits.
- Ensure sufficient, timely appropriations and proper budget oversight for VA.
- Authorize VA to receive reimbursements from TRICARE and Medicare.
- Never reduce one veteran's benefits to pay for another.
- Modernize and reform VA and DOD programs that do not meet the needs of service members, veterans and families.

Disability Assistance and Memorial Affairs

To ensure veterans and their survivors have timely access to earned benefits, Congress and VA must:

- Implement the VFW's recommendations to improve the VA disability claims process, specifically appeals, digital claims, DBQs and disability examinations.
- Crack down on unaccredited claims consultants known as Claim Sharks.
- Study all toxic and environmental exposures, and implement programs to ensure health care and benefits are provided to all exposed service members and veterans.
- Increase Dependency and Indemnity Compensation, burial allowances and other benefits for survivors.
- Improve the accuracy of disability compensation claims related to military sexual trauma.

Education, Employment and Transition Assistance

To ensure veterans succeed after leaving military service, Congress, VA, DOD and DOL must:

- Improve education benefits through modernized student housing and supply allowances, child care stipends, parity for National Guard and Reserve members and elimination of delimiting dates.
- Improve the delivery of the Veteran Readiness and Employment program to include administrative support for counselors and standardized training.
- Ensure parity of VA and DOD education programs with other federal programs.
- Expand small business, hiring preference, tax incentives and entrepreneurship resources for veterans and military spouses.
- Increase funding for HUD-VASH vouchers, grant and per diem payments and pilot programs to combat veteran homelessness.
- Conduct oversight of VA's Transition Assistance Program to ensure compliance with the law, and require the inclusion of accredited claims representatives.
- Protect the VA Home Loan Guaranty program and expand it to the reserve components.
- Eliminate red tape preventing effective use of education and employment benefits.

National Security, Foreign Affairs and POW/MIA

To fully support the all-volunteer force, protect our nation's citizens and defend American interests around the world, Congress and DOD must:

- Ensure DPAA is fully funded to perform its personnel recovery mission.
- Deter threats to our national security by supporting our allies in Ukraine, Israel, Korea and Taiwan.
- Ensure all service members who served in harm's way—to include foreign nationals, translators and allies—receive the recognition, care and benefits they may have earned.

Health Care

To ensure service members and veterans receive timely access to high-quality health care without increasing cost shares, Congress, VA and DOD must:

- Eliminate service member and veteran suicide.
- Improve the coordination of community care at VA, including CHAMPVA and the Foreign Medical Program.
- Strengthen care and research for mental health, blast overpressure and traumatic brain injuries.
- Research the efficacy of alternative therapies for PTSD.
- Improve oversight of Vet Centers to ensure adequate staffing, resources and funding.
- Enhance programs and services for women and underserved veterans.
- Preserve the integrity of TRICARE.
- Properly implement VA and DOD health IT systems.
- Expand nursing home eligibility and long-term care options.

Military Readiness

To maintain a strong and ready all-volunteer force capable of protecting American interests, Congress and DOD must:

- Enhance quality of life and health care programs that allow service members to focus on the mission.
- Ensure equity of benefits for reserve component service members.
- End the military retirement pay and VA disability compensation offset.
- Provide benefits enrollment for all transitioning service members.
- Eliminate sexual assault and harassment from the military.
- Increase military base pay so that it is competitive with relevant civilian pay.
- Ensure that military housing and work spaces are safe and modern.
- Eliminate food insecurity in the military.




So What ARE “The Cooties”?

The Military Order of the Cootie of the United States (MOC) is a non-profit Veterans Service Organization known as “The Honor Degree of the VFW”. Founded in September 1920, the MOC is based on the principles of good humor and fun. Following the outbreak of WWII, the Cooties recognized a need to entertain hospitalized troops and Veterans during their confinement and rehabilitation at Veterans Administration facilities throughout the country. The MOC service program is described as a directive to “Keep ‘em Smilin’ in Beds of White.” Each year the Cooties volunteer thousands of hours of time worth nearly 20 million dollars (2024-25) to VA Hospitals and domiciliaries throughout the United States.

Why a “Cootie”? When the MOC was founded, most of the VFW members were WWI Veterans. They looked for something humorous that they all had in common – the parasitic louse they all spent many non-combat hours attempting to eradicate was the answer. On the positive side though, Cooties are **Industrious** (you usually find many together); **Fraternal** (they work to remain with their host); **Persistent** (they remain on the job through thick and thin). Their goal is to “Increase and Multiply”, while remaining “Closer than a brother, busier than a bee”.

The distinctive red hat and unusual uniform sets the Cooties apart and draws attention to the plight of those less fortunate. They sacrifice a little of themselves to bring a smile or a laugh during what is normally a difficult time for our heroes.

In addition to their Hospital work, the MOC also continues to support the VFW National Home in many ways. The Annual Tomb Trek to the Tomb of the Unknowns in Arlington National Cemetery, to honor the fallen, was inaugurated in 1934.



How Do I Join?

Membership in the MOC or the Auxiliary (MOCA) is open to active VFW and VFW Auxiliary members in good standing, who have demonstrated their ability as a leader in their Post or Auxiliary. The other requirement is to honor the MOC prime directive: Have Fun.

Upon announcing their candidacy for **VFW** or **Auxiliary** elected office – whether new candidate or current office holder – those running for office are afforded **one “free article”** outlining their announcement and qualifications. Space is limited, so standard editing policies apply, with 450 words maximum. A “Dear Comrades” (“Dear Auxiliary Members”) announcement letter format seems to work pretty well. Candidates must also supply one good quality “head and shoulders” .jpg photo electronic file for publication. Current “file photos” may be used as well. **Publication of the “free article” is typically scheduled for the March issue**, following the Mid-Winter Conference.

Candidates are then encouraged to purchase paid advertising in the Wisconsin VFW News at the substantially discounted VFW member rates currently in effect. **These ads typically publish in the March and/or May papers.**

Submitting Items to the **WISCONSIN VFW NEWS**

The following tips will give your item its **best** chance at getting published.

- Items may be snail-mailed, but EMAIL is **best** – wivfweditor@gmail.com
- Try to send items right away and no more than 2 weeks after the event.
- Consider *publicizing your public events in advance*. (See page 3 in paper for DEADLINES)
- **PHOTOS:**
 - > MUST be IN FOCUS.
 - > **MINIMUM** .jpg file size is 1 MB or larger, but the larger the file, the better.
 - > MUST be an **ORIGINAL** image, not cropped or reduced. Downloaded or emailed (**NOT TEXTED!**) from the original digital device is the **BEST**. Those photos will usually be **2-4 MB** in size, which is **much better** for our printing purposes.
 - > **SEPARATE** .jpg files, **NOT** embedded in word documents please.
- A well-grouped and lighted photo with *everyone looking at the same camera*. You have a better chance of a better photo if folks take photos **ONE CAMERA AT A TIME!**
- Out of focus? Can't use. Period. Check what you just took on your device **before** the group disperses. Then you'll see if you need more takes!
- Take a nice GROUP shot of all winners – we probably don't have room for 3-6 photos from each event. And group them in a nice sitting/standing group – not spread out in one line!
- **Action** photos – doing, building, hauling, folding, saluting, etc. - create extra interest.
- Names (and titles) of those in the photo **MUST** accompany the photo submission. Period. List them left to right, by rows/seated/standing – whatever applies. Interesting details are a bonus!
- You do **NOT** need to write a “perfect story” – just make sure you supply all of the important details!

Visiting WVH Union Grove


