Understanding Oklahoma Criminal Law and Your Rights


Bail and Bond System in Oklahoma

In Oklahoma, the bail and bond system plays a vital role in the criminal justice process. Bail refers to a monetary guarantee paid to the court to ensure that a defendant appears for future court dates. If the defendant attends all required hearings, the bail amount is refunded.






Conversely, if the defendant fails to appear, the bail is forfeited. The courts have also recognized that bail can be set for additional purposes, provided it does not exceed what is necessary for those purposes. Resetting Bail in Oklahoma While your charge is pending, you can file a motion to reduce your bail at any time. Oklahoma statutes prioritize ensuring the defendant's presence at trial and protecting public safety as the primary governmental interests. What's The Difference Between Bail and Bond Bail is a cash deposit or property amount submitted to the court as a guarantee for your appearance at court proceedings.



Although both bail and bond serve to ensure court attendance, cash bail is refundable at the conclusion of your case, while a bond is based on a percentage of the bail amount and does not require full payment upfront. Typically, a bondsman will charge 15% of the bail amount. Although the initial payment is lower with a bond, this amount is not refundable at the end of your case.
