

# Coroner's Court Opens In TCI



The Coroner's Court has been achieved under the stewardship of Chief Justice Mabel Agymang.

On 20th November 2023, the first Coroner's Court of the Judiciary of the Turks and Caicos Islands was officially opened. The establishment of a court dedicated to coronial matters is the response to a growing need to deal with the increasing number of unexplained deaths in the islands. The resultant backlog requires the focused, urgent attention of a magistrate dedicated to the performance of this very important jurisdiction of the court.

The function of the Coroner includes the making of orders for postmortem examinations, the holding of inquests to determine the causes of, and circumstances surrounding unexplained deaths, matters related to streamlining procedures in relation to sudden or unexplained deaths, and ancillary matters.

The work of the Coroner assists in providing answers to grieving families regarding the cause of death of their loved ones, giving them closure. The exercise of the coronial jurisdiction also ensures the safety of the country, as the Coroner may provide recommendations to relevant institutions and to the Government for measures that may prevent reoccurrence of accidents that lead to death.

On 18th August 2023, Her Honour Ms. Mickia Mills was appointed the first Coroner of the Turks and Caicos Islands.

Her Honour Ms. Mickia Mills assumed office on 15th November 2023, in time for the first sitting on November 20, 2023.

# “Fresh” Squatter Settlement Identified In Blue Hills



SIMONS: “There is no way that those people are going to have any kind of settled future there.”

The Informal Settlements Unit (ISU) said it has discovered an additional squatter community located somewhere in Blue Hills, Providenciales, inching up the total of informal settlements in the Turks and Caicos Islands to 46.

Head of the ISU retired judge, Justice Carlos Simons made the revelation while addressing a media briefing at this office at the Laporte Plaza in Providenciales on Monday, November 27. “Within the last three weeks, a fresh new in-

formal settlement has been discovered...we say ‘discovered’ because the various agencies don’t have the staff or the equipment to keep a 24-hour/seven days a week surveillance. So, in Blue Hills, on Crown Land, an informal settlement has been discovered that brings the number in the TCI altogether to 46 informal settlements now. And this one is on Crown Land...entirely on Crown Land,” Simons revealed. He pointed out that since they settlement is

Crown Land, the occupants would be forced off the land.

“There is no way that those people are going to have any kind of settled future there. And the overarching objective of the ISU is to build safer, more sustainable communities in the TCI. That (newly found settlement in Blue Hills) is not safe, sustainable community. And so, along with others, it will be dismantled as the time approaches, and the work of the ISU permits,” Simons affirmed.

He added: “We are not sure how many (structures are on the land), but from the aerial footage that we have seen, and the ground level inspection that we have been able to do, it appears to be around 30 potentially habitable structures.”

The ISU Head pointed out that he would not divulge any information at this time regarding the location of the newly discovered squatter settlement, because of, among other things, to not create a sense of uneasiness among the occupants until the situation is properly assessed. “One of the things we don’t want is to create concerns where we can lower the temperature. But I made that statement (regarding the new squatter settlement’s discovery) because I think it ought to be made. And people ought to know that the building of illegal structures must stop...it simply must stop. And this has been done in the face of all the appeals that historically have been made, and more recently have been out of this office,” Simons noted. Simons told the reporters that the ISU has had successes recovering land previously in the possession of squatters. However, he was unable to say at the time how much was recovered.

“We have not begun to measure the structures (recovered). What we have done is, we have tabulated the number of acres that have been occupied by informal settlements, and we have deducted from that total acreage the acreage that have been recovered.

“So, I think the number of acres that we are dealing with is probably in the region of about 500 or more, and most of it is in Providenciales, some in Grand Turk,” he said.

To fully recover land now occupied by squatter, Simons warned that it would take some time because of the approach the ISU will be willing to take.

“We don’t know how long it is going to take, and we don’t know how much it is going to cost. But we know that it is going to take a while, especially if we intend to approach the work in a humane and equitable way, which we intend to do, without putting people out in the road, especially young children, older folks or other persons who are challenged in any way,” he promised.

# DIRE CLIMATE CHANGE WARNING FOR TCI

By the end of the century, it is predicted that about 10 percent of the Turks and Caicos Islands land mass could disappear under water, if more is not done globally to combat the rapid rate of climate change, according to the latest United Nations Development Programme (UNDP) Sea Level Rise Platform finding.

New hyperlocal data released by Human Climate Horizons, a collaboration between the United Nations Development Programme (UNDP) and the Climate Impact Lab (CIL), maps in detail this fivefold increase in susceptibility to flood damage along the world's densely populated coastlines. The data platform makes it possible to see where sea-level rise impacts may most threaten homes and infrastructure.

Latin America, the Caribbean, the Pacific, and Small Island Developing States (SIDS), including the Turks and Caicos Islands are at the forefront, projected to lose significant land and critical in-

frastructure to permanent inundation. It is predicted that hundreds of highly populated cities are exposed to increasing flood risk if the current emissions pathway is left unchecked. The UNDP said at the highest levels of global warming (SSP5-8.5), approximately 160,000 square kilometers or 61,776.34 miles of coastal land (an area larger than the territory of Greece or Bangladesh) would be inundated by 2100, compared to a future with no climate change. According to the UNDP, new data revealed that the extent of coastal flooding has increased over the past 20 years because of sea level rise, meaning 14 million more people worldwide now live in coastal communities with a 1-in-20 annual chance of flooding. "Continuing our current course of global greenhouse gas emissions (SSP2-4.5) is projected by the end of the century to expand this 1-in-20 floodplain to areas today populated by nearly

73 million people," the UNDP said in a statement.

According to the UNDP report, which was released on November 28, 2023, by 2039 the Land Inundation Impact rate per average for the Turks and Caicos Islands is predicted to stand at .073 percent, with the global average predicted to be at 0.02 percent.

The UNDP report further stated that by midcentury – 2040 to 2059 - the Land Inundation Impact is estimated to rise at an average of 2 percent, and an estimated global average of 0.04 percent. And by the end of the century – 2080 – 2099 – the Land Inundation Impact average for the TCI could rise by an average of 10.8 percent, with the world average predicted at 0.09 percent.

As it relates to the expected Land Inundation Impact per Kilometer for the Turks and Caicos Islands, the UNDP said by 2039, 6.8 square kilometers or 2.6 square miles of its land will expose to sea level. At that time the global total inundation is expected to stand at 26,956 square kilometers or 10,407.77 square miles.

The report further stated that between 2040 and 2059 the number could rise to 18.7 square kilometers or 7.2 square miles, with the world's number set to increase to 47,734.2 square kilometers or 18,430.27 square miles. The UNDP noted that by 2080 to 2099, the TCI stands to lose 100.6 square kilometers or 38.84 square miles of its land mass. At that time the world average is expected to climb to 113,538.4 square kilometers or 43,837.42 square kilometers.

The UNDP predicted that by the next decade sea level rise average for the Turks and Caicos Islands is estimated to climb to 11.4 centimeters or 4.48 inches, with the global average predicted at 8.47 centimeters or 3.33 inches. By midcentury the sea level rise for the Turks and Caicos Islands will jump to 24.8 centimeter of 9.76 inches, with the global level estimated to be 18.15 centimeters or 7.14 inches.

And by the end of the century, the sea level rise for the Turks and Caicos Islands is set to jump to 55.4 centimeters or 21.81 inches, with the world average rise set at 40.73 centimeters or 16.03 inches.

Looking at the Population Flood Exposure Impact for the Turks and Caicos Islands, the UNDP stated that by the next decade, the number should register at 2.9 percent, with the global average being 0.18 percent by midcentury, the number is expected to rise to 6.39 percent, with the global average set at .039 percent. And by the end of the century the population flood exposure impact should affect 12.39 percent of the local population, and globally 0.9 percent. The latest data derived from satellite and tidal gauge observations and model ensembles from the Intergovernmental Panel on Climate Change (IPCC) Sixth Assessment Report.

"These projections are not foregone conclusions, instead, they can be a catalyst for action," said Hannah Hess, associate director at the Climate Impact Lab. "Swift and sustained action to reduce emissions will affect how quickly and how much coastal communities are impacted. Reducing emissions not only mitigates risk but buys us more time to proactively respond and prepare for rising seas."

# Towards a brighter tomorrow

It is a few days over a year since India assumed the G20 presidency. It is a moment to reflect, recommit, and rejuvenate the spirit of 'Vasudhaiva Kutumbakam' (One Earth, One Family, One Future).

As we undertook this responsibility last year, the global landscape grappled with multi-faceted challenges, among them recovery from the pandemic, looming climate threats, financial instability, and debt distress in developing nations, all amid declining multilateralism. In the midst of conflicts and competition, development cooperation suffered, impeding progress.

Assuming the G20 chair, India sought to offer the world an alternative to status quo, a shift from a gross domestic product (GDP)-centric to human-centric progress. India aimed to remind the world of what unites us, rather than what divides us. Finally, the global conversation had to evolve; the interests of the few had to give way to the aspirations of the many. This required a fundamental reform of multilateralism as we knew it.

Inclusive, ambitious, action-oriented, and decisive, these four words defined our approach as G20 president, and the New Delhi Leaders' Declaration (NDLD), unanimously adopted by all G20 members, is testimony to our commitment to deliver on these principles.

Inclusivity has been at the heart of our presidency. The inclusion of the African Union (AU) as a permanent member of the G20 integrated 55 African nations into the forum, expanding it to encompass 80 per cent of the global population. This proactive stance has fostered a more comprehensive dialogue on global challenges and opportunities.

The first-of-its-kind 'Voice of the Global South Summit', convened by India in two editions, heralded a new dawn of multilateralism. India mainstreamed the Global South's concerns in international discourse and has ushered in an era in which developing countries take their rightful place in shaping the global narrative.

Inclusivity also infused India's domestic approach to G20, making it a people's presidency that befits that world's largest democracy. Through "Jan Bhagidari" (people's participation) events, G20 reached 1.4 billion citizens, involving all states and Union Territories (UTs) as partners. And, on substantive elements, India ensured that international attention was directed to broader developmental aims, aligning with G20's mandate.

At the critical midpoint of the 2030 agenda, India delivered the G20 2023 Action Plan to accelerate progress on the sustainable development goals (SDGs), taking a cross-cutting, action-oriented approach to interconnected issues, including health, education, gender equality, and environmental sustainability.

A key area driving this progress is robust digital public infrastructure (DPI). Here, India was decisive in its recommendations, having witnessed the revolutionary impact of digital innovations like Aadhaar, UPI, and Digilocker first-hand. Through G20, we successfully completed the DPI Repository, a significant stride in global technological collaboration. Featuring over 50 DPIs from 16 countries, it will help the Global South build, adopt, and scale DPI to unlock the power of inclusive growth.

For our One Earth, we introduced ambitious and inclusive aims to create urgent, lasting, and equitable change. The declaration's 'Green Development Pact' addresses the challenges of choosing between combating hunger and protecting the planet by outlining a comprehensive road map with employment and ecosystems being complimentary, consumption is climate conscious, and production is planet-friendly.

In tandem, the G20 declaration calls for an ambitious tripling of global renewable energy capacity by 2030. Coupled with the establishment of the Global Biofuels Alliance and a concerted push for green hydrogen, the G20's ambitions to build a cleaner, greener world is undeniable. This has always been India's ethos, and through Lifestyles for Sustainable Development (LiFE), the world can benefit from our age-old sustainable traditions.

Further, the declaration underscores our commitment to climate justice and equity, urging substantial financial and technological support from the Global North. For the first time, there was a recognition of the quantum jump needed in the magnitude of development financing, moving from billions to trillions of dollars.

G20 acknowledged that developing countries require US\$5.9 trillion to fulfil their nationally determined contributions (NDCs) by 2030. Given the monumental resources required, G20 emphasised the importance of better, larger, and more effective multilateral development banks. Concurrently, India is taking a leading role in UN reforms, especially in the restructuring of principal organs like the UN Security Council that will ensure a more equitable global order.

Gender equality took centre stage in the declaration, culminating in the formation of a dedicated Working Group on the Empowerment of Women next year. India's Women's Reservation Bill 2023, reserving one-third of India's Parliament and state legislative assembly seats for women, epitomises our commitment to women-led development.

The New Delhi Declaration embodies a renewed spirit of collaboration across these key priorities, focusing on policy coherence, reliable trade, and ambitious climate action.

It is a matter of pride that during our presidency, G20 achieved 87 outcomes and 118 adopted documents, a marked rise from the past.

During our G20 presidency, India led deliberations on geopolitical issues and their impact on economic growth and development. Terrorism and the senseless killing of civilians is unacceptable, and we must address it with a policy of zero tolerance. We must embody humanitarianism over hostility and reiterate that this is not an era of war.

I am delighted that during our presidency India achieved the extraordinary: It revitalised multilateralism, amplified the voice of the Global South, championed development, and fought for the empowerment of women, everywhere.

As we hand over the G20 presidency to Brazil, we do so with the conviction that our collective steps for people, planet, peace, and prosperity will resonate for years to come.

# Police Records Office Operating On Same-Day Processing



**SAUNDERS:** "When it comes to projects, especially Capital projects, Government is set-up like NASA - a bureaucracy. But to get further faster, a SpaceX type structure is needed."

If you apply to the Police Records Office early in the morning, chances are you might get the document back the same day, as that office is now reporting day application processing time. The fast pace with which that office has been processing police records is a far cry from about three months ago when applicants had to wait for up to three months to collect their documents.

Deputy Premier and Minister of Finance Hon. E. Jay Saunders, who designed new processing system told members of the media about efficiency of the new system via social media conversation.

Members of the public, up to recent time, complained bitterly about the snail's pace process that the police record processing system was taking, after the administration of that office

had changed the conventional format to an online platform. Members of the public lamented that because of the ultraslow pace of the police record processing, they were unable to conduct certain businesses, including travelling.

As a result, current Acting Commissioner of Police Rodney Adams reached out to the Deputy Premier and Minister of Finance for his assistance to upgrade the system. Saunders has a rich background in software development. Even though that assignment would fall within the aegis of the Premier's Office, Saunders jumped on it.

"If you remember, 12 months ago, if someone applied for a Police Record, it was taking up to three months to get it. It got so bad that in January 2023, I took on the personal responsibility to fix it," Saunders said.

At the time of completion of the system, Saunders said he was eventually aiming for a same day processing service from that office, based on the software's capacity to process the documents.

"Just three months ago, applicants were complaining that they had to wait three months to collect their police records after application. As you are aware, the new Police Records application was soft launched on the 28th of June 2023. With the fix, we quickly got the Police Records processing time down to three days," Saunders crowed, asserting that the intention for the medium term was to reduce the processing period to a single day.

"Notwithstanding the significant reduction in processing time, I went further and promised a turnaround time of one day by the end of 2023," Saunders further boasted.

He pointed out that last week the administrators of the system reached out to him to convey the good news that the system was already making same day processing for applications that submitted their document in the morning hours.

Saunders said the Police Records Office conveyed to him that as of November 22, that office had processed approximately 11,892 applications submitted.

"The average turnaround time during the week is 24 hours- next business day, and Mr. Williams (from the Police Records Office) reported that he is starting to see that the early morning applications are being processed same day," Saunders added, pointing out that that office had processed 10,000 applications by October 25.

"Very impressive stats!!," Saunders proclaimed. Having achieved that feat, Saunders said he would be seeking to improve other government departments if given the leeway. The long lines outside the treasury almost daily is in his cross-hairs.

"With that milestone, I'm now turning my attention to the long lines that form outside of Treasury every day, for persons to make payments to Government. I'm giving myself until the 31st of March 2024, to put the Treasury line on the endangered list," The deputy premier promised. Akin what he wants to do with e-services in the Turks and Caicos Islands to international space travel, Saunders noted: "Since I'm having a conversation with you all, let me put this in perspective. When it comes to projects, especially Capital projects, Government is set-up like NASA- a bureaucracy. But to get further faster, a SpaceX type structure is needed.

"The new Police Records application worked because I took personal responsibility for its success and failures and made all of the design decisions for it. This is what Elon Musk does for SpaceX. That's why they're able to do space travel better, on a lower budget, with less casualties, than governments, which are known to make decisions by committee," Saunders articulated.

# Ministry of Fisheries Announces Ground-breaking Spiny Lobster Artificial Habitat Program



In response to the significant challenges faced by fishermen in the aftermath of the 2018 hurricanes, the Ministry of Fisheries has announced an innovative pilot program, the Spiny Lobster Artificial Habitat Program.

The initiative is designed to address the decline in spiny lobster catch levels caused by the destruction of natural habitats, consequently impacting the economic viability of lobster fishing for local communities.

#### **Background: Challenges and Economic Impact**

The Caicos Banks, renowned for their rich marine biodiversity, suffered severe habitat loss due to the accumulation of sands in the cracks and crevices of the seafloor after the 2018 hurricanes. This depletion of natural habitats has led to a direct correlation with the decline in spiny lobster catch levels over the years. Compounded by the rise in fuel prices and the overall cost of living, lobster fishing has become a less lucrative endeavour, with the economic cost per day soaring from \$307 in 2010 to \$493 in 2022.

Recognizing the urgency of the situation, the Ministry of Fisheries has undertaken a comprehensive study to devise strategic solutions that not only replenish lobster habitats but also ensure the sustainability of the industry for future generations.

#### **The Spiny Lobster Artificial Habitat Program: A Holistic Approach**

As part of the ministry's commitment to supporting local fishermen and fostering sustainable practices, a pilot program is underway to construct 150-200 artificial habitats on the Caicos Bank. The following key components outline the comprehensive strategy of the program:

The Spiny Lobster Artificial Habitat Program, spearheaded by the Ministry of Fisheries, is not just a strategic move to revitalize spiny lobster populations but a dedicated effort to enhance the livelihoods of fishermen and their families. The program's multi-faceted approach, encompassing financial incentives, community involvement, and ecological conservation, aims to bring about tangible and lasting improvements to the lives of those who depend on the sea for their sustenance.

#### **Valuable Caribbean spiny lobsters get their food from an unexpected source**

Artificial habitat serves to provide lobsters with shelter and thus increasing their survival from natural predators.

The infusion of financial incentives into the Spiny Lobster Artificial Habitat Program serves as a life-line for fishermen, providing them with a supplementary income during traditionally challenging periods, such as the Christmas/Winter Season. By compensating registered fishermen for their labour in constructing artificial habitats, the program offers not only a short-term economic boost but also establishes a foundation for long-term sustainability.

While the tourism industry has undeniably played a pivotal role in the economic development of the islands, the benefits have not always trickled down to all sectors of society. Fishing communities, such as South Caicos, have stood on the periphery of the economic boom, facing challenges that threaten their traditional way of life. The Spiny Lobster Artificial Habitat Program represents a conscientious effort by the government to bridge this gap and ensure that every Turks and Caicos Islander shares in the prosperity of the nation.

In expressing her commitment to the well-being of fishing communities, the Hon. Josephine Connolly, Minister with Responsibilities for Maritime and Fisheries Management, remarked, "Our islands have witnessed remarkable economic growth, particularly in the tourism sector. However, it is crucial that we do not leave behind the communities that have sustained themselves through generations of fishing. The Spiny Lobster Artificial Habitat Program is not just a conservation initiative; it is a testament to our commitment to inclusivity and ensuring that the economic prosperity of the islands reaches every corner and every family."

Minister Connolly further emphasized the importance of sustainable development, stating, "We recognize the delicate balance between economic growth and environmental preservation. This program is designed not just to increase lobster

stocks but to empower our fishermen to thrive in harmony with our marine ecosystems. It is a step towards a future where our traditional ways of life coexist with progress, and where no one is left behind."

As the Spiny Lobster Artificial Habitat Program takes its initial steps, the Ministry of Fisheries remains steadfast in its commitment to a holistic vision for sustainable growth. The success of this program is not merely measured in lobster catch levels but in the improved well-being of fishermen, the resilience of fishing communities, and the equitable distribution of economic benefits across the islands.

The Ministry invites all stakeholders, from fishermen to environmental advocates, to join hands in creating a future where prosperity is synonymous with sustainability. The long-term vision of this project is that these artificial habitats will increase spiny lobster stock levels, enhancing profitability for fishermen and indirectly improving their livelihoods.

While this initiative is currently in its pilot phase, its success hinges on the collaborative efforts of the fishing community, stakeholders, and the Ministry of Fisheries. As part of the broader project, "Sustainable Livelihood for Fishermen," the artificial habitat program signifies a commitment to a holistic approach that balances ecological conservation with economic prosperity.

The success of the Spiny Lobster Artificial Habitat Program relies on the collective commitment of the fishing community, government agencies, and environmental organizations. The Ministry of Fisheries encourages public support and anticipates expanding the initiative with a larger number of 4,000 artificial habitats in the coming years. The Ministry will be hosting a public meeting with all commercial fishermen in Providenciales at the Felix Morley community Center on Wednesday 30 November 2023 starting at 6:00 pm to present more information on the proposed lobster casitas and how fishermen can play a role and to hear more about the Ministry's plans to ensure sustainable livelihood of fishermen and their families.

# 'Let It Grow' Programme Blooms in Schools across the Turks and Caicos Islands

The Ministry of Education and Department of Agriculture's comprehensive farming programme, 'Let it Grow', which saw the launch of the island's first in-school hydroponics system at the Clement Howell High School earlier this year, has brought great success to the Turks and Caicos Curriculum Development Unit.

The 'Let It Grow' programme, supported by the Sandals Foundation, was designed to support the establishment of school farms at all public and private educational institutions, providing over 4,000 students and 110 teachers with the necessary skills and knowledge to foster the development of agriculture as an alternative career choice, while promoting entrepreneurship and sustainability within the community.

Now, at the close of its first year of execution, 'Let It Grow' has successfully established farms in fourteen (14) public and two (2) private schools, with each introducing clubs centered around farming concepts. To support the farming in schools programme, upgraded irrigation systems were also set up in eight (8) schools, with others benefiting from needed soil, fencing and other farming resources. The programme provides more hands-on experiences to students - reinforcing the three pillars of the Let It Grow programme- Sustainability, Entrepreneurship and Responsibility.

Heidi Clarke, Executive Director at Sandals Foundation, expressed delight in the outcome of the programme which saw farming concepts being introduced to schools' curriculum via guides, lessons, and project-based learning.





"The Let it Grow programme saw the systematic capacity building of students and teachers from all 14 of the island's public schools where they learned to establish and maintain small farms. These schools have since set up gardens that enable students to grow their own vegetables and fruits, which not only promotes healthy eating habits, but also provides a sustainable source of food for the school. As the foundation zoned in on projects this year that support the region's food security, we couldn't ask for anything else."

Elisann Delancy, Curriculum Development Officer for the Turks and Caicos Islands Government Department of Education, says, "The Let It Grow Programme has made significant progress since implementing Phase 1. Positive results have been seen across the board, with feedback from students and teachers being overwhelmingly positive. The programme's impact has surpassed initial expectations, with students showing an increased interest in gardening and a deeper understanding of environmental issues."

"The success of Phase 1 has raised hopes for future phases of the programme", Delancy continued, "With continued support and investment, the Let It Grow Programme can expand its reach and impact, further promoting environmental awareness and sustainability in schools and communities. The programme has truly proven its worth, and its continued growth and success will undoubtedly benefit future generations."


# Series Of Activities Marked Raymond Gardiner High School 50th Anniversary

# TCI To Benefit from First Caribbean Comtrust's/ CCRIF \$80,000 Disaster Preparedness

The FirstCaribbean International ComTrust Foundation and CCRIF SPC (formerly the Caribbean Catastrophe Risk Insurance Facility) recently met to celebrate the Foundation's donation of US\$75,000 to help enhance rainfall monitoring systems and disaster preparedness in the Caribbean and another US\$5,000 to print and disseminate additional copies of CCRIF's children's publication on "Hazards, Disasters and Climate Change", developed for children ages 8 to 12 years old.

The grant of US\$75,000 will be used to enable at least 4 Caribbean countries to improve their weather monitoring networks by adding automated weather systems and other equipment to their existing networks. These new automated weather systems (AWSs) will enhance these countries' early warning systems and their ability to better prepare for hydro-meteorological events such as hurricanes and severe rainfall events throughout the year.

These systems also can inform longer-term planning. AWSs can incorporate a range of sensors that can provide data to enable national meteorological services to undertake more detailed and reliable analysis of climate trends to inform national strategies on climate change and disaster risk management.

The FirstCaribbean International ComTrust Foundation is a registered charity which was established in 2003, to support CIBC FirstCaribbean's community relations programmes. The Bank makes contributions to causes within the Caribbean in the areas of Health & Wellness, the Community & the Environment, and Youth & Education. Since its inception in October of 2002, through the ComTrust Foundation, CIBC FirstCaribbean has donated more than US\$30M to worthy projects across the Caribbean.

This donation from the ComTrust Foundation

will support an existing initiative currently being implemented by CCRIF that focuses on providing much needed assistance to its member governments to enhance their AWS networks. In 2020, CCRIF worked with the Caribbean Institute for Meteorology and Hydrology (CIMH) to undertake a situational analysis to determine if there were existing gaps in rainfall measuring networks of its member governments and the extent of these gaps.

According to Isaac Anthony, CCRIF's Chief Executive Officer, "The Situational Analysis, which assessed the rainfall measuring network of 19 of CCRIF member governments, indicated that only 5 Caribbean countries have over 70 per cent of the recommended level of AWS coverage. The minimum coverage was 10 per cent of optimal coverage, the maximum was 90 per cent of optimal coverage, with an average of 40 per cent of optimal coverage across the countries".

Having reviewed the report, the CCRIF Board took the decision to provide support under its Technical Assistance Programme to member countries in the region to strengthen their network of automated weather stations (AWSs). CCRIF also reached out to the FirstCaribbean International ComTrust Foundation based on the goals of the Foundation to determine if this was an area that they would be willing to provide support for. The rest is history!

To date, CCRIF has assisted 4 countries (Belize, Antigua and Barbuda, Turks and Caicos Islands, and Cayman Islands), providing them with approximately US\$250,000 in support to improve and expand their rainfall data collection and measurement systems.

These resources from the ComTrust Foundation will support an additional 4 countries to expand their rainfall monitoring networks. CCRIF will

match these resources from ComTrust to support another 4 countries in the region. By the middle of 2024, 12 countries in the Caribbean would have additional AWSs and enhanced rainfall measuring networks, which will help governments to better prepare their populations in the face of the increasing frequency and intensity of hydro-meteorological hazards.

CIBC FirstCaribbean's CEO, Mark St. Hill, who also serves as the Chairman of the ComTrust Foundation, noted: "Our bank is committed to maintaining strong environmental standards and to conducting our activities in an environmentally and socially responsible manner that contributes to long-term value for our clients, employees, communities, and our shareholders. "Climate change has been engaging our region for some time, and our bank has established itself as a leading financial partner for stakeholders seeking to address the issue. We actively seek to support the Caribbean region's transition to a low-carbon economy and advancing of sustainability and climate resiliency initiatives in the territories in which we operate."

The "Hazards, Disasters and Climate Change" booklet allows children to learn about the different types of hazards that affect the Caribbean; actions to take before, during and after these natural hazard events; climate change; and how to take care of our natural environment.

Since its first publication in 2021, CCRIF has distributed over 2,000 copies to schools, ministries of education, disaster preparedness and management agencies, public libraries, and civil society organizations throughout the region. # Marilyn's 'silly little dress'


## What we can learn?

### Film Fashion

We've all seen that iconic 1954 scene (in some form at least) from *The Seven Year Itch* when Marilyn Monroe stood above a New York City subway grate wearing a white dress. As the train passed, her dress blew upwards, with Marilyn flirtatiously trying to keep it down. This scene, while only lasting a few seconds, became one of the most iconic scenes in movie history.—making the dress one of the most famous of all time in the process. Designer William Travilla didn't think much of the white dress, once calling it 'that silly little dress'. Little did he know that it would be celebrated for generations. It was ultimately sold in 2011 for a record \$4.6 million, one of the highest ever paid for a movie costume. This dress has stood the style test of time.

### Thousands of Spectators

Filming this now iconic dress scene took place at 1am while thousands of fans looked on. The take took 14 times to get right while 100 male photographers tried to capture the moment. The scene was then ultimately re-shot on a lot in California as the noise made it difficult to transfer to film. However, the original location shots were what was used for ads and promos. However much fanfare surrounded the filming, this image was made iconic by her confidence. For it's time, filming a scene of such a 'provocative' nature was unheard of. It's rebelliousness of that era was what made it iconic. The confidence with carrying out such a scene, in front of thousands no less, is what made this era-defining.



### Look of Death

Monroe's then-husband, Joe DiMaggio, was apparently less than thrilled at the sight of the seductively billowing dress. In his book, Wilder, director of 'The Seven Year Itch', described the 'look of death' on DiMaggio's face as he stormed off the set to the nearby St. Regis Hotel. It was then chronicled by many that when Marilyn returned to the hotel, the couple was in heated debate. This, apparently being one of several straws that ended their marriage. Back in Los Angeles 3 weeks later, their divorce was announced. News headlines read 'Marilyn Splits with Joe Over Sexy Pics'.

If there's anything we can learn from this ordeal, it's that we should embrace body autonomy, no matter the situation. Marilyn embraced her body and sexuality and in turn became an example to women today on not minimising yourself so that others can feel big. So, don't change what you wear because someone is piercing you with a 'look of death'. Instead, wear what makes you feel good, powerful, confident, sexy. Then, all the right things will follow.

The event, which took place October 23 to 27, forms part of the Caribbean Birding Trail Project – an initiative of BirdsCaribbean aimed at promoting nature-based, authentic experiences that benefit local people and encourage the protection of the Caribbean's natural resources, including birds and their habitats.

Lisa Sorenson, Executive Director at BirdsCaribbean says, "The 5-day interactive program targeted persons working as guides who would like to expand their businesses by adding bird-watching or "birding" to their tour offerings. The sessions were also open to those who work in outreach and education about birds and nature."

Participants explored the importance of preserving the Turks and Caicos Islands' birds and nature while strengthening the island's local ecotourism sector. They also learned bird identification, guiding techniques, and environmental interpretation—making connections to natural resources through story telling. Everyone received a package of materials including binoculars, a bird field guide, bird ID cards, CBT hat, endemic birds of the Caribbean, and many other resources.

"Globally, the tourism market for wildlife watching and wildlife photography is growing, and bird

tourism is a significant part of this market. The Caribbean Birding Trail seeks to attract these markets to the Turks and Caicos Islands and the wider Caribbean. Integral to this is having well-trained guides who can help connect eco-tourism travellers with the cultural and natural resources of the island, creating meaningful and authentic experiences," said Sorenson.

When asked what they most appreciated, one participant commented, "The mix of different people and to be inspired by the facilitators to seek a profitable but sustainable way forward and also a healthy way forward for the spirit. The materials given were awesome! And more than I was expecting.

"The content of the workshop was outstanding, presented at the right pace and by the best instructors," said another participant.

Known for its commitment to the conservation of the Caribbean's natural resources and ecosystems, the Sandals Foundation funded the training workshops and other initiatives to support the creation of a cadre of trained bird and nature interpretive guides on the islands.

Heidi Clarke, Executive Director at the Sandals Foundation said the organisation was, "proud to support this programme which taught participants how to inspire people and engage audiences through storytelling aimed at preserving TCI's incredible birds and nature."

"Collectively," Clarke continued, "We can build a stronger eco-tourism market in TCI that provides sustainable livelihoods and supports environmental conservation. Helping trainees learn about the bird tourism market and how they can tap into this rapidly growing and lucrative ecotourism sector will be beneficial for years to

The Caribbean Birding Trail Certified Interpretive Bird Guide Training Workshop was hosted and coordinated by BirdsCaribbean and the Turks and Caicos National Trust, with additional support from the Department of Environment and Coastal Resources and the Royal Society for

the Protection of Birds.

BirdsCaribbean is an international, non-profit organisation committed to the conservation of Caribbean birds and their habitats. The organisation aims to raise awareness and empower local partners to build a region where people appreciate and conserve bird populations and

ecosystems, through education, science and advocacy.

Similarly, the Turks & Caicos National Trust (TCNT) is a membership, non-profit organisation dedicated to the preservation of the natural, historical, and cultural heritage of the Turks and Caicos Islands.

To verify the validity of your documentation you should contact the Crown Land Unit or check the registers of the title with the Land Registry.





**Someone sold me land and I have a receipt. I have since learned that the land was Crown Land and not theirs to sell. What should I do?**

If the property is Crown Land then you need to contact the Crown Land Unit who will investigate the issue and refer you to the relevant authorities if a fraudulent act has been committed. Under section 23(1) of the Crown Land Ordinance, it is an offence for a person to purport to sell or lease Crown Land to another person without lawful authority or title to do so, whether or not any purchase price or rent is paid.



# What diabetics can do at Christmas



CHRISTMAS IS a time to enjoy yourself and have foods that you would not regularly eat at other times of the year. However, being a time of celebration, many traditional Christmas foods tend to be high in saturated fat, free (added) sugars and salt than our usual diets.

"At some point during the festive period, you may find that you have higher blood sugar levels than normal due to being less active than usual, overindulging, or changing your routine. While one or two high readings should not affect your long-term health or diabetes management, take care not to let your blood sugar levels stay high for long, as you could start to feel unwell," Dr Chybar Virgo said.

She said if you self-test your sugar levels, it is a good idea to do this more often over the Christmas period, so you can catch changes in your blood sugar sooner and avoid a hypo or hyper. "Stress and illness can raise your blood sugar levels," she said.

Although we all love putting our feet up and relaxing over the festive period, it is important to keep active. Being physically active can help lower your blood sugar levels, blood pressure and blood fats over the Christmas period and help you manage your weight.

"There are many easy and fun ways to fit in some physical activity. A brisk walk is a great way to stay active. Playing with the children or dancing the night away at a party can help towards keeping healthy as well. You could also try some active party games," Dr Chybar Virgo said.

Eating and drinking at Christmas time is part of the fun, and there is no need to completely miss out on certain foods and drinks. However, be mindful about what you are choosing, and do not beat yourself up if you do eat more than you usually would, or have foods that are not as healthy for you.

"Everyone should be making healthy food choices year round, but the festive period should not affect your long-term health and diabetes management, as long as you plan for it and get back on track right away," Dr Chybar Virgo said.

## QUICK TIPS FOR HEALTHY EATING DURING THE CHRISTMAS HOLIDAYS

A healthy diet is important for managing diabetes. Try these tips to make your festive occasions a little healthier:

- Fill up on the array of vegetables available.
- Keep an eye on your portion sizes. Fill your plate up with vegetables first, as we tend not to get enough of these.
- Serve yourself, if possible. Someone else might pile certain foods high, so choosing your own options for starchy carbs, protein and healthy fats will help you keep your blood sugar levels on track.
- If you are having a dessert, try to stick to one portion of your sweet treat, and think about what it is served with.
- Do not drink on an empty stomach, as this increases your risk of hypos if you manage your diabetes with insulin or some medications.
- Steam your vegetables rather than fry or boil – this does not use oil and keeps more vitamins and minerals. Including vegetables at each meal can help prevent your blood pressure and blood cholesterol going up over the holidays.
- We should all try to eat less salt to help manage our blood pressure.

# Jamaica repatriates nine Haitians

The nine Haitians who were intercepted near Hope Bay, Portland, on Monday, November 27 after fleeing their vessel shortly after landing on the beach in Long Road on Sunday night, have been repatriated.

The Haitians, five adult females and four adult males, boarded a Jamaica Defence Force (JDF) coast guard vessel shortly before 7 p.m. on Wednesday at the Boundbrook wharf in Port Antonio, after being transported from a holding area at Manchioneal in the parish by the police.

Attorney and founder of human rights group Freedom Imaginaries, Malene Alleyne, who has been

complaining bitterly about the police refusing her access to speak with the Haitians, asserted that once again the Government of Jamaica has violated international law.

Earlier Alleyne had said Freedom Imaginaries requested precautionary measures from the Inter-American Commission on Human Rights. She said that the request was under study and that the Haitians should not be returned home, while the process is under way.

According to Alleyne, there could be serious implications arising from the Government's return of the Haitians to their homeland.

"I think it would mark a very serious disintegration for rule of law in Jamaica and it will have implications for all persons in Jamaica and their rights," she said.

"The Government will not allow us to speak to the Haitians. These things unfolded in a matter of hours at a location very far away. All of these factors militate against access to justice for Haitians. At no time was I granted access to speak to the Haitians. I went to the health facility in Port Antonio and I was barred from speaking to the Haitians. And it has been like this since September involving two separate groups of Haitians," she added.

On Monday, the Portland police launched a search for a group of Haitians, who abandoned their vessel after landing in the dead of night on Sunday at Long Road beach in the parish.

However, the police managed to intercept a taxi near Hope Bay, some 36 miles away from the Long Road beach, and nine Haitians, including one that was residing in St James for more than two years, was discovered aboard the vehicle.

They were taken into police custody and later screened and processed by health officials.

It is still not clear how many Haitians landed in Long Road.

The police say items of clothing belonging to adults and children were discovered in the 28-foot sailboat in which they arrived. However, when the nine Haitians were intercepted in Hope Bay, no children were found aboard the taxi.

# Henry Kissinger, secretary of state under Presidents Nixon and Ford, dies at 100

Former Secretary of State Henry Kissinger, the diplomat with the thick glasses and gravelly voice who dominated foreign policy as the United States extricated itself from Vietnam and broke down barriers with China, died Wednesday, his consulting firm said.

He was 100.

With his gruff yet commanding presence and behind-the-scenes manipulation of power, Kissinger exerted uncommon influence on global affairs under Presidents Richard Nixon and Gerald Ford, earning both vilification and the

Nobel Peace Prize.

Decades later, his name still provoked impassioned debate over foreign policy landmarks long past.

Kissinger's power grew during the turmoil of Watergate, when the politically attuned diplomat assumed a role akin to co-president to the weakened Nixon.

"No doubt my vanity was piqued," Kissinger later wrote of his expanding influence. "But the dominant emotion was a premonition of catastrophe."

A Jew who fled Nazi Germany with his family in his teens, Kissinger in his later years cultivated the reputation of respected statesman, giving speeches, offering advice to Republicans and Democrats alike and managing a global consulting business.

He turned up in President Donald Trump's White House on multiple occasions. But Nixon-era documents and tapes, as they trickled out over the years, brought revelations — many in Kissinger's own words — that sometimes cast him in a harsh light.

Never without his detractors, Kissinger after he left government was dogged by critics who argued that he should be called to account for his policies on Southeast Asia and support of repressive regimes in Latin America.

The Turks and Caicos Islands ladies will go up against Bonaire in their final international match of the year, in the Road to CONCACAF Women's Gold Cup Tournament, at the TCI Field on Monday, December 4, starting at 3:00pm.

The Turks and Caicos Islands, who for all intents and purposes are out of the contention, remain winless after two outings, and would no doubt be looking to end the year on a strong note.

In their game against Belize at home on Oc-

tober 26, the youthful TCI aggregation went down 0-6, in an encounter which saw the local girls almost matching their far more mature opponents stride for stride. In a previous game on September 26, the local girls went down 0-5 to their more fancied opponents Aruba.

This is a game that the TCI should fancy their chances of taking all three points, having drawn goalless with Bonaire at the Stadion Antonio Trenidat in Bonaire on September 21. The TCI, however, will have to fight hard

for that win though, because Bonaire are no pushovers, having beaten one of the group's fancied teams Aruba 3-1 in a home game on October 26.

Aruba, however, got their revenge on October 30 at home when they trounced Bonaire 5-0.

Belize is the only unbeaten team in the competition so far, having won all of their matches.

The 2024 CONCACAF W Gold Cup qualification competition, also known as the Road to CONCACAF W Gold Cup, is a women's football tournament contested by 34 of the senior women's national teams of the member associations of CONCACAF.

The competition will decide six of the twelve participating teams of the 2024 CONCACAF W Gold Cup, the inaugural edition of the W Gold Cup.

The qualification competition, known as the "Road to Concacaf W Gold Cup", began with the group stage, featuring 34 women's national teams of CONCACAF split into three leagues (A, B and C). Each league features three groups, containing three teams each in League A, and four teams each in Leagues B and C.

The teams in each group will play against each other home-and-away in a double round-robin format. The top three teams in League A will qualify directly for the W Gold Cup. The three group runners-up of League A and the three League B group winners will participate in a play-off on 17 February 2024 to compete for the final three spots at the W Gold Cup.

The play-offs were originally planned to take place in March 2024, but have been moved to February to accommodate the W Gold Cup final tournament also being moved from June to February and March 2024). The two CONCACAF women's national teams that qualify for the Summer Olympics in 2024 will receive a bye directly to the W Gold Cup, skipping qualification.
