

How do I know if I am squatting on Crown Land?



Government Provides Update On Oil-based Substance Allegedly Released From Carnival Magic

The Department of Environmental and Coastal Resources (DECR) has provided an update on the discharge of soot from the Carnival Magic as the cruise boat was about to depart Grand Turk.

The following is the news release from the DECR:

A photo of the Carnival Magic, which is alleged to have emitted what appeared to be black oil-base substance off the coast of Grand Turk.

The Department of Environment and Coastal Resources (DECR) wishes to inform the general public about an incident on November 1, 2023, in Grand Turk, which led to the release of a substantial amount of soot into the surrounding environment.

At approximately 17:30 local time on November 1, 2023, a cruise ship bearing the call sign "Carnival Magic" was preparing for departure at the Port of Grand Turk when it experienced a complete blackout. This unexpected power outage resulted in the discharge of a significant quantity of soot from the ship.

The Port Agent promptly notified the Port Authorities and the Department of Environment and Coastal Resources, which swiftly dispatched teams to the scene to assess the situation. Upon examination, it was determined that the substance released into the water was soot, covering an estimated area of around 2000 square feet.

In response to this incident, a comprehensive plan was implemented, which included deploying containment booms to mitigate the spread of the soot away from the ship. Local operator Talbot, who was near the port area, also assisted. The DECR worked assiduously with the Port Authority, Grand Turk Cruise Center, and local volunteers to remove the soot from the water even though unfavourable sea and lighting conditions hampered it.

The Carnival Magic cruise ship departed from the Port of Grand Turk at approximately 8:45 PM that evening.

This incident, a first-time occurrence of this nature in the Turks and Caicos Islands, is currently under investigation. The Department of Environment and Coastal Resources, in collaboration with the Ports Authority and the Department of Fisheries and Marine Resources, is actively working alongside the Cruise Centre to review existing measures. The goal is to prevent future incidents of this kind and enhance the efficiency of response and mitigation measures.

The Minister, Hon. Josephine Connolly, emphasized that the "Ministry and, by extension, the Government remain committed to ensuring the protection and preservation of our pristine environment, and we are dedicated to responsibly addressing this incident."

We appreciate the understanding and cooperation of the community and will provide updates as the investigation progresses.



Tourists Caught With Guns Get Lighter Sentence Than Locals, Says Hon. Jameka Williams

WILLIAMS: "Classism is alive and well in these islands"

Government's Appointed Member to the House of Assembly Hon. Jameka Williams is calling on the Tourism Ministry, Royal Turks and Caicos Islands Police Force and Hotel Association to launch an education campaign to educate tourists on the risk of bringing guns on their trips to the TCI.

Making her contribution in the House of Assembly on October 26, Williams described the incidences of tourist caught with guns and ammunition either on arrival or departure as worrying and unfortunate.

"It is unfortunate that in these islands we have seen a spike in the number of cases with our tourists bringing firearms and ammunition into

the TCI," she highlighted. "Perhaps the Tourism Ministry in collaboration with the RTCIPF and the Hotel Association should launch a campaign to educate our tourist and discourage these actions."

Telling the House that she will always be a strong backer of the police force's fight against criminality, Williams pointed out that the country already has a gun issue and hinted that, tourists arriving with weapons only exacerbates the problem.

"A few months ago, in this house we passed laws to modernize our police force and increase fines and offences as it relates to gun crime. There is no secret that we have an issue with gun re-

lated crimes, and I want to reassure this House that the police department that will always have my support when apprehending those persons who make the decision to carry or use an illegal firearm to cause harm. Last I checked we do not manufacture or distribute firearms in this country. If you are found with an illegal firearm you should be prosecuted.

"But the public has a concern and if they are concerned so am I. Classism is alive and well in these islands. I can go on and on of many examples of it, but I'll stick to the issue of firearm and ammunition," she stated.

She asserted that some tourists were not getting the prescribed sentences stipulated by law as it relates to gun crimes. The penalty for gun crimes in the TCI is automatic incarceration as prescribed by law.

Williams told the House that she believes the playing field should be made equal when it comes to gun crimes. She believes that the justice system should move with equal alacrity and imposition of sentence for all parties regardless of locals or tourists.

"The same tourists that I mentioned who was either found with a firearm or ammunition, in their case it appears as if our justice system handles their cases swiftly and they are given a fine as their penalty although recently a tourist was sentenced to 8 months imprisonment.

"But when it is our Turks and Caicos Islands people who find themselves in similar circumstances, our justice system seems to not move so swiftly, and their usual punishment is the mandatory minimum sentence.

"There must be equality and balance in the penalties and punishments given to firearm offenders regardless of their nationality, race, color or ethnicity," Williams insisted.


She added: "There are many firearm-related prosecutions where our people meet the same criteria as visitors, that is ...they are law-abiding citizen, hardworking and have a clean police record and so on. However, that still seems to not satisfy our courts as sufficient for the court to make a finding of exceptional circumstances, thereby given those persons a lower sentence than the mandatory.

"When it comes to our Turks and Caicos Islanders the ruling handed down is heavy handed and it's usually substantial jail time. I am appealing to us in the house and our justice system to review this trend, or perhaps this House may need to legislate situations that amount to Exceptional circumstances, so that we can help our judiciary in bringing some balance as it relates to the adequate punishment."

The Government's Appointed Member used her final minutes on the floor to recommend the provision for exceptional circumstances. These, she said, should be:

- No previous convictions;
- Good character as evidence by reference from members of the community;
- Early guilty plea; and
- Substantial cooperation with the Police.

CHARTING CMEx's LEGACY

"Where there is no vision, the people perish: but he that keepeth the law, happy is he." – Proverbs 29:18

This week a wave of nostalgia enveloped me, transporting me back to 2001 and the inaugural Caribbean Media Exchange (CMEx) on Sustainable Development symposium in Ocho Rios, Jamaica.

The genesis of this international event, to bridge the gap between journalists (young and experienced, local, regional and foreign) and the Caribbean and international travel and tourism sector, was a merged vision of many, including Allen Chastanet, who at the time was a Senior Vice President at Air Jamaica; his boss the late Gordon "Butch" Stewart, Chairman of Air Jamaica; Lelei LeLaulu, president of Counterpart International; and my son Bevan, who was a communications consultant with both organizations.

All agreed with the need for regional and international media, public and private sectors, as well as non-governmental organizations to be better educated on the real value of tourism to the people and the economies of the Caribbean. The successful Ocho Rios intervention, which was staged in the aftermath of the tragic September 11 attacks on America, highlighted the resilience

of the tourism sector.

As we embarked on our journey we were well supported by the Caribbean Hotel and Tourism Association, the Caribbean Alliance for Sustainable Tourism, and countless stalwarts like renowned St. Lucian hotelier Berthia Parle, Puerto Rican tourism guru Terestella Gonzalez-Denton among many personalities and institutions representing the region's public and private sectors. Over time, this modest forum evolved into a powerful platform championing sustainable tourism development in small island developing states. Since its advent, CMEx mounted over 20 gatherings across the Caribbean region and in the U.S. These sessions, mostly the four-day version, were always brimming with fervent discussions, pioneering ideas, tangible takeaways and recognition awards.

Our trajectory has been steadied by a business model which harmoniously blends public-private, NGO, academic, media, and youth support. We have even been told by entities like the UNWTO that CMEx inspired them to launch a communications initiative with parallel objectives. We've mobilized the expertise from these sessions for initiatives such as an HIV/AIDS communications project funded by Coca-Cola for Haiti and suc-

cessive iterations of the UNFPA Caribbean Media Awards, held in Jamaica.

Recognition awards underscored our commitment not just to host events but to create transformative experiences that galvanize stakeholders throughout the Caribbean. Awards events have been held in Florida and New York in 2013, 2014, 2019 and they now return to Miami in December.

After our last event we were able to donate generously to the Caribbean Hotel and Tourism Association Education Foundation (CHTAEF), the Errol and Nita Barrow Educational Trust, and Bahamian scholars who had been impacted by a devastating Category 5 storm which lashed The Abacos and Grand Bahama.

However, like many entities, CMEx was not impervious to the challenges ushered in by the COVID-19 pandemic. Our effervescent initiatives were paused. But as they say, challenges often harbor opportunities in disguise.

Preparations are now in full swing for a lunchtime gathering at the Loews Coral Gables on Saturday, December 2.

CMEx 2023 honorees are a tribute to the stalwarts of Caribbean tourism and communications. The recognition of luminaries such as broadcasters Julian Rogers and Pat Montague, and tourism heads Nicola Madden-Greig (President, CHTA); Dona Regis-Prosper (Secretary-General, Caribbean Tourism Organization); Rosa Harris (Director of Tourism, Cayman Islands); Michele Paige (CEO, Florida-Caribbean Cruise Association) and many more underscores the strength and resilience of our industry.

The day will also spotlight our unwavering commitment to supporting tourism education and charitable endeavors in the Caribbean and beyond.

I'm filled with optimism and fervor for the potential that awaits.




The largest can approach nearly 32 inches in length, although 16-24 inches is far more common. It's easy to tell the difference between adult male and female iguanas, as males tend to be much larger and have elaborate dorsal spines.

To verify the validity of your documentation you should contact the Crown Land Unit or check the registers of the title with the Land Registry.





Someone sold me land and I have a receipt. I have since learned that the land was Crown Land and not theirs to sell. What should I do?

If the property is Crown Land then you need to contact the Crown Land Unit who will investigate the issue and refer you to the relevant authorities if a fraudulent act has been committed. Under section 23(1) of the Crown Land Ordinance, it is an offence for a person to purport to sell or lease Crown Land to another person without lawful authority or title to do so, whether or not any purchase price or rent is paid.



Understanding and treating Dengue

Dengue fever is an illness spread by the bite of mosquitoes infected with one of the dengue viruses. Symptoms are usually flu-like but can worsen to severe dengue haemorrhagic fever, a life-threatening condition.

Most people who get dengue will not have symptoms, but for those that do, the most common symptoms are high fever, headache, body aches, nausea and rash. Most will also get better in one to two weeks, while some people develop severe dengue and will need care in a hospital.

According to Dr Orlando Thomas, medical doctor and functional medicine practitioner at Thomas Medical and Shockwave Centre, the infection is passed from person to person. "The mosquito is the vector that transfers dengue, but the host is us. We infect the mosquitoes and then they pass it on to somebody else," Dr Thomas said.

Dengue viruses are spread to people through the bite of an infected Aedes species (Ae. aegypti or Ae. albopictus) mosquito. These mosquitoes also spread Zika, chikungunya, and other viruses.

"The Aedes aegypti most commonly passes the dengue virus. It is the species that requires blood to multiply. They get blood from us, so when they suck our blood, they transfer the blood that is in our system and bite someone else, and so it is passed on," Dr Thomas said. Almost half of the world's population, about

four billion people, live in areas with a risk of dengue. Dengue is often a leading cause of illness in areas with risk. Each year, up to 400 million people are infected by a dengue virus. Approximately 100 million people get sick from infection, and 40,000 die from severe dengue.

Dengue is caused by one of any of four related viruses: dengue virus 1, 2, 3, and 4. A person can be infected with dengue multiple times in their life.

"If you are in a house with someone who has dengue, the mosquitoes can bite that person and then bite you, and you almost get it directly. Seventy-five per cent of persons who get dengue has no symptoms. Only 25 per cent has symptoms, and less than one per cent die from dengue. So, your chance of surviving dengue is greater than 99 per cent. It is not that scary, but very serious in some cases, so do not take it lightly," Dr Thomas said.

NATURAL REMEDY

Less than one per cent of people get severe dengue and this comes with severe symptoms, including vomiting blood, bleeding gums, severe abdominal pain, rapid breathing, spots on the skin that look red, severe lethargy even after the fever has passed.

Dr Thomas says that while it is easy to fall prey to the mosquito-borne viral disease, recovery can take its time. However, natural home remedies can speed up your healing process and


replenish the body by providing essential nutrients in time of need.

Papaya leaves are considered to be one of the best and the most effective natural remedies to fight a dengue infection.

"Papaya leaf juice can be great for boosting platelet count in people suffering with dengue. Platelet count comes down drastically in dengue patients, and it can actually have fatal outcomes. It is important for doctors to work towards boosting platelet count in dengue patients, and for this, papaya juice has been scientifically proven to be beneficial," Dr Thomas said.

To prepare this home remedy, wash and cut papaya leaves in a bowl and add a glass of water to it. Crush it coarsely to make a watery paste. Sieve the prepared concoction and drink it. This will help effectively in increasing the platelet count and boost your immunity.

The Ministry of Health and Wellness declared an outbreak of the dengue virus on September 23, 2023, due to an increase in cases throughout the island. Over the last three months several hundred cases of dengue have been reported, including of the more severe cases. To date, there have been over 1,000 confirmed dengue infection cases in Jamaica. All parishes have recorded dengue cases, with Kingston and St Andrew, St Thomas, St Catherine, Portland, and St James recording the most confirmed cases.

The event will be held between November 20 and 22, between the hours of 12pm to 4pm at the Gustavus Lightbourne Sports Complex in Providenciales. The Sports Performance Long-Term Athlete Development Clinic is a follow-up to the Long-Term Athlete Development Sym-

posium held in June 2022, where the concept of LTAD was introduced to P.E. teachers, coaches, athletes, as well as National Sports Governing Bodies.

The main objectives of the clinic are to:

1. Develop broad knowledge of natural movement fundamentals
