GRAVEL MSHA is February 5th - This is Mandatory! Keep an eye out for letters that we will be sending out with dates and times of training that you have to attend.

Even though we are heading into the winter months, the Gravel Department is still busy.

- Odessa is pumping 47B for the I-80 job from Elm Creek to Odessa. Koss Construction finished the eastbound lane and will do the westbound lanes next year.
- Elm Creek is pumping road gravel and still has a few projects to button up and working on getting stockpiles built up.
- Lexington is pumping MSE wall material for the new Lexington Viaduct on the east part of town.
- Cozad is not pumping as we are moving the rotary. The dredge was taking on water, so we put an extra float under it a couple years ago, but it is starting to slip out.
- Gothenburg we moved to the north and trying to get pumped in. We have not pumped over there for quite a few years, so it has a lot of nasty debris along the bank.
- North Platte we moved the rotary last month and switched from pumping off the tower to the rotary pumping pre-crush for asphalt.
- Ogallala is pumping 47B.
- Gates is pumping pre-crush for asphalt and road gravel.
- Indianola is pumping road gravel.



Truck drivers have been busy hauling to local customers, redi-mix plants, county stockpile areas, feedlots, the new viaduct under construction in Lexington, and contractors working in the area. **Rock haulers** are transporting limestone into the region and taking road gravel back to Lancaster County. We've committed to supplying up to 25,000 tons, with most of it needing to come from Cozad.

It's great news that 20 out of our 24 truck and pups have been DOT certified, a positive milestone for both the gravel department and the shop team. Meanwhile, the maintenance crew has been focused on cleaning up the area, moving rotaries and towers, and organizing equipment in the warehouse and Hood building.

As winter approaches, please remain vigilant for ice buildup on equipment and roadways.

Thank you for all your hard work and dedication in 2024! Now let's see what we can accomplish in 2025!

The winter months come with unique challenges, including increased risks of slips, trips, and falls due to snow-covered walkways, icy patches, and wet surfaces. Even a thin layer of ice can turn a safe path into a hazardous one. To minimize these risks:

- Wear footwear with proper traction.
- · Use handrails when available.
- Take shorter, slower steps on icy or snowy surfaces.
- Regularly clear pathways of snow and ice, and use ice melt or sand to improve traction.

Additionally, always stay aware of your surroundings, especially when entering or exiting vehicles or equipment. Vigilance and preventive measures are key to reducing hazards during this season.

In the event of any accident, injury, or hazardous situation:

- Promptly report it to your supervisor and a member of the safety team.
- Contact emergency personnel or appropriate authorities immediately if necessary.
- Submit a completed incident report to the safety department within 24 hours.

As we celebrate this year's accomplishments, it's also important to turn our focus to the opportunities and challenges ahead in 2025. Safety remains the cornerstone of our success, and we're committed to building on this year's record to achieve an even stronger safety performance next year.

Randy & Seth's Crew finished several projects this year. Below is a quick review of the asphalt paving year.




Temperatures have been all over the place making it hard to decide when to call it a season. The season end push to get work completed for the winter is on us and in full force. Winter break can't come soon enough.

Tis the season for all kinds of weather. We could see sunny and 60's, rain, lighting, snow and ice all in a short span of time, which means we must be ready for what the winter brings our way. All locations should have procedures in place to combat whatever conditions present themselves. Keep walkways free from snow and ice, and make sure steps to trucks and equipment are free from snow and ice and have proper PPE for the conditions. All of these are a MUST to keep injuries and accidents from happening. Don't take unnecessary risk, usually the results go against you!

Reminder to all CDL Holders and Drivers

Each year we are required to make sure that all of our CDL/drivers are registered with the Clearing House. You will get a notification from the Clearing House asking you to log into your account and give Paulsen's permission to view your information. It is a MUST & REQUIREMENT that you respond to this email request. Please reach out to anyone in the Safety Department if you need help!

Speak Up for Safety: Reporting Incidents and Near Misses

The Safety Team and the Safety Committee want to remind all employees to report all incidents as soon as possible! If the incident requires notification to the Supervisor/Foreman then they will reach out to one of the Safety Team members for a response. ALL injuries and accidents are investigated to determine the cause and what can be done to avoid the incident from happening again. An area that we fall short in is reporting NEAR MISSES! We want all employees to feel comfortable reporting an event that could have caused an accident so that hopefully in the future that
