COSMETOLOGY & BARBER STUDENTS CAN ENROLL TOGETHER!

BARBER AND COSMETOLOGY PRACTITIONERS CAN WORK UNDER THE SAME ESTABLISHMENT LICENSE.

Schools can now provide both Barber and Cosmetology students licensing programs in the same location. Merging the two students for 700 classroom hours and the remaining 300 course study in the respective licensing curriculum.

Barber and Cosmetology licensees are now referred to as Practitioners!

In June of 2021 a bill was signed to consolidate barbering and cosmetology law.

Additionally, Barbers and Cosmetologist may now work in either type of a license be it Beauty or Barber.



ANTI - HUMAN TRAFFICKING CEU COURSE BEFORE YOU CAN RENEW YOU LICENSE

Before they can renew their licenses, many TDLR licensees are required to complete an approved human trafficking prevention training course on how to spot human trafficking:

More than 83,000 health professions practitioners including massage therapists, athletic trainers, audiologists, behavior analysts, dietitians, dyslexia therapists, hearing instrument fitters and dispensers, midwives, orthotists, prosthetists, podiatrists and speech-language pathologists

Starting in 2025, more than 30,000 barbers will be required to complete the continuing education courses.



**CHRISTINE M. JENKINS
INVENTED HAIRWEEV**

PATENT HAIR WEEVE TECHNIQUE 1952

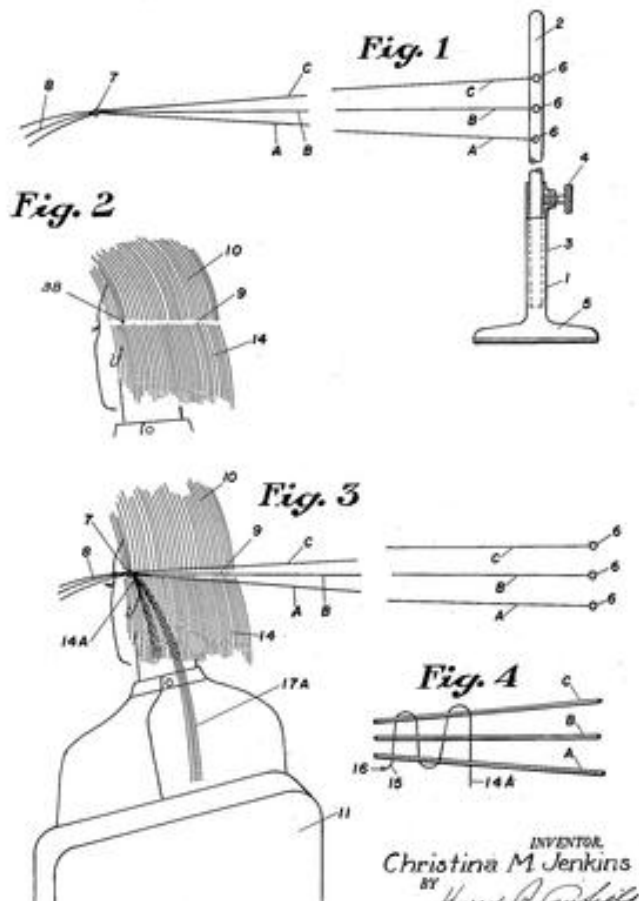
Christina M. Jenkins was born in Louisiana, she graduated with a B. S. from Leland College. In 1949, while working for a Chicago-based wig manufacturer, she started to tackle the problem of wigs not staying securely on the customer's head. Her thought process eventually led her to a new method for permanently attaching commercial hair to live hair dubbed Hairweev.

She received U.S. Patent 2,621,633 for Hair-weev on December 16, 1952. She moved to Ohio and began teaching Hair-weev to licensed cosmetologists at Christina's **Hair-weev Academy**. The process involves 3 cords and a weaving device called a weaving frame. This results in a natural weft for attaching the commercial hair

She offered the cosmetologists that she trained franchising opportunities to use the technique. However, many students did not fulfil the financial obligations of the franchise agreement. As a result, Jenkins quickly lost control of her invention and personal finances began to suffer. She attempted to take legal action against these individuals. However, Jenkins lacked the finances she needed to do so and was unable to continue running the business. The sale of hair extensions is currently a billion dollar industry. There are many different hairweaving techniques today. Her invention was a game changer for the hair industry. Christina Jenkins died in 2003.

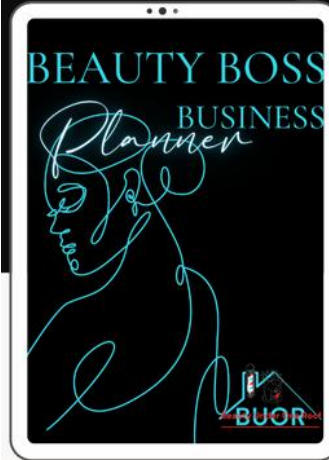

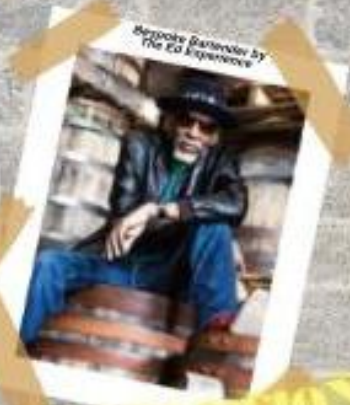
