#### SOCIAL PROTECTION IS AN INVESTMENT IN THE RESIDENTS OF ANTIGUA AND BARBUDA

Social Protection is an investment, rather than a handout that empowers families and communities by enhancing their income and skills enabling them to be self-sufficient.

Different institutions have come together to develop a fair and transparent system.

#### WHAT IS SOCIAL PROTECTION?

Social Protection is an investment in individuals and families that helps them to survive and thrive with vulnerabilities throughout their life cycle and thus reduces vulnerability and social exclusion.



# SOCIAL PROTECTION PROGRAMMES AND POLICIES HAVE AN ALL-ROUND INCLUSIVITY APPROACH

Social Protection concerns everybody. Anyone can become vulnerable at any stage of life because of a personal, country or global shock and may find themselves in need of help.

Each case is assessed against eligibility criteria and will be determined by your family situation.

# I AM A PERSON LIVING WITH A DISABILITY, CAN I STILL GET ASSISTANCE?

Each case is assessed against eligibility criteria and will be determined by your family situation.

#### IF MY APPLICATION IS DENIED WHAT CAN I DO?

There will be an opportunity to appeal.

### HOW LONG DOES IT TAKE TO GET ON THE PROGRAMME?

The Social Protection Board meets twice monthly and applications are reviewed and processed for approval during those times.

# WILL THE CLIENTS' PRIVATE INFORMATION REMAIN CONFIDENTIAL?

Yes, the clients' private information will be kept in the strictest confidence.
