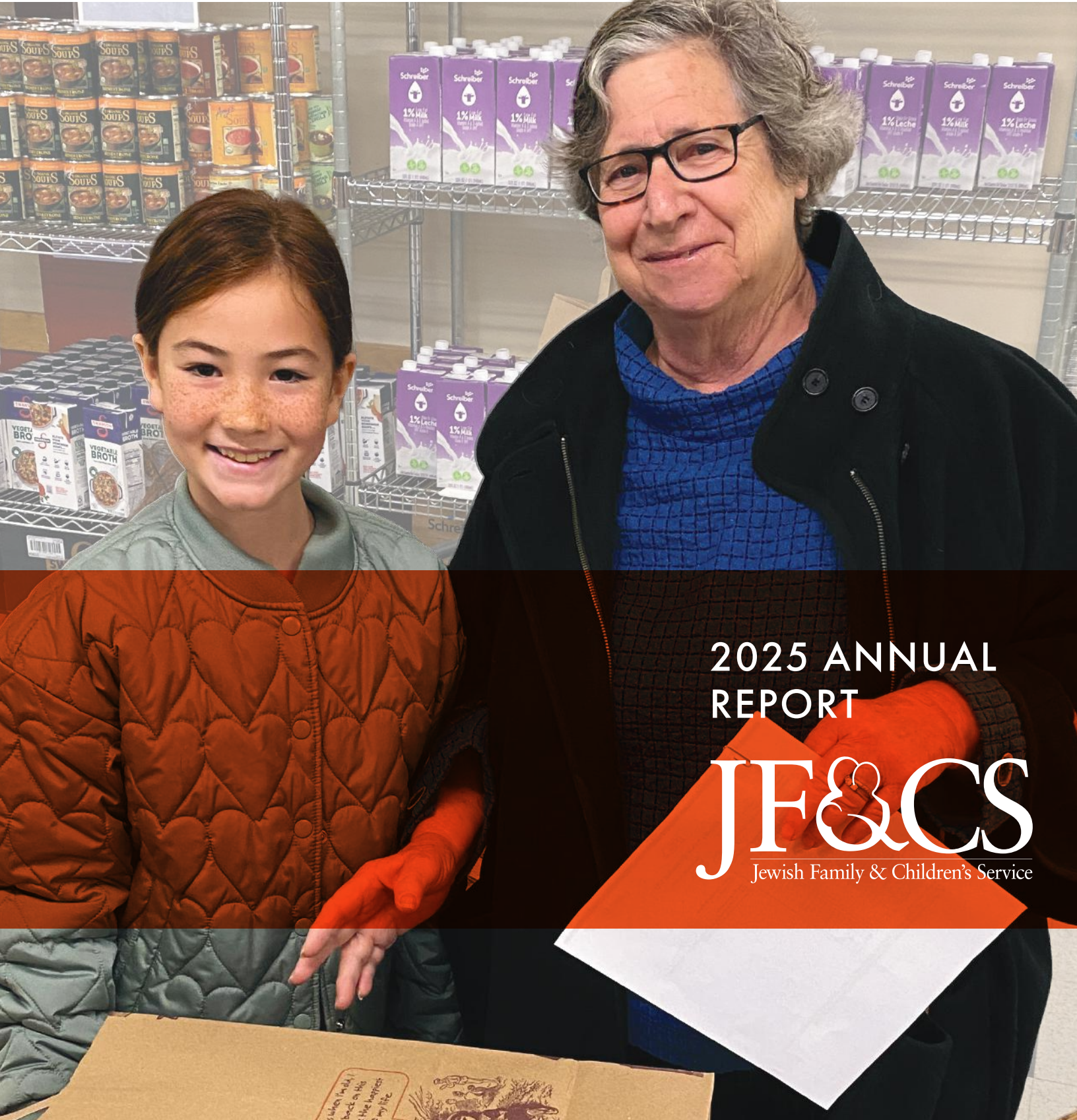

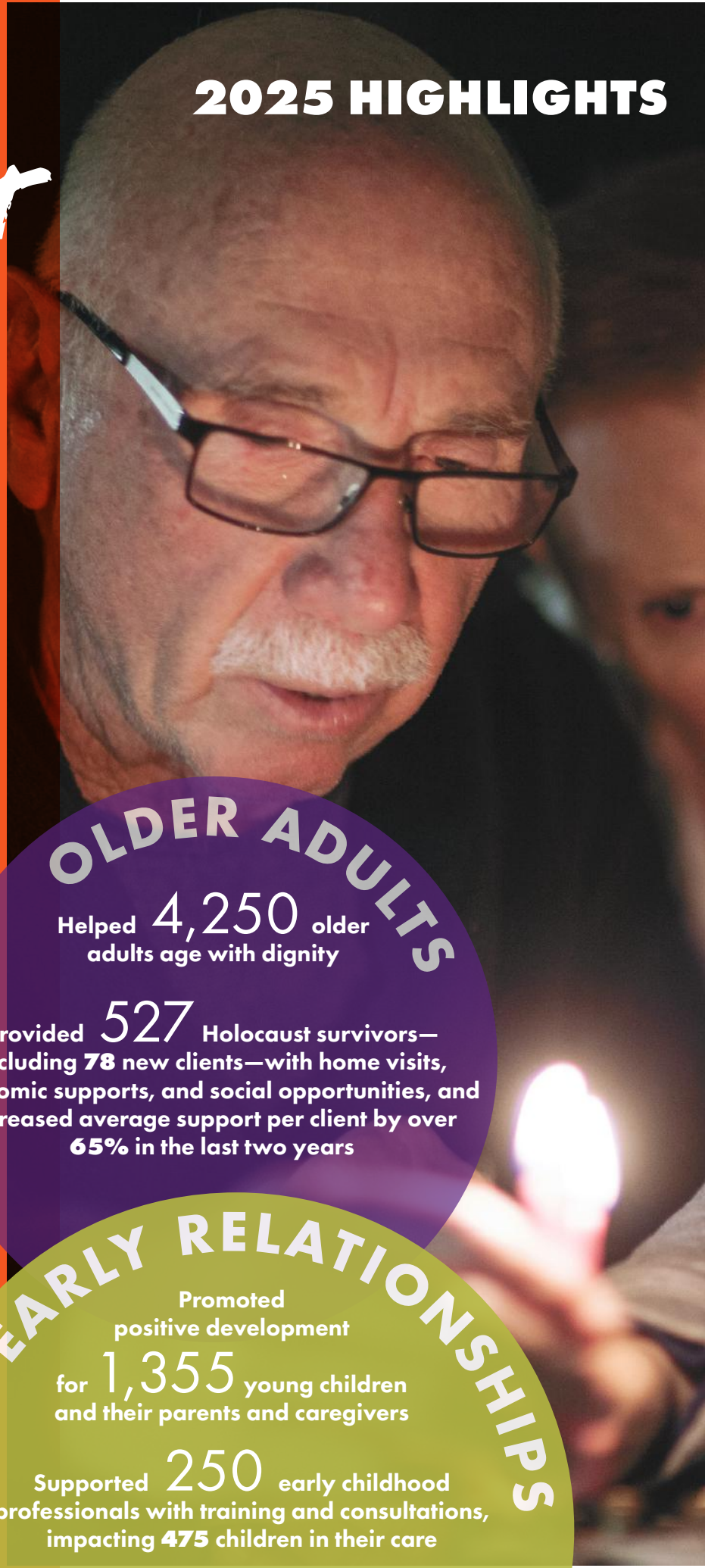

LETTER FROM THE CEO

Dear Friends,

One year ago, we launched a new strategic plan and made a clear commitment: to meet our community's social service needs in a holistic, integrated way—all under one roof. It's a goal which is both simple and profound, and which reflects the values of *chesed* (lovingkindness) and *tzedakah* (charity and justice) that JF&CS is built on. I am so grateful to our community for sharing these values, and for helping us to be a lifeline for thousands of people in their most vulnerable moments.

This year has tested our shared commitment in real and sometimes sobering ways. The needs around us didn't just grow, they surged. More than 600 Holocaust survivors previously unknown to JF&CS turned to us for help meeting their most basic needs. Nearly 800 families have come to rely on our Family Table program for groceries each month, up from about 500 just four years ago. And nearly 3,500 people came to JF&CS to address their mental health needs.

As I'm reminded every day, behind each of these numbers is a person, a family, and a moment of real uncertainty.

Their surging need has unfolded even as government funding became more constrained and less predictable. Key funding streams have shrunk overnight, and others are at high risk.

Yet with your support, we protected vital services, grew our impact, and continued to innovate, even when difficult decisions were necessary. This year, we embedded social workers in partner synagogues, launched clinical support groups for struggling new parents, expanded supported living options for people with disabilities, and so much more.

Thank you to the many donors and volunteers who stepped forward—again and again—to ensure that JF&CS could respond with the scale and urgency this moment requires. Every family served and every moment of stability restored carries your imprint.

To me, our work at JF&CS is a living expression of our Jewish values in action—not as a theoretical concept, but as a daily, hands-on responsibility. Thank you for believing in JF&CS and for standing behind our work during an especially demanding year. You have truly met this moment, and because of you, so have we.

LETTER FROM THE PRESIDENT



Dear Friends,

As I conclude my term as President of the Board of Jewish Family & Children's Service, I find myself filled with gratitude and pride. It has been one of the greatest honors of my life to serve in this role.

For more than three decades, my connection to JF&CS as a volunteer has been a labor of love. I firmly believe that the work this agency does—caring for people when they are facing some of life's hardest moments—is the most important work there is.

Over these past three years, I've had a front-row seat to what it truly means to meet the moment. One moment that will stay with me occurred last November during the sudden shutdown in SNAP benefits. As people faced the immediate reality of not knowing how they would put food on the table, JF&CS mobilized rapidly. JF&CS today is operating in one of the most challenging environments the human services world has ever seen. And yet, day after day, our staff and volunteers show up with skill, care, and an unwavering commitment to the mission. Guided by the agency's "Under One Roof" strategy and strengthened by the partnership of donors who believe deeply in this work, they deliver an incredible range of services with excellence and humanity.

I know that so many of us who care about JF&CS are bound by a sense of shared responsibility for one another, and a desire to leave the world better than we found it. This is the foundation on which the agency stands, and it's what continues to inspire my connection to this work.

RESPONDING TO RISING VULNERABILITY WITH CULTURALLY SENSITIVE SERVICES

The new Greater Boston Jewish Community Study from Combined Jewish Philanthropies underscores the complexity of need in our community: Among roughly 138,000 local Jewish households, nearly three-quarters contend with financial, health, disability, mental health, or human service challenges—and nearly a quarter face three or more at once.

JF&CS plays a unique role in responding to this moment. Guided by Jewish values, we proudly serve anyone who comes to us for help, regardless of background, while also holding a distinct responsibility to care for the Jewish community. Our culturally sensitive services span mental health, basic needs, aging, disability services, and domestic abuse support.

The urgency of our work caring for the Jewish community grew significantly over the past year. We dramatically increased support for aging Holocaust survivors to address their rapidly intensifying care needs, and 645 survivors newly connected with JF&CS for basic needs assistance. We also responded to soaring demand for Family Table, our kosher food pantry: 986 households were enrolled during 2025, with nearly 700 households receiving groceries each month—a number that continues to grow.

To make it easier for people to seek help, JF&CS expanded outreach across the Jewish community—working with clergy, embedding social workers in synagogues, and piloting peer-led support groups in Jewish settings across the region. These efforts strengthen communal capacity, lower barriers to care, and ensure that community members know where to turn when they need support.

ERIC

FROM CRISIS TO STABILITY



Jennifer was deeply worried about her uncle, Eric. Once a successful professional and devoted father, he had faced mounting personal and financial challenges that left him isolated and at risk of eviction.

Encouraged by a friend at her synagogue, Jennifer reached out to JF&CS. “We’re in over our heads,” she said. Our staff listened with compassion and worked with her to connect Eric to health insurance, therapy referrals, rental assistance, disability income, and groceries from our Family Table food pantry.

Eric soon began working with a JF&CS case manager, making meaningful progress toward greater stability. When he later experienced a severe mental health crisis, his JF&CS case manager stayed by his side, helping him process the trauma and access the care he needed to begin his recovery.

Today, despite their challenges, Eric and his family are experiencing renewed hope. They are grateful to have found a place where mental health support, family relationships, and Jewish values all come together under one roof.

MEETING THE MOMENT IN THE...

Earliest Years

BECAUSE THE EARLIEST RELATIONSHIPS SHAPE EVERYTHING THAT COMES NEXT

Serving a family in the earliest years of a child's life can have a lifelong impact. For families facing added complexity—poverty, trauma, premature birth, or substance use—the impact of timely, expert support can make a profound difference.

Through parent groups, home visits, and clinical services, JF&CS's Center for Early Relationship Support helps parents build secure, nurturing relationships with their children—the foundation for lifelong resilience and well-being. Our teams of home visitors, parent-child clinicians, and early childhood mental health consultants deliver compassionate, culturally responsive care at pivotal moments.

Over the past year, JF&CS promoted positive development for more than 1,300 families with young children. In 2025, we continued to scale our effectiveness by training 250 staff in early education centers, impacting 475 children in their care. We also taught home-visiting skills to partner organizations, introduced new clinical groups that combine clinical expertise with the power of peer support, and contributed to research demonstrating the effectiveness of our parent-child psychotherapy model.

By surrounding families—and the professionals who serve them—with expert support during the earliest years, JF&CS helps families strengthen the relationships that shape lifelong development.

JOHN

NAVIGATING AN UNEXPECTED PATH



John is the single father of a young daughter. When her mother's substance use disorder led to their child being placed in foster care, John found himself facing a moment he had never expected—preparing to parent his daughter on his own.

He turned to JF&CS for support at a critical time. Through our parenting group, John learned about young children's emotional needs, how they communicate them, and how caregivers can attend to them with care. Alongside this support, we helped him secure housing with space for his daughter and stability for their future together.

When the time came to welcome his daughter home, JF&CS stood with John through the emotional complexity of reunification—honoring the bond his daughter had formed with her foster family while helping John step fully into his role as her primary caregiver.

Today, John's daughter is thriving, surrounded by the love of her father, her extended family, and the supportive adults who helped meet this pivotal moment with compassion and care.

Mental Health

INTEGRATED SUPPORT THAT HELPS PEOPLE MOVE FROM CRISIS TOWARD RESILIENCE

Across Greater Boston, people are carrying more than they can hold. Rates of anxiety, depression, and trauma remain elevated—shaped by the lingering effects of the pandemic, ongoing global instability, rising fear and uncertainty in daily life, and, in the case of the Jewish community, surging antisemitism.

JF&CS's integrated approach to mental health strengthens every area of our work with clients, from basic needs and disability services to parenting and aging. Our mental health services span a wide range of needs and entry points—from our Mental Health Connect helpline, where callers access psychoeducation, therapist matching, and guidance, to clinical case management, to support groups that bring together 1,200 people annually around shared experiences such as caregiving, postpartum mood disorders, suicide loss, and grief.

In the past year alone, JF&CS helped over 3,400 people address mental health needs. We completed successful pilots embedding social workers in local synagogues and offering new peer-led models for group support, lowering barriers to care.

By meeting people where they are—with care that is accessible, holistic, and compassionate—JF&CS is rising to meet the mental health crisis of this moment.

PAULA

FINDING
HER WAY
BACK TO
STABILITY



Paula, a woman in her late 70s, called JF&CS's Mental Health Connect helpline after losing her longtime therapist. She was coping with multiple stressors at once: her son's cancer diagnosis, unpaid utility bills, and past trauma that was triggering depression and anxiety.

Our social workers looked at Paula's entire situation and helped her find a new therapist, while also assisting in stabilizing her finances. When Paula was diagnosed with Alzheimer's disease shortly thereafter, our team continued to coordinate her care, supporting Paula as she processed this news and adjusted to what it meant for her future.

Today, Paula is receiving mental health treatment and engaging more regularly with others. With coordinated support addressing both emotional and practical needs, she feels reassured and better equipped to navigate what lies ahead.

People with Disabilities

BUILDING INDEPENDENCE AND BELONGING THROUGH LIFELONG SUPPORT

People with disabilities and their families often face a maze of barriers: fragmented systems, long waitlists, and the steep “cliff” when young adults age out of school-based services at 22. Yet we know that caring for a loved one with a disability—and helping them grow their independence—can bring tremendous joy.

JF&CS provides integrated, lifelong support for people with disabilities—beginning in childhood and extending through adulthood and aging. Our services include special education advocacy for school-age children, transition planning for young adults, life skills development, employment support, benefits navigation and advocacy, and a range of residential living options. At every stage, our work is rooted in partnership: honoring each individual’s goals while helping them build independence, confidence, and connection to their community.

In 2025, JF&CS supported 1,304 people with disabilities and their families. We responded to a 22% increase in helpline inquiries, expanded participation in our day programs, broadened skill-building and community-based offerings, and introduced a health and wellness curriculum—enhancing our clients’ physical and emotional well-being.

By providing holistic, coordinated support across the lifespan, JF&CS helps people with disabilities build independent, purposeful lives.

When Elana began working with JF&CS, she was focused on building the skills she would need to live more independently. She started by strengthening daily living skills at home—planning meals, managing a budget, and caring for her family dog. As her confidence grew, she set her sights on employment. With individualized support from our team, Elana secured a job at a local audiovisual company, where she continues to thrive.

That success opened the door to new goals, including expanding her financial literacy and planning for greater independence. Today, Elana is actively working toward her goal of moving into her own apartment—guided by her own determination and supported every step of the way by JF&CS.

Older Adults

EXPERT CARE AND CONNECTION TO SUPPORT AGING WITH DIGNITY

As our population ages, older adults and their caregivers face mounting challenges. Rising care costs, shrinking support networks, and increasing loneliness intersect with the growing prevalence of chronic illness, neurological disease, and other age-related conditions.

JF&CS offers a continuum of services designed to help older adults remain safe, connected, and respected. Our programs include professional care management through Your Elder Experts, support for people living with dementia and Parkinson's disease, services for Holocaust survivors, spiritual and communal care, and practical guidance through housing, health, and end-of-life decisions.

Over the last year, we expanded both the reach and impact of this work as we supported 4,250 people in aging with dignity. In 2025, we deepened our support for Holocaust survivors, broadened access to culturally responsive wellness programming in our home base of Waltham, and brought our proven approaches to supporting people living with dementia and their care partners to a national stage.

As the older adult population continues to grow rapidly—and more families find themselves navigating aging-related decisions—we will continue to expand and tailor our services to help older adults and their caregivers through the later stages of life.

NAVIGATING
CHANGE,
TOGETHER



David was worried—and exhausted. He loved his mother, Ruth, deeply, but as her dementia progressed, the responsibility of making the right decisions for her care felt overwhelming.

David reached out to JF&CS after an incident at Ruth's independent living community made clear that she needed more care than the residence could provide. A seasoned JF&CS care manager stepped in immediately—advocating within the residence, helping David navigate complex family dynamics, and identifying a setting better suited to Ruth's evolving needs. She coordinated every aspect of the transition, ensuring continuity of care and minimizing disruption during a stressful time.

Today, Ruth has settled into her new home and appears calmer and more engaged. David, in turn, has peace of mind knowing his mother is safe, supported, and in the right place.

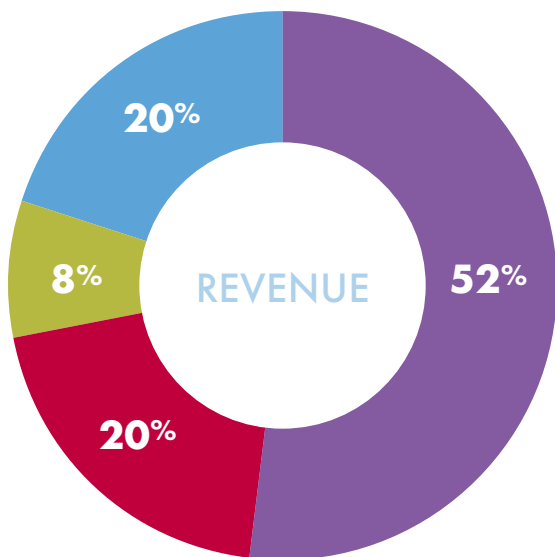

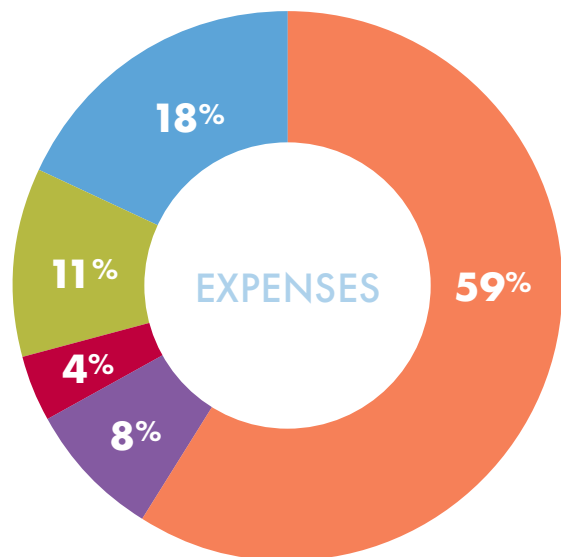

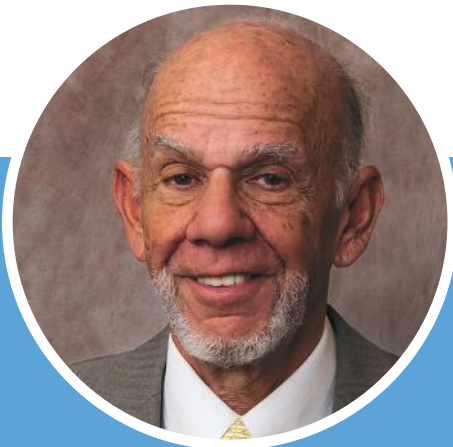
