
This program provides skills and knowledge needed in today's welding industry, and combines hands-on welding with classroom instruction in the five commonly used welding processes; Oxyacetylene Welding (OAW), Shielded Metal Arc Welding (SMAW), Gas Metal Arc Welding (GMAW), Flux Cored Arc Welding (FCAW), and Gas Tungsten Arc Welding (GTAW).

CWC is an Accredited Test Facility with the American Welding Society. With up-to-date welding equipment, be trained according to the AWS D1.1 Structural Steel Welding Code, as well as the API 1104: Welding of Pipelines and Related Facilities Standard. Additionally, the degree offers courses in metallurgy, blueprint reading, and weld inspection to build depth of understanding in the welding field.

Students are also given the opportunity to take Welder Performance Qualification Tests to become an American Welding Society Certified Welder. This is in addition to the AAS Degree and the Certification 1 and 2.
