Nevada's Autism Treatment Assistance Program (ATAP) was created to assist parents and caregivers with the expensive cost of providing Autism-specific treatments to their child with Autism Spectrum Disorder (ASD). ATAP is a statewide program that provides temporary assistance and funding to pay for evidenced-based treatment such as Applied Behavior Analysis (ABA) for children on the Autism Spectrum, who are under the age of 20 and are diagnosed as a person with Autism Spectrum Disorder by a physician, psychologist, child/adolescent psychiatrist, pediatric neurologist or other qualified professional. A diagnosis from a multidisciplinary team is acceptable when in accompanied by an appropriate assessment report.

Common indicators of autism may include all or some of the following symptoms:

- ✦ Hand flapping or other repetitive behaviors
- ✦ No babbling or pointing by age 1
- ✦ No single words by 16 months or two-word phrases by age 2
- ✦ Not responding to name
- ✦ Loss of language or social skills
- ✦ Excessive lining up of toys/objects or other ritualistic behaviors
- ✦ Lack of smiling or social responsiveness
- ✦ Poor eye contact
- ✦ Difficulty expressing emotions

Symptoms need to be evaluated by an expert

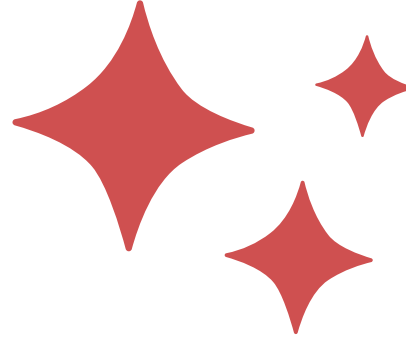

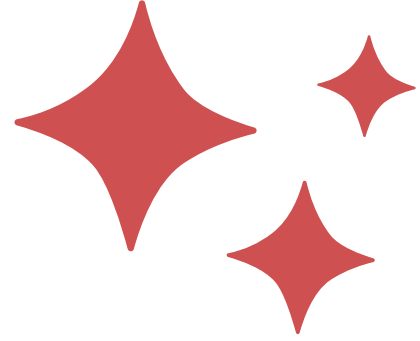
