# President's Report



For the past eight years I have had the privilege of being President of the World Naturopathic Federation. It has been my honor to oversee the growth of the WNF from its inception to its current status as a lead organization in the global naturopathic profession and a recognized organization within Traditional and Complementary Healthcare. I am so grateful for the support of so many individuals from naturopathic organizations around the world that supported the WNF vision of establishing an international presence for the naturopathic profession and that have recognized the importance of coming together with a common voice. With the support and collaboration of the global naturopathic profession, we have accomplished so much.

The WNF is a committee driven organization. Please check out the tremendous accomplishments outlined in the committee updates. Other WNF accomplishments in the last year included:

- **Dissemination of the Health Technology Assessment – Naturopathy (HTA):** The HTA was published in December of 2021. Since the time, complimentary copies of the HTA were shipped to WNF members and sponsors around the world thanks to the support of the Naturopaths and Herbalist Association of Australia (NHAA) and the General Council Register of Naturopaths (GCRN) and the admin staff of the WNF from Canada. In November of 2022 the Naturopaths and Herbalists Association of Australia (NHAA) hosted the official global launch event for the Health Technology Assessment – Naturopathy. The event included more than 150 health care professionals, state health officials, and political representatives who gathered at Parliament House in Canberra Australia for an event broadcasted to the international naturopathic community. As president of the WNF, has had the privilege of bringing greetings via Zoom and urged members to use this occasion as a springboard for the profession in their home country. Locally a panel that included the other two editors of the HTA – Dr. Amie Steel and Dr. Jon Wardle – discussed the importance of the HTA to supporting regulation of the naturopathic profession globally.
- **Supporting a new WHO Traditional Medicine Strategy:** In 2023 the current WHO Traditional Medicine Strategy: 2014-2023 expires and at the 2023 World Health Assembly in May, the decision to extend the current WHO Traditional Medicine (TM) Strategy and to develop a new WHO TM Strategy will be voted on by the WHO Member States. Here is the draft proposal EB152/CONF./9. The draft decision foresees giving the WHO until early 2025 to develop a new TM Strategy, in consultation with Member States and stakeholders which will put a greater focus on “safe and evidence-based traditional and complementary medicine” – so the timing of the HTA and our focus on building research capacity in the naturopathic profession is timely and necessary.
- **Traditional, Complementary and Integrative Healthcare collaborative:** For the past few years the WNF has been part of an international collaborative that is working towards greater collaboration between all types of healthcare. WNF is one of the sponsoring organizations and continues to participate in ongoing meetings.

Behind the scenes, the WNF is wonderfully supported by Dave Deeley the Assistant Secretariat, Tina Jennings, our bookkeeper and Katherine Pomykacz who is our fabulous Marketing Co-ordinator. Thank you team for your ongoing support.

I look forward to continuing to work with WNF members and sponsors as I take on the role of Chief Executive Officer (CEO) for the WNF and hand over the reigns of the WNF to Tobey-Ann Pinder the WNF representative from Naturopaths and Herbalists Association of Australia (NHAA).

# Secretary General's Report



I write this report as outgoing Secretary General, meaning that this will be my last report. This is a bittersweet moment, but has given me pause to reflect on the incredible achievements that WNF has made over the past years.

When the first steps were created to develop a globally representative naturopathic professional organisation, there was no certainty that the organisation would be able to formally start, let alone thrive. Some critics suggested that there were too many differences in the profession across countries, but WNF demonstrated that the profession is united more by its similarities than divided by its differences. Other critics suggested that such an organisation would not help develop and promote the reputation of the naturopathic profession, yet through WNF the naturopathic profession was one of only two traditional medicine professions (the

other being Chinese medicine) formally invited to the Astana Declaration on Primary Health Care meeting and numerous World Health Organization initiatives. Importantly, these efforts have been underpinned by a rigorous data-driven approach and significant collaboration which has entrenched the naturopathic profession as a valuable and reliable partner in numerous global health initiatives.

Over the course of this year, the WNF has continued its momentum towards becoming a truly global organisation representing naturopathic practitioners. The WNF-led initiatives around environmental health and natural products and immunity have been cited extensively in research and government documents. Under the leadership of Dr Iva Lloyd, the WNF has made leaps and bounds and despite its relative youth is now considered the equal of professional organisations many years its senior. Part of the reason for my stepping down is that the WNF is now entering the next phase of its development. It has survived and thrived childhood and adolescence and can now look towards the bright future in adulthood.

For the first phase of its existence WNF was still in development – its future still hopeful but unclear with most efforts focused on developing a solid financial, governance and policy foundation that could be sustained into the future. WNF is now in a position where it can focus more on developing the profession's capacity to leverage the power of naturopaths in addressing global health challenges. Building capacity in education and research will be key to this, and this will be some of the priorities of WNF over the next few years.

My own transition will be focused on this too, as I become representative of and educational member – you don't get rid of me that easy. Thankfully, Dr Iva Lloyd will transition into my role, which will be amended to reflect the new and exciting phase of the WNF. Many of WNF's successes are directly related to Dr Lloyd's vision and action in her role as President, and the WNF is extraordinarily lucky to have her move into this operational role.

The future for naturopathic medicine is bright, and I look forward to this new phase of WNF helping the naturopathic profession meet its true potential.

# Educational



The WNF supports naturopathic accreditation and the highest in naturopathic educational standards in each country. The activities of the WNF Educational Committee included the following in the past year:

- The Educational Committee started off the year with the WNF Naturopathic Educational Guide that was approved by the WNF Executive. This guide will further clarify the direction of naturopathic education globally based on the reports and analysis conducted by the WNF over the last seven years.
- During the last year the WNF Educational Committee facilitated a number of discussions with representatives from 14 different naturopathic schools and WNF organizations to discuss the challenges and benefits of technology-enhanced learning for various aspects of the naturopathic curriculum. This was a great opportunity for the naturopathic community to support each other through challenging times. As a result of those discussions, a subcommittee\* was formed to look at the benefits and health impacts of technology used by patients to monitor their health. The result was an Overview of Digital Healthcare Monitoring Devices Report reviewed and approved by the educational committee that will serve as a reference for naturopathic educational programs and the naturopathic workforce.



- A major accomplishment of the WNF Educational Committee was the comparison of the naturopathic accreditation documents from the Council on Naturopathic Medical Education (CNME) from North America, The Australian Register of Naturopaths and Herbalists (ARONAH) from Western Pacific and the Organisation der Arbeitswelt Alternativmedizin Schweiz (OdaAM) (Switzerland). This project was led by Cathrina Geldard a Naturopath from Southern Cross University, Australia with input from the WNF Educational Committee. The accreditation comparison indicated that there was a high-level of consistency between the three accreditation documents and will serve the profession as more countries look to adopting naturopathic accreditation standards.

The September 2023 WNF General Assembly includes a working group on assisting naturopathic educational institutions moving forward to one of the established naturopathic educational programs – either a 2500-hour practitioner-level program or a 4000+ hour naturopathic doctor program. The work accomplished by the WNF Educational Committee will serve as the framework for this meeting.

This year we have been collaborating with the WNF Communications Committee to bring public attention to the toxins and the effect on humans in personal care products through a social media campaign. This social media campaign will be followed by a focus on obesity, a problem that is increasing globally.

The Environmental Health Committee is on a mission to educate people across the globe so we can protect ourselves and our planet. The committee continues to develop its website with research-based

information on the effects of toxins in our home, work, food, personal care products, the environment, and specific health conditions, [www.wnf-environmental.org](http://www.wnf-environmental.org).

This year the Environmental Health Committee recognized Earth Day with a video to bring awareness to the impact of Climate Change. This video also presents potential solutions.

The Environmental Health Committee is seeking additional members from all world regions as we discover the commonalities and differences in how pollutants affect us. We do know that the climate crisis is the most dramatic expression of the impact of humans on the planet. As naturopaths and naturopathic doctors, we can play a role in educating each other and our patients and be a part of the solution. # Research



The WNF Research Committee had a very productive year. The key accomplishments included:

- **WNF Research Survey** which was designed to identify the gaps between the findings in the HTA and naturopathic research activities. The survey results will help to guide the activities of the WNF research group and the greater naturopathic research community. For example, the survey indicated the need for the naturopathic community to focus on building research capacity globally.
- **White papers on Non-Communicable Diseases.** The WNF released four White Papers on NCDs. The topics include: NCDs, Hypertension, Type 2 Diabetes and Mental Health. These White Papers are a great resource when building alliances with patient groups (i.e., your local diabetes association), policy makers and government. They are available on the WNF website in several languages.
- **Update of the WNF Book List** which is a comprehensive listing of books written by Naturopaths / Naturopathic Doctors. This report is updated every other year and currently includes over 1250 books.
- **Live Review on natural health products (NHPs) and COVID.** In May of 2022 the WNF launched the Live Review on natural health products (NHPs) researched with respect to the prevention and treatment of COVID. The goal of the Live Review was to act as a resource, attesting to the abundance and nature of the published peer reviewed evidence being synthesized on NHPs for application to COVID. It was updated monthly and resulted in an open-access Interim Report on a Live Review of Systematic Reviews of Natural Health Products and Natural Therapies in the Prevention and/or Treatment of COVID-19 in the CAND Journal. We thank the Canadian College of Naturopathic Medicine (CCNM) for working with the WNF on this important project.

At the 2023 WNF General Assembly we will be discussing how to effectively increase naturopathic research capacity globally. Part of that initiative involves creating a guide for the global naturopathic community that outlines the key steps required to build naturopathic research capacity globally. Completing this guide will be a major focus the WNF Research Committee in the upcoming year.

# Communications



The WNF Communications Committee had a very productive year. The WNF has over 9653 social media followers and reached 162,226 individuals with the 555 posts made in 2022. The WNF Social Media include 5 social media accounts including [Facebook](#), [Twitter](#), [Instagram](#), [LinkedIn](#), and a [YouTube Channel](#).

Promoting the publication of the [Health Technology Assessment on Naturopathy](#) was the subject of over 91 posts, both from the WNF and from the naturopathic community. The WNF's Environmental Health Campaign was another top topic again this year with a focus on the toxins in personal care products and the health-disrupting impact of plastics. This was the 2nd year for the WNF Environmental health campaign and this year the posts reached a

worldwide audience of over 3100 people through more than 24 posts in the first two months of the campaign. Monthly highlights of the [Live Review on natural health products and COVID-19](#) also received great response from the naturopathic community. Other activities include sharing member's posts, campaigns, and meetings and highlighting key messages from the [WNF Key Messages](#) document. Please share widely the WNF posts with your community and make sure to be part of the conversation.

Other key accomplishments included the publication of the [WNF Social Media Guide](#) and the [Naturopathic Key Messages](#) document which was based on the highlights of the HTA. The key messages are broken-down by the following categories: Key Stats on the Global Naturopathic Profession, Defining the Naturopathic Profession, Naturopathic Care, Regulation and Education of the Naturopathic Workforce, Naturopathic Research and other information. The Key Messages are customizable to each country and are designed to support promotion of the naturopathic profession.

Tina Hausser graciously compiled a [WNF Highlights video](#) which outlined the key WNF accomplishments in 2022. # Naturopathic Roots



In 2022 the WNF naturopathic roots committee undertook its 4th project that is writing the naturopathic history by world region. After publishing the WNF Roots Report, the 100 page White Paper on Naturopathic Philosophies, Principles and Theories and the WNF Terminology Document, the next roots committee's aim is to compile the history of naturopathy by world region. In detail are being looking at the foundation and development of the naturopathic profession globally and continue to define naturopathy as a traditional system of health care with its deep roots and long history. To preserve the traditional knowledge and indicate its use in modern naturopathic practice globally is the objective of this project.

Starting with the draft from Europe, requesting input from country organizations, reviewing and putting together by the committee, other world regions will follow with this structure.

The committee members are currently working on the 3rd draft, completing Europe and compiling the history of Western Pacific and Africa.

The focus of compiling information is on:

- The introduction of naturopathy to the region
- Foundation of first associations
- Founding first educational institutes
- Key contributors
- Historical timeline
- Naturopathic care unique to the region
- In which way is traditional knowledge such as naturopathic philosophies, principles and theories being included into practice
- How regions combine naturopathy with their local traditional medicine aspects

This is a live project adding information as needed, please reach out to the WNF if you wish to contribute to the content about naturopathic history in your country, we will make sure to include the information.





## 2 Year Plan 2021 – 2023






