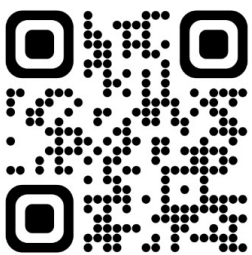

The early withdrawal penalty for certificates of one year or less original maturity is all earned dividends up to a maximum of 3 months earnings.
