Not having local credit history

The way all local banks and credit providers check customers' creditworthiness is by gathering their local historical data such as:

- Last three payslips
- Residential address and time lived there
- Latest local tax return
- Run local credit report (where available)
- Employment details and income

As a newcomer to a foreign country where the expat does not have any credit, they will be unable to provide the majority of the required items on the list above.

So instead, our suppliers work around the local credit system, requesting more attainable documents.

Documents needed for lease approval

- Employment contract
- Copy of passport
- Copy of work visa (visa type may matter)
- Copy of driver's license
- Credit application form
- Bank details/bank statements (not all countries)
- Tenancy agreement and utility bills (not all countries)

Three basic steps when leasing a car

These are general steps that apply to many countries where we offer expat car lease. For more specific details, please visit that country's page on our website ExpatRide.com

DETERMINING VEHICLE NEED

We will send the expatriate an introductory email with questions to determine which of our lease or long-term rental programs are best suited for them (in some cases, a long-term rental may be the better option). This information will include vehicle preferences, vehicle allowances, assignment start and end dates, etc.

PERSONAL CAR SHOPPER SERVICE

Our Personal Car Specialist will explore all available vehicle options according to the expatriate's needs, wants, and budget. They will then negotiate pricing on the expat's behalf, suggest vehicle options, and provide personalized, non-binding quotes.

INSURANCE, REGISTRATION, & DELIVERY

Should the expatriate decide to proceed, they will also receive assistance with practical matters such as car registration (where required) and delivery. Insurance guidance will be offered if insurance is not part of the lease program.

FREQUENTLY ASKED QUESTIONS

Why can it be difficult for an expat to lease a car in their new country?

Leasing a car can be a daunting task for expats without knowledge of the local auto market. Questions may include what vehicles are common, what documents are required, what does it cost, how do I obtain auto insurance, how long it takes, and where to go to find a lease, for example.

In addition, it can be challenging to obtain lease approval without local credit history. ExpatRide overcomes this by working around the local credit system.

What are the benefits of using ExpatRide?

Is a local credit history needed to lease a car with ExpatRide?

No, we work around the local credit system. To do this, a few documents (passport, work visa, employment contract, etc.) are required to obtain lease approval.

What is Personal Car Shopper Service?

Our Personal Car Specialists work to find the best fit for each family. The goal is to match needs, wants, or budget. They will locate the preferred car with a dealer or manufacturer. In most cases, our Personal Car Specialist gets competitive pricing based on arrangements previously made with vehicle manufacturers, dealerships, and financing companies.

In addition to locating a suitable vehicle, they also complete all tasks from start to finish—including setting up a finance agreement, registration, license plate coordination, etc.

Who is responsible for maintenance of a leased vehicle?

As part of the lease agreement, usually the lessee is responsible for servicing the vehicle in accordance with the manufacturer's minimum recommendations and as requested by the manufacturer in connection with any recall campaign.

Who can drive the leased vehicle?

In most countries, any person named on the auto insurance policy can also drive the vehicle.

What happens if the leased car must be returned before the end of the lease agreement?

This depends on the country and the type of lease agreement signed. In most cases, there will be a penalty, or the remaining months left on the lease will have to be paid.

What payment options are available?

The monthly payment is set up to be paid directly from the lessee's local bank account to the finance company. In some countries, the monthly payment can be directly billed by ExpatRide to the employer/RMC.

What other services does ExpatRide offer?

ExpatRide offers car rental, airport transfers, chauffeur service, armored cars, and bus service.


