# Bremond Block Historic District National Register 1970


- Eight homes built between 1850 and 1910

- Architect not documented




# Who was Harvey North?

- Harvey born 1810 in Goshen, Connecticut. Died 1881.

# Athalie North Obituary



#### Oblinary.

Dien.—In the city of New York on the ninth of July, 1877, Miss Etlen Athalie North, only daughter of Harvey and Athalie North, at the age of twenty-four years and one day.

The deceased left Germany, where she had just ended a three years course of musical instruction, only a few weeks ago in the fullest enjoyment of health. When only a few miles from Sandy Hook she was unexpectedly taken with hemorrhage of the lungs. A loving and expectant father and mother were saddened by telegraphic news of this sad event and hastened to the beside of their beloved child. But, alas, disease had made rapid strides. In a long and painful struggle between youth and medical skill and death, the latter obtained the mastery and left grief-stricken parents to mourn the loss of a cherished darling whom they had accustomed themselves to look upon as the comfort of their old age. May she rest in peace, and may her corrowing father and mother and

brothers be able to bear their affliction

with fortitude.

 In 1877, Athalie, North's youngest daughter, died from tuberculosis at 24 years old.

 She was on her way home from studying piano in Germany.

#### 1876-1881 -North Financial Reversals

- Real estate investments faltered by 1876. Harvey
- North died in 1881. In 1883 Catherine North sold
- to William Gaines at half the original cost.
  - Catherine North moved in with son William North
- in Villa Bellevue, next door.

#### A LONG FIGHT FOR A CHILD.

#### TO BE CONTINUED BY MRS. AUGUSTA E. GAINES IN THE DIVORCE COURT.

St. Louis. Oct. 18 .- To-morrow, or perhaps later in the week, the Gaines divorce suit will be called in the Circuit Court, and it will be a great sensation. Mrs. Augusta E. Gaines, the plaintiff, is the daughter of one of the most prominent citizens of St. Louis, Capt. Albert J. Evans. The defendant is Col. William P. Gaines of Austin. Texas, of a very wealthy and prominent family, part owner of the Austin Statesman, and identified with many public and private enterprises. Their marriage at St. George's Church in this city in 1883 was a great social event.

The fight is for the possession of a little daughter. When the couple separated Mrs. Gaines came to the home of her parents, bring-ing her little four-year-old daughter, with her. col. Gaines followed and abducted the child under sensational circumstances. The mother employed detectives and soon located the little one in Austin. For eighteen months the little due in Austin. For eighteen months the mother made continuous but fruitless, efforts to ket the child, making three trips to Texas for the purpose. Then she resolved to do as her husband had done-steal the girl. She was assisted by her father in making all arrangements. She dressed herself as a school girl and went to Austin, and soon discovered that Col. Gaines, who traveled about considerably always contributed.

about considerably, always took the child and a nurse with him. She followed them about, and finally her op-portunity came in Houston. She drove in a She followed them about, and finally her opportunity came in Houston. She drove in a closed carriage to where the child was at play, selfed it, and drove to a landing on a bayou that runs into Galveston Bay. Her father, Capt. Evans. had a tug waiting, and they boarded it. They were caught in a storm on the bay, and after a rough experience were forced to abandon all hope of reaching Galveston, and put in at a point where the Southern Pacific Railroad could be sasily reached. Meanwhile her husband, with a posse of rangers, had started in pursuit, and at the railroad station overtook the abductors. The little girl was disguised in boy's clothes, but the Sheriff insisted on making an examination. The mother, revolver in hand, saides would kill him if he touched the child. Then one of the posse of rangers, shotgun in hand, came to the front and said:

"I will never assist in taking a child from its mother, Madame. I will be your escort to the Louisiana State line."

He kept his word, and they got away. All this and much more will be brought out during the trial.




# "The Philanthropist"








#### "The Extreme Makeover"

Evans hired noted San Antonio architect Alfred Giles, who created limestone arches, crenellations, buttressed retaining walls and tower.





- Austin Woman's Club was chartered in October 1929






