His appointments have involved disputes worth up to £110 million both in the UK and internationally, across sectors such as energy and process engineering, transport infrastructure, hospitals, education, housing, and hotels and leisure. He has extensive experience with all major standard forms of contract, including FIDIC and NEC, regularly resolving disputes involving highly complex technical and legal issues. Alongside his professional practice, Matt contributes to the development of dispute resolution through teaching and examining. He is currently also a part-time PhD student at Queen Mary University of London, undertaking research into international law and arbitration and, in 2024, he co-authored his first book, *Adjudicating Construction and Engineering Disputes*.
