



- Ensure your qualifications meet Australian standards for early childhood education and care.
- Verify that documents are authentic and equivalent to local qualifications.

When is Translation Necessary?

Translation is needed if your documents are:

- Not in English.
- Required for assessment by ACECQA or an Australian employer.

Translation Requirements

ACECQA specifies that translations must:

- 1. Be accurate and certified.
- 2.Be completed by a NAATI-accredited translator (National Accreditation Authority for Translators and Interpreters) if the translation is conducted in Australia.
- 3. Meet equivalent standards if the translation is done overseas, such as:
 - Translators officially recognized by your country's government or embassy.
 - Translators who are part of professional associations like FIT (Fédération Internationale des Traducteurs).

How to Get Your Qualifications Translated

Step 1: Locate a Certified Translator

- Within Australia: Use NAATI's online directory (<u>www.naati.com.au</u>) to find accredited translators.
- Overseas: Contact your country's Australian embassy or consulate for recommended translators.

Step 2: Provide Required Documents

You'll need:

- Original qualification certificates.
- Academic transcripts (if applicable).
- Supporting documents like course descriptions or syllabi (if requested by ACECQA).

Step 3: Request Certified Translations

- Ensure that translations include official stamps, the translator's accreditation number, and contact details.
- Translations must match the format of the original documents for easy cross-referencing.

Submit Your Translations to ACECQA

Once your documents are translated, submit them to ACECQA for assessment.

How to Apply:

- Visit the ACECQA qualification assessment portal:
- <u>www.acecqa.gov.au</u>
- Complete the online form.
- Upload:
 - Certified copies of your original documents.
 - Certified translations.
- Pay the application fee (AUD 115 as of Jan 2025).

ACECQA Assessment Process

ACECQA will assess whether your qualifications:

- Meet the approved qualification standards under the NQF.
- Align with Australian early childhood education and care requirements.

Processing usually takes 8-10 weeks, but this can vary depending on the complexity of your case.

Additional Tips

- If you're unsure whether your qualifications need assessment, check the list of ACECQAapproved qualifications on their website.
- Keep both original and translated documents handy for employers, as they may request additional evidence.

Migration and Visa Agents

What to Look for in a Migration Agent

- MARA Registration: Check that the agent is registered with the Migration Agents Registration Authority (MARA). You can verify their credentials at <u>www.mara.gov.au</u>.
- **Specialization:** Choose an agent who specializes in the visa category you need (e.g., skilled, family, employer-sponsored).
- Experience: Look for agents with a strong track record and positive client testimonials.
- Transparency: Ensure they provide clear advice on fees, eligibility, and processes.

Common Visa Categories These Agents Assist With

- Skilled Migration (Subclass 189, 190, 491): For professionals meeting skill shortages.
- Family/Partner Visas (Subclass 820, 309, 100): For partners and family members of Australian citizens or permanent residents.
- Employer-Sponsored Visas (Subclass 482, 186): For businesses sponsoring workers.
- Student Visas (Subclass 500): For international students studying in Australia.
- Visitor Visas (Subclass 600): For short-term visits.

Costs

Migration agent fees vary depending on the complexity of your case. As a general guide:

- Initial Consultation: \$100-\$200 (sometimes free).
- Visa Application Assistance: \$1,500-\$5,000 (or more for business visas).
