Estate Planning – Definitions

Estate – refers to everything you own, including your assets, properties, possessions, investments, bank accounts, life insurance policies, retirement accounts, and more. It encompasses all of your financial and non-financial assets. Your estate may also include debts and liabilities..

<u>Will</u> – a legal document, signed by you and your witnesses, that sets forth your wishes regarding the distribution of your property and the care of any minor children.

<u>**Trust**</u> – a trust agreement is a document that spells out the rules that you want followed for property held in trust for your beneficiaries.

<u>Living Trust</u> - a legal way to manage and pass on your belongings while you're alive and after you're gone. It helps avoid legal complications and keeps things private.

Land Trust - a legal arrangement where someone else holds the property title for you, while you still enjoy the benefits and control over the property. It can help with privacy and property management.

Power of Attorney (POA) – a document that allows you to appoint a person or organization to manage your affairs if you become unable to do so.

<u>Beneficiaries</u> – people or entities who you would like to receive any part of your estate or trust, including, but not limited to family members (children, grandchildren, in-laws, etc.), friends, and charities.

<u>Property</u> – any tangible personal items or real estate you currently own (i.e., homes, money, jewelry, artwork, automobiles, etc.).

Executor – The person who manages your will.

<u>Trustee</u> – The person who manages your trust.
