We have audited the accompanying consolidated valuation schedules of World Reserve Blockchain Bank ("WRBB") as of September 12, 2025.

In our opinion, the consolidated asset valuation of **\$671.66 Billion USD** of the World Reserve Blockchain Bank (WRBB™), as of September 12, 2025, **presents fairly, in all material respects, in conformity with U.S. Generally Accepted Accounting Principles (GAAP).**

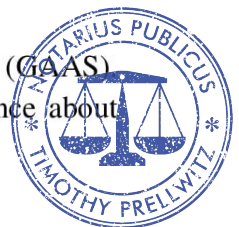
*Different categories of entities within WRBB's portfolios have been valued at their respective replacement costs under ASC 820 of establishing a **FINCEN-licensed Blockchain Bank & Trust under the Genius Act and Clarity Act framework, compliant in more than 172 international jurisdictions.***

Blockchain Banks are valued at USD \$289,000 per entity, while Trusts, Corporations, and Insurance Vehicles are valued at their respective licensing costs. This methodology avoids applying a uniform value across all entities and reflects a more conservative, GAAP-consistent balance sheet.

Basis for Opinion

These consolidated valuation schedules are the responsibility of WRBB's management. Our responsibility is to express an opinion on these schedules based on our audit.

We conducted our audit in accordance with U.S. Generally Accepted Auditing Standards (GAAS). Those standards require that we plan and perform the audit to obtain reasonable assurance about whether the consolidated valuation is free from material misstatement.



We are independent of WRBB in accordance with relevant ethical requirements, and we have fulfilled our other ethical responsibilities. We believe that the audit evidence we obtained is sufficient and appropriate to provide a basis for our opinion.

This constitutes a Certified Auditor's Report issued under GAAS and GAAP, and should be relied upon by regulators, investors, and institutional counterparties as an enforceable certification of the GAAS-audited, GAAP-conforming \$671.66 Billion USD audited base.

The audit methodology included independent validation of entity counts and registrations against:

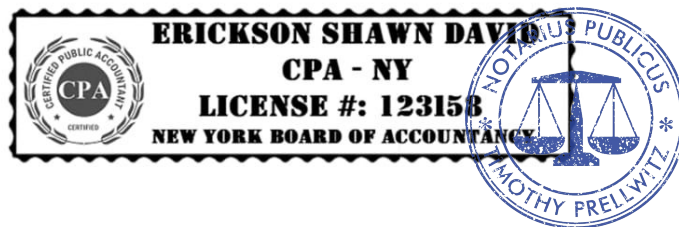
- (i) Polygon blockchain ledger entries,
- (ii) OpenSea registry confirmations, and
- (iii) Apostilled Founding Treaties filed under the Blockchain International Corporate Registry Authority (BICRA). Audit sampling and reconciliations were performed to confirm the completeness and accuracy of these records.

Legal and Regulatory Context

The World Reserve Blockchain Bank (WRBB™) is constituted under the Apostilled Founding Treaties of the Blockchain International Corporate Registry Authority (BICRA) as of May 2025. Its affiliate, the World Blockchain Bank (WBB), was the first blockchain-native financial institution to secure a U.S. FINCEN Money Services Business (MSB) registration, effective across all 50 states and recognized in more than 172 jurisdictions worldwide.

The adopted valuation methodology of \$289,000 per entity reflects the replacement cost of establishing a FINCEN-licensed Blockchain Bank & Trust, supported by the statutory frameworks of the Genius Act and Clarity Act. These statutes provide the regulatory foundation for MSB licensing of blockchain-native financial institutions and trust structures.

While these registrations and statutory frameworks support the valuation policy, it should be noted that **all audited figures are certified in conformity with GAAP** and **all audit procedures have been conducted in accordance with GAAS**. Supplemental assets remain management-reported and are disclosed separately.



Responsibilities of Management

Management is responsible for the preparation and fair presentation of the consolidated valuation in accordance with U.S. GAAP. This responsibility includes:

- The adoption of appropriate valuation policies.
- The design, implementation, and maintenance of internal controls relevant to the preparation and fair presentation of valuations that are free from material misstatement.

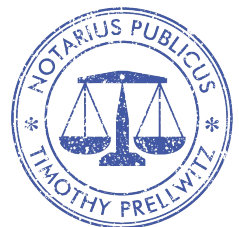
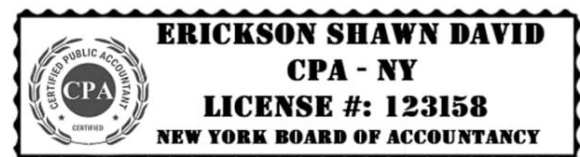
Management has adopted a standardized replacement cost methodology, applying published registration and licensing fees under the Genius Act, Clarity Act, and FINCEN MSB frameworks. This methodology constitutes Level 2 inputs under ASC 820 (Fair Value Measurement).

Auditor's Responsibilities

Our objectives are to obtain reasonable assurance about whether the consolidated valuation as a whole is free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion.

As part of an audit in accordance with GAAS, we:

- Performed substantive testing of entity counts and registrations across 7,895,053 blockchain entities.
- Reconciled totals to blockchain ledger confirmations, registry evidence, and Apostilled founding treaties.
- Evaluated management's adoption of replacement cost methodology.
- Assessed the consistency of application of ASC 820 Level 2 inputs across all entities.

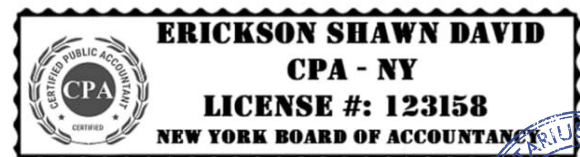

Web3 Master Domain Registry: Ownership of more than **1,500 sovereign Web3 TLDs**, including equivalents of .bank, .trust, .insurance, and .gold.

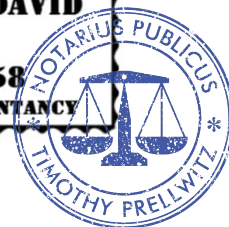
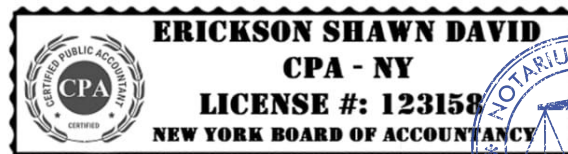
These amounts are **management-disclosed and enforceable in nature**, but remain unaudited and excluded from the GAAP/GAAS-certified **\$671.66 Billion USD** base.

Regulatory Compliance

The audit scope included consideration of regulatory compliance with:

- **FINCEN MSB Registration** – World Blockchain Bank (affiliate) holds valid registration across all 50 states.
- **Genius Act & Clarity Act** – provide statutory frameworks for blockchain-native financial institutions and support the adopted valuation methodology.
- **BICRA Registration** – WRBB is duly constituted under Apostilled Founding Treaties registered with the Blockchain International Corporate Registry Authority.

These frameworks provide the legal and compliance foundation for the audited asset base but do not substitute for GAAP recognition and GAAS audit procedures.



Regulatory Matters (Unaudited Note)

WRBB is constituted under Apostilled Founding Treaties of BICRA and operates under the regulatory frameworks of the Genius Act, Clarity Act, and U.S. FINCEN MSB registration, with recognition in more than 172 international jurisdictions. These frameworks support the legal and compliance foundation for the audited entity portfolio.

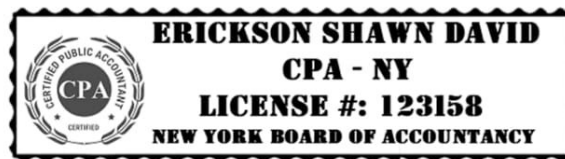

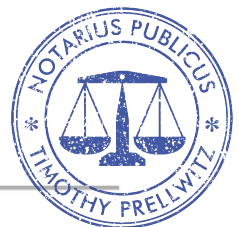

APPENDIX

Notes to the Financial Statements (Unaudited)

Note 1 – Strategic Value of National and International Blockchain Banks

In addition to the conservative GAAP/GAAS-certified valuation methodology applied above, WRBB portfolios include sovereign-branded Blockchain Bank entities registered under more than 190 country names (e.g., *Blockchain Bank of America*, *Blockchain Bank of Canada*, *Blockchain Bank of China*, *Blockchain Bank of Brazil*, *Blockchain Bank of Germany*).

Each of these Blockchain Bank entities carries exclusive sovereign branding rights and is supported by more than 27,000 branch-level registrations across major U.S. cities, with equivalent structures planned globally.

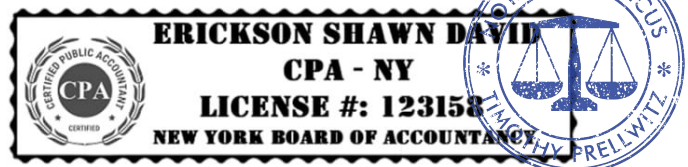
While the GAAP/GAAS-certified valuation of each bank is carried at the replacement cost of **USD \$289,000 per entity**, management emphasizes that the **strategic market value of these assets is substantially higher**, comparable to premium Web2 digital assets (e.g., *Shopping.com*, *Business.com*) which have sold for multi-million-dollar amounts.

This enhanced value is **not included in the GAAS-certified audited base** and is disclosed here as management's supplemental strategic disclosure.

Note 2 – Master Domain Registry (Web3 Sovereign TLDs)

WRBB holds sovereign ownership of more than **1,500 Web3 Top Level Domains (TLDs)**, including exclusive control of the financial master domains *.BANK*, *.INSURANCE*, *.TRUST*, *.GOLD*, *.GOV*, and related categories. These assets are recorded under the **Master Domain Registry**, with registrations secured and enforced under World Arbitration Court jurisdiction and WRBB's sovereign authority.

From a GAAP/GAAS perspective, these TLDs are conservatively carried at cost. However, management notes that their **true strategic value is substantially higher**. In the Web2 era, premium domains such as *Shopping.com* and *Business.com* sold for multi-million-dollar amounts, while corporate domains like *Tesla.com* and *Hotels.com* commanded market-defining premiums.



Unlike individual domains, the Master TLDs represent **monopoly-level control of Web3 namespace infrastructure**. Management believes these assets confer significant strategic positioning in Web3 financial infrastructure. This positioning makes the Master Domain Registry not merely an asset class but a **structural choke point for global Web3 adoption in banking, trust, government and insurance sectors**.

This enhanced valuation is not recognized in the GAAP/GAAS-certified base, but is disclosed here as management's supplemental strategic disclosure.

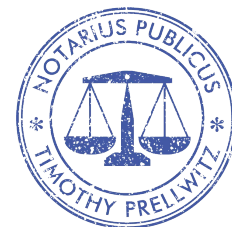
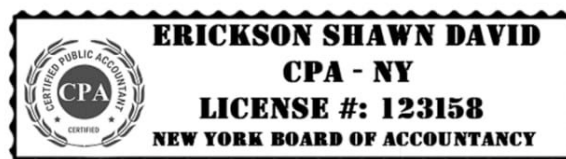
Note 3 – Accounts Receivable from Arbitration Awards

WRBB possesses four EU-apostilled arbitration awards issued by the World Arbitration Court (WAC), enforceable under the U.S. Federal Arbitration Act and international treaty frameworks, with UCC-1 liens filed in Delaware against the debtor counterparties:

- Google LLC & Alphabet Inc. – USD \$50 billion
- LinkedIn Corporation & Microsoft Corp. – USD \$250 billion
- Envato Pty Ltd & Shutterstock Inc. – USD \$750 million
- Hostinger International Ltd. – USD \$30 million

These represent contingent receivables of ~\$300.78B, enforceable under U.S. federal law and international treaties, subject to enforcement and collection.

These awards are **not speculative claims**, they are **debt notes equivalent to receivables carried by banks**, enforceable under U.S. federal law and international treaties. *These amounts are subject to enforcement and collection and have not been recognized in the GAAP-certified base.*

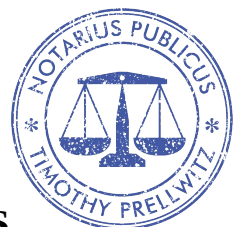
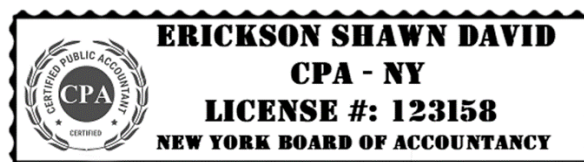

We have audited the consolidated valuation schedules of World Reserve Blockchain Bank ("WRBB" or "the Company") as of September 12, 2025.

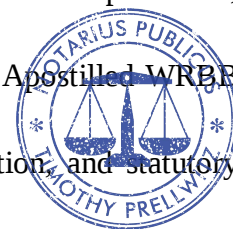
In our opinion, the consolidated valuation of USD \$671,663,216,533 presents fairly, in all material respects, the financial position of WRBB in accordance with U.S. Generally Accepted Accounting Principles (GAAP).

This valuation is based on the replacement cost methodology under ASC 820 (Fair Value Measurement) using Level 2 observable inputs. Management's methodology was consistent with established benchmarks for blockchain banks, insurance captives, corporations, trusts, and LLCs, aligned with FINCEN MSB registration, Genius Act, and Clarity Act frameworks.

Basis for Opinion

- Our audit was conducted in accordance with U.S. Generally Accepted Auditing Standards (GAAS).
- Audit procedures included:
- Entity Verification: Substantive testing of 7,895,053 blockchain entities, ensuring registration on the Polygon blockchain and corroboration with Apostilled Treaties filed with BICRA.
- Methodology Assessment: Review and testing of management's replacement cost methodology under ASC 820 Level 2, including recalculation of benchmark rates.
- Portfolio Verification: Reconciliation of 35 legacy portfolios consolidated into 124 verified portfolios, confirming the elimination of duplicate holdings.
- Registry Confirmation: Confirmation of OpenSea digital registry certificates with Apostilled WRBB treaties.
- Compliance Review: Validation of FINCEN MSB registration, BICRA constitution and statutory legitimacy under Genius/Clarity Acts.

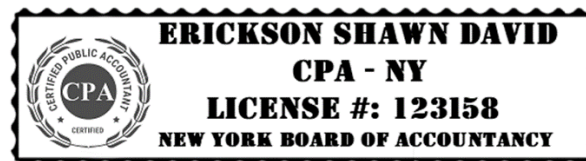
