


ADVOCACY

TGCSA was founded on the principle that the food industry is better off if it is seated at the table when public policy is being made. TGCSA is your advocate before the state legislature, and all regulatory and policy-making agencies.

In recent years we have secured major victories for our members, including:

- 2012 Extending the schedule for distribution of SNAP benefits from a ten-day period to a twenty-day period, smoothing out major disruptions in product distribution and labor scheduling
- 2014 Securing the ability for retail food stores to sell wine
- 2016 Increasing the commission on cigarettes from 8% to 15%
- 2017 Prohibiting local laws banning plastic bags, Styrofoam containers
- 2018 Allowing for wine & spirit sales seven days a week (Sunday sales)
- Pandemic TGCSA maintained weekly meetings with the Governor, FEMA, TEMA, and other key departments to ensure the industry remained wellsupplied and informed.
- 2023 Allowing for food store sales of "ready to drink" wine-based cocktails

The list of bad ideas proposed in the Tennessee General Assembly during is too long to include here! TGCSA has a strong record of defeating these bad ideas.

By adding your company's voice to the unified voice of Tennessee's food industry, we all become stronger.

In 2024 we will be engaged in fights in many areas, including:

SCHOLARSHIPS

Valuable higher education scholarships are available to associates, and children and spouses of associates, of TGCSA member companies, through the Tennessee Grocers Education Foundation, a 501(c)(3) nonprofit corporation. Since its inception, TGEF has awarded more than \$4.2 million in scholarships for college!


