WORK OPPORTUNITY TAX CREDIT (WOTC)

L.A. County America's Job Centers of California (AJCCs) can help you qualify for the Work Opportunity Tax Credit (WOTC), a federal tax credit available to L.A. County employers who hire employees from certain targeted groups that have faced barriers to employment.

WOTC is a workforce tax credit that incentivizes workplace diversity and access to good jobs for all L.A. County employees. Employers earn tax credits ranging from \$1,200 - \$9,600 based on the qualifications of the employee, hours worked and current wage rate.

We can help you qualify for WOTC plus assist in sourcing and recruiting your next rockstar employee.
