

#### The Philippine Statistical Development Program

#### **Legal Basis**

Republic Act No. 10625 or the Philippine Statistical Act of 2013 mandates the Philippine Statistics Authority (PSA) to prepare, in consultation with the PSA Board, a Philippine Statistical Development Program (PSDP).



PSA Board Resolution No. 1, series of 2023, "Enjoining Members of the Philippine Statistical System to Participate in the Formulation of the Philippine Statistical Development Program 2023-2029 and Approving the Creation of a Steering Committee and Sectoral Working Groups for this Purpose," states that PSDP 2023-2029 will be formulated with guidance from a Steering Committee and inputs from Technical Committees (TCs), Interagency Committees (IACs), RSCs, Task Forces (TFs), Technical Working Groups (TWGs), and Sectoral Working Groups (SWGs).

#### What is PSDP?



The National Strategy for the Development of Statistics of the Philippines



Mechanism for setting directions, thrusts and priorities of the PSS in the medium term for the generation and dissemination of statistical information for policy and decision-making of the government, private sector and general public




Contains priority statistical development programs and activities designed to provide vital information support to national development planning and international commitments



A tool for integrating and coordinating the statistical activities of the government.

#### **PSDP Milestones**



The National Economic Development Authority (NEDA) and spearheaded PSDPs from 1976 to the formulation of 1987. When the Philippine Statistical System (PSS) was reorganized in 1987, by virtue of Executive Order 121, the formulation of PSDP was transferred to then National Statistical Coordination Board (NSCB). Under Republic Act No. 10625, the Philippine Statistics Authority continued the formulation of the PSDP as one of its mandated functions.

- Improvement of the generation of relevant, timely, and quality statistics to address recent developments and emerging statistical demands.
- □ Strengthening of the data ecosystem to include enhancement of administrative-based data, citizen-generated data and big data as possible sources of official statistics.
- Enhancement of data governance, coordination, and research and development at the national and subnational levels.
- Investment on necessary statistical resources and program.
- Strengthening data dissemination and advocacy of statistics through conduct of press conferences, use of various social media platforms and communications technology resources, and laymanizing statistical terms to be understood by ordinary people.
- Advocacy on the utilization of statistics for the formulation and implementation of policies and programs.
- Conduct of more consultation workshops and users' fora to improve appreciation of statistics.
- □ Strengthening mechanisms on data privacy/security to enhance the trust of data users.
- □ Enhancement of the management and harmonization of the PSS to uphold the promotion of quality statistics.
- Creating more capacity development programs to support existing human resources in the PSS as well as data users and stakeholders for better generation, dissemination and utilization of statistics.
- Maximizing use of ICT, i.e., online data portal and reporting systems, to improve accessibility and utilization of data.
- Strengthening institutional linkages between the national and local governments for the generation and utilization of local and national statistics.
- Strengthening partnerships with the international statistical community through adherence to international commitments such as the Sustainable Development Goals (SDGs), ASEAN Code of Practice, and the adoption of UN Fundamental Principles of Official Statistics as well as active involvement in international conferences/meeting.





#### **Chapter Scope and Coverage**

The PSDP 2023-2029 outlines the key statistical development programs and activities from 2023-2029. It aims to continually respond to the existing and emerging requirements of development planning and policy formulation considering information demands, recent events and adherence to international commitments.
