Protecting and Providing: Steeley's Dual Focus on Safety and Opportunity in Camden

CAMDEN, NJ - Joshua Steeley, a Camden, New Jersey native, transformed a life-threatening experience into a powerful mission to serve, protect, and uplift his community. As the founder and president of Aziel Protection LLC, Steeley leads a growing security firm that spans New Jersey and Pennsylvania, offering top-tier services backed by military, law enforcement, and private investigation experience & training. Aziel Protection represents a commitment



Steeley:

What motivated me to start my own security firm was an incident in 2012. I was the victim of a potential homicide. I was sitting on my father's steps at 813 Newton Avenue that's where I'm from in Camden, downtown. I was on the phone talking to my children, about to take my father to work. A car pulled up in the middle of the street. Two guys hopped out of the back seat and started approaching me, asking if I was selling drugs. I said, "No, man, I don't sell drugs. You have to go around the corner." Then those two guys opened fire on me—about 11 shots. I hit the ground and went into fight-or-flight mode. I didn't have a firearm on me at the time. It was in the house because I didn't have a license to carry it outside the house back then. So I fled the other way. That eventually led me to managing a large club—Haason Reddick' club. We had about 30 employees. I did the club scenes, personal protection for mayors and high-end clients, and I traveled from Florida to California providing bodyguard services.

The travel part was difficult because I was a single father at the time, raising my three kids by myself. I couldn't travel as much, so I started subcontracting those services to others. I shifted my focus to creating more consistent, passive income through scheduled site security, which allowed me to be more present as a father.

Now, I service various sites including supermarkets, car lots,

to community empowerment—particularly for young men and women in Camden—through job creation, mentorship, and second-chance opportunities. With a deep foundation in faith and an entrepreneurial spirit, Steeley has also launched a nonprofit initiative to help young people discover purpose and stability through career development and business ownership.

In an exclusive interview with the nation's premier faithbased and professional newspaper for winners, Anointed News Journal, Joshua Steeley shares how surviving violence ignited his mission to build safer communities, empower youth, and lead with purpose through faith and entrepreneurship.

Collins:

Who is Josh Steeley?

Steeley:

Joshua Steeley is an African American male born and raised in Camden, New Jersey. I'm 40 years old. I've been doing security for a little over a decade. I'm done private investigating in Philadelphia for about eight years. I also had a security company in Philadelphia. I'm a father—a father of six. I'm a God-fearing man. Serving is my passion. I serve others. That's how you become a leader: by serving first. I'm trying to impact my community more, particularly by helping youth get jobs in the security and law enforcement fields.

Collins:

Josh, you are also the founder and president of your own security firm. Tell us about the name of the security firm and what your mission is.

Steeley:

Aziel Protection LLC. The security firm was founded in 2014. We service New Jersey and Pennsylvania—those are the two states I'm concentrating on. The name is backed by

Cars were following me, circling the block. So I hid until the police were called.

I remember that feeling—being helpless. Hopeless. By the grace of God, He preserved me for a reason. At that moment, I said, "God, I can either take this down a negative path and go on a hunt, or I can serve—serve those who were in my situation, who felt helpless and hopeless, who didn't have anyone to back them up, and who were victims." There are programs—if you're a victim, you can go to Camden County and get psychological therapy and support. I did that. But the experience encouraged me. I said, "I never want to be caught without a firearm again, and I want to help others who've been through what I went through." Not everyone makes it out—but I had the opportunity to. So I want to give back to my community. And I'm servicing the downtown area where I almost lost my life.

Collins:

So how large is your security firm at this time, and what services do you provide?

Steeley:

The security firm currently operates in Pennsylvania and New Jersey—that's where my main focus is right now. I do have concealed carry permits that allow me to operate across the United States, but I'm concentrating on the tri-state area. I have about 18 employees, and we're growing. My goal is to reinvest in my community. I can take contracts in Delaware or Florida, and I get offers regularly, but I often turn them down because I want to stay focused here in Camden, where I was born and raised, and also in Philadelphia.

We have a lot of family in Philadelphia and a strong client base there as well. I actually started out as a fugitive recovery agent, which is a bounty hunter. That was my first license in the state of Pennsylvania. At the time, New Jersey didn't allow private individuals to do that unless you were a police officer or a retired police officer. So I went out of state, got all my licenses, and then transferred them over to New Jersey. That was my strategy, because I had declined becoming a police officer. It wasn't financially viable for me at the time, and I couldn't hire the people I wanted to hire. I've always had an entrepreneurial mindset and wanted to build a team.

and Camden County OEO buildings—providing overnight protection to prevent break-ins and safeguard employees. We also cover events, hotels in Atlantic City, and more. I'm still growing, still hiring good people, and staying focused on the mission.

Collins:

Now, Josh, you're 40 years old. A lot of young people might have taken the safer route and entered into law enforcement as a police officer, correctional officer, or similar. You chose the path of entrepreneurship. When you look at where you are today, what are your thoughts? Are you happy that you chose the entrepreneurship route?

Steeley:

Collins:

Yes, I'm happy that I chose the entrepreneurship route. I did train with SWAT in Chester, PA, alongside a lot of police officers. That's where I received my training. My instructor was Tom Dickson, a former Chester police officer who later became a firearms dealer. He owns about 31 acres of land where we conduct our firearms training.

So I do train with law enforcement. I like the path I chose because I'm able to provide jobs and salaries. I've always wanted to help the community, especially by giving people the financial means to provide for their families. I also have many connections in law enforcement, and for individuals who want to work in security, build their resume, and later transition into law enforcement, I strongly encourage it.

I'm one of the few who skipped the route of becoming a police officer but still earned the credentials similar to those of a retired officer. Most retired officers start a security company after their service. Somehow, I was able to train with law enforcement and work under private investigators and police officers, which allowed me to become a private investigator myself. That's how I earned the credentials to own a security company. In New Jersey, you can't just open one; you need five years of experience as a private investigator or be retired law enforcement. I met the requirement by working under police officers as a private investigator.

a Hebrew meaning: "God is our underlying strength." I named it that because I'm a Christian and I believe in a higher power. I got that name from praying, asking God what I should call my company. So it has religious values. We view ourselves as soldiers—to help preserve life and property, and to assist any individuals who are victimized.

Collins: All right, so Josh, let me ask: what motivated you to start your own security firm?

So I began as a bounty hunter, then became a private investigator in Philadelphia. I worked on a few homicide cases, and also handled many infidelity investigations. What words of encouragement would you give to a young man or woman who wants to pursue entrepreneurship or a career in law enforcement?

Steeley:

I'd say go for your goals. Pursue whatever you feel God has called you to do. Think about it, write it down, and weigh the pros and cons—the positives and negatives—and then go for it.

We have a lot of older individuals in the community who want to help younger folks before they get into trouble. I tell them, "Hey, you got your concealed carry yet? No? Then get it. You have your SORA card? No? You should get that too." You can build your resume in law enforcement before making choices that could disqualify you from getting those credentials. The law has opened up opportunities in that area.

So I encourage everyone to exercise their Second Amendment rights—to protect themselves and others. The world is not getting any safer. We need people who are willing to step up, help keep the world safe, and preserve life and property for those working to build better lives for others.

Collins:

So, Aziel is a full-service security firm. I believe you offer both armed and unarmed services. How can people acquire your services?

Steeley:

Yes, that's correct. They can email me at info@azielprotection.com. Let me give you the contact numbers too. I have two lines: one for Camden, New Jersey—(856) 383-0383, and one for Philadelphia—(215) 403-6770.

Collins:

The Anointed News Journal has over 180,000 readers weekly. In conclusion, what do you want to say to the readers of The Anointed?

Steeley:

First of all, I'd like to thank you, Mr. Chris Collins, for allowing me to be part of your news journal—and for allowing me to serve you when you attend various government meetings and events. It's truly a pleasure to serve you.

To anyone in need of our services—we're available. We also offer referrals. If you know anyone in need of security services, we provide a referral incentive, which could be a cash deposit or a percentage of the contract value, depending on the terms. It's a finder's fee—something that helps us grow. And when we grow, our community grows.

I'm also working closely with James Stewart—he's the person I send male and female applicants to for their security clearance training. I'm hiring directly from my city. I have a deep desire to see Camden residents working with us, not to be biased, but because we serve Camden—and I want Camden residents to benefit economically. When we hire from our own community, we help bring income and opportunity back into the city. It's all about building Camden up from within.

Conclusion:

Joshua Steeley's story is one of resilience, faith, and purposedriven leadership. Through Aziel Protection LLC and his nonprofit efforts, he continues to uplift his community by creating opportunities, mentoring youth, and promoting safety across Camden, Philadelphia, and beyond. His commitment to service and entrepreneurship serves as a powerful example of how one life transformed can lead to the transformation of many.

Highlights of the town hall include:

On the Future of Patient Care if These Cuts Pass:

Senator Kim – "Major changes in budget cuts could very well impact [a public hospitals] ability to continue to provide care. I wish I could tell you something otherwise, but I want to make sure I'm telling you the truth. This legislation, as it stands coming out of a House of Representatives, is the single largest healthcare cut in our country's history. So this is really severe in terms of what we're facing."

On the Realities for Tom Spadaro and Others in the Disability Community if Medicaid is Cut:

Tom Spadaro – "I have been a total quadriplegic since I was 11 and was involved in a gun accident. I am dependent upon a ventilator, and have truly depended upon others, all of my life, 24 hours a day for 46 years. Over the years, [Medicaid] evolved with all these different changes to make it better for the disabled community...it came with the ability to go to school, to go to college...it's given me dignity, and it's taken a burden off of my family and my partner. If I lose Medicaid, I feel like I'm getting shot in the head again. This time, it's not a bullet. It's legislation."

Collins:

And what can someone expect when they acquire your services?

Steeley:

You can expect the highest level of security service. We have retired police officers, martial arts instructors, firearm instructors, and retired military personnel. I do my best to hire top-tier individuals.

Our services are affordable, but not cheap—in terms of quality. We provide the highest level of professionalism and skill in the private security field.

Collins:

What's next for Joshua Steeley?

Steeley:

I'm currently forming a nonprofit called Camden Rising Entrepreneurs And Mentors, or C.R.E.A.M.; The mission is to give back to the youth—something I'm very passionate about.

I played football for Camden High, and I've seen a lot of talented athletes who go to college but don't make it out. Still, they have heart, drive, and discipline—qualities that can translate well into security and protection work.

So, I'm working with high school students who may not be sure what's next after graduation, especially with the rising cost of college. Each year, I plan to sponsor around five graduates to go through security clearance training. I'll give them internships with my firm, then offer them full-time employment. Once they turn 21, I'll help them get their armed license, starting them at a salary of \$40,000 and up.

I also mentor both young men and women, helping them figure out their path—not just in security, but in business in general. I'm a serial entrepreneur, and I help others start LLCs, get formation documents, obtain EINs, build credit, and launch their own businesses. By Chris Collins

Senator Andy Kim Holds Statewide Town Hall Focused on Impact GOP Budget Bill Would Have on Disability Community in NJ

JERSEY CITY, N.J. – This evening, Senator Andy Kim (D-NJ) held a statewide telephone town hall focused on the disability community and what the upcoming reconciliation bill will mean for their lives. More than 5,400 New Jersey residents from across the state dialed into this virtual event.

During the town hall, Senator Kim discussed how changes to Medicaid and other programs under the Republican-lead reconciliation bill would reduce access to healthcare coverage for the disability community.

Senator Kim was joined by Tom Spadaro, a Toms River based disability advocate who was instrumental in helping Ocean County's disability community receive PPE during the pandemic. He was also joined by Peg Kinsell, Policy Director for SPAN Parent Advocacy Network, and Director of the Military Family Support 360 Project at Joint Base McGuire-Dix-Lakehurst.

Each guest speaker recounted their personal experiences using Medicaid and provided details on how families and caregivers will be harmed by additional barriers for needed treatment. They emphasized how these proposed cuts and barriers would radically damage the quality of life of the roughly 200,000 New Jerseyans who rely on Medicaid for help with their disabilities. During the town hall, Senator Kim heard from constituents regarding their fears about what will happen if Medicaid is cut, and what cuts would mean overall for their access to necessary treatments, equipment, aides, and appointments. He also answered questions about ways he is supporting Federal workers during this time, the current situation in the Middle East, and how he and other Democratic Senators are working to oppose the current Republican budget bill, which threatens to cut Medicaid, SNAP, Pell Grants, and other critical fund-

Senator Kim – "[Medicaid recipients] aren't asking for the moon, but are just looking for some support; they are struggling from food insecurity, struggling when it comes to keeping the heat on, and are, again, people with disabilities, people that have challenges when it comes to be able to afford this moment right now in terms of just how many different costs they are facing. And this is just about trying to help them through these difficult times."

On Supporting the People, not the Bottom Line:

Senator Kim – "When we are talking about people on Medicaid, the vast majority of [Medicaid recipients] are employed themselves or in a household with at least one worker...this pushes back upon the idea that there's widespread fraud or 'lazy people who don't want to work'. That is not what we're talking about here. We're talking about one in every three kids in New Jersey gets healthcare through Medicaid...two million out of nine million in New Jersey are on Medicaid. So this could be really devastating to so many people."

On What the These Billion of Cuts in Medicaid Will go Towards:

Senator Kim – "This is something that could very well get 16 million people in this country to lose their healthcare, something that would have a lot of impact when it comes to food assistance, benefits, and many other aspects of people' lives.

And for what purpose? It's not about bringing the deficit down. It's not about being fiscally responsible that way, or efficiency. It's really just a transfer from those that need care the most to tax cuts for the wealthiest Americans." Senator Kim works to expand access to opportunity through education as a member of the Senate Committee on Health, Education, Labor, and Pensions (HELP). Kim also sits on the Committee on Commerce, Science, and Transportation; Committee on Banking, Housing, and Urban Affairs; Committee on Homeland Security and Governmental Affairs; and the Special Committee on Aging.

We have a network of entrepreneurs working with us who guide others into entrepreneurship. Some people bounce from job to job because they were meant to be their own boss. Once they realize that, everything starts to click. They just need help tapping into what they believe God called them to do.

Delaware State University, EHRI to host Inaugural GWEP Symposium Focused on Aging Care

DOVER, Del. – Delaware State University, in partnership with Education Health and Research International (EHRI), will host the inaugural Delaware Geriatric Workforce Enhancement Program (GWEP) Symposium on Wednesday, June 18, at the Milford Wellness Village.

Funded by a five-year, \$5 million federal grant through the Health Resources and Services Administration, the Delaware GWEP is part of a national initiative to improve care for older Americans through education, workforce development and community collaboration. Delaware State University is one of 42 academic institutions selected nationwide to lead these efforts.

"The Lifetime Achievement Award was presented in recognition of her extraordinary leadership, lifelong community impact, and unwavering dedication to improving the lives of girls and young women in underserved communities," said Karen Thomas '77, President of the Simmons University Alumnae Association. Morris's acceptance speech, in which she recounted her journey from public housing in New Jersey to the halls of Simmons, moved audience members to tears. Many described it as one of the most powerful and resonant moments of the weekend.

Classmates and attendees praised Morris not only for sharing her deeply personal story but for giving voice to a collective experience. As one alumna remarked, "It wasn't just Leslie's story — it was our story. But only she had the courage to stand in it and speak it."

In addition to being an honoree, Morris played a key role in organizing the reunion weekend — including a Boston Harbor cruise that brought together more than 30 classmates, family members, and faculty, along with a slate of memorable Class of '75 events. Her leadership and presence were felt throughout the celebration.

Simmons University's recognition of Morris reflects a broader acknowledgment of her life's mission: empowering girls not only to dream, but to believe their dreams can come true. Her impact continues to ripple across generations — from Camden, NJ, to Boston and beyond. "I was one of the girls Ms. Morris helped when I was a teen mother in Baltimore in 1983," said Lisa, now in her 50s. "Ms. Morris was a social worker in a teen pregnancy and parenting program, and I was fortunate to have her as my counselor. It was a rough time in my life, and she helped me through it. Forty-

Sasha, now a senior at Creative Arts High School in Camden, applied to and received her acceptance letter to Simmons in February 2025. Morris has always believed in the power of exposure and opportunity. "We can't expect young people to make good choices if they don't know what choices they have," she often says. Without that pivotal trip to Boston, Sasha may never have discovered Simmons, just as Morris herself might never have known about Simmons had her guidance counselor not arranged for her to meet Brenda Franklin, a Simmons recruiter who had visited her high school decades earlier.

As Sasha prepares to begin her Simmons journey this fall, Morris reflects with pride and humility. "The dream lives on," she says.

Rep. Norcross Fights to Increase Funding for Faith-Based Security Amid Antisemitic Violence

June 4, 2025

WASHINGTON, DC — Last week, Congressman Donald Norcross (NJ-01) joined 45 of his congressional colleagues in sending a letter to President Trump urging him to increase funding for faith-based security measures. Congressman Norcross has long been a supporter of this increase, and the recent violent attacks on our Jewish community have made this even more urgent. The letter was a response to the recent shooting of two Israeli Embassy staff members, Sarah Milgrim and Yaron Lischinsky, who were murdered outside the Capital Jewish Museum in Washington, D.C. last month. A few weeks after the two were murdered, another horrific attack fueled by antisemitism occurred, this time in Boulder, Colorado. Twelve people were injured.

The Non-Profit Security Grant Program (NSGP) is one of the most effective and critical programs for protecting the Jewish community and all faith-based communities from attack. There are many examples available that demonstrate the direct return on investment for communities under threat. For example, in July 2023, when an armed gunman attempted to breach the Margolin Hebrew Academy in Memphis, NSGPfunded access control doors prevented the shooter from entering the school. In 2021, when gunfire struck the Jewish Family Service building in Denver, impact-resistant window filming, purchased with NSGP funds, stopped the bullets from penetrating into the facility, protecting those inside. It is no wonder that in FY2023, for the first time in the history of the program, all 55 eligible states and territories applied. Nevertheless, only forty-three percent of applicants received funding. Therefore, we ask that you request \$500 million for the NSGP in FY2026.

As you know, the FBI has lead responsibility for federal domestic terrorism investigations and domestic intelligence efforts. Domestic terrorism investigations have more than doubled since 2020, according to the FBI. Pursuant to the National Defense Authorization Act (NDAA) for Fiscal Year 2020, the FBI and DHS, in consultation with the Director of National Intelligence, are required to report on the domestic terrorism threat in the U.S. and actions taken to combat this threat. Given the significant increase in the number of domestic terrorism investigations, we urge you to increase funding for the FBI, especially its intelligence capabilities.

Although the role of federal law enforcement agencies is critical with regards to responding to antisemitic hate crimes, local law enforcement are on the front lines when these attacks occur. It is local police departments that build relationships and trust with Jewish communities. These relationships are imperative to ensure that hate crimes do not go unreported. Nevertheless, year after year, multiple law enforcement agencies serving populations greater than 100,000, in addition to many other jurisdictions, fail to share hate crimes data with the FBI. It is impossible to address hate crimes when the FBI does not understand their extent. We urge you to increase funding for local law enforcement, including for grant programs that support state and local efforts to combat hate crimes such as the Matthew Shepard and James Byrd, Jr. Hate Crimes Program, Jabara-Heyer NO HATE Act, and the Community-based Approaches to Prevent and Address Hate Crimes Program, to ensure that antisemitic hate crimes are addressed and prosecuted in a timely manner.

Collingswood's Historic Homes: A Glimpse into Centuries Past

In the tri-state area—Collingswood, New Jersey has as rich a history as any in the region—an equally as important. Like most of the land surrounding Collinswood long before European colonization—the area was occupied by the Lenni Lenape Indians.

When Irish and English Quakers inhabited the land in the 1600s around the Cooper River—combined with the Collings family who owned parts of the region one hundred years later—Collingswood was born. In the spring of 1888—it was the New Jersey State Legislature which would make Collingswood official. Nearly 137 years later—Collingswood contains three fascinating historic homes in our area.

Even though we do know that Isaac Hollingham bought the land around what would eventually become the Stokes-Lee House in 1693—accounts vary when Isaac Hollingham II would build the house. He began that project between 1700–1717 with the construction of what would become the houses' northern end. Jacob Stokes who was a relative of Joseph Ellis by marriage—would develop the southern end of the house in 1761. Having been sold again in 1828—the home is currently not open to the public.

In the letter to President Trump, the lawmakers request \$500 million for the Non-Profit Security Grant Program (NSGP), one of the most effective programs for protecting faith-based communities from attack. They also request increased funding for the FBI to investigate acts of domestic terrorism and for programs that support state and local efforts to combat hate crimes.

Dear President Trump,

We are writing to express our concern regarding the sharp rise in threats to the Jewish community as evidenced by and following the recent murder of two Israeli Embassy staff members, Sarah Milgrim and Yaron Lischinsky, here in Washington, D.C. In 2023, there were 2,699 reported religious-motivated hate crimes, of which sixty-three percent were driven by antisemitism — the highest number ever recorded by the Federal Bureau of Investigation (FBI) since it began collecting data in 1991. At a time when hate and violence against the Jewish community is at historic levels, it is imperative that the federal government take the necessary steps to increase funding for enhanced security measures. From bollards to prevent vehicular attacks, reinforced doors to keep intruders out, to the hiring of additional security personnel, the federal government must increase funding to ensure that the Jewish community is equipped with the necessary tools to prevent loss of life in the case of an attack. We ask that you include these necessary funding increases in your Administration's FY2026 Discretionary Budget Request.

Finally, although Jewish institutions can use the NSGP to hire additional security personnel, the majority of Jewish institutions have either not been recipients of these grants or cannot afford the additional costs incurred. Given that your Administration has made clear its goal to respond to the rise in hate crimes, we urge you to explore opportunities, in cooperation with the House Appropriations Committee, to include dedicated assistance in FY2026 for faith-based organizations to hire additional security personnel. In light of recent events, it is more clear than ever that Jewish institutions are in desperate need of additional personnel support.

Thank you for your time and attention to these urgent requests as you finish drafting your FY2026 Discretionary Budget Request.

The Collins-Knight House isn't only significant as a house—but also having been built on the Newtown Colony tract—which dates from the time of William Penn. Deportation would result in a significant labor shortage, which could place increased demands on healthcare, education, and social services, putting additional pressure on local governments.

Cultural and Demographic Effects Immigrants are integral to the cultural landscape of the United States. From language and traditions to innovative ideas, immigrants have enriched American society. A mass deportation effort would significantly reduce this diversity, particularly in cities with large immigrant populations like New York, Los Angeles, and Miami.

Impact on Innovation Immigrants play a vital role in driving innovation, particularly in STEM fields. According to recent reports, 55% of U.S. startups valued at over \$1 billion were founded by immigrants. Deporting such talent would hinder creativity, stifle economic growth, and diminish America's competitiveness on the global stage.

Conclusion

The consequences of mass deportation would be far-reaching and lasting. Not only would it disrupt the U.S. economy resulting in labor shortages, reduced GDP, and lost tax revenue—but it would also have serious social, cultural, and demographic repercussions. Families would be torn apart, communities destabilized, and public services strained. Over time, America risks losing the very qualities that have made it a global leader in innovation and cultural exchange.

It is essential to recognize that these policies affect all of us—not just immigrants or people of color. We must understand the interconnectedness of our society and work toward solutions that foster unity, compassion, and progress for everyone.

Dear Community,

As I sit here reflecting, waiting for a bowl of pho, I find myself contemplating the significant changes that have taken place under the current administration. I am a Guatemalan immigrant, a former military spouse, and now a mother of two retired military children. Over the years, I've witnessed firsthand the profound impact of political decisions on immigrant and military families, and today, I feel compelled to share my thoughts on the developments we are seeing under President Trump's leadership.

Much has transpired in a relatively short amount of time, and for many of us—myself included—these changes have caused considerable disruption. The mass deportation policies enacted by this administration have torn families apart and are deeply affecting communities across the country.

I vividly remember Election Day and the shock I felt at the rhetoric being espoused by a leader whose actions and words seemed completely disconnected from the realities faced by immigrant and undocumented communities. The idea that such language could translate into policy was inconceivable at the time.

As we reflect on February 2, 2025, two weeks since Trump assumed office once again, the scope of these policies has already had a profound impact on Americans, even though many have yet to fully comprehend their significance. There is a misconception that only people of color or immigrants are affected by these policies, but I want to make it clear: regardless of your political stance, the policies being enacted by President Trump's administration will affect you as well.

Immigration and Its Importance to America's Success Whether or not you approve of immigration, we cannot overlook the fact that America was built on immigration. Our nation's diversity is what makes it unique, rich in culture, and Social Impact Deportation policies disproportionately affect families, many of whom include U.S. citizens. Over 5 million U.S. citizen children have at least one undocumented parent. The trauma and long-term psychological effects of family separations cannot be overstated. Additionally, these policies breed fear, which undermines community trust and cooperation with law enforcement—potentially jeopardizing public safety. Thank you for taking the time to read this.

Muralist Meg Saligman to launch Ministry of Awe — a sixstory immersive art experience housed within a 19th-century bank

Renowned muralist Meg Saligman has produced over 40 permanent public works worldwide, but her works in Philadelphia have been considered a catalyst for the contemporary mural movement. At IPW, Saligman revealed new details about her latest project, Ministry of Awe, opening in 2026. Housed in the former Manufacturer's National Bank in Philadelphia's Old City neighborhood, Ministry of Awe will be a traversable, living work of art, dedicated to inspiring awe. With six stories and over 8,500 square feet (nearly 750 square meters) of interactive space, including immersive exhibits, live performances, and soundscapes for visitors to explore, Ministry of Awe will be unlike any other arts destination in the region. Ministry of Awe will also function as a hub for community participation and imagination, teeming with opportunities for visitors to engage with the space in a hands-on manner, which will evolve the artwork's look and feel over time. For Saligman, the Ministry of Awe's home in the former bank, which was built in 1870 and designed by Frank Furness, is a key part of the story-redefining the conventional cultural experience by bringing the unexpected and the sublime to a seemingly mundane space. "We're creating a living, walkable piece of art that's deeply rooted in Philly's rich history, right in the birthplace of American democracy and finance." Art lovers visiting Philadelphia can also enjoy works throughout the city, both in museums and galleries and on public display in the neighborhoods. In addition to the PMA and PAFA, the Barnes Foundation, Rodin Museum, and Calder Gardens (opening September 2025) are located within steps of one another on Benjamin Franklin Parkway, ensuring that hundreds of works by Renoir, Van Gogh, Cezanne, Matisse, Picasso, and more are easily accessible.

Meanwhile, Philadelphia's Magic Gardens in South Philadelphia, the Ministry of Awe, the various walking and bus tours offered by Mural Arts Philadelphia, the hundreds of pieces of public art around the city, and the galleries dotting the neighborhoods allow visitors plenty of opportunities to connect with local and emerging artists and enjoy innovative forms of art, including immersive and interactive experiences.

In the press conference held for global travel media at U.S. Travel's IPW 2025, Sasha Suda, the George D. Widener Director and CEO of the Philadelphia Museum of Art (PMA), announced A Nation of Artists opening in April 2026, a dualvenue exhibition that will unite three extraordinary collections of American art. This collection will feature more than 1,000 unique pieces on exhibit in the Philadelphia Museum of Art, one of the largest art museums in the country, and the Pennsylvania Academy of the Fine Arts (PAFA), the first art school and museum founded in the U.S.

The collection will be carefully divided across the two institutions for display. At PAFA, the exhibition will highlight how American artists learn and develop. At the PMA, the exhibition will highlight the evolution of American identity and visual culture through art.

"What makes American art so powerful is not only where it was made, but who made it—and why," said Sasha Suda, a native of Canada. "A Nation of Artists will highlight the creative contributions of women, immigrants, Indigenous makers, self-taught artists, and academic painters alike and present a broad and vibrant picture of artistic expression that was happening across the country through both familiar icons and voices that have historically been overlooked. We couldn't be happier to partner with PAFA and the Middleton family on this once-in-a-generation exhibition and we look forward to welcoming everyone—from neighbors down the street to visitors from across the region, the country, and around the world—to be part of this celebration."

To enrich the collection, the majority owner of Philadelphia's Major League baseball team, the Phillies, John S. Middleton and his family will contribute pieces from their private art collection that have never been seen by the public. The Middleton Family Collection, one of the most significant private holdings of American art, will be integrated across both venues, promoting deeper reflection through the collaborative process. "This exhibition is for everyone—no prior knowledge of art or history required," said Middleton. "As someone who believes in the power of storytelling to connect people, I'm thrilled to partner with these two storied institutions to share the works that have brought our family so much joy and inspiration. Just like baseball, art has the power to bring people Like Philadelphia itself, both A Nation of Artists and the Ministry of Awe projects are grounded in history but reaching for higher levels of creativity and self-discovery.

Philadelphia is well-known to the world as the birthplace of American democracy, but audiences are now recognizing the city as a destination rich in history, culinary innovation, walkable outdoor spaces, and now especially, arts and culture Philadelphia is home to some of the world's finest museum collections as well as the largest collection of public and street art. Mural Arts Philadelphia, which has helped created over 4,000 street murals in the city since 1984, and the city's 1 percent for public art law have helped make access to art in Philadelphia as democratic as the ideals laid down by the founders in the city in 1776. "Art is absolutely part of who we are in Philadelphia. From the sculpture of William Penn by Alexander Milne Calder that sits atop Philadelphia City Hall, to the thousands of murals found through city neighborhoods, Philadelphia makes sure that experiencing art is part of our daily routine," said Caren. "And we're always looking for ways to bring new art into the public sphere: new museums, new murals, and new ways to experience it. Visitors are going to see that on another level in Philadelphia in 2026."
