113

BOREHOLE WELLS

113 borehole wells were drilled in Sierra Leone bringing clean water access to over 49,313 people.

1,518

HOUSEHOLDS

1,518 households have safe piped water delivered in Cambodia, impacting 6,831 people.

7,485

LIBERIANS

Over 7,485 citizens in Liberia have access to a stand-alone water system for residents and surrounding communities through the Zolupay Project and wells at ELWA Hospital.

HOPE, HEALTH, AND SUSTAINABILITY

While hospitals were closing their doors due to crippling fuel shortages in Haiti over the past year, La Gonave Wesleyan Hospital stands as a beacon of hope. Recognizing the escalating urgency of the situation, WHI initiated the construction of a PSA Oxygen Generation Plant to combat the oxygen scarcity that had gripped the nation.

Through this transformative initiative, the hospital is now a fully solar-powered facility ensuring uninterrupted and urgently needed medical care.

February 2022 was a pivotal time. Together with strategic partner, Build Health International, WHI finalized an ambitious master plan to include the following :

- A PSA Oxygen Generation Plant to secure a sustainable source of oxygen
- Increased electrical capacity to power the entire medical compound
- Expanded lab services to respond to patient needs 24/7
- Improved internet connectivity
- A fully staffed and operational blood bank
- A water supply system overhaul

In addition to meeting the medical needs of Haitians, World Hope's commitment to nurturing education and security for vulnerable children remained steadfast.

The Child Sponsorship Program, despite the adversities posed by gang violence and internal displacement, persevered in supporting partner schools. Financial assistance, educational materials, and teacher training continued to bring education to children despite the obstacles.

New classrooms were unveiled at our partner school north of Port-Au-Prince and a state-of-the-art computer lab came to life at our partner school in the city center. Plans were set in motion for a modern sanitary block and a robust water supply system for the school.

These 2022 achievements signify a substantial stride forward in our commitment to sow seeds of hope and empower positive change in the lives of Haitians. The journey continues, as we stand shoulder to shoulder with communities, forging a path toward a brighter future.

LET'S **HEAL TOGETHER** THROUGH MEDICAL AND HEALTH CARE SERVICES

14,590

PATIENTS

7,090 patients were seen at La Gonave Wesleyan Hospital and an additional 7,500 children were examined during the yearly check-up medical program.

1,692

CHILDREN WITH DISABILITIES

1,692 children living with disabilities in Sierra Leone received physiotherapy, behavioral, and/or psychosocial support and equipment through Enable the Children.

2,123

WOMEN SCREENED

2,123 women in Sierra Leone were screened for cervical cancer and 131 of these women were found positive and received thermal ablation treatment on-site.



ACHIEVEMENT THROUGH DISABILITY

The Enable the Children program focuses on providing vital support services, physiotherapy, and occupational therapy to more than 1,000 children with disabilities residing in and around Freetown, Sierra Leone.

The obstacles these children face extend beyond just physical limitations; there are deeply rooted cultural misunderstandings about disabilities, making these children some of the most vulnerable in the world.

Amidst this backdrop of adversity, Joan, a spirited 16-year-old, emerged as a shining example of resilience and achievement.

In 2022, Joan received an extraordinary invitation that would change her life. She was chosen to represent Sierra Leone at the 2022 Paralympic Games held in Tokyo, Japan. What made her journey even more inspiring was the fact that Joan had only started the sport of javelin throwing earlier that year.

As Joan set her sights on Tokyo, it was a journey fraught with uncertainties. The COVID-19 pandemic created numerous travel restrictions, casting doubts on whether Joan could participate.

But where there is determination, there is a way. After navigating the complexities of pandemic-related travel restrictions, both Joan and her mother managed to make their way to Tunisia for the African Paralympic Games. There, Joan's talents shined brightly, earning her two prestigious medals – one silver and one bronze – as she competed in various Track and Field events.

Yet, this remarkable journey was more than just a personal achievement. It was a beacon of hope for children living with disabilities in Sierra Leone. Joan's participation on the global stage was not just about winning medals but also about breaking down cultural barriers and changing perceptions.

In 2022, the ETC program continued to make a profound impact, not just in providing therapy and support but in nurturing the dreams and aspirations of children like Joan. The year was a testament to the power of determination, resilience, and support, offering a glimpse of the brighter future that lies ahead for all children with disabilities in Sierra Leone.

SURVIVORS AIDED

948 survivors were served in Cambodia, the Philippines, Liberia, and Sierra Leone through counseling, legal services, family reintegration, and more.

15,211

CHILDREN AND EDUCATORS

15,211 school children and educators were trained on trafficking prevention and response.

1,602

CHILDREN SPONSORED

1,602 children were sponsored through child sponsorships in Sierra Leone, Liberia, Philippines, Zambia, and Haiti and received a safe, quality education.

PROMOTING SURVIVOR SUPPORT

It is through collaboration with staff, partners globally, and local community members that we forge the path to fight against Sexual and Gender-Based Violence (SGBV) around the world.

We hold deep gratitude for individuals like Akara (name changed for her protection), whose unwavering commitment to ending SGBV and supporting its survivors is a beacon of hope in her community. For the past 17 years, Akara has been a pillar of strength in her role with the Commune Committee for Women and Children (CCWC) in Cambodia. Her focus lies in supporting women and children in her commune with a special emphasis on aiding survivors of violence.

Akara generously shared her story with us, shedding light on her profound work, and the invaluable support she receives from World Hope to advance anti-SGBV initiatives in Cambodia.

Before joining hands with World Hope to partake in specialized training sessions, Akara found her role immensely challenging. It seemed the cases were never-ending, and the women and children who had endured the trauma of violence were struggling to find the healing and closure they so desperately needed.

"I am a CCWC member who needed professional skills to help my people, so WHI helped me acquire the skills and techniques necessary to support women and children. I would like to request WHI to continue the project of helping women and child survivors, to keep raising awareness among villagers so they have a better understanding of SGBV and are more open to collaboration."-Akara

Her initial approach towards conflict mediation primarily involved encouraging survivors to seek legal support in cases of severe violence. However, many cases remained hidden, and Akara felt ill-equipped due to her limited skills in assisting these women and children. She noted the transformative impact of WHI's activities on her community, particularly in improving her daily work.

In 2022, WHI conducted comprehensive training sessions and provided technical support and supervision to the CCWC. Post-training, CCWC workers applied the valuable lessons they learned to their cases, receiving crucial monthly supervision to refine their skills.

Akara eagerly participated in the training sessions and continues to receive support as she assists survivors of SGBV. In cases of conflict, Akara facilitates resolution, and for serious incidents, she connects survivors with legal support.

"I think it is very helpful and good for me to have the skills that I learned with WHI for helping women and children affected by violence and abuse. After attending a short training with WHI, I learned a lot about working with clients. When women and child survivors need help, I coordinate to find other services based on their needs."

"After I learned and received some support from WHI, it helped me better understand my professional role, gain new knowledge, and identify problems and solutions more effectively. Above all, I have learned not to rush in giving advice or responding without a thorough understanding of the client's specific needs."

Akara's journey exemplifies the transformative impact that dedicated partnership, training, and support have on individuals working tirelessly to combat SGBV. In the heart of Cambodia, her story symbolizes hope and resilience, echoing the essence of our mission at World Hope International.

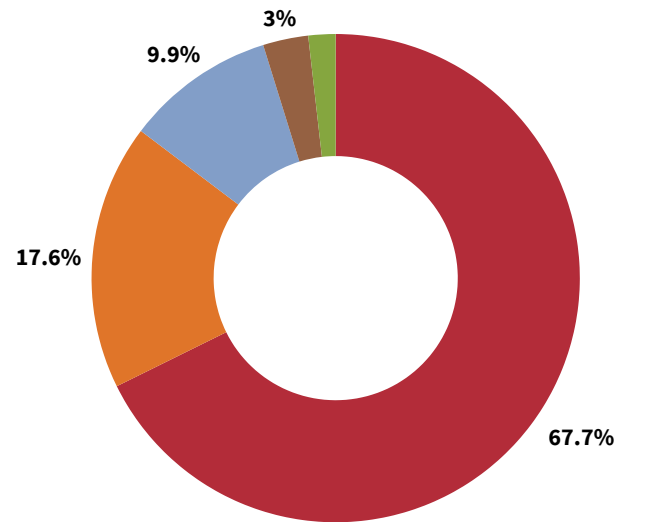

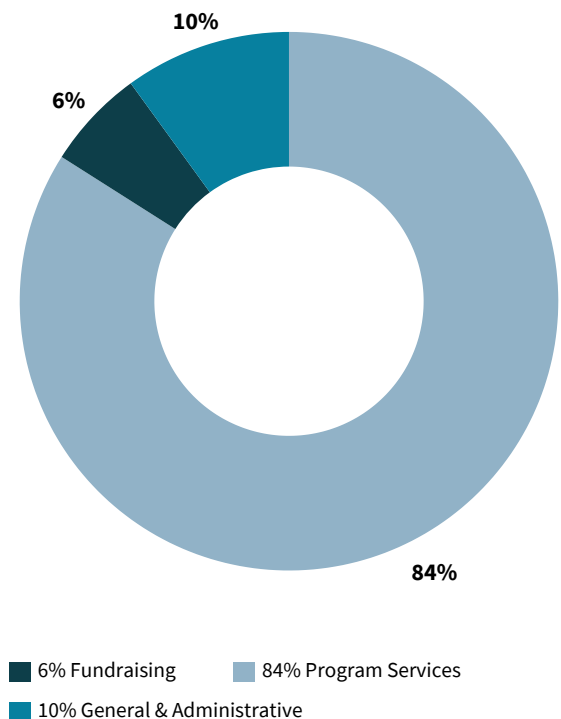
