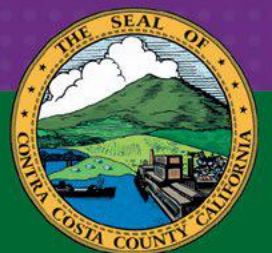

# Local Former Secret Service Reveals Agency Missteps in Trump Shooting

Eric Enos of Concord was a former Secret Service agent for 11 years. Some readers may recall his column "Tales of the Secret Service" in the Diablo Gazette from 2016 through 2018.

In his initial article to Diablo Gazette in July 2016, he writes, "It is protection that most people think of when they think of the Secret Service. For me it was by far the most interesting and unique aspect of the job and the sole reason I became a Special Agent with the Secret Service. Protection operations are extremely detailed, time consuming, and often require days and even weeks away from home."

After the shooting incident of former President Trump, traditional and social media outlets were offering conflicting versions of the incident. Will we ever know the whole story? I decided to ask Enos his assessment of the event from the perspective of his experience and training. We spoke for hours, and this is a summation of that discussion.

"I saw it on TV like everybody else. I'm just speaking from my time at the service and my training and knowledge. My first observation was that I was really impressed that the agents performed exactly the way we were trained once shots were fired. Trump goes to the ground and the agents immediately form a human shield on top of him with their bodies. I was extremely impressed with that and the speed with which it took place. The first two agents got there probably before he even made it all the way to the ground. That was exactly how we were trained.

Once they made the decision to evacuate, their job was to do just that, shield and evacuate, not fight. You have other assets that are there to eliminate the threats. In addition to the counter snipers, you have agents posted all around the stage and throughout the event, as well as other local and state law enforcement.

But the evacuation was where I saw the first breakdown of the way we train. There was a call that came out, "shooter down." Well, that's one shooter. You don't know what other danger is out there. There could be multiple shooters. But once they heard that call, they decided to evacuate to an armored suburban which should have happened immediately and swiftly. Several times, Trump's head was exposed while pumping his fist multiple times. That should never have happened. Protectees should never be exposed like that. Agents are trained to push the head down and keep it down and get him out of there shielding him with their bodies the entire way. But Protectees are also informed of those response tactics.

Was protocol not followed as far as the setup? I seriously doubt it. The largest part of work and effort that goes into a site like this, a rally, is not on the day of the event. It's all the advanced work that took place days before the event: all the determination of what assets will be needed, where they're going to be needed, where are areas of opportunity for a would-be assailant or assassin. Whether it be a physical attack with a knife rushing the stage or a shooter. All that is mitigated with the advance work. I heard they had five up to eight days for this rally, which is ample time to do the advance work correctly. Many times, during a campaign, you may only have two days to do an advance.

Generally speaking, there is a coordination of three circles of protection around the protectee. The inner circle is primarily comprised of Secret Service agents, shift agents who remain with Trump, and post standers in and around the crowd and surrounding areas.



The second ring of security is going to be comprised of agents and local law enforcement. The outer ring is primarily local and state police posted out on

the fringes of the area.

We have meetings with our agents and law enforcement at the end of every day to discuss every site and every element of the visit and to see what changes have taken place.

This is all standard for any site. Part of that advanced work is, of course, the counter sniper team. Their advance work identifies all the areas of potential opportunity for a would-be sniper, high ground, line-of-sight to the podium and to where the protectee is going to be. Everything is put on a map and on a grid.

You do not have to have a person posted on every rooftop, but you have assets on the ground making sure nobody is accessing a rooftop. So how that breakdown happened, I don't know. We won't know, I guess, officially until the FBI investigation is finished."

"He's spotted on the roof. What should have happened at that point?" I asked.

"Well, the breakdown began with him even being up there. Event goes and people outside of the main event observed a suspicious person with a range finder and gave a description to local law enforcement. Under normal communication, they are trained to pass that information on to the Secret Service command post.

The Secret Service Command post is comprised of a representative from every law enforcement entity that is part of that visit. Local police, state police, sheriffs, any military assets that may be there, as well as a fire marshal or representative for the fire department, ambulance, etcetera. Everybody that's assigned to a protective level has a representative in that command post operating on different communication frequencies, and it all comes together in the command post.

So, I guess, it's safe to assume that the Secret Service knew there was a "person of suspicion" because of this range finder. The vast majority of Secret Service events and rallies will have persons identified as possibly suspicious until it's been investigated and identified.

They get a call that there's a suspicious person in a certain area. They respond to that area and attempt to identify the person. And then they will question the person or take whatever action is deemed necessary to either confirm or debunk the suspicion. Mind you, that would not have the Secret Service prevent Trump from taking the stage. It was suspicious person, not an identified threat — enormous difference in terminology.

Now, the counter sniper teams have eyes on all those areas and you have a person on a low-level rooftop with an unobstructed line of sight to the podium and the protectee. That was definitely a failure somewhere. There is no logical or acceptable explanation for that.

It is my understanding that the threat was not identified until the time that the shooter began firing. They should have been able to see him crawling up the rooftop. That is unacceptable. That was another failure or breakdown.

I was never involved in a situation where we had an actual attack. And most



agents aren't. That is the point of all the advance work, communication systems and working with other law enforcement agencies, to gather as much intelligence as possible. And that's why this is such a rare event."

"Do you think it was the right move that the head of the department should resign?"

"Ultimately, yes, because of the way it was handled afterwards. Why the Service didn't get in front of this immediately is concerning. There was a press conference that evening and the Secret Service was not present there. That silence from the Secret Service was deafening.

It took her to testify before Congress

nine days later to start trying to get some answers, but her answers were vague.

Every site is unique, but all are fundamentally planned this way. There's just not going to be a logical or an acceptable excuse for what happened."

While Enos was never involved in an actual attack, in his column published November 2016, he recalls an incident in a Bush/Cheney rally in Fresno where agents spotted a person in a trench coat behaving suspiciously among an excited crowd of 8,000. How that ended may surprise you. I have reposted that article on our website, diablogazette.com. You will find it interesting reading.

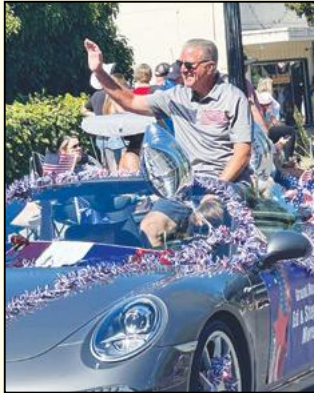
The City Council is currently deeply involved in interviewing Candidates for City Manager. This process is moving along very well, and we should have a finalist selected soon. We will keep you posted.

# Power Play Politics - No Does Not Always Mean No

In the course of city council considerations and votes, it is often thought that the vote settles things. In some cases, it does but at times, it is simply the continuation of negotiations. wherein one side of the issue at hand is making a statement to force another look at the issue. or another step to reach a desired resolution. In politics, "No" does not always mean "No."

It often means "try again," "Come back with more clarity", or "I really was not kidding when I asked for 'X'."

In Concord we recently had just a situation in which what was thought to be a slam dunk approval was shot down 4-1. Those who voted "No" had various reasons: an alleged verbal agreement was not committed in writing, a state mandates were offering conflicting guidance, review project costs to taxpayers, and so forth.

After this vote, we had seven days to submit financial filings that required a positive vote to receive millions of dollars in funding from the state to support this project. There was a noisy scramble to add in what should have been presented in the first place. The key here is that the power play by the four No votes left open the possibility of a redo. Conditions were then met and six days later, a 5-0 vote moved the project forward.

Sometimes the power play does not lead to a resolution and is simply left on the table (or the dais) because there is no apparent willingness or is simply not feasible to reconsider. Some time ago, there was a case where a committee of two councilmembers worked for six months on a proposed allocation of funds and made a stern recommendation to the full council. The Brown Act prevents any of the

other councilmembers from having a private discussion on the project with those two whose intense efforts cemented their support for their recommendation.

In the public meeting, two other councilmembers had opposite views and were intent on their positions. A compromise was presented by the third remaining councilmember to which neither side would agree. In a power play, the councilmember then suggested taking the compromise or the vote would support the original recommendation. The vote went down 3 to 2 in favor of the original recommendation and things moved on.

One of the hardest things in California politics is to make a power play to force a moderate compromise. This forces a situation where we in California oscillate between extremes.

What makes this compromise play harder to pull off repeatedly is that both extremes clobber the one in the middle. We are left with the gathering of raw power on one side or the other and little capacity for a real power play in the middle to make things work in the classic nature of politics.

# CC Library's Adult Literacy Program, Project Second Chance

Offers free, confidential basic English reading, writing, spelling and conversation instruction

Contra Costa County Library has a wealth of free resources and programs that help improve the lives of residents throughout our County. A trip to the library is no longer simply borrowing a book. Our libraries are community centers where there is something for everyone – kids on summer break can receive a free lunch and watch a movie, numerous cultural festivals, a secondary classroom where everyone can learn new skills, or where community members can learn to read.

One of the primary strategic goals of the County Library is to champion personal and community engagement in literacy, learning, and reading to enrich lives. Project Second Chance (PSC), our adult literacy program, is one program that helps achieve this goal. Founded in 1984, PSC has helped more than 6,500 community

members accomplish their personal literacy goals related to family, career, community, and self-development.

PSC provides free, confidential, one-on-one basic English reading, writing, spelling, and conversation instruction to adults who are 16 and older and are not in high school. PSC is designed for adults who read or write below a 6th-grade level in English. People from various backgrounds and age groups have joined PSC for reasons such as never having the opportunity to learn to read, self-improvement, wanting to read to their grandchildren, and overcoming dyslexia. The program allows students to set their own specific goals, such as passing the General Educational Development Exam (GED), taking the California Driver's License Exam or furthering their economic growth.

Project Second Chance provides a fulfilling learning and teaching environment. Learners and their tutor meet for 90-minute lessons, twice a week, for at least six months. The one-on-one sessions provide a comfortable atmosphere where learners have the privacy to express their reading skills without embarrassment and, over time, increase their confidence. And tutors have an opportunity to directly impact our community, develop their professional skills and work with their learner to find material that resonates. Both tutors and learners have described PSC as fun, inspirational, a cultural exchange, and a way to form friendships. It is a win for everyone who participates in the program; a true second chance.

PSC serves adults in all communities represented by the Contra Costa County Library

system and is currently looking for volunteer tutors. No teaching experience is necessary, and tutors should feel comfortable with their own English reading, writing, and spelling. PSC staff provides a comprehensive training program and ongoing support for tutors.

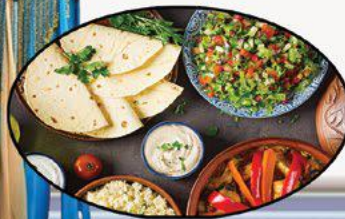

Making a meal from recipes my kids' love does not mean the adults won't like it. I look for recipes that can be made "plain" most of the way, holding back on some of the more "adult" ingredients to add later.

One of my kids does not like classic potato salad but loves baked potatoes with sour cream. Here is a potato salad recipe that uses all the favorite toppings for a baked potato. It can be served warm or cold, and the main flavor ingredients can all be served on the side.



### LOADED POTATO SALAD

#### INGREDIENTS

- 5 large rose potatoes
- 16 oz. sour cream
- 1 bunch chives
- 1 cup bacon bits
- 2 cups cheese
- Salt and pepper, to taste
- Parsley or dill, (optional) to taste

#### DIRECTIONS

Cut potatoes into small, bite size pieces. Boil in water for 10-15 minutes until very soft. Stir in remaining ingredients. Serve warm or cold.

Got a vegetarian in the group; serve the bacon bits in a small dish on the side. Another one hates onion; the onions make a great "optional" garnish.

Yield: 8 servings

Grilled sausages are the main course for this meal. They, too, are easy to adjust to suit your guests. For more adventurous eaters, Beer-Braised Sausages are moist and infused with the flavors of garlic, onion and beer. If those ingredients don't work for some of your diners, just leave those dogs out of the braise. For the non-sausage eaters, it's easy to cook a couple of standard hot dogs or even a veggie dog.

Grilled sausages and bacon-studded potatoes would be great with a meaty

Syrah. However, a hot summer night calls out for a cold beer. Summer Ale is perfect. Crisp and light, the flavors often include a citrus-y character. Not too hoppy or bitter, ales are made with malted wheat and traditional top-fermenting "ale" yeast. The head is unusually abundant due to the natural protein deposits of wheat, with a thick consistency similar to meringue. Summer Ales generally have alcohol content of 5% and are a welcome reprieve from 14% alcohol wine.

Keeping things cool at the end of the meal, pick up some sorbet or your favorite ice cream. Ice cold foods do not work with most alcoholic beverages. If your choice is fruit based, muddle orange slices with fresh basil and top with ice cold sparkling water. The flavors and temperatures will harmonize beautifully.

So, go on. Pair Up!

### BEER-BRAISED SAUSAGES

#### INGREDIENTS

- 3 beers, your choice of style
- 1/2 onion, rough chopped
- 5-6 garlic cloves, rough chopped
- 6 uncooked sausages

#### DIRECTIONS

Bring the beer, onion and garlic to a low boil. Add sausages and cook for 15-20 minutes. Finish cooking on the grill to crisp casing.

Yield: 6 servings

## Dog Agility – Is This Sport Right for You?

The sport of dog agility requires a handler to memorize a course of up to twenty obstacles and guide their off-leash dog successfully through it within a set time. There are many ways to bond with your dog, but the depth of communication between dog and handler in this team sport is unparalleled. It does require a considerable time commitment and a great deal of patience to train the dog. Owners should also decide if their fitness goals are compatible. Because the handler usually runs alongside their canine partner, it means everyone gets a workout.



The types of obstacles a dog is required to master include navigating a set of six or twelve vertical weave poles, tunnels, running up a board and tipping it to the ground and running down (the teeter), jumping through a circular ring (the tire), crossing a narrow board that stands at a height of about four feet off the ground (the dog walk), launching themselves up, over and down wide boards set up in the shape of an "A" (the A frame), plus jumping over a variety of bars held up with vertical posts. The jumps can be a single bar, a series of staggered ascending bars, or solid slats where the dog can't see the ground that lies beyond it. It is typical for a dog to have one obstacle that is more challenging than the others. My first agility dog often avoided the teeter. My current dog struggles to complete the weaves.

Because dogs are making split decisions as to what obstacle is next, handlers must be aware of their body language. For example, the dog is watching the direction of their owner's feet, looking at where the arms are pointing, or where the side of their face is directed. This body language can even be more important than a verbal command as to where the dog thinks you want them to go next. And at competition trials, the pup must listen to their handler without the incentive of food or toys.

If it sounds like a lot to learn, it is. But competing at the Canine Performance Events (CPE) Dog Agility Nationals this May with my border collie mix,

Charlie, was a highlight of my year. After completing nine runs over the three-day Nationals event, Charlie walked away with six ribbons and one fourth place metal. But even more important was the quality time I spent with my dog.

Keeping yourself and your dog safe is important, so owners should start by taking classes that teach both the handler and dog how to navigate the obstacles safely. # Candidate Nomination Period Open Through Aug. 9

Are you interested in running for City Council? In this year's general election on Nov. 5, Concord voters will elect councilmembers in districts 2 and 4. The candidate nomination period runs through 5:00 p.m., Friday, August 9.

If you are interested in running for office, watch the short video on the City's candidate-information webpage, <https://cityofconcord.org/1021/Candidate-Information>, about the four important steps you will need to take. Completed paperwork must be submitted by Friday, Aug. 9, by 5:00 p.m.

To pick up a candidate nomination packet, you must make an appointment with Concord City Clerk Joelle Fockler. To make an appointment, please call 925-671-3390 or email [cityclerk@cityofconcord.org](mailto:cityclerk@cityofconcord.org).

To be eligible to run for City Council, a candidate must be a resident of Concord and a registered voter in the District of the office sought at the time nomination papers are issued. The Treasurer is an at-large position, and candidates must be a resident of Concord and a registered voter at the time nomination papers

are issued.

The nomination packet includes the Nomination Paper, Ballot Designation Worksheet, Candidate Statement (optional), Code of Fair Campaign Practices (optional), Statement of Economic Interests Form 700, and Campaign Finance Disclosure statements. The City Clerk is a candidate's primary source of information during the nomination and election process.

The Candidate Instruction Guide provides an overview of City Government and responsibilities of an elected City Councilmember and City Treasurer. It provides detailed information related to the process of running for elective office, overviews each of the nomination documents, and provides guidance and information related to campaign reporting requirements for candidates and elected officials.

All qualified candidates for city office will be invited to a meeting on Wednesday, August 14, to review the provisions of the Concord Municipal Code for elections. Candidates will be provided a Candidate Information Binder at the meeting.

# Clayton Watch Launches Website in Time for Upcoming Election

At the Clayton City Council meeting on July 16, resident Gary Hood announced that Clayton Watch has formed a Political Action Committee (PAC) and has launched a new website, [claytonwatch.org](http://claytonwatch.org).

Clayton Watch is spearheaded by local activists Gary Hood and Bill Walcutt. The two are well known in the community for their conservative positions and their displeasure with certain members of the Council, Planning Commission and others in City Government as well as past decisions and conduct.

They are known to walk neighborhoods to distribute flyers, attend council meetings, and engage on social media platforms such as Next Door to express their position on various issues. Their opponents see them as being hateful and vindictive. As a result, hostilities have escalated.

Clayton Watch has been accused of using divisive tactics by distributing flyers containing misinformation and hit pieces; however, opposing factions have countered with their own attack including a flyer calling Hood and Walcutt puppet masters over the current City Council.

City government has been faced with high turnover in several key positions for the past few years. Is this because of the activities of Clayton Watch? You decide.

In the site's first few days, it has already exceeded 10,000 pageviews. While the site maintains a conservative narrative, anyone can research copies of past email exchanges with City personnel, news articles, Requests for Information, city budgets and audits, community activities, updates on city projects, candidate statements and much more.

# Election Security: 2-Step Verification? Try 48-Steps

Security is layered into every aspect of Contra Costa County's elections and local officials take many steps – 48 steps to be exact – to protect our vote. The Contra Costa County Elections Division guarantees election security by securing technology, processes, facilities, and people.

“Elections are more secure than ever and we're proud of Contra Costa's reputation for fair and secure elections,” says Kristin B. Connelly, Contra Costa Registrar of Voters. “We want to show voters everything we do to protect their vote.”



## Facts About Elections

1. Is the voting system or equipment connected to the internet?

No. The voting system and tabulators are never connected to the internet, they do not have modems nor hardware that could be remotely activated, all USB ports are locked and many layers of cybersecurity are in place.

2. How do election officials prevent voter fraud?

Many security measures help prevent voter fraud, including registration and signature verification. Only eligible people can register to vote and they sign under penalty of perjury that they meet eligibility requirements. Registration is validated against DMV and Social Security records and if an applicant cannot be validated, they must provide a government-issued photo identification the first time they vote.

3. Can people vote more than once?

No. Safeguards are in place so only one ballot is accepted per voter and only the first ballot received is counted. Voters sign their ballot return envelope, or when they check in at a polling place, so officials can confirm their identity, check that they are registered to vote and that they only vote once.

4. Is voting by mail secure?

Yes. Voting by mail is a highly regulated process with many checkpoints, people and systems

working together to keep it secure. Ballots are only mailed to active, registered voters and the envelopes have unique ID numbers for tracking (click to sign up). Mail-in ballot envelopes are signature verified against the voter's signature on file. If a signature is missing or not a match, voters are contacted to cure their challenged ballot status. Ballots are not counted until signatures are verified.

5. How can I trust that votes are counted correctly?

6. The voting system and equipment are tested before and after every election to ensure they are working properly and two election staff are always with ballots and voting equipment. See for yourself – all election activities are open to public observation and watched by certified election observers. Why does it take so long to count the votes?

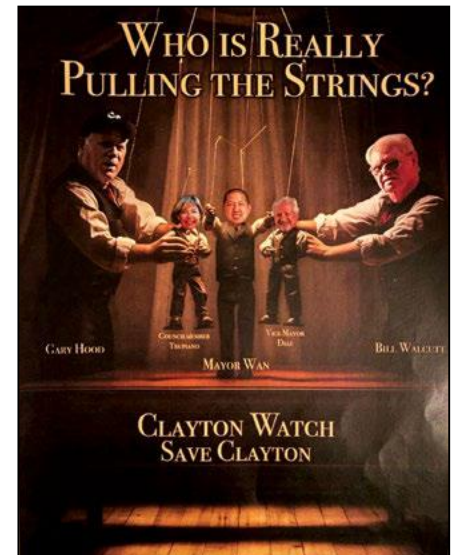
Election officials do not tabulate votes or share results until after the polls close at 8 p.m. on Election Day. Outcomes are not final until the official canvass is complete and certified, which can take up to 28 days after presidential elections. Officials ensure every eligible ballot is counted, voters only voted once, proper procedures were followed, and the voting system counted the ballots properly.

# Waterwise Gardening Tips

For dedicated gardeners, the dry summer months mean higher water bills. Wasting water is never fashionable in Contra Costa, even in abundant water years like this. How can a conscientious gardener save both money and water, especially during these dry months? Here are four tips for the waterwise gardener.

**1) Plant Choices:** Saving water begins at the garden center. Low-water-use or California native plant choices are well-labeled and easily found. Many varieties are as beautiful, or more so than traditional English garden (regular water requirements) choices. Some of my favorite landscaping plants that require little to no watering (once established) are: succulents of all types, flannel bush, narcissus and daffodils, penstemons, ceanothus, euphorbias, gazanias, mallows, California poppies, yarrows, lupines, and South-African irises.

**2) Mulching:** A 3-inch layer of mulch is the waterwise gardener's friend because it keeps soil root areas moist. Many garden centers and soil suppliers sell high-quality fir mulch. But fir mulch comes at a price to consumers and the environment. It is a by-product of tree harvesting and is trucked to the Bay Area from the Pacific Northwest, adding to its cost and increasing hydrocarbon pollution. Most local tree trimming services provide local mulch for FREE if you call them. Local tree mulch is just as "clean" and disease-free as Northwest fir mulch. However, you can request specific types of mulch when you call the trimming service (e.g., redwood versus eucalyptus). Remember though, not to mulch within 5 feet of your home for wildfire safety.

**3) Drip Irrigation:** Flexi-tubes with drip emitters, soaker hoses, or micro-sprays have been the go-to choices for waterwise gardens for 25 years.

Drip emitters provide the right water portion to the right spot around root bases of long-lived ornamentals or trees. Emitters are available in 1/2-gallon per hour (GPH) to 3 GPH water flows.

Micro-sprays focus above-ground watering to small areas of annual or vegetable plantings. 5/8" flexi-tubing runs from your water valve through your landscape to provide water to emitters, soakers, or sprayers. Avoid lines in high traffic areas as they can be pulled up or tripped over.

**4) Water Bulbs and Reused Plastic Bottles:** Commercially available glass or plastic watering bulbs are great waterwise choices for indoor plants or containerized outdoor plants. They come in a variety of sizes, volumes, and decorative shapes or colors and add an attractive element as well as preventing overwatering. Properly moist soil will stop accepting water from the bulb until the soil becomes drier through plant absorption or evaporation. Therefore, the bulb

provides consistent, correct water amounts. You can easily see when the clear glass bulb needs more water.

A less expensive alternative is to repurpose your empty plastic bottles as watering bulbs. They will need a support stick to hold them upright, then bury their opening an inch or two deep. If you are against using plastic in your all-natural garden, use a clear glass (e.g., white wine) bottle instead.

Waterwise gardening will reduce your summer water bills and save precious water for our next drought. Try it!

**Seasonal Notes:** If your veggies have been cared for till now, you will be rewarded with fabulous harvests this month. Tomatoes, squashes, beans, eggplants, cucumbers, corn, and other summer favorites should be in full production. Protect your ripening veggies from hungry rodents with 1/2" wire mesh or row cover cloth. Row cover can also protect against sunburn on hot days. Also, condition empty beds now for winter vegetables such as broccoli, cauliflower, salad greens, and sugar snap peas. Plant your seeds or seedlings after Labor Day weekend.

## Contra Costa County Unveils New Administrative Building, Plaza In Martinez

Contra Costa County unveiled its new administrative building Tuesday, July 9. The county calls it "a new cutting-edge office administration building and civic plaza located in the heart of downtown Martinez."



The new building stands on the site previously occupied by the 12-story former county building built in 1964. The site also held the old county jail, which was built in 1902.

County supervisors awarded a \$58 million construction contract to Webcor in 2021 to demolish the old building and replace it with the new three-story structure.

The new site will hold several county administrative departments, including the public defender's office, the office of racial equity and social justice, and the county sheriff's civil division.

"The new building showcases state-of-the-art architecture that harmonizes beautifully with the surrounding historic buildings, rejuvenating the public plaza," the county said in a statement.

Funding for the project came from \$45 million in bonds issued in 2021, with the rest coming from the county's general fund capital reserves.

# City in Desperate Search for New Marina Manager

The City of Martinez is looking for a new marina manager but will have to become the marina's interim manager in the meantime.

Mayor Brianne Zorn and Jill Bergman, the city's community and economic development director, say there's much set to happen at Martinez's waterfront, headed by the renovation of the city's fishing pier starting this fall and filing applications in October for a maximum \$20 million federal Environmental Protection Agency (EPA) Environmental and Climate Justice Community Change Grant that city leaders hope would jumpstart the long-awaited transformation of the Martinez waterfront and marina.

But other things, at least in the short term, are diverting people's eyes from the waterfront prize — most notably the imminent departure of the company that has managed the Martinez Marina since 2005 and the recent closure of the bait shop near the marina.

The planned August 21 loss of Almar Marina Management, which coincides with that Torrance-based marina management company being acquired by a rival company, is a "major blip" in the city's plans, Zorn said. But she insists the city is committed to a smooth transition to interim management of the marina, and, subsequently to a new management firm.

Zorn and Bergman met with concerned residents outside the Harbormaster's building, answering questions about the city's plans for the marina and waterfront.

"Our highest priority is to find funding to make the needed infrastructure improvements" at the marina," Zorn said. "That is where that \$20 million federal Environmental and Climate Justice Community Change Grant would come in.

One part of that infrastructure, Bergman said, would be a rebuilt seawall around much of the marina. That particular project, she said, figures to be a "domino piece" that, once completed, would make the marina more attractive to boaters and, hopefully, potential developers.

The city hopes one or more of those developers will help bring the Waterfront Marina Trust Land Use Plan to life. The city's plan includes an improved marina, a restaurant, expanded boat storage, an expanded skate park, a "community stage" that could host concerts and other amenities. That stage won't be the existing amphitheater, though; that will be torn down eventually.

One bit of early good news the city received a \$2.458 million grant from the U.S. Department of Housing and Urban Development to renovate the fishing pier, extending its life for an estimated 30 more years. Zorn said she hopes work will begin on that shortly and be finished by next summer.

There have been various plans for major improvements along Martinez's waterfront for two decades or more, few of which went beyond the planning stage. When asked why this series of plans is any different, Zorn said much of it boils down to City Council leadership.

# John Muir Land Trust Makes Major Acquisition Along Franklin Ridge

The John Muir Land Trust (JMLT) is poised to acquire two additional properties along the Franklin Ridge southwest of downtown Martinez.

The Martinez-based trust has raised the \$6.5 million needed to permanently protect the 134-acre Barnett Ranch and 100-acre Kenneth Gerlack Preserve as part of its Franklin Ridge Expansion, it announced in a news release. The two tracts, which the trust describes as pristine, will be added to the Franklin Ridge Wildlife and Trail Corridor, "a beautiful natural landscape...that is a vital refuge for native wildlife and a treasured recreational haven for outdoor enthusiasts."

Putting together the Franklin Ridge corridor has been a 35-year project. "The importance of adding these two new properties cannot be overstated," the trust's executive director, Linus Eukel, said in a press release.

The corridor is "home to over 20 local species, including vital predators such as mountain lions, and endangered and threatened species such as the iconic California red-legged frog," Eukel said in the release. "Here it is possible to walk in the footsteps of famed naturalist John Muir himself, who lived nearby and hiked and wrote about its delightful ravines, hilltops, plateaus, open grasslands, and



stunning panoramic views."

Funding for the Barnett and Gerlack acquisitions includes a \$2 million grant from the California Wildlife Conservation Board; \$1.23 million from the State Coastal Conservancy; \$500,000 each from two anonymous donors; \$300,000 generated by a challenge match from David and Janice Hammond of Alamo; and, "most importantly from thousands of local residents who contribute regularly to support JMLT's conservation work in Alameda and Contra Costa counties."

Said Eukel, "We are so grateful to the donors, volunteers, and to all of JMLT's generous and passionate community of supporters who came together to secure this important win in local conservation. It is ordinary people with extraordinary vision who make such achievements possible."

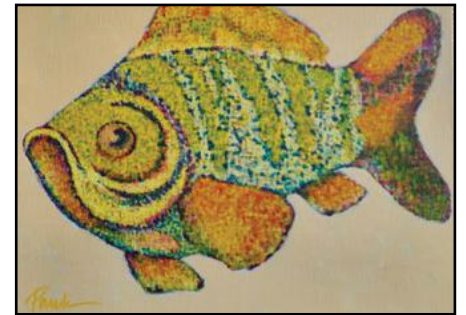

Once she alerts her daughter and son-in-law to what has happened, they take it as a sign that Thelma may be declining, and changes need to be made regarding her care. Thelma, on the other hand, is steaming mad and wants to confront the horrible people behind such a swindle.

She decides to reconnect with her friend Ben (Richard Roundtree in his final performance), who is currently in a nursing home. Originally, Thelma only wants to borrow Ben’s motorized scooter, but he quickly gets roped into her elaborate vigilante quest to find the scammers.

This is all played for laughs as we watch Thelma and her friend do their best with their limited faculties; while also proving



they are still vital and productive members of society. There is also a lot of tenderness, especially in the loving relationship between Thelma and her grandson.

At 94 years old, June Squibb proves she is up to the task of being the leading lady and carrying a film. Her comedic timing is spot-on and she commands every scene she is in. Many well-known faces also pop up in the film and all deliver the stellar acting we have come to expect from them. Parker Posey puts on her hysterical best as the worried daughter, and Malcom McDowell and Richard Roundtree deliver dynamic performances.

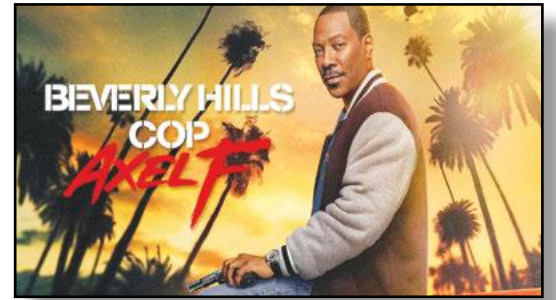
The messages about how we view the value of older citizens in today’s society resonate, and it is solidified by actors who have been around a long time and can still bring their A-game.

This time, his daughter, who is a defense attorney, is caught up in a case that involves some shady characters and possible police corruption. When this extends to the sudden disappearance of his old friend, Detective Billy Rosewood, Foley uses his rule-breaking ways to attempt to solve the case.

Murphy and Paige have a typical strained father-daughter relationship trope, but they play well off of each other and their combined talent rises above the predictable storyline.

Lovers of car chases and explosions will not be disappointed. Although this is a direct-to-Netflix film, the budget is more of a blockbuster theatrical release with no expense spared to bring full throttle action.

As for Murphy, he appears to be a member of the “Paul Rudd Never Ages Club.” He looks great and carries himself like an action hero. He has not lost his comedic touch and it is this ability that has always made these films appealing to an audience that may not usually watch action films.

While this movie may not create new fans, or offer anything fresh to the action film genre, it is a satisfying addition to the Beverly Hills Cop franchise and a fun way to spend your viewing time.

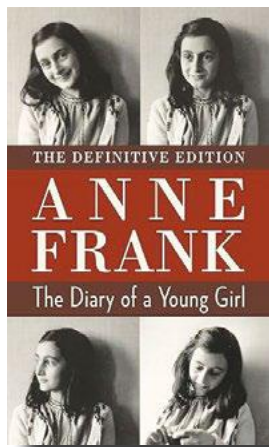


## Anne Frank: The Diary of a Young Girl

I recently reread “The Diary of a Young Girl” because of a planned visit to tour the Anne Frank House in Amsterdam. Unlike the version I read in school, the definitive edition by Anne Frank (Bantam reprint, 1997, mass market paperback, 400 pages, \$8.09) is unabridged. The book chronicles her life between June 12, 1942 and August 1, 1944, during the Nazi occupation of the Netherlands. It describes her fears, frustrations, and dreams while living in a secret upstairs annex of her father’s spice business. Anne shares the cramped space with her family, Mr. and Mrs. Van Daan and their son, Peter, and an unmarried dentist, Fritz Pfeffer.

The book is a published diary that Anne named “Kitty.” Her entries typically begin with “Dear Kitty” and read like she is sharing her intimate thoughts with a good friend. Her words are forthright, honest, and, above all, revealing. Not only does she share her private thoughts about her changing body and the hardships she endures, but her opinions about the Van Daans, her parents, the helpers that work in the office, and her roommate, Fritz Pfeffer. It is a historical documentary about the restrictions put on Jews and the consequences for them if caught.

While Anne showers her father with praise in her diary, her feelings toward her mother are



more complex. She reveals the annoyances that developed between the people crammed into the tight space. As Anne matures, a budding romance blossoms between her and the Van Daan’s son. Despite her youth, there are pearls of wisdom sprinkled throughout the book.

The tour I took of the annex in June during a visit to Amsterdam deepened my appreciation of the book. As I walked on the same stairs as Anne and tried, without success, to not make them creak, I could imagine how stressful it would be to live in fear for two years in these tight quarters. While none of the furnishings remain, Anne’s love of movie stars is still apparent on the pictures fixed on the wallpaper in her room. It was a startling reminder of how young she was and what a tragic loss to the world for this talented writer to have been taken from us.

I found reading the unabridged version was much more poignant than experiencing the content as a teenager. I highly recommend picking up this classic, even if you had read it in school.

Annelies Marie Frank (12 June 1929 to February 1945) was a German-born diarist and writer who lived in Amsterdam during the Nazi occupation. She did not live to see her dream of becoming a writer realized. Her father, Otto Frank, the only annex survivor, lobbied for its publication in 1947. It was first published in English in 1952. “The Diary of a Young Girl” has been the basis for several plays and films and has been translated into over sixty languages.

\$22,866 in liquidated damages for 14 employees.

## Exercise Less, More Often

If your exercise goals are simply to improve or maintain health and wellness, I am a huge fan of the "Do Less, More Often" philosophy. I know that I feel the best when I am able to exercise periodically throughout the day - just enough to challenge the body a little, without depleting the resources I need to adult my way through the world. This method also does not require a gym membership, a huge block of time on my calendar or even a change of clothes.

Here are some of my current favorite ways of moving: going for a quick walk, dancing with my daughter, jumping on the trampoline for a few minutes, running up and down the stairs, or lifting something heavy for a few reps. (I use my 40 lb. child, but even a gallon of milk makes an excellent kettlebell.) These can all be modified to any level of fitness. The goal is to keep moving. You should leave each "session" feeling more alert and energized for the next part of your day.

When there is time for a "workout," I love skill-building activities. Exploring new ranges of motion and trying new movements like handstands, or even coordinated efforts like throwing and catching a ball.

These are all complex multi-sensorial



movements that require use of multiple areas of the brain. Your brain thrives with novelty, and learning new things in a playful manner is usually a great pick-me-up in addition to improving strength and flexibility. It can also go a long way in injury prevention (unlike repetitive movements done with little thought or attention).

While there is merit in pushing your limits occasionally, regular exercise should not feel daunting. Our brains and bodies were designed to move, and it does not have to look like a "workout" to get the results. Movement is medicine: it needs to be taken regularly in appropriate doses.

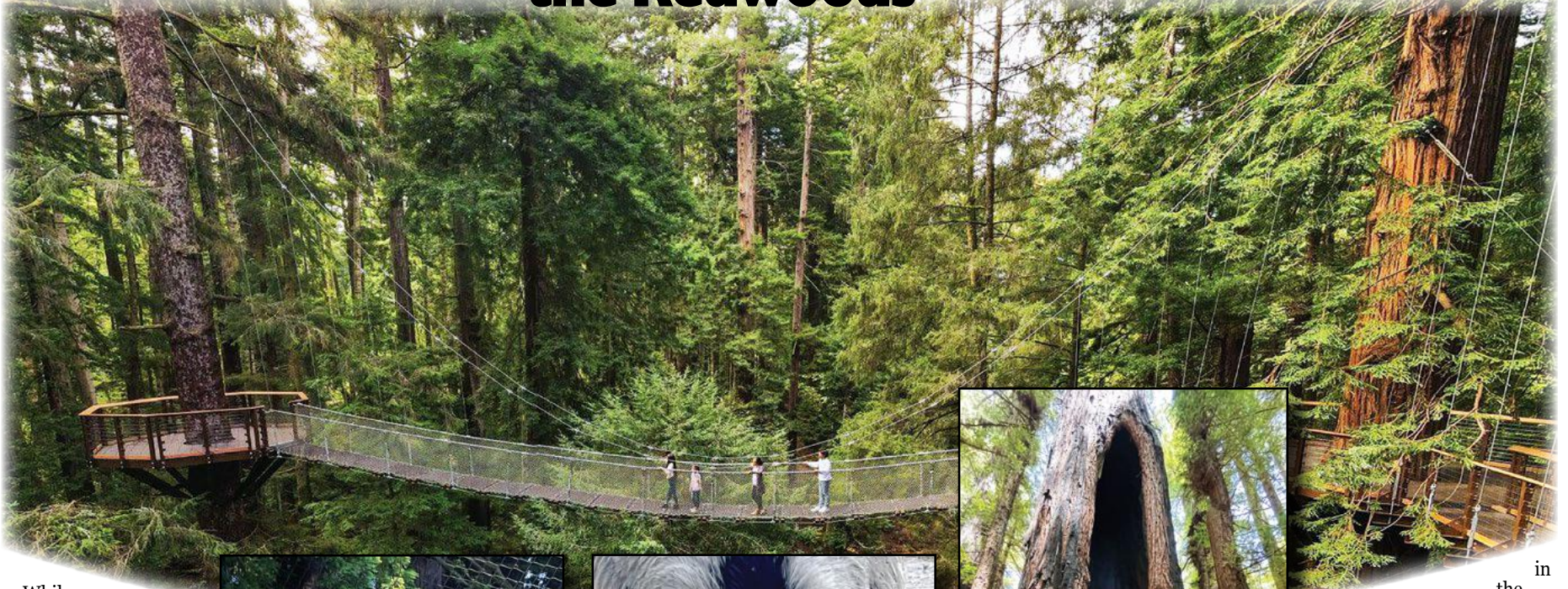

## For an Aerial Adventure, Skywalk the Redwoods



While Muir Woods National Monument in Marin is a short drive to escape the crowds and avoid transport buses, heading to the northern end of the state is an excellent alternative to view the iconic California coast redwoods.

The approximately four-hour drive to Humboldt Redwoods State Park in Weott, California, is well worth the drive. Given the distance and the number of things to see, a weekend getaway is warranted. Camping enthusiasts should consider one of the nearby campsites. parks.ca.gov/

The most impressive thing about Redwoods is their height, which gives them the distinction of being the tallest trees on earth. Some coast redwoods soar to 300 feet. The next tallest pine tree species reaches 268 feet.

The Redwoods Visitor Center is a destination in and of itself. Located just south of the town of Weott, the comprehensive exhibits include the world's first "motorhome," a unique vehicle that was a hollowed-out redwood log planted on top of a custom frame, photos and newspaper articles about the historic flood of 1964, plus interactive displays for kids, wildlife exhibits, souvenirs, and much more. Also

worthy of a quick look while in Weott is The Four Fireplaces, or the Federation Hearthstone, designed by Julia Morgan. Morgan was the first woman to receive the highest award from the American Institute of Architects, the AIA Gold Medal, posthumously in 2014.

But to really see the redwoods in a whole new way, keep driving north for another hour on Highway 101 to experience the redwood skywalk. If you make a weekend excursion out of this trip, drive the twenty-plus-mile Avenue of the Giants, which runs parallel to Highway 101. It is worth the extra time.

The Avenue of the Giants has been called the finest forest drive in the world. There are multiple hiking options along this

route and several access points to the Eel River, a federally designated Wild & Scenic Waterway, and home to an ancient creature called the Pacific lamprey. Lampreys are jawless fish that have existed since before the dinosaurs.

Pepperwood, located at the northernmost end of the Avenue of the Giants and Humboldt State Park, is also definitely worth the stop. At the Drury-Chaney Groves trail, head-height ferns flourish in the redwood understory, creating a jaw-dropping experience reminiscent of the scenery in Jurassic Park.

The redwood skywalk is a must-see for redwood enthusiasts. This attraction was voted the number one Aerial Adventure Park in the nation by USA Today Readers. The exhibit opened in 2021 and, at just under one-quarter of a mile, is the longest skywalk

in the western United States. Located in the Sequoia Park Zoo in Eureka, California, this walkway rises 100 feet into the canopy of old-growth and mature second-growth redwood trees. The bridges and platforms of the skywalk are suspended from the trees in a manner that avoids harm to the redwoods.

The adventure sections of the attraction have open mesh decking and provide a unique viewing experience.

The nine platforms offer fascinating information about the trees. Redwoods are considered conifers. They produce cones and have needle-like leaves. Redwoods can survive lightning strikes and are adapted to wildfires. They do not contain pitch or resin, and their thick bark is fire resistant. Redwoods are also one of the fastest growing trees and a single tree can produce millions of seeds in a single year. They can control its climate by condensing fog moisture into drops that rain down and soak the soil. They also help combat climate change because they absorb more carbon dioxide in their plant tissues than any other tree on the planet.

After visiting the skywalk, be sure to visit the animal exhibits. All zoo animals were either born on site or are unable to survive in the wild. Two brown bears are rescues and are a delight to watch.

Another unique feature of the zoo is an opportunity to see bush dogs, an extremely rare species. The eleven bush dogs in the United States can be found in only four facilities. These 10–15-pound scrappy animals are known to take down animals much bigger than themselves such as an 80-pound greater rhea.

The greater rhea is the largest bird species in South America. It is related to African ostriches and Australian emus. There are many types of birds on display including two beautiful bald eagles, a flock of flamingos, colorful scarlet ibis and golden pheasant. A screamer showing off her egg and an African grey parrot that says "hello" were other highlights of the animal exhibits.

Kids will enjoy the barnyard exhibit that includes guinea pigs, donkeys, miniature horses, and chickens. The Sequoia Park Zoo and redwood skywalk are open year-round and an assured enjoyable adventure for the whole family.

## Port Chicago 50 Exonerated On 80th Anniversary Of Disaster That Killed 320

On the 80th anniversary of the Port Chicago disaster, the U.S. Navy on Wednesday, July 17, exonerated the 50 African American sailors convicted of mutiny after they refused to load explosives onto ships following explosions that killed 320 men.

The Navy also exonerated the 208 men who initially refused, then went back to work loading explosives, but were convicted of disobeying orders.

“Today’s announcement marks the end of a long and arduous journey for these Black sailors and their families, who fought for a nation that denied them equal justice under law,” President Joe Biden said in a statement. “May we all remember their courage, sacrifice, and service to our nation.”

Port Chicago was at the northern tip of the former Concord Naval Weapons Station, a busy hub during World War II in the Pacific against Japan. Sailors were loading the S.S. E.A. Bryan cargo ship when unsafe conditions led to it and another ship exploding on July 17, 1944, killing 320 men — two-thirds of them African American — and wounding another 400. The explosion also destroyed a train and flattened the town of Port Chicago. The cause of the blast, which was powerful enough to be felt as far away as San Francisco, was never determined.



The dangerous task loading of weapons was done exclusively by African American sailors at the base and was supervised by white commanders, who frequently pushed sailors to work harder. The disaster accounted for about a quarter of



all African American deaths in World War II.

The 50 African American sailors were convicted of mutiny after refusing to go back to loading ammunition at nearby



Mare Island in Vallejo in the weeks after the disaster, while white commanders were granted leave.

Each of the sailors were sentenced to a dishonorable discharge, 15 years confinement with hard labor and total forfeitures of their pay.

During subsequent reviews of the general court martial, the dishonorable discharges were suspended and the period of confinement was reduced from 15 years to 17 to 29 months. The Navy said by January 1946, nearly all the sailors were released and given the opportunity to finish their contracts.

The sailors were represented during their appeal by future Supreme Court justice Thurgood Marshall, for whom the East Bay Regional Park District named its nearby still-to-be-developed park on the former Navy base.

Marshall was lead counsel for the National Association for the Advancement of Colored People.

Though all 50 were convicted and sentenced to prison, Marshall’s campaign was widely credited with President Harry Truman’s decision to end segregation in the armed forces in 1948.

“This is a monumental day for justice and for the families of the Port Chicago 50,” said Congresswoman Barbara Lee, D-Oakland. “I appreciate the Secretary of the Navy taking this crucial action to exonerate these courageous men who were unjustly court-martialed by the Navy following the explosion at Port Chicago. On the 80th anniversary of this tragic event, it’s fitting that these men are not only exonerated, but honored for their service to this country.”

## County Bar Association Task Force Influences the Navy to Act

Last year on the 79th anniversary of the Port Chicago Disaster, Jonathan Lee, Contra Costa County Bar Association’s (CCCBA) chair of the Port Chicago Task Force, sent an email to the Secretary of the Navy. He wrote, “next year on the 80th commemoration event, I hope to see you here with the announcement of full exoneration for the Port Chicago 50.”

Lee is an assistant US Attorney who volunteered to lead the Task Force in a personal capacity. Lee’s vision came true.

On July 17, Navy Secretary Carlos Del Toro, as quoted in the Washington Post, called the charges “a tremendous wrong. I have made the decision inherent within my authority dating to the laws of the time, to set aside the court-martial of all sailors convicted as part of the Port Chicago incident.”

The Port Chicago Disaster, that occurred 80 years ago on July 17, 1944, claimed the lives of 320 men and left hundreds wounded. The little town of Port Chicago was flattened and the blast registered 3.4 on the Richter scale in Berkeley.

Post-disaster, 50 men were charged with mutiny for refusing to return to work under the same hazardous conditions under which the blast occurred, resulting in guilty verdicts for each defendant. The all African American sailors, faced injustice during a time of Navy segregation and racial inequality. The shame and discrimination continued well after they served their time and returned home, robbing them of opportunities that an honorable discharge afforded other veterans.

In February 2022, the CCCBA established the Port Chicago Task Force with the goals of raising awareness of the disaster and advocating for the exoneration of the Port Chicago 50. For the last two years, the CCCBA Port Chicago Task Force led by Jonathan Lee, a member of CCCBA’s Board of Directors, has actively communicated exoneration arguments to federal, state, and local

leaders, as well as the Department of the Navy.

The Alliance and the Task Force made presentations to Bay Area elected officials Mark DeSaulnier, Barbara Lee, John Garamendi, the Contra Costa Board of Supervisors and the mayors of Albany, Antioch, Brentwood, Concord, Danville, Lafayette, Martinez, Orinda, Pittsburg, Pleasant Hill, and Walnut Creek, who all signed on with resolutions calling for exoneration.

“[This] action by the Navy cements the legacy of the Port Chicago 50 as catalysts for the modern civil rights movement,” said Jonathan Lee who chaired the Task Force and has worked tirelessly on this project. “They served with honor at a time of great peril for our nation, while facing racial discrimination in every aspect of life, including their service. As a result of their trial and convictions, and through the efforts of Thurgood Marshall and others, the armed forces were desegregated by 1948.

This has been an 80-year cry for justice, and our Task Force’s work to shine a light on this injustice that occurred in our own backyard illustrates the power of the legal community to redress injustice.”

CCCBA President David Pearson said, “Congratulations to the families of all of the men wrongfully convicted 80 years ago. The exoneration has been a long time coming. Thank you to all who worked so hard to make the exoneration a reality including the CCCBA’s own Jonathan Lee who spearheaded the Bar Association’s efforts to assist the families of the brave men.”

The Port Chicago Alliance hosted a four-day festival highlighted with the 80th Commemoration ceremony at Port Chicago where the exoneration was announced in the presence of Carlos Del Toro, the Secretary of the Navy and Sean Coffey, General Counsel.

## Exoneration Puts Port Chicago as Catalyst for National Civil Rights Movement

Did Port Chicago injustice start the national civil rights movement?

Yulie Padmore believes it did. Padmore is the executive director of Port Chicago Alliance which hosted the four-day Port Chicago Festival in July.

“I’ve been working at this for quite some time, since 2019,” Padmore says. “And by this, I mean, the exoneration of Port Chicago 50.”

On July 17, national news announced that the Secretary of the Navy exonerated the 50 plus the 208 savers that were wrongly convicted in 1944. The Navy has corrected a historical wrong.

“What this means for our nation is monumental because we can say California was the catalyst of the desegregation of the Navy and armed forces, which expanded to the workforce, school system, and folks with different heritages.”

As far as the future, Padmore firmly believes this addendum to history should be shared.

“When we’re talking about the civil rights era in the United States, we think of Montgomery bus boycott, Rosa Parks, Martin Luther King. We’re now at a point where we can talk about what was the catalyst for that.”

When we think about different museums throughout the United States, oftentimes, student educational field trips go to Washington DC. But now, we have an opportunity for a cultural center here in California and a place for folks to learn about our role in this civil rights history and how that ties in with all of the other history in America.

The city of Concord passed a proclamation proclaiming July 17th as “Port Chicago Remembrance Day.”
