

What motivated me was the flexibility and the commitment to myself—wanting more, wanting to do something different, wanting to get into the finance industry, and empowering people by helping them understand their finances. I wanted to help them open businesses and move forward despite certain challenges they may be facing.

Collins:

Now, you have been a professional in the tax industry for just shy of 20 years. Is there something you saw among small business owners or grassroots individuals wanting to establish nonprofits that pushed you to offer your services in the urban marketplace?

Alston:

Yes, definitely. The first thing that comes to mind is that many businesses are not properly incorporated from the start. Their foundation isn't solid when it comes to ensuring that their paperwork is complete. By that, I mean obtaining an IRS EIN number, making sure they are properly registered as a nonprofit in New Jersey, and ensuring they have the correct banking documents. I noticed that when it came to paperwork and the foundation of running a business, many people were unprepared. This often led to missed opportunities, such as applying for grants or contracts, because they first had to go back and complete their paperwork before even being considered.

Collins:

A lot of small business owners don't manage their back-office operations well and lack proper support. Why is it important for small business owners and nonprofits to acquire the services of someone like you?

Alston:

Small business owners, especially in the beginning, often don't have the resources to hire specific people to handle their bookkeeping or paperwork. As a result, they are unprepared and lack essential financial documents, such as a profit and loss statement, which shows whether their business is profitable or needs improvement. Because they don't have this foundation in place, a company like ATAX can be very helpful.

Collins:

For those who may be in their comfort zone, working a 9-to-5 job but searching for more and wanting to pursue opportunities outside of their comfort box, what words of advice would you give to someone who wants to become an entrepreneur?

Alston:

My advice would be: don't wait too long. Sometimes you have to make small sacrifices. If you can't leave your 9-to-5 job just yet, there's nothing wrong with starting that dream or business on the side. If you don't start, you'll never know. The key is to avoid procrastination and not feel like you can't do it. If you have an idea or want to start a business, do it as soon as possible. It doesn't mean you have to leave your 9-to-5 immediately—it may take a year or two—but you should start pursuing it now. The most liberating thing for me was becoming a full-time entrepreneur. The flexibility of running my business and working hard for myself has been incredibly rewarding.

Collins:

In your opening statement, you mentioned that education is extremely important. Education comes in many forms—some may pursue college, secondary education, or trade schools. Why is education so important in achieving your dreams?

Alston:

There are several reasons why education is important. First, I want to continue learning so I can provide the best service and most accurate information to my clients. Second, my mother was taken out of school in the second grade, and education wasn't prioritized. I want to be a role model for my family, my grandchildren, and anyone else who looks up to me. Even as an entrepreneur, I believe education is key. Knowing where you're going, how to get there, and being able to lay out a plan is fundamental to success.

Collins:

Let's get back to ATAX. You are a franchisee, and in this geographical area, I believe there are three ATAX locations. What territories are you responsible for, and where are you located? How can people get in contact with you?

Alston:

I am the franchisee for the Pennsauken ATAX at 5900 Westfield Avenue. The goal is to transition to Camden full-time.

Collins:

For those who want to contact you, what is the best number?

Alston:

The best number is (856) 668-0064. They can also email me at malston@atax.com.

Collins:

Tax season has just begun. However, you provide services year-round. What are you expecting as you enter tax season?

Alston:

We are already up and running at 6th Street and have started processing tax returns. Right now, we are focused on 2024 income tax preparation. We also assist clients who haven't filed in the past few years. We handle business tax filings, including partnership returns, S-Corp filings, and nonprofit returns. We have the resources and back-office support to manage it all.

Collins:

After the traditional tax season ends on April 15th, many tax providers shut their doors. However, your doors remain open. What would you like to say to the public when April 15th arrives and they still need services?

Alston:

We are here year-round. Our office at 111 North 6th Street will be our main location. We will be open at least three to four days a week from 11 AM to 5 PM. Just because tax season ends doesn't mean we close our doors. If you receive a letter from the IRS or have a tax-related issue, email it to us, and someone will get back to you.

Collins:

Does ATAX provide some of the services that traditional tax firms offer, such as same-day refunds?

Alston:

Yes, we do. We partner with TPG Bank, which allows us to offer refund anticipation checks. This means if you don't have the money upfront for tax preparation, the fee can be deducted from your refund. We also offer refund advances—depending on the refund amount and if you qualify, you can receive up to \$4,000 the same day, sometimes within hours.

I want to emphasize that many people procrastinate when it comes to taxes. They assume it will be a negative experience, but I always tell people to just get it done. No tax situation is too complicated to fix.

Collins:

Maritza, I want to thank you for interviewing with Anointed News Journal. We have over 180,000 weekly readers. In conclusion, what would you like to say to them?

Alston:

I am grateful for Anointed News Journal, my family, and the people who surround me and uplift me every day. I appreciate my sisters and those who have supported me on this journey.

Collins:

Maritza Alston's dedication to financial empowerment and community service continues to make a lasting impact on small businesses and individuals seeking financial stability. Through ATAX, she provides essential tax and bookkeeping services while educating her clients on the importance of financial preparedness. 






Virtua Health is Now Enrolling Patients in SPYRAL AFFIRM Clinical Study

Study investigating minimally invasive procedures for uncontrolled hypertension launches in South Jersey

Mount Holly, N.J. - Virtua Health is now enrolling patients in the global SPYRAL AFFIRM Clinical Study, which evaluates the long-term safety, efficacy, and durability of the Medtronic Symplicity Spyral™ Renal Denervation System in patients with uncontrolled hypertension and associated medical conditions. Virtua performed the state's first renal denervation procedure using the Symplicity system at its Mount Holly hospital in January 2024.

The procedure is an adjunctive treatment for patients whose hypertension (high blood pressure) cannot be sufficiently regulated through lifestyle changes and medication. About one in three adults worldwide – 1.1. billion people – have hypertension.1

Many people with hypertension have no symptoms and are possibly unaware of their compromised health. Others may experience symptoms of hypertension, such as kidney or heart dysfunction, before being appropriately diagnosed.2

"Increasing awareness is key to tackling the issue of hypertension given it is preventable, detectable, and treatable," said Virtua interventional cardiologist Kintur Sanghvi, MD, FACC, FSCCAI. "Virtua is pleased to provide the Symplicity blood pressure procedure to qualified patients and, starting now, to participate in the clinical study."

The SPYRAL AFFIRM Clinical Study will enroll up to 1,300 patients worldwide and monitor the participants for three years. Additionally, up to 100 subjects from prior SPYRAL clinical program studies will be included and followed for two more years.

Symplicity Spyral is clinically proven to help reduce high blood pressure,3-5 which can lower serious health risks.6 The procedure uses a minimally invasive technique that targets specific nerves near the kidneys that can become overactive and cause high blood pressure. After mild sedation, the doctor inserts a thin tube into the artery leading to the kidney. The doctor then administers radiofrequency energy to calm the excessive activity of the nerves connected to the kidney. The tube is removed, leaving no implant behind.

To date, Dr. Sanghvi and his team have performed the renal denervation procedure for more than a dozen patients at Virtua Health.

"I have been pleased with the improvements I've seen among my patients thus far. It has reaffirmed my belief that renal denervation represents a significant stride forward in how we mitigate hypertension," Dr. Sanghvi said. "By participating in the study, Virtua's patients will contribute to our collective understanding of how to effectively treat hypertension and change lives."

A Lifetime of High Blood Pressure

Chris Grasso, 61, of Manasquan, N.J., was diagnosed with high blood pressure in his early 20s and has been treated with medications for uncontrolled high blood pressure since his early 30s.

"My blood pressure was 210/160—totally out of control—and my medications were increased every year," he explained. "In addition, my anxiety level was extremely high because my doctors told me that I had a high risk of suffering a stroke."

When his cardiologist told Chris that medical options to treat his high blood pressure were becoming scarce, he mentioned a clinical trial assessing the treatment of uncontrolled high blood pressure with renal denervation. Chris began researching and was devastated to learn that the trial had recently closed.

His research, however, led him to Dr. Sanghvi, who explained that although Chris was a perfect candidate for the procedure, FDA approval was required before he could begin performing it. Fortunately, the timing was on Chris' side this time, and FDA approval followed shortly after that conversation. In February 2024, Chris became the second patient to undergo the Medtronic Symplicity Spyral™ renal denervation procedure at Virtua.

Because the SPYRAL AFFIRM Study is ongoing, Chris' specific blood pressure measurement cannot be shared, but he is delighted by his personal progress. Within two weeks, his blood pressure decreased and his anxiety regarding an increased risk of stroke disappeared. Over the next six months, his blood pressure continued to drop, and he feels like he truly has a new lease on life.

"This procedure was life-changing," he said. "Dr. Sanghvi saved my life."

Virtua Health Selected to Participate in Davos Alzheimer's Collaborative U.S. Fellowship Program

MARLTON, N.J. - Virtua Health is among 10 U.S. health systems selected to participate in the Davos Alzheimer's Collaborative Healthcare System Preparedness U.S. Fellowship Program. The project is led by the Davos Alzheimer's Collaborative (DAC), a pioneering worldwide initiative seeking to cure Alzheimer's disease and improve brain health.

DAC's goal is to end Alzheimer's Disease by mirroring the success of global efforts against infectious diseases such as HIV/AIDS, COVID-19, and malaria. The project is designed to support health systems in implementing early detection of cognitive impairment and Alzheimer's disease in primary care settings across the United States. The 10 participating health systems intentionally represent a diverse cross-section of healthcare delivery models, geographic regions, and patient populations.

"We are partnering with diverse healthcare systems nationwide to accelerate the adoption of early detection for cognitive impairment using the DAC Healthcare System Preparedness Blueprint. The program will produce a U.S.specific early detection Blueprint, offering evidence-based training and tools to enable health systems to implement programs quickly and sustainably, ultimately improving access to cognitive evaluation for millions of Americans," said Tim MacLeod, Ph.D., director of DAC Healthcare System Preparedness.

"Virtua recognizes the growing population of individuals 65 and older and is committed to expanding our clinical capacities and developing programs that reflect their distinct needs," said Jennifer Khelil, DO, MBA, Virtua's executive vice president and chief clinical officer. "The U.S. Fellowship Program, and the generous grant that supports our participation, will serve as a catalyst for Virtua Medical Group to offer an array of new and expanded dementia-related services for older individuals," explained Sam Weiner, MD, chief medical officer for VMG and a vice president with Virtua Health. "Virtua is grateful for this opportunity to participate in this initiative focused on improving early detection and the accurate diagnosis of our many patients living with Alzheimer's Disease."

ICYMI: NJEDA and Coriell Institute for Medical Research Announce New Innovation Center in Camden

Strategic Innovation Center will support the growth of local biotech companies and promote regional scientific and biomedical innovation

TRENTON, NJ -- The New Jersey Economic Development Authority (NJEDA) and the Coriell Institute for Medical Research announced the creation of a new Strategic Innovation Center (SIC) in Camden, leveraging the world-class assets available at Coriell to support biomedical research and innovation. The new innovation center will be fully equipped with state-of-the-art incubator and laboratory spaces for emerging biotech companies, will drive economic growth in the region and establish Camden as a leader in life sciences innovation. The project is expected to create approximately 150 new permeant jobs, plus 100 construction jobs.

"Since taking office, my Administration has been laser-focused on advancing New Jersey's innovation economy through targeted investments in our most crucial industries and sectors," said Governor Phil Murphy. "The NJ Biomedical Strategic Innovation Center is set to redefine biomedical research and development by uniting private companies, premier academic institutions, and leading entrepreneurs to pave the way for groundbreaking biomedical technologies, further cementing New Jersey's legacy of leadership in innovation and life sciences."

"Under Governor Murphy's leadership, New Jersey has made historic investments in its innovation ecosystem, empowering entrepreneurs with the resources they need to thrive, further solidifying the state's position as a global leader in innovation," said NJEDA Chief Executive Officer Tim Sullivan. By partnering with leading corporations and academic institutions, the NJ Biomedical Strategic Innovation Center will leverage the state's brightest minds to create companies of the future, generating high-quality jobs, and growing New Jersey's economy."

The NJ Biomedical SIC will encompass approximately 45,000 square feet at the Lewis L. Coriell Medical Research Center in Camden, which will be in close proximity to the headquarters of Campbell's and Subaru, building upon the city's economic strength and commitment to attracting world-class enterprises. The Coriell Institute will leverage its international reputation in biobanking and cutting-edge biomedical research to support innovative startup companies at the SIC.

The Coriell Institute for Medical Research is a leader in biomedical innovation and is home to some of the most famous biobank collections, including the National Institutes of Health's premier collections representing thousands of human diseases. Coriell scientists work to accelerate scientific discovery by generating world-class biomaterials and conducting groundbreaking research in biobanking and epigenetics.

"Coriell is thrilled to partner with Governor Murphy and the NJEDA to expand the life sciences ecosystem in southern New Jersey," said Jean-Pierre Issa, MD, President and CEO of the Coriell Institute. "Boasting attractive advantages including the opportunity to collaborate with Coriell Institute's world-class scientists, having immediate access to Coriell's world renowned biobanks, and operating in a more affordable locale, will make the CoLabs incubators a highly desir able destination for emerging biotech companies."

The SIC will host emerging biotech companies, with a focus on cancer research, epigenetics, stem cells, and drug development. The innovation center will also enter into cooperation agreements with Rutgers University, Rowan University, and other New Jersey institutions of higher education to promote academic collaboration.

Pending approval by its Board, the NJEDA intends to invest \$20 million to support the NJ Biomedical SIC. The Coriell Institute will invest over \$21 million to construct the innovation center, including lab and co-working space that will house specialized equipment and offices.

"The creation of the Strategic Innovation Center is a monumental step in strengthening Camden City's position as a center for innovation in life sciences," said State Senator Nilsa Cruz-Perez, Assemblyman William Moen, and Assemblyman William Spearman (LD-5). SICs are facilities that support research and development, innovation, and entrepreneurship through mentorship, networking opportunities, hands-on training, business support services, and education opportunities. SICs can be accelerators, incubators, or research centers. Having a physical location where entrepreneurs can collaborate will help support new, diverse innovators and help drive long-term economic growth.

Last week, the NJEDA announced it was partnering with Nokia Bell Labs to create the NJ Nokia Innovation Center and New Jersey Bell Labs Venture Studio focused on accelerating and commercializing intellectual property in the fields of communication, artificial intelligence (AI), cloud computing, and optical and wireless networks.

Governor Murphy Signs Legislation Establishing Rape Kit Tracking System

TRENTON, NJ — Governor Phil Murphy today signed S715/A908, which requires the Office of the Attorney General to establish an internet-based rape kit tracking system. The bill, which unanimously passed both the Senate and General Assembly before reaching the Governor's desk, requires the Attorney General to issue guidelines or a directive establishing a sexual assault forensic evidence (SAFE) kit tracking system accessible to the victim; State, county, or municipal law enforcement officers; and, as deemed appropriate, employees of a health care facility or laboratory.

"Survivors of sexual assault who show strength and resilience in coming forward deserve recognition and support," said Governor Murphy. "This well overdue bill cements into law the work our Administration has undertaken to support survivors. Through the groundwork laid by the Office of the Attorney General, in collaboration with the Division of Violence Intervention and Victim Assistance, the Division of Criminal Justice, and other law enforcement officials, survivors will have access to a dedicated tracking system to stay informed through every step of their pursuit of justice."

"In New Jersey, we understand the impact of sexual assault victimization and have been implementing survivor-centered, trauma-informed policies in response," said Attorney General Matthew J. Platkin. "In March 2023, we issued a Directive that expands the amount of time we retain SAFE kits and have since required all kits submitted to law enforcement with the survivors consent be brought to the lab for analysis. In 2023, LPS secured federal funding to create a sexual assault kit tracking system that will provide more transparency and autonomy to those who have been harmed. For more than a year, we have been coordinating with multiple State agencies to implement this system. We thank the Legislature and Governor Murphy for sharing these priorities."

In 2023, Attorney General Platkin announced the receipt of \$2 million in competitive federal funding to establish an advanced tracking system for the state's SAFE kits.

Later that year, Attorney General Platkin issued a statewide law enforcement directive to ensure that sexual assault survivors have access to the medical, investigative, and supportive services they need and deserve, and that evidence collected in sexual assault cases is preserved and processed in a victim-centered and efficient manner. This directive extended the required retention period for evidence, including DNA evidence, from sexual assault medical examinations from five years to 20 years; established statewide procedures and guidelines for tracking, storing, and determining how and when such evidence is submitted for testing; and mandated that all SAFE Kits provided to law enforcement with a victim's consent be submitted to the forensic laboratory for testing.

The primary sponsors of the legislation are Senator Renee Burgess and Assemblywoman Verlina Reynolds-Jackson. Other prime sponsors include Senator Paul Moriarty, Assemblywoman Michele Matsikoudis, and Assemblywoman Annette Quijano.

"This law is a critical step forward in ensuring justice and support for survivors of sexual violence. By establishing a rape kit tracking system, we are providing survivors with the transparency they deserve and holding the system accountable for its role in securing justice," said Senator Burgess. "When it comes to a rape or sexual assault, the gathering and preservation of physical evidence is of paramount importance to improving New Jersey's response to sexual assault cases and helping to restore trust in our criminal justice system."

"This legislation is a significant moment in our fight to ensure justice for survivors of sexual assault. The implementation of SAFE Kit procedures to be used in rape or sexual assault cases provides law enforcement with an invaluable tool as they conduct their investigations and also offers survivors peace of mind as they navigate a system that too often leaves them in the dark," said Senator Moriarty. "This legislation puts New Jersey solidly in line with several other states, enabling investigators to track evidence better and streamline data in pursuing justice."

"Establishing a tracking system for sexual assault forensic evidence kits is of the utmost importance, ensuring a level of transparency and healing exists within our communities," said Assemblywoman Reynolds-Jackson. "Through A908, we aim to empower victims by providing them with the ability to track the progress of their evidence, ensuring their voices are heard and their rights are protected."

"Allowing survivors of sexual assault to track their kits puts power back into their hands and provides critical transparency during the investigative process. This law acknowledges the immense courage and vulnerability of victims, as well as the deficiencies in our justice system. I am proud to sponsor a law that makes New Jersey a more just place for those who have experienced the trauma of rape and sexual assault," said Assemblywoman Matsikoudis.

Financial Focus: Time for New Year's Financial Resolutions

Now that the calendar has flipped, it's time for some New Year's resolutions. You could decide you're going to exercise more, lose weight, learn a new skill, reconnect with old friends — the possibilities are almost limitless. This year, why not add a few financial resolutions to your list?

Here are a few to consider:

Reduce your debts. It may be easier said than done, but if

For a short-term goal, you don't necessarily need to invest aggressively for growth you just want the money to be there for you when you need it.
- Review your estate plans. If you haven't already created your estate plans, you may want to do so in 2025. Of course, if you're relatively young, you might not think you need to have estate plans in place just yet, but life is unpredictable, and the future is not ours to see. If you have already drawn up estate plans, you may want to review them, especially if you've recently experienced changes in your life and family situation, such as marriage, remarriage or the addition of a new child. Because estate planning can be complex, you'll want to work with a qualified legal professional.

You may not be able to tackle all these resolutions in 2025. But by addressing as many of them as you can, you may find that, by the end of the year, you have made progress toward your goals and set yourself on a positive course for all the years to come.



Governor Murphy Unveils Proposal to Align Preschool and Child Care Facilities Standards, Bolstering State's Mixed Delivery Model

Altering Square-Footage Requirement Could Open Up Thousands of Classrooms in Child Care Centers to State-Funded Preschools

TRENTON, NJ — Governor Phil Murphy today announced a cross-agency effort spanning the New Jersey Department of Education (DOE), the New Jersey Department of Children and Families (DCF), and the New Jersey Department of Human Services (DHS) to align preschool and child care square footage requirements to a single standard. This move aims to bolster the State's mixed delivery model by addressing one of the most frequently cited barriers faced by local education and child care officials as communities across New Jersey look to establish or expand state-funded preschool and child care programs. Mixed delivery refers to serving three-to-four-year-old children in classroom settings that meet all State regulations, and are operated by a combination of school districts, Head Start programs, and private providers.

DOE and DCF have begun the process of amending their respective rules to hold state-funded and licensed child care centers and preschool programs to the same minimum space requirement of 42 square feet of usable space per child. The Administration intends to formally publish the rulemaking proposal for public comment in spring 2025.

The proposed rule change is backed by national research on best practices in classroom space per preschool child. The National Resource Center for Health and Safety in Child Care and Early Education and the American Academy of Pediatrics recommend preschool classroom square footage should range between 42 to 54 square feet per preschool child.

"Our mixed delivery model has played a key role in our rapid expansion of preschool seats. By working together, school districts, Head Start administrators, and licensed private providers are able to better meet the diverse needs of our communities. We know that access to local, high-quality preschool and child care options is crucial for New Jersey families. Not only do these services ease financial burdens on working parents, they also help our young children start to develop social skills and an educational foundation that will aid them throughout their academic careers," said Governor Murphy. "Aligning standards makes preschool expansion accessible across the early childcare industry, helps futureproof the state's early childhood ecosystem, and represents another step we're taking to keep New Jersey as the best place to raise a family."

Currently, State regulations for child care facilities licensed by DCF require 35 square feet of usable space per child. DOE's current standard requires a minimum of 950 square feet per classroom. This misalignment can limit opportunities for communities to partner with Head Start programs or private providers in order to offer preschool services through "We've listened to the calls of local school leaders, licensed providers, and Head Start administrators who have voiced that state regulations on classroom size are limiting in creating and expanding access to high-quality preschool programs," said Kevin Dehmer, Commissioner of the New Jersey Department of Education. "Our goal is to work in partnership with local school officials to address these concerns head-on, helping them bring this valuable educational benefit

to families in their communities."

"At DCF, we recognize that New Jersey needs both a thriving child care industry, and accessible, high-quality pre-K," said Christine Norbut Beyer, Commissioner of the New Jersey Department of Children and Families. "This plan allows comparable, research-based space requirements so that, whether your child is served by one of our state's licensed child care centers, or in a pre-K classroom, they'll have the same room to grow and learn. It also respects existing child care facilities by grandfathering them in at the space requirement that was in place when they became licensed. By giving parents more options through comparably regulated child care and pre-K facilities, we're supporting New Jersey's working families and setting children on a path to lifelong learning."

"Affordable, high-quality child care is essential to the state's economic health and crucial for New Jersey families to thrive. This proposed rule will expand access to care through the ability of more private providers to partner with local school districts under the State's Pre-School Program," said Sarah M. Adelman, Commissioner of the New Jersey Department of Human Services. "The change to the classroom space requirement is a perfect example of how state agencies can work together to adjust to the changing landscape of care for our three- and four-year-old children. Parents will now have more choices when considering where their children play, learn, and grow during this crucial developmental period."

DOE's amended square footage regulations will apply to school districts that received preschool education aid (PEA) in August 2017 or thereafter, and to all classrooms relocating to a space not previously occupied for use as a school or child care facility. PEA classrooms will still be held to a class size limit of 15 students. Schools will be able to use smaller rooms to serve fewer than 15 children per classroom, if they find it is advantageous to do so and if they still meet the 42 square foot per-child requirement. The proposal will also allow PEA funding for preschool classrooms without toilet rooms, provided the toilet room is located on the same floor as the classroom, designated for use only by preschool students, and that the district provides direct supervision of preschool students. The Department's revised standard will not include square footage requirements for storage, equipment, or furnishings that are built-in or not easily movable.

Altering the State's square-footage requirements could open up thousands of classrooms in child care centers to statefunded preschools.

DCF's amended regulations will increase the minimum indoor space requirements from 35 to 42 square feet of usable activity indoor floor space. Licensed child care facilities that meet the existing 35-square-foot requirement will be grandfathered into the new regulation.

Rep. Norcross Votes No on Republican Medicaid Cuts

February 26, 2025

WASHINGTON, DC—Today, Representative Donald Norcross (NJ-01) voted no on House Republicans' budget plan to direct Congress to slash government programs that Americans use to access healthcare, food, childcare, and more, including a minimum of \$880 billion in cuts to Medicaid, so that they can afford to give the wealthy tax cuts. The budget would give the wealthiest Americans and big corporations \$4.5 trillion in tax cuts while leaving everyone else behind.

"Trump and his Republican hacks in Congress are trying to take away Medicaid and basic healthcare from millions of



Americans, including children and seniors," said Congressman Donald Norcross. "This isn't political theater; this is really happening. Thirty-seven percent of the federal funding that New Jersey receives is through Medicaid. Cutting this funding hurts families that depend on Medicaid, will decimate our state's budget, and force healthcare providers to raise costs for everyone to make up for the increase in uncompensated care they have to provide to uninsured people." Some of the biggest cuts proposed by Republicans in the budget resolution would be to Medicaid, the Affordable Care Act, and the Supplemental Nutrition Assistance Program (SNAP). 72 million Americans receive healthcare through Medicaid which covers everything from childbirth to nursing home care. The Affordable Care Act delivers lower healthcare prices and expands coverage to tens of millions of Americans, and SNAP helps provide food to over 40 million children, seniors, veterans, and working parents.

Impact of Republican Budget Cuts on NJ-01:

- 164,843 people on Medicaid are at risk of losing their healthcare Including 68,724 children and 16,000 seniors
- 97,000 people count on SNAP to put food on the table
- 28,000 people who receive coverage under the Affordable Care Act could see their average premium go up by \$1,440 per year — a 62% increase
- Many families would face even steeper consequences.
- Example of the impact cuts to the Affordable Care Act could have: A 60-year-old couple with a household income of \$85,000 in NJ-01 would see their health insurance costs increase by \$15,702 per year — a 217% increase in premiums.

Norcross, Horsford Reintroduce Tipped Income Protection and Support (TIPS) Act February 13, 2025

WASHINGTON, DC— Today, Representatives Donald Norcross (NJ-01) and Steven Horsford (NV-04) reintroduced the Tipped Income Protection and Support (TIPS) Act to eliminate the subminimum wage for tipped workers across the United States and end the income tax on tips these workers receive.

"Far too many workers across the United States are struggling to put food on the table and provide for their families. By eliminating the subminimum wage and taxes on tips, we can put more money into the pockets of tipped workers," said Congressman Donald Norcross. "While there's still more work to be done when it comes to increasing the federal minimum wage, this legislation marks a pivotal step in the right direction toward ensuring tipped workers get a fair day's pay for a hard day's work."

"A tip is a gift, not a guarantee, and it's beyond time that we recognize that in our tax code," said Congressman Steven Horsford. "Adding insult to injury, many tipped service workers across the country earn a paltry \$2.13 per hour with employers counting on tips to make up the difference and ensure a dignified wage. Nevada is helping to lead the nation in eliminating this inhumane subminimum wage, and my TIPS Act would make dignified wages the law across the United States."



QUALIFICATIONS

Lead-based paint in buildings poses serious health risks, particularly for children who may ingest paint chips or inhale lead-contaminated dust. The New Jersey Lead Remediation and Abatement program (LRAP), funded by a \$180 million. federal grant, aims to address this issue by supporting the removal of lead-based hazards from low- to moderate-income households.

Households with incomes at or below 80% of the area median income for the County in which the municipality is situated, residing in one to four family residential properties constructed prior to 1978, are eligible.

HOSING QUALIFICATIONS

The property must meet the following qualifications: Property was built prior to 1978, has lead-based paint hazards, contains no more than 4 residential units and is free from structural issues.

TO APPLY

To apply for the GRANT, we require your property details, Household Member details, Income information by household member and Proof of Residency (lease agreement, NJ icense, utility bill)

STEPS YOU CAN TAKE TO REDUCE YOUR POTENTIAL EXPOSURE TO LEAD IN DRINKING WATER

We test and monitor for a wide range of contaminants, including lead. While these tests indicate that lead is not an issue in the treated water leaving our facilities, lead levels might be detected at some properties if lead exists in the service line or internal plumbing. You cannot see, smell or taste lead, and boiling water will not remove lead. Here are steps you can take to reduce your potential exposure if lead exists in your home plumbing.

- 1. Flush your taps. If the water in your faucet has gone unused for more than 6 hours, flush the tap with cold water for 30 seconds to 2 minutes before drinking or using it to cook.
- 2. Use cold water for drinking and cooking. Hot water has the potential to contain more lead than cold water. If hot water is needed for cooking, heat cold water on the stove or in the microwave.
- 3. Routinely remove and clean all faucet aerators.
- Check to see if your interior plumbing or faucets contain lead and replace any that do. Look for the "Lead Free" label when replacing or installing plumbing fixtures.
- 5. Follow manufacturer's instructions for replacing water filters in household appliances, such as refrigerators and ice makers, as well as home water treatment units and pitchers. Look for NSF 53 certified filters.
- 6. Flush after plumbing changes. Changes to your service line, meter, or interior plumbing may result in sediment, possibly containing. lead, in your water supply. Remove the aerator from each faucet and run the water for 3 to 5 minutes.
