

- 3. Catering costs are arranged direct with the Marae, and will be notified on the hire quote and invoice.
- 4. Full hire costs must be settled no later than 10 days prior to arrival.
- 5. A compulsory Bond of \$ 200, <u>MUST</u> be paid to confirm booking by the invoice due date.
- 6. The marae Trustees reserve the right to adjust hire rates as needed based on circumstances. Any changes will be communicated to hirers in a timely manner.




















Process to raise concerns
