The Government of the Turks and Caicos Islands has released the draft Bail Bill 2025 for public review and feedback, describing the legislation as a critical step in reforming and modernizing the country's bail system

The proposal comes at a time when rising violent crime has placed renewed attention on bail laws, with police lamenting cases in which offenders accused of serious crimes have managed to secure release pending trial. Officials say the new bill is intended to balance the constitutional rights of accused persons with the need to protect the public and maintain confidence in the justice system.

According to the Government, the draft Bail Bill 2025 will serve as a single, comprehensive statute governing all aspects of bail in criminal proceedings. By consolidating existing bail-related laws into one framework, the Bill aims to eliminate inconsistencies, provide clarity, and ensure that decision-making on bail is fair, transparent, and predictable.

Among its key provisions, the Bill:

- Brings together all bail laws under one statute;
- Safeguards constitutional protections for individual liberty;
- Establishes clear and uniform rules for granting or refusing bail;
- Applies consistently across all levels of the court system;
- Sets out procedures for dealing with breaches of bail conditions. The Government noted that bail decisions can often be contentious, particularly in cases involving violent crime, repeat offenders, or threats to community safety. By setting out consistent rules, officials hope to reduce uncertainty for the judiciary, law enforcement, and the public at large.

In announcing the consultation, the Government highlighted that the reform is designed not only to protect the rights of accused individuals but also to ensure that communities remain safe while cases are before the courts

"This Bill provides a modern legal framework that will improve predict-

ability in the justice process while strengthening transparency in bail decisions," a Government statement said. "It also ensures that the constitutional rights of individuals are respected, even as we work to address public concerns about safety and violent crime."

Police officials have in recent months expressed frustration at instances where individuals charged with serious offences, including violent crimes, were able to obtain bail. Law enforcement leaders argue that this sometimes places communities at risk, undermines their efforts to combat crime, and can erode public confidence in the system.

The Bail Bill 2025, therefore, represents an attempt to strike a careful balance between individual freedoms and collective security. Officials say the legislation reflects international best practices while also being tailored to the needs and realities of the Turks and Caicos Islands. The Government is inviting all members of the public to participate in the consultation process. The draft Bail Bill 2025 has been published on the Attorney General's Chambers website and is open for review. Citizens, stakeholders, and interest

The consultation period runs from 13th August 2025 to 27th August 2025, after which the feedback will be reviewed and considered before the Bill is finalized for presentation to the House of Assembly.

Authorities stress that public participation is vital in shaping the final law, which will have lasting implications for both the justice system and community safety.

## September 1 Deadline to Replace Pallet Garbage Holders

The Environmental Health Department (EHD) is reminding residents and businesses that the use of pallet garbage storage is no longer an acceptable method of waste containment.

All individuals and establishments have 30 days to dismantle pallet garbage holders and replace them with safe, durable storage solutions. Acceptable alternatives include:

- Secure garbage bins with tight-fitting lids
- Concrete garbage houses or

enclosures

The Department warns that pallet-based storage poses serious environmental and public health risks, such as:

- Attracting rodents, stray animals, and insects
- Loose waste dispersal during wind and rain
- Unsanitary conditions caused by leakage, spillage, and improper containment
- Compliance Deadline: September 1, 2025

After this date, properties found using pallet garbage storage may face warnings, fines, or enforcement actions under the Public and Environmental Health Ordinance, Section 8.49.

This law empowers health officers to require property owners or occupiers to provide suitable receptacles for waste at their own expense. Penalties for non-compliance include:

• \$100 fine for residential premises

• \$500 fine for commercial premises

It is a defence to prove that compliant receptacles were unavailable on the Islands at the time of the offence

The EHD is urging residents to act now, emphasizing that proper waste storage is essential to keeping communities clean, safe, and healthy. For guidance on compliant garbage storage solutions, contact the Environmental Health Department at: 338-2142 / 2143; EHD@gov.tc.

## THE DEPARTMENT OF GENDER AFFAIRS LEADS CRITICAL TRAINING ON DOMESTIC VIOLENCE ORDINANCE AND MENTAL HEALTH RESPONSE

The Department of Gender Affairs within the Ministry of Home Affairs, Religious Affairs and Transportation successfully hosted a comprehensive two-day Multi-Sector Stakeholders Training on the Domestic Violence Ordinance and Mental Health Response, held July 10-11 at the Atrium Conference Room in Providenciales.

This all-encompassing initiative brought together key stakeholders from various sectors, including law enforcement, healthcare providers, social workers, and community leaders, to deepen their understanding of the Domestic Violence Ordinance and the critical role they play in addressing the mental health impacts associated with domestic violence. The event also focused on strengthening governance, justice, security, and social welfare frameworks addressing gender-based violence in the Turks and Caicos Islands.

This important training session aimed to support and advance the implementation of the National Domestic Violence Ordinance while addressing the mental health consequences tied to domestic abuse. Participants included representatives from the Royal Turks and Caicos Islands Police Force, the Ministry of Border Force, TCI Red Cross, Inter-Health Canada, the Department of Social Development, the Ministry of Education, the Human Rights Commissioner, and the Department of Behavioural Health Services.

The first day was facilitated by the Grace Bay Medical Centre team, led by Medical Director Dr. Sam Slattery and psychologist Ms. Daniela Hernandez. The session covered a range of topics, including trauma and emotional dysregulation, the physical effects of trauma, brain function impact from abuse, stress management in high-pressure environments, and self-care strategies for professionals working with survivors. Day two was presented by the Attorney General's Chambers with Chief Parliamentary Counsel Dr. Gogontle K. Gatang-McCartney providing an in-depth review of the Domestic Violence Ordinance.

Honourable Shaun Malcolm, Minister of Home Affairs, Religious Affairs, and Transportation, praised the training during his opening remarks, emphasizing the unwavering commitment of the government to tackling domestic violence and supporting victims. He further stated that "Addressing domestic violence and its far-reaching consequences on mental health is a top priority for the government." This reassurance from the government's highest levels underscores the seriousness with which this issue is being addressed.

Mrs. Carolyn Dickenson, Director of Gender Affairs, highlighted the session's significance, stating, "This training is vital to equipping frontline workers with the knowledge and tools they need to support survivors and uphold the National Domestic Violence Ordinance effectively. ## High-Powered Weapon, Bullets Seized

The Royal Turks and Caicos Islands Police Force (RT&CIPF) has taken another step in its crackdown on illegal weapons, successfully recovering a high-powered rifle, 255 rounds of assorted ammunition, and weapon accessories during a targeted operation in Blue Hills, Providenciales.

According to police, the operation was carried out on August 22, following intelligence that led officers from the Tactical Unit and Criminal Investigations Division to conduct extensive searches in an open area of the Blue Hills community.

High-powered weapons have been featured in a number of murders in recent time, including the mass shooting at a popular hookah night spot along the Leeward Highway on that island, where at least three persons were gunned downed a many several others injured.

The seizure marks a significant interception in the Force's ongoing efforts to reduce gun-related crime across the islands.

The Royal Turks and Caicos Islands Police Force said no arrests were made during the operation, declaring that investigations remained ongoing. The force said it would not relent until those seeking to create mayhem are brought to justice. As a result, the Governor's Office has okayed six-day nighttime curfew in the community of five cays, which began on Wednesday, August 22.

Five Cays Curfew

The curfew, which came into effect at 7:00 p.m. on Wednesday, will remain in force until 5:00 a.m. on Tuesday, August 26, 2025. During this period, residents of Five Cays are required to remain indoors from 7:00 p.m. to 5:00 a.m. daily, except in cases of essential travel to and from work, medical emergencies, or other circumstances specifically authorized by the police ground commander.

All businesses within the designated area, including shops and bars, must close by 6:00 p.m. for the duration of the curfew. Individuals moving around within the restricted zone will be required to carry identification at all times.

The curfew order, published in the Government Gazette as Legal Notice 33 of 2025, is the third of its kind issued under the Disaster Management Act this year. However, unlike earlier orders, this action follows a recent amendment to the Disaster Management Act, passed by the

House of Assembly, which grants the Royal Turks and Caicos Islands Police Force new powers to declare areas plagued by criminal activity as "disaster zones." With the approval of the Governor, such declarations enable swift enforcement of curfews and other emergency restrictions aimed at restoring law and order.

In her notice, Governor Daniel-Selvaratnam cited threats to national security in Five Cays, linked to escalating gang violence and organized crime. She stated that the declaration was necessary "to prevent or minimise loss of human life, illness or injury to humans, property loss or damage to the environment, and to restrict access to the area."

The geographic boundaries of the disaster zone were clearly set out in the Gazette, covering the Five Cays Roundabout, Five Cays Junction, South Dock, and Five Cays Beach.

Five Cays, long identified as an area with entrenched gang activity, has in recent months been the scene of violent clashes that have alarmed residents and prompted calls for stronger intervention.

About a week and a half ago, the community was plunged into mourning and fear after a woman was brutally murdered by unknown gunmen. The

police have not established a motive for the killing.

Law enforcement officials say the new powers under the Act will allow them to respond more decisively to security threats, particularly in neighborhoods most affected by organized crime. The Governor has urged full cooperation from residents and business owners, stressing that the restrictions are temporary but necessary to stabilize the situation.

Community reaction to the announcement has been mixed. While many residents welcome the stronger police presence and measures designed to improve safety, some have expressed concern about the social and economic impact of nightly curfews, particularly on small businesses that rely on evening trade and entertainment.

The Opposition has previously warned that extraordinary powers must be exercised with accountability and transparency, to avoid infringing on civil liberties. However, government officials maintain that the legislation strikes the right balance between public safety and the protection of rights, pointing to the fact that the curfew is limited in scope and duration.

## Al is here to stay

Any new innovation that can affect our lives in revolutionary ways is often met with a great deal of scepticism and, to some extent, fear.

When the Internet was born there were those who prophesied the end of human civilisation as we know it. Those of a more religious and superstitious disposition saw it as the end of the world. Even today, Bill Gates, who can be considered as the premier architect and innovator of placing the Internet within the grasp of any human being that would want to own a personal computer, is today ridiculed and vilified by certain conspiracy theorists who view him as an evil to mankind. His perceived role in the creation of COVID-19 vaccines is the butt of conspiracy theorists to

These reactions are, understandably, at the extreme ends of ignorant reactions to innovation. They nonetheless underscore the suspicions and scepticisms that lurk in the minds of people, even some you would consider intelligent, with regard to developments that can have far-reaching consequences for all of us living on this planet.

For some, artificial intelligence (AI) is the latest threat to humanity. Out of ignorance we often say the most outrageous things about subjects that we know nothing about. Instead of educating themselves on these subjects, the tendency of far too many people is to go with the crowd, which often ends up in a pit of deeper ignorance, if not arrogance.

I have seen over the years that people with religious dispositions tend to be the ones who become more arrogant in their assertions about what they do not know. They believe that their belief in God gives them a divine right to be right at all times and they have to defend God — as if he needs a lawyer.

Like all new innovations, AI has to be carefully investigated and properly curated to meet the needs of humankind. Even the creators themselves gawk at its awesome possibilities, both for ill and good.

My concern is that the development is going at a speed which hardly allows any regulation or guardrails to be put in place to ensure the technology really works well for the betterment of humanity. The major world powers, like the United States and China, seem to be in a desperate hurry to outdo each other in deploying this technology.

What is not being talked about is how to regulate it so that its worst excesses can be mitigated and we do not create a Frankenstinian which no one can control.



It is believed by some creators that generative AI, which not only analyses data but creates new content, ought to be subject to greater transparency than is now the case. Generative AI does not just mimic and collate existing data, but actively creates its own data. And there's the rub. Data can be manipulated for evil ends to spread misinformation and create deepfakes of people's identity. It may also pose security risks and promote cyber warfare. There is the need for transparency and regulation to mitigate these concerns.

To the best of my knowledge there is not a great deal of thinking, much less action, taking place in this regard. The poor relationship between the United States and China, exacerbated by their tariff wars, serve as a grave distraction which does not provide any room for consultation on these matters. Might is right, so each side proceeds with its own agenda oblivious of the danger before them and the world.

This is particularly true of the United States under President Donald Trump, who believes that what he says is gospel. At a time when we need well-thought-out approaches to serious problems, such as setting up guardrails for AI technology, we have someone in the White House whose impulsivity and transactional approach to grave problems can only be an impediment to the prog-

ress we seek.

This is where AI technology gives me concern. No one has to be worried about the good that the technology can provide in the revolution in medicine and so many areas of human endeavour. It is just a tool to be used judiciously. My preferred tool is Microsoft's copilot. Before I tuned into AI in any serious way, I was concerned about what it could do to human creativity and morality in student research and outcomes. Should one outsource one's brain to a machine? But, for me, the experience so far has been illuminating and wonderfully liberating. By putting my copilot to work I can instantly have more data and information in a few seconds than I would have using Bing, Google, or any other search engine. With its assistance and it is still an it — you are able to collate and synthesise material in a way that is time-saving, leading to greater productivity on your part.

greater productivity on your part. If you lose touch with your creativity, it is because you want to cheat by relying on the machine to do your work for you. One has to approach AI with a sense of personal integrity. Approaching AI with a strong moral sense is to me the best guarantee of good outcomes in using the technology. The key is to use the information provided to enhance your own thinking and creativity. Again, it is what you do with the tool at your

disposal

Of one thing I am sure: AI is here to stay. Properly regulated, it can be a boon to humankind. And, contrary to religious dogmatism, it is not a signal that the world is coming to an end anytime soon.

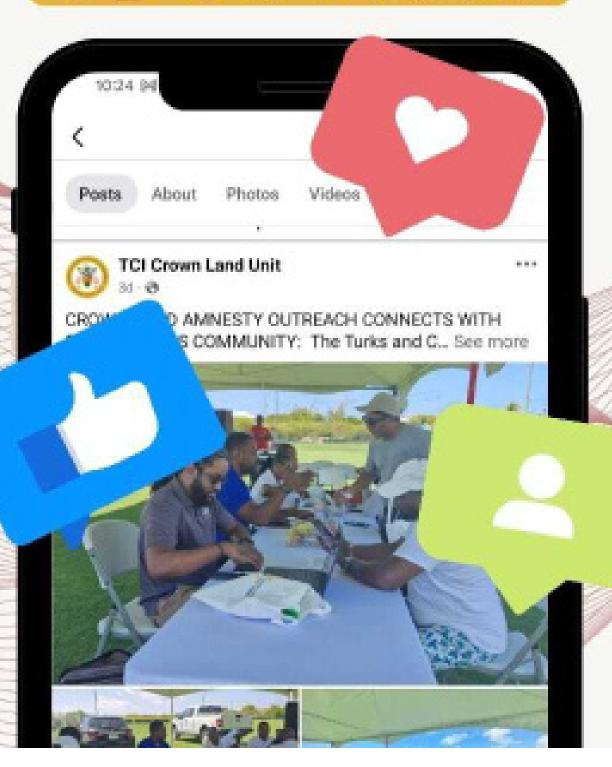

## ISU Says La Tortue Demolition Is Largest Land Reclamation in Turks and Caicos

The Informal Settlements Unit (ISU) has confirmed that last week's demolition at La Tortue, Blue Hills, was the largest land reclamation exercise ever carried out in the Turks and Caicos Islands.

Over a three-day operation that ended on August 10, a multiagency team cleared 218 unauthorized structures from land registered to a private owner (Block and Parcel 60509/1). The exercise was led by the ISU in support of the Planning Department and was initiated at the request of the Royal Turks and Caicos Islands Police Force (RTCIPF) in the interest of public safety.

Heavy equipment operators secured the perimeter on the first day, before moving on to full clearance and accessibility improvements over the following two days. The operation was completed without major incident.

The ISU worked alongside the Crown Land Unit, RTCIPF, Border Force Department and the TCI Regiment in what officials describe as a coordinated effort to enforce lawful land management.

"The La Tortue reclamation represents a milestone in our commitment to ensuring that enforcement actions are carried out

efficiently, lawfully, and in the public interest," the ISU said in a statement.

Authorities emphasized that the clearance is part of ongoing efforts to address informal settlements

across the islands and safeguard both land rights and community safety.

## Audaciously Different

#### A Message to Young People Who Feel Like They Don't Belong

At 15 years old, I moved to a brandnew country. A country I'd only visited once, but I had heard enough stories to dream of summers spent there and imagine the reality I'd want Jamaica to be. In my mind, it was lush, freeing, full of promise. Of course, the idyll I had built was a stark contrast to the smoldering, humid reality of Kingston that greeted me when I arrived. But even the heat, the culture shock, and the change of environment weren't the hardest things to adjust to.

#### The greatest obstacle was yet to be hurdled

I had just left behind everything I knew my friends, my school, the way people spoke, moved, greeted each other. I moved from one curriculum to another, from one national culture to another. But what caught me most off guard was the structure of my new academic environment.

I would be attending an all-boys institution. That fact alone didn't worry me at first. To some, it might have seemed like an easier place to blend in we were all boys, all Black, all in uniform. But the truth is, that setting made me feel even more different.

In a school of nearly 2,000 boys, only two of us myself and my twin spoke differently, walked differently, held different social courtesies, and carried different beliefs. Our accents marked us before we opened our mouths. Our posture and mannerisms made us feel alien even before we got to speak our truth. There was an unspoken pressure to "toughen up," to shed anything considered soft or strange, and conform to a culture that already had unwritten rules of how to be accepted. It wasn't just about schoolwork or sports it was about social survival. In those early days, I'll be honest it felt like the safest thing to do was to blend in. To mimic. To adjust. To compromise.

I remember moments when I felt pressure to adopt behaviors that didn't align with who I was to speak more aggressively, act disinterested in academics, perform a version of masculinity that was loud but empty. I saw boys doing things to gain clout and belonging bullying others, downplaying their talents, hiding their emotions. And I felt that same pull. That's what negative peer pres-

sure looks like: the subtle, constant suggestion that you are not enough unless you become someone else. What changed everything was getting honest about who I wanted to be, not who I was trying to impress. I found ways to make the culture work for me and reminded myself: fitting in is temporary but standing for something lasts.

So, I chose to be audaciously excellent, even if it meant being misunderstood. I carried myself with purpose, built real friendships, leaned into what mattered, and over time, the very things I was teased for became the reasons I was respected.

To every young person who feels out of place: you don't have to twist yourself to be accepted. You weren't made to fit a mold you were made to reshape the narrative. Not always to break glass ceilings, but to be willing to. Never let peer pressure turn you into a stranger to yourself. It took me time to understand that the journey to self-acceptance isn't linear. You'll have days where you question your worth. You'll have moments where rejection feels personal. But hold fast to your vision. Hold fast to your values. They are your compass in a world trying to

pull you in every direction.

Looking back, I realize that not fitting in gave me the freedom to build my own lane. I became a version of Antwon Walkin that Jamaica, Kingston and Kingston College will always remember and respect. And now, I use that lane to lead as a National Youth Parliamentarian, a youth advocate, a student leader, International Diplomat and a proud voice for young people who feel voiceless. So, if you're struggling to fit in, that's your sign that you're not meant to. Maybe you're meant to lead the way out. Great people rarely fit in not because they're trying to be different, but because they're committed to being themselves in a world that often demands uniformity.

The truth is, fitting in defeats the construct of individuality. When you dilute your essence to match the expectations of others, you surrender the very thing that sets you apart: your unique voice, your vision, your way of thinking. History remembers the ones who dared to be original the ones who walked against the crowd, who turned discomfort into courage, and who embraced their authenticity even when it was unpopular.

Individuality isn't a weakness to overcome; it's a gift to protect. It's what allows your story to echo beyond your time. Be bold. Be grounded. Be you — unapologetically. Your difference is not your weakness. It is your assignment. To Hell with fitting in.

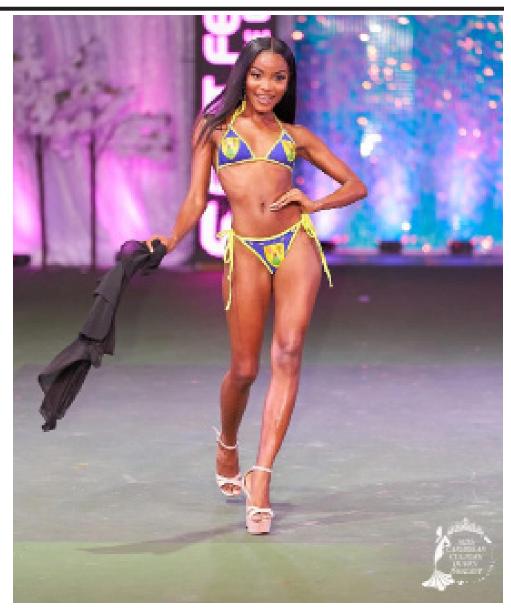

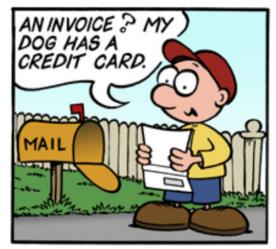

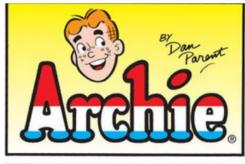

Fermented foods like yogurt, kefir, sauerkraut, kimchi, miso, and tempeh contain live cultures that support a diverse and thriving microbiome. Even a spoonful a day can make a difference.

Highly processed foods and refined sugar can disrupt your gut flora, feed pathogenic bacteria, and contribute to inflammation. You don't need to be perfect, just be mindful. Aim to crowd your plate with real, whole foods most of the time.

Chronic stress can reduce the diversity of gut bacteria, weaken your intestinal lining, and affect motility (how food moves through the system). Support your nervous system through breathwork, time in nature, movement, or simply slowing down.

Your gut is constantly communicating with you, through your digestion, your cravings, your skin, your mental clarity, and your energy levels. Symptoms like gas, bloating, acne, constipation, or fatigue are not random. They're your body's way of saying something needs attention.

The more you slow down and tune in, the easier it becomes to notice what supports you and what doesn't — whether it's a food, a habit, a pace of life, or a pattern of stress.

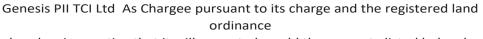

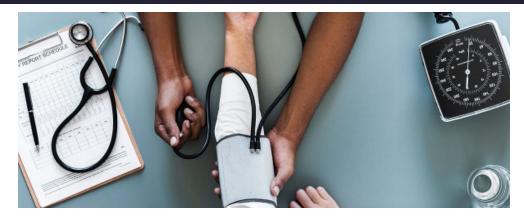

On the other hand, sharp spikes and crashes in blood sugar can lead to fatigue, hunger, irritability and higher risk of chronic diseases like insulin resistance and diabetes," Dr Chybar Virgo said. Here are some tips to setting up your morning routine for blood sugar success:

#### • KEEP CAFFEINE IN CHECK

Some research shows caffeine intake, especially over 250 milligrams per day (roughly 2.5 cups of coffee), can temporarily raise blood sugar levels. Caffeine stimulates the release of hormones like adrenaline, which stimulates the liver to release glucose and raises blood sugar. To minimise potential spikes, be sure to drink your morning cup with a balanced meal and consider limiting the amount you have.

• GET MOVING

Incorporating physical activity into your morning routine can be a quick and effective way to support healthy blood sugar levels. Movement activates your muscles to use glucose for energy, reducing the amount circulating in your bloodstream. Your morning movement does not need to be intense, simple stretches, yoga or a brisk walk can make a noticeable difference.

#### • SET VISUAL REMINDERS

You can organise medication using a pill box, and organise by expiry date. Place medication where you can easily see it, and a glass of water by your bedside.

#### AVOID BEDTIME MISTAKES

To avoid bedtime mistakes and improve sleep quality, minimise screen time, avoid caffeine and heavy meals before bed, establish a relaxing bedtime routine, and create a comfortable sleep environment. Additionally, avoid stress, intense exercise, and alcohol close to bedtime.

#### • BREATHE, HYDRATE, GET LIGHT

The phrase 'breathe, hydrate, get light' likely refers to advice for feeling better, possibly in the context of fatigue or dehydration. It suggests focusing on breathing deeply and regularly, ensuring adequate fluid intake, and spending time in natural light.

#### • CHECK FASTING BLOOD SUGAR LEVELS

To check a fasting blood sugar level, a blood sample is taken after at least eight hours of fasting (no food or drink except water). This test is typically done first thing in the morning before breakfast. Normal fasting blood glucose levels are generally considered to be below 100 mg/dL (5.6 mmol/L). Levels between 100 and 125 mg/dL (5.6 to 6.9

mmol/L) indicate prediabetes, and 126 mg/dL (7.0 mmol/L) or higher on two separate tests suggests diabetes.

#### • EATING A BALANCED BLOOD SUGAR FRIENDLY BREAKFAST

A balanced, blood sugar-friendly breakfast includes a combination of protein, healthy fats, and fibre-rich carbohydrates to help stabilise blood sugar levels. Examples include eggs with whole-wheat toast and avocado, Greek yogurt with berries and nuts, or a low-carb smoothie with protein powder

and spinach. Avoiding processed carbohydrates, sugary drinks, and large portions is also important.

Creating a blood sugar—friendly morning routine does not have to be complicated. Simple habits like staying hydrated, eating a nutrient-packed breakfast, having an earlier dinner and incorporating movement can make a big difference. ### "CARPHA, UK-PHRST Lead Landmark Outbreak Response Training for Caribbean Health Pros"

The Caribbean Public Health Agency (CAR-PHA), in collaboration with the UK Public Health Rapid Support Team (UK-PHRST) and the World Health Organization's (WHO) Global Outbreak Alert and Response Network (GOARN), has successfully concluded the Regional GOARN Tier 1.5 Orientation to National and International Outbreak Response Workshop, followed by an Evaluation Workshop of CARPHA's response plans and mechanisms, marking a significant step forward in strengthening the Region's capacity to respond rapidly and effectively to public health emergencies.

This first of its kind three-day event in the Caribbean, consisting of two outbreak response workshops back-to-back - held from August 18–20, was funded through The Pandemic Fund Grant, with CARPHA serving as the Executing Agency and the Inter-American Development Bank (IDB) as the Implementing Entity. It brought together 34 participants, comprising representatives from 10 CARPHA Member States along with CARPHA personnel based in Trinidad and Tobago.

Attendees included emergency response focal points from ministries of health, public health surveillance officers, laboratory professionals, and specialists in risk communication and One Health – an approach that recognises the interconnectedness of human, animal, and environmental health in the prevention and control of disease threats.

These intensive workshops were designed to help close identified gaps in the Region's emergency response architecture, particularly in relation to the deployable response workforce, internal operational processes, and multisectoral coordination mechanisms. Strengthening these areas is essential for improving both the speed and the effectiveness of regional responses to fast-evolving health threats, such as pandemics, vector-borne diseases, and other acute public health emergencies.

Through a combination of classroom sessions, hands-on simulation exercises and facilitated discussions, the GOARN workshop exposed participants to the transfer-

able skills and key considerations required for effective international deployment and provided insight into deployment mechanisms and processes.

The accompanying response plan review then examined CARPHA's capacity and capability to respond, using relevant scenarios to stress test existing plans and procedures, clarify roles and decision-making arrangements, and identify practical improvements in multisectoral coordination.

This practical approach ensured that participants left the training with enhanced technical skills and the confidence to apply them in high-pressure situations.

Dr. Lisa Indar, Executive Director of CAR-PHA, praised the collaborative effort and its impact:

"These workshops strengthen our collective readiness to face the next public health emergency. By enhancing the skills of our regional deployers and testing our coordination protocols under realistic conditions, we are ensuring that CARPHA and its Member States can respond quickly and decisively when outbreaks occur. Our continued priority is the safeguarding of lives and protection of our livelihoods."

Dr. Ed Newman, Director of the UK-PHRST and Co-Deputy Chair of the GOARN Steering Committee, noted the lasting value of the programme:

"We're delighted to partner with CARPHA on this initiative in support of their vision to expand regional Public Health Emergency Response capacity and capability. Working alongside GOARN, we're proud that UK-PHRST has the expertise to deliver these workshops, sharing our learning and experience and that of our partners- helping ensure CARPHA and its Member States are better equipped to respond to future public health emergencies.

"This partnership demonstrates the power of international collaboration in building resilient public health response systems and reflects our shared commitment to strengthening global health security."

British High Commissioner to Trinidad and Tobago, H.E. Jon Dean added "The UK is proud to have supported this important

initiative through the UK Public Health Rapid Support Team, in close partnership with CARPHA and WHO GOARN. The training represents a meaningful step toward strengthening the speed and effectiveness of public health emergency responses in Trinidad and Tobago and across the Caribbean. This collaboration reflects the UK's enduring commitment to regional cooperation, resilience, and shared learning with the Caribbean."

Delivering the keynote address at the opening ceremony, the Minister of Health of Trinidad and Tobago, Dr. the Honourable Lackram Bodoe, highlighted the strategic importance of the collaborative effort underpinning the workshop.

"This gathering represents far more than a training exercise. It is a strategic commitment to fortifying our collective defence against the ever-evolving threats of infectious diseases and public health emergencies. It is also a statement that the Caribbean, though small in size, stands united in purpose and prepared for action."

By the close of the workshops, participants

had tested and refined CARPHA's regional outbreak coordination mechanisms, identified strengths and areas for improvement in operational readiness, and strengthened their ability to collaborate across borders and sectors.

The knowledge and skills gained will now be integrated into national public health systems, expanding the region's pool of professionals who are trained, tested, and ready for rapid deployment.

By building a skilled and responsive health emergency workforce and testing coordination protocols under realistic conditions, this initiative supports the long-term sustainability of emergency preparedness in the region and contributes directly to reducing the public health impact of future pandemics and other acute threats.

In doing so, it advances one of the key goals of CARPHA's Pandemic Fund Project – to ensure that Member States have the systems, infrastructure, and human resources in place to detect, respond to, and contain public health threats before they escalate.

## Two Americans drown, another bitten by shark in The Bahamas

A 63-year-old American man, who was attacked by a shark while spearfishing near Big Grand Cay, The Bahamas, has been airlifted to the United States (US) for medical treatment.

A statement from the Royal Bahamas Police Force did not identify the American national, but the incident occurred a few weeks after another American, 66-year-old Mike Raich, survived a shark bite while spearfishing off Spanish Cay.

In that case, one of the shark's teeth was left lodged in his arm, and doctors said he narrowly avoided life-threatening damage to major nerves and arteries. Raich, a United States Marine veteran, required surgery to reattach his tricep but has since recovered.

Meanwhile, Bahamian police say they are also investigating the death of two American tourists who drowned in sep-

arate incidents over the last weekend at Celebration Key on Grand Bahama.

"Our lifeguards and medical team responded to two separate water emergency incidents at Celebration Key... one in the lagoon and one at the beach," Celebration Key said in a statement

"Sadly, both guests have passed away. One guest was sailing with family on Mardi Gras, and one guest was sailing with family on Carnival Elation. Our thoughts and prayers are with the guests and their families, and our care team is providing assistance."

In its statement, the police said in the first incident, the body of a 79-year-old man had been discovered on board a commercial boat.

"According to the initial report, the

male became unresponsive while snorkelling on a beach. A lifeguard assisted him from the water, and CPR was administered, but to no avail. As a result, the male who is reported to be an American national was pronounced deceased by a medical doctor," the police statement said.

It said that in the second incident, a 74-year-old American woman became unresponsive while swimming in a pool.

She was assisted out of the water by a lifeguard, and CPR was administered, but she later died.

"An autopsy will be performed on both victims to assist with determining the exact cause of death. The investigation continues in both matters," the police said without disclosing their names.

### Trump targets mail-in ballots ahead of 2026 US elections

US President Donald Trump said Monday he would lead a "movement" against mail-in balloting as he seeks to eliminate a voting method used by nearly a third of the country ahead of next year's midterm elections.

Trump — who has spent years railing against postal ballots, even though they have benefited his Republicans and he has voted by mail — said he would sign an executive order to help bring "honesty" to the midterms.

"I am going to lead a movement to get rid of MAIL-IN BALLOTS, and also, while we're at it, Highly Inaccurate, Very Expensive, and Seriously Controversial VOTING MACHINES," he posted on his Truth Social platform.

Mail-in and absentee ballots can be counted after Election Day in 18 states so long as they're postmarked on or before that date, and just over 30 per cent of those cast in the 2024 election were submitted by mail.

There is no evidence that postal voting is less secure than other methods and pro-democracy groups say ending it could disenfranchise millions of Americans with disabilities and other difficulties turning out in person.

But Trump repeatedly spread misinformation about the practice as he campaigned in 2020 and 2024. After his defeat in 2020, he falsely claimed that tens of thousands of fraudulent mail-in ballots had helped Democrat Joe Biden beat him.

Trump said Friday his Russian counterpart Vladimir Putin — whom US inves-

tigators found interfered on the Republican's behalf in the 2016 election — agreed with him that letting voters send in ballots by mail risked election integrity.

"You know, Vladimir Putin said something, one of the most interesting things," Trump told Fox News.

"He said, 'Your election was rigged because you have mail-in voting.' He said, 'Mail-in voting, every election.' He said, 'No country has mail-in voting. It's impossible to have mail-in voting and have honest elections.'"

Trump claimed falsely in his Truth Social post and again at an Oval Office press

event on Monday that America is the only country in the world that uses postal voting.

In fact, data compiled by the International Institute for Democracy and Electoral Assistance show there are 34 countries worldwide allowing in-country postal voting — including Germany, Britain, Denmark, and US neighbour Canada.

Trump issued an executive order in March directing Attorney General Pam Bondi to "take all necessary action" against states counting absentee or mail-in ballots received after the election, even if they were postmarked by Election Day.

A judge ruled that Trump lacked the authority to impose state election rules and blocked the edict.

The US constitution is clear that the "times, places and manner" of congressional elections is up to the legislatures in each state and not the business of the president.

Despite his criticism, Trump cast mail ballots twice in Florida in 2020 primary elections and used absentee ballots in New York in 2018 and 2017. But he voted in-person in the 2016 and 2020 presidential elections.

His critics suspect his main concern in seeking to end mail-in voting is that it benefits Democrats, who outnumber Republicans using absentee or postal ballots.

### Oblique Seville beats Noah Lyles again in men's 100m

Noah Lyles's search for a 100m win this season continues after the Olympic champion was beaten for a second time in three races by Oblique Seville in a downpour.

Oblique Seville scorched to an impressive win on Wednesday (20 August) at the 2025 Athletissima Lausanne meet, the 13th stop on this season's Diamond League athletics circuit, beating Olympic champion Noah Lyles for a second time this season.

Seville started fast out of the blocks in wet conditions and quickly opened up a big gap to the field, never looking back as he posted an impressive 9.87-second time into a-0.3m/s headwind.

"Yeah, I'm back, but to be honest in these conditions, it's very difficult even to run that fast, and to come out here and I'm the only person who managed to show my dominance," Seville said to Olympics.com's Evelyn Watta.

As usual, Lyles had a slow move out of the blocks, but managed to move up a spot past Seville's Jamaican teammate Ackeem Blake to finish second in 10.02, with Blake sharing that time in a photo-finish

It was the Olympic champion's third in-



ternational race this year over the distance, having previously lost to Seville at the London Diamond League then to Kishane Thompson on Saturday at the Silesia Diamond League.

The gap between Lyles (and the field) and Seville only served to emphasise just how impressive the latter's win was, while Lyles's comeback from an injury-disrupted start to the season contin-

ues without a win over the short sprint. "I love to run and compete, so this is a very odd type of season for me. I've never had a season like this before, where I've had so few races," he had told journalists in a pre-event media huddle on Tuesday.

With the World Championships in Tokyo fast approaching, Lyles — who is also the defending world champion from Bu-

dapest in 2023 — is still trying to find his

"I just had a really bad reaction to the gun," Lyles told Olympics.com after his 10.02. "After that, there's not much I can do. We all gotta run in the same thing; just because it's bad conditions doesn't mean fast times can't be run.

"We'll go to Zurich (for the Diamond League Final), and after that, Worlds."

Italian journalists Filippo Biafora and Annalisa Ferrante say Reggae Boy Leon Bailey is a strong addition to the AS Roma squad but will need to perform at a high level consistently if he's to make an impact for the Serie A club.

Bailey, who is set to be officially unveiled as a Roma player today, arrived in the Italian capital on Tuesday to much fanfare before completing his medical ahead of his season-long loan from English Premier League club Aston Villa. Roma has an option to make the move permanent for £18.9 million after agreeing a £1.7-million loan fee with Villa.

The 28-year-old becomes the club's second high-profile attacking signing under new manager Gian Piero Gasperini.

Biafora, who writes for Italian newspaper II Tempo, says Bailey can add a much-needed spark to Roma's front line. "Bailey is a player who brings a certain dynamism to Roma's attack, which at times has looked a bit too static," he tells the Jamaica Observer. "His change of pace and his bursts of acceleration can prove decisive in adding that touch of unpredictability to the attacking phase." Ferrante, senior editor and reporter at LaRoma 24 and TeleRadioSterio, says she expects Bailey to thrive under Gasperini's watch.

"Gasperini knows how to get the best out of attacking wingers and has a track record of turning players into decisive weapons," she tells the Observer. "If Bailey finds physical consistency and confidence, Gasperini can truly help him reach the level many expected from him at the start of his career."

Bailey becomes just the second Jamaican-born player to compete in Italy's top flight, joining striker Trivante Stewart, who played for Salernitana after moving

from Mount Pleasant FA in 2023.

Ferrante says the move will make more people open their eyes to Jamaican football.

"It is very rare and very significant," she says. "Having a Jamaican at a prestigious international club like Roma is a source of pride not only for him but for the entire Jamaican football movement. He can become a role model and open the door for other talents from Jamaica," she notes.

Though Stewart struggled for game time and goals during Salernitana's relegation, Biafora doesn't foresee the same future for Bailey due to his previous high-level experiences.

"Several players coming from the [English] Premier League have performed very well in Serie A," he says. "It has almost become a pattern to see many of them raising both the level of their teams and their own performances.

"I think this is exactly Roma's hope in pursuing this move. And in reality, I wouldn't even call it a gamble, because Bailey is a player who is already well-known, not too old, and still has plenty of room to grow. The real objective here is to bring in a player who can help the team take that step up in quality. In some respects, I would compare it to what Gervinho represented for Roma a few years ago."

The former Genk and Bayer Leverkusen winger was deemed surplus to requirements at Villa after an underwhelming campaign last season which saw him register just two goals and four assists in 38 games across all competitions.

It was a step down after a standout 2023-

24 season where he notched 14 goals and 14 assists in guiding Villa to a top four finish and UEFA Champions League football.

Biafora says Bailey will need to rediscover his old form throughout Roma's league and UEFA Europa League campaign to be regarded as a success.

"A successful season for him would probably mean coming close to double figures in goals, but more importantly, raising the overall standard of Roma's attack. At the moment, the team scores too little and creates too few real threats," he says

"So beyond the specific numbers of goals and assists, the main objective should be to help the attack become more dangerous — whether that means scoring himself or setting up the centre-forward with assists. That contribution could be even more valuable than just focusing on his personal stats."

Roma finished fifth in Serie A last season, scoring 56 league goals — the second lowest of the teams that finished in the ton 10

Ferrante says Bailey will have a big task in improving the team's attack, though admitting it won't fall on solely his shoulders.

"The burden is significant, but not overwhelming," she says. "Fans will expect decisive plays and moments of quality from him, especially in key matches. He won't be the only protagonist, but he was brought in precisely to make the difference, so he will have to take on responsibilities."

## West Indies Women to benefit from training camp in India

Cricket West Indies (CWI) has taken another major step in its groundbreaking India development programme, sending 15 of the region's most talented women's cricketers to a high-performance training camp at the Chennai Super Kings Academy.

The squad, led by Head Coach Merissa Aguilleira and supported by assistant coaches Ryan Hinds and Tremayne Smartt, along with team manager Yasmine St Ange, departed Barbados on August 12 for the intensive two-week programme, running from August 13 to 30. The group includes established senior players such as Ashmini Munisar, Zaida James, Djenaba Joseph, and Trishan Holder, alongside current and former West Indies Under-19 standouts like Naijanni Cumberbatch, Niya Latchman, and Samara Ramnath.

The camp is designed to sharpen their skills against spin bowling, enhance technical proficiency, and build mental

### Big honour for late Jamaican American basketball star Ryan Reid

THE legacy of Ryan Reid, the former Florida State University and Jamaica national team standout who died suddenly from a heart attack on July 9 at age 38, will be permanently enshrined by his alma mater, Boyd Anderson High School, in Lauderdale Lakes, Florida.

Reid was widely respected for his dedication, toughness, and leadership on and off the court. Boyd Anderson High will honour him for a stellar high school career in which he averaged 18 points, 12 rebounds, and three blocks per game over his final three seasons before graduating in 2005. The ceremony will see his number 42 jersey raised to the rafters.

At Florida State, where he played from 2006 to 2010 under Head Coach Leonard Hamilton, Reid earned a reputation as one of the hardest workers and fiercest competitors in the programme's history. He graduated with a degree in social science in 2010 and was selected in the second round of the NBA draft that same year by the Indiana Pacers before being traded to the Oklahoma City Thunder, where he was part of the 2012 NBA finals team.

Coach Hamilton remembered Reid not only for his contributions to the Seminoles but for his character and values.

"The thing that was special about Ryan is that, more than anything, he was an unbelievable human being. He was courteous, polite; people liked him for who he was, even beyond basketball. He was a gentleman in every stretch of the imagination," he said.

Hamilton emphasised Reid's academic diligence and emotional intelligence as much as his basketball acumen.

"Academically, he was responsible. He always showed up to his tutoring sessions and did everything he needed to do to earn his degree. Socially, he was fun to be around, he always lightened the mood.

But one thing you could always count on with Ryan was that he gave everything he had, every possession, every practice, every game. He never made excuses, ever." While Reid's college averages were modest — 6.8 points and 4.0 rebounds in his best season, with career totals of 624 points and 490 rebounds over 126 games — his impact was immeasurable, particularly in intangibles like leadership, defence, and hustle.

"He got drafted mostly on his toughness and his defensive ability," Hamilton said. "He never backed down. That was just his nature. He took great pride in not letting anyone outwork him."

Reid also made a lasting impact internationally, serving as a central figure in the golden era of Jamaica men's basketball from 2009 to 2013.

His performance at the 2011 Caribbean Championships, where Jamaica fielded an undermanned squad, was pivotal to qualifying for the 2012 Centrobasket tournament and the 2013 FIBA Tournament of the Americas (TOA) where Jamaica famously defeated world number 3 Argentina and number 9 Brazil to win the bronze medal.

"He literally put us on his back and shoulders," said Ajani Williams, former NBA player and president of the Jamaica Basketball Association.

"Unquestionably, no Ryan, no FIBA TOA. He was a gracious human, a great man, husband, dad, friend, and patriot. He loved Jamaica and his parish of birth, Portland."

Paulton Gordon, current JBA president, also praised Reid, saying, "Ryan was a giant in every sense of the word, a true leader who displayed the pride and passion reflective of a true Jamaican. He will be sadly missed."

The Oklahoma City Thunder, through

their Thunder Legacy Network, also paid tribute: "Ryan made his mark on our organisation through his authentic good nature and hard-working spirit, and it is truly tragic to have lost him at such a young age. Our deepest condolence go to his family and friends."

Kendrick Perkins, Reid's former Thunder teammate and now an ESPN analyst, posted on Instagram:

"Rest in Peace young Fly high my brother

Current FSU Head Coach Luke Loucks, who was Reid's teammate during his college years, also reflected on his presence. "Ryan was more than just a great basketball player, he was a great competitor, a trusted teammate, a natural leader, a devoted husband and a loving father...His personality filled every room, his sense

of humour lifted every moment, and his presence made us all better, on and off the court."

Coach Hamilton echoed those sentiments: "Ryan and I had a really, really good relationship. He made the same kind of impact in high school, and I'm sure that's why they're retiring his jersey because of who he was and what he represented. He not only represented his parents, but his people, his family in Jamaica. If people could emulate him, they'd be moving in the right direction."

Reid is survived by his wife Rebecca, daughter Yaya, son Preston, mother Jasmine Mullings, father Kenneth Mullings, sister Rosmarie "Dionne" Lindo, cousin Audley Lindo, and a host of loved ones who continue to mourn a man gone too soon but never to be forgotten.

## Clock Malfunction Denies TCI Mixed Relay Team National Record in The Bahamas

The Turks and Caicos Islands national track and field team put in a gritty showing at the North American, Central American and Caribbean (NACAC) Senior Championships, held August 15–17 in Nassau, The Bahamas.

The highlight was expected to be a national record in the mixed 4x400m relay, but a clock malfunction cruelly robbed the squad of official recognition.

The quartet of Melique Evans, Yanique Haye-Smith, Rayvon Black, and Tanesia Gardiner produced a superb run of 3:36.57, bettering their previous best of 3:38.24. The team crossed the line fourth overall in a highly competitive field. However, the electronic timing system failed during the race, forcing officials to rely on hand times for all four teams. Under World Athletics and NACAC rules, hand-timed marks may be used for placings but cannot be ratified as national or area records. It meant that despite their breakthrough performance, the TCI quartet's new standard will not enter the official books.

Veteran sprinter Yanique Haye-Smith once again led the charge individually. In the women's 400m, she placed fourth in her preliminary heat with a strong 55.50 seconds, advancing to the final. There, she faded slightly and crossed the line in 57.81 seconds to finish eighth overall. Roniesha Johnson also contested the 400m, clocking 1:02.48 for 14th place.

In the men's long jump, Melique Evans managed 6.21 metres, which placed him 10th in the standings. The mark was well short of his personal best 6.95m, recorded earlier this year at the CARIFTA Games, but he gained valuable senior-level experience.

Sixteen-year-old Rayvon Black, the youngest member of the TCI delegation, contested the men's 200m. Facing some of the best sprinters in the hemisphere, Black finished 22nd out of 26 competitors and did not advance. His participation was still historic, as he was officially the youngest competitor registered at the championships.

In the women's 800m, Tanesia Gardiner, a student at Monroe College in Upstate New York, ran a determined race to finish seventh in 2:22.84. Her consistent performances over the season have underlined her status as one of the territory's most promising middle-distance athletes.

Although the disappointment of the relay record overshadowed the meet, the NACAC Championships proved an important stepping stone for the Turks and Caicos Islands team. With athletes ranging from seasoned campaigners like Haye-Smith to newcomers like Black, the event showcased the balance of experience and youth within the program. Against top regional talent, the TCI competitors demonstrated resilience, com-

mitment, and the ability to compete on

the international stage.
