THE FUTURE OF AFRICAN TRADE

With the implementation of the African Continental Free Trade Area on January 1st, 2021, African states have an opportunity to break free from the shackles of economic nationalism that have plagued swathes of the continent for centuries and trapped so many of its people in poverty. The benefits of African free trade are numerous, however, so are the challenges.

The Initiative for African Trade and Prosperity (IATP) is guided by the core belief that bottom-up free market policies are the most effective way to alleviate poverty, amplify individual liberty, and create a more peaceful future.

The project is supported by the Institute of Economic Affairs and the Vinson Centre for the Public Understanding of Economics and Entrepreneurship at the University of Buckingham. The IATP partners with, and provides financial support to, local think tanks, groups, and scholars making the case for freedom right across Africa.



THE OPPORTUNITY


By 2035, the AfCFTA will have lifted 30 million people out of extreme poverty and 68 million from moderate poverty

Since decolonisation, economic nationalism has plagued swathes of Africa. However, on January 1st, 2021, thanks to the introduction of the African Continental Free Trade Area (AfCFTA), that could change. The AfCFTA is the world's largest free trade area and represents the first opportunity in Africa's history for states to pursue an intra-continental trading relationship based on free trade and continued economic liberalisation.

Within 13 years, the AfCFTA aims to eliminate 97% of tariffs on goods traded between member-states. The World Bank predicts that if fully implemented by 2035, the AfCFTA will lift 30 million people out of extreme poverty, 68 million from moderate poverty, boost regional income by over \$450 billion, and increase average wages for both skilled and unskilled workers by approximately 10 percent. Moreover, the AfCFTA would play a vital role in mitigating the substantial economic damage inflicted by the COVID-19 pandemic.

THE CHALLENGE

Never in Africa's history has there been a more important time to make a case for free trade

The future of free trade in Africa is far from secure due to insufficient participation among African Union member states, particularly from the continent's larger economies, delays in implementation, increasing calls for economic nationalism post-Coronavirus, and the lack of support for free trade from some governments who have already ratified the agreement, the future of free trade in Africa is far from secure. Certain opponents of free trade, often represented by influential trade unions and far-left political parties, have already achieved success in promoting a protectionist narrative within their countries. These negative voices must be met with a strong, positive message explaining the enormous benefits bottom-up free trade solutions will bring to each and every community in Africa. If this challenge is not addressed, the prosperity and opportunities of a continent-wide Free Trade Area will remain elusive.

Whilst AfCFTA has put the notion of 'free trade' in the news across the continent, in the absence of a strong and coordinated voice advocating for free trade and, more importantly, without support given to those best positioned to effect change, the realisation of a continent-wide FTA could dissipate.

THE SOLUTION

Together we will help remove barriers to human flourishing in Africa Africa has by far the greatest number of people living in extreme poverty. The AfCFTA will not serve as a sole remedy to African poverty, but it presents a significant opportunity to enhance the wellbeing of millions of people.

More than two dozen free enterprising think tanks are currently based in Africa, along with thousands of students and scholars with an interest in free trade. Until recently, however, there was no organisation or project dedicated to making an African-wide free trade area a reality.

That is why we launched the **Initiative for Africa Trade and Prosperity (IATP)** which seeks to be a unifying voice for open and liberal trade across the continent. Through IATP we partner with local groups and think tanks in the region, offering grants, assistance, and educational resources to amplify their voices and increase their effectiveness. We also find and connect with students, teachers, writers, and thinkers to build a stronger and more unified voice that advocates for free trade. Alongside creating a connected movement, the IATP provides tangible outputs: original research and articles for publication; a virtual library of books related to trade and classical liberal thought in Africa; hosting lectures and seminars (virtual or in person), producing videos, and appearing on TV, radio, and podcasts.


















PARTNERING TO ENCOURAGE CHANGE

SPOTLIGHT 1 BRINGING CHANGE TO TANZANIA





Educate and Empower

Partnering with Liberty Sparks has enabled the IATP to support the leading voice for change and freedom in Tanzania.

The IATP has supported Liberty Sparks through various grants to undertake activities encouraging Tanzanians to take control of thier own future and promote greater freedom and inclusiveness.

The IATP supported Liberty Sparks in hosting thier annual Uhuru Conference.

This one-day conference brought together over 600 Tanzanian students who are interested in economics and entrepreneurship. Throughout the day, the students recieved copies of the Swahili translation of the IEA's 'An Introduction to Trade and Globalisation' by Dr Eamonn Butler. The conference held discussion sessions surroudning the book, encouraging the students to set up reading groups and enter essay competitions on the topics.

For students who are passionate about the African Continent Free Trade Agreement, Liberty Sparks hosted seminars to discuss the benefits of wider ratification and how free trade can create a freer and more prosperous Africa.

With the support of other IATP grants, Liberty Sparks have been able to run educational training events focused on approaches to free trade and globalisation which reached 204 Government agency officials, 42 Members of Parliament, 16 senior journalists and 35 primary and secondary school teachers.

The Congo We Want

The IATP is thrilled to have provided technical and financial support to the Center for Development and Enterprises Democratic Republic of the Congo's first ever educational project on free trade in the DRC.

The project 'The Congo We Want' advocates for education on the benefits of free trade between the DRC, its neighbours and the rest of the world.



CDR-DRC have been hosting seminars with business leaders, cross-border traders, and journalists educating them on the ideas present in the IEA's 'Introduction to Trade and Globalisation'.

The IATP has provided support to CDE with the production of a policy brief which talks about the state of trade in Africa and analyses the consequences of protectionist trade policies on the Congolese people.

The team at CDE-DRC have engaged with 40 senior public officials and have managed to provide them with copies of the policy brief and the IEA book and educate then about the virtues of free trade.

Espoir Bindu, Executive Director of CDE-DRC said "This project in the DRC is considered one of the most appropriate solutions to reduce the rate of poverty in the DR Congo. This educational project has been reflected in the public speeches of several influential leaders of civil society and the media who has also written 13 Articles about the ideas of free trade that we have taught them."


