Dr. Laurette Bristol - Bio-Data

Dr. Laurette Bristol is a citizen of the Republic of Trinidad and Tobago. She is currently serving as a Senior Lecturer at the School of Education, University of the West Indies, Cave Hill Campus, Barbados. She previously served as the Programme Manager, Human Resource Development at the CARICOM Secretariat with responsibility for the leadership, management, coordination, and harmonisation of strategies that enable the implementation of the CARICOM Human Resource Development 2030 Strategy, which was approved by Heads of Government in 2017.

Dr. Bristol has over 25 years' experience in the education arena as a practicing primary school teacher, a Teacher Educator and Tertiary Education Administrator in the Caribbean and Australia. She is a published author of books (single authored, co-authored, and co-edited), and numerous internationally peer reviewed book chapters and research journal articles. Her research emphasises the historical impact of the colonial experience on classroom practices, prefiguring post-colonial educational aspirations and actions. More specifically she has an international research profile that spans the fields of professional development, mentoring, leadership, and school transformation.

Dr. Bristol was recently elected to serve as Programme Chair- Caribbean Studies in Education (CASE), Special Interest Group (SIG)- American Educational Research Association (AERA).

Dr. Juneann Garnett is a Senior Assistant Registrar at the University of Guyana, Registry with responsibility for the management of the Committees & Archives Unit. She holds a first degree in Agriculture, a Postgraduate Diploma in Development Studies, and a Library Technician's diploma all from the University of Guyana. She has a Master of Arts degree in International Studies from the University of Ohio and a Doctor of Education degree (Leadership and Innovation) from Arizona State University.

In 2017, Dr. Garnett became the Assistant Registrar for Committees and Archives. Since then she has focused on developing a system that will allow easy access and retrieval of institutional records. She posits that if the University's Governance systems are supported by the documentation of clear policies and procedures with relevant access to institutional records and knowledge for all stakeholders, innovations will be faster diffused within the University. The University's leaders would be working within a framework that allows for good communication, knowledge transfer, and information sharing; this would foster positive and necessary change. Dr. Garnett's research interests lie in focusing on the potential of the effective dissemination of information to address contemporary social problems both within and without organizational constructs. Her dissertation research explored how an Electronic Records Management System could be used to foster good governance and institutional cohesion at the University of Guyana.

Dr. Garnett has presented research papers at several regional conferences and won first prize at the University of Ohio's International Studies, Graduate Student Research Expo 2015. She also worked with Professor Lawrence Carrington on the governance reform project for the University of Guyana, which was completed in 2018.

Dr. Maurice D. Smith received his professional training at the Mico University College in Kingston, Jamaica. Having earned undergraduate and graduate degrees with honours from both Northern Caribbean University and the Nova Southeastern University respectively, he is a Jamaica 2010 Fulbright Scholar who has read for a Doctor of Education [with high commendation] in educational leadership and policy from Howard University. Having been previously engaged as the Principal Director of the National College for Educational Leadership [NCEL], he was in 2015 appointed Permanent Secretary in the Ministry of Education, Youth and Information. Between 2017 and 2019, Dr. Smith was engaged as an international educational consultant to the World Bank, UNESCO and Organization of Eastern Caribbean States where he provided policy and technical advice to governments across Latin America, the Caribbean and the Middle East.
