

# **IRA Calendar**

## **JANUARY**

- IRS Form 1099-R sent from custodian if money/investment(s) were withdrawn in 2023 (No later than January 31st).
- IRA custodian sends out required minimum distribution (RMD) notifications (if applicable) for 2024.



Q4 Account Statement released – accountholders are notified when available [year-end fair market value (FMV) of IRA included].

## **FEBRUARY**

STRATA will send accountholders and sponsors a request for FMV (if applicable).

## **MARCH**

☐ March 31

FMVs are due to STRATA from investment sponsors.

☐ Max out IRA contributions for the 2023 tax year.

## **APRIL**

□ April 15

Deadline to file 2023 tax returns and complete IRA contributions for 2023 (unless extensions apply). April 17, for residents of Main and Massachusetts.

☐ April 30

FMVs are due to STRATA from accountholders (if applicable).



Q1 Account Statement released— accountholders are notified when available.

## MAY

□ May 31

STRATA files Form 5498 with the IRS (reporting all IRA contributions for 2023) and makes a copy available to accountholders.

## JUNE

Enjoy your summer!

## **JULY**

☐ Conduct a mid-year review of your IRA investments.



Q2 Account Statement released – accountholders are notified when available.

# AUGUST

Enjoy your summer!

#### **SEPTEMBER**

□ Review and update IRA beneficiary designation, email, and physical/mailing address.

#### **OCTOBER**

☐ Schedule RMD distribution for 2024 (if applicable). Must be processed by December 31, 2024.



Q3 Account Statement available – released are notified when available.

## **NOVEMBER**

☐ Talk to a financial or tax advisor about the benefits of pre-tax retirement savings, investment allocations, and strategy for 2025.

# **DECEMBER**

□ December 1

RMD distribution for 2024 (if applicable) must be submitted to STRATA in order to meet the December 31, 2024, IRS deadline.
