
## >>> LEARN YOUR RIGHTS IN COMMUNITY (LYRIC)

During the sessions, Attorney Wise and Attorney Collard presented scenarios and guided students in practicing how to safely and confidently assert their constitutional rights.

CJLP students hosted the annual Spring Symposium, focusing this year on Criminal Justice: Mental Health. The event featured guest speakers from the Aurora Police Department expert Crisis Team—Sergeant Buchholz and Clinical Social Worker Clinician Jennifer Fierberg from U.C. Health—who shared insights into mental health crisis response. CJLP students opened the program by presenting the historical context of deinstitutionalization, its societal impacts, and relevant case law, along with discussions on local policy initiatives and recent reforms. 

COURSE

# Criminal Justice and Law I

CRJ 1010 • CRJ 1045

This course combines Introduction to Criminal Justice (CRJ 1010) and Correctional Process (CRJ 1045). This course concentrates on potential careers in the criminal justice system and law enforcement in general. Students will learn about the agencies and processes involved in the criminal justice system: the legislature, the police, the prosecutor, the public defender, the courts, and corrections. The course includes an analysis of the roles and problems of the criminal justice system in a democratic society, with an emphasis upon inter component relations and checks and balances. This course aligns with the Colorado Community College course Introduction to Criminal Justice (CRJ 1010) and Correctional Process (CRJ 1045).

# Criminal Justice and Law II

CRJ 2005 • CRJ 2057

This course combines Principles of Criminal Law (CRJ 2005) and Victimology (CRJ 2057). **Principles of Criminal Law focuses** on common law and statutory law crimes, the Model Penal Code, elements defining crimes and penalties, defenses to criminal accusations, and definitions and distinctions between criminal and civil law. Victimology demonstrates to the student the role the victim plays in the criminal justice system. The traditional response that a victim receives from the system will be studied and the psychological, emotional and financial impact these responses have on victimization will be analyzed. This course aligns with the Colorado Community College course Principles of Criminal Law (CRJ 2005) and Victimology (CRJ 2057).
