GEORGE NEWS

2019/2020 has been a very busy but rewarding year for us in George. With increased caseloads from the smaller animal welfare organisations in our area and with a shortage of staff, some days proved to be more challenging than others.

We sadly bid a fond farewell to our Veterinary Nurse, Karla Scholtz, in July 2019 when she left welfare to join a private veterinary practice in George.

A big thank you to our two 2019 CCS Vets, Natasha Clark and Kimberley Van Der Schyff, for sharing their passion and knowledge with us during the year. They participated in numerous local sterilization projects throughout the year and we salute both these Vets for all their hard work and dedication and for always going the extra mile with every case. With the guidance and expertise of Dr. Smith, I am sure that their time spent at the PDSA was beneficial to them and we wish them well with their future veterinary careers.

Thanks to our volunteers and the public of George, we held two very successful street collections this year on Saturday, 29 June 2019 and Saturday, 30 November 2019.

We were nominated by Dotsure Pet Insurance to participate in their Polar Bear Plunge at Victoria Bay on Saturday, 27 July 2019. Unfortunately we did not win the R20 000 up for grabs, but we received a bakkie load of blankets for our hospital. We were also interviewed by the SABC during the day and we made the news channel that evening.

On 4 October 2019, we participated in the "World Animal Day" celebrations in Oudsthoorn in collaboration with their State Vet and the Animal Care Team, a local welfare organisation. Free rabies vaccinations were offered to cats and dogs and a total of 425 animals were vaccinated. The day was a huge success and very well supported.

On 2 January 2020, we very pleased to welcome Dr. Stacy King, our CCS Vet for 2020 and Nelene Boltman, a newly qualified Veterinary Nurse, to our team in George. We wish them well and hope that they enjoy their time with us at the PDSA.

Last, but not least, our charity shop has done exceptionally well this year, raising money for animals in need. A big thank you to the George community for their continued support of our charity shop and sometimes, despite many challenges, a big thank you to all my loyal volunteers, who are responsible for the day to day running of the shop.

SOWETO NEWS Sango Mbiko

I would like to take this opportunity to greet all members and generous supporters of the PDSA (SA).

During the last quarter of 2019 our mobile clinics were not operational; we were only operational from our Mofolo hospital and Pimville Clinic. Although our mobile clinics were suspended we found that clients who used our mobile service were accessing our hospital and clinic services, which meant that we had an increase in our daily cases. Luckily in December 2019 our mobile service was restored. The news was well received by our clients who were not fortunate enough to have transport to either Mofolo or Pimville.

During the first quarter of 2020 we were hit with another blow when the country was placed on lockdown level 5. Most of our operations were reduced and clients were allowed to visit our hospital but had to adhere to strict COVID-19 protocols. We only treated emergencies and no operations were scheduled until we were on level 3. Pet owners abandoned their animals as they could not take care of them due to job losses resulting in financial difficulties; our hospital bore the brunt with our kennels filled to capacity.

We were unable to meet some of our social responsibilities that were set out for this year due to events being cancelled because of COVID-19 restrictions in place. We only managed to do one Spay Campaign before lockdown, we attended the Soweto Dog Show and the Rainbow Nation Animal Rescue show.

I would like to sincerely thank our sponsors and supporters. Despite all the challenging times, they continue to support PDSA. We know that it was not easy, but you still made it your mission to give to the needy, we thank you. To those who usually support us but could not do it this year believe me we understand, and we know as soon as things are back to normal you will continue supporting us.

To PDSA Soweto staff, thank you for your dedication. PDSA would not be where it is today without you. Iris Dlamini we thank God that you are back with us after you contracted COVID-19. Last but not least, to our management thank you for your continued support.

TREASURER'S REPORT

The financial year ended 31st March 2020 was another challenging period for the PDSA. Investment income continued to remain under pressure but total income nevertheless increased by 2% to just beyond R20m. We saw a reduction in total collections direct from the public of 3.5%, largely due to the 3 mobile vehicles in Soweto being off the road for an extended period. Thankfully, we are now back to full capacity in this area.


Management and staff reduced total expenses for the same period by 1.5%. The net result is a reported operating loss of R5.3m before bequests. Bequests of R4.6m were gratefully received as always, leaving us with a net deficit of R700,000.

Case figures were down to 112,000 for the year, again largely as a result of the mobiles being off the road.


Management continues the daily effort to keep total expenses in check to ensure the long term sustainability of the PDSA as the organisation rides out these tough economic times.
