



#### When to Change the Fuel Filter

I have been following a maintenance schedule for what is apparently an older bike, and it says to change the fuel filter every 25,000 miles. However, when I looked at the schedule for a 2013 Touring bike, it says to change the fuel filter every 100,000 miles. Which is it?

The factory schedule for your year and model would be the correct schedule. You always have to bring into consideration not only miles but riding conditions and time.

#### **Engine Skips**

We have a skip in the engine after warming up just at a constant speed. If you throttle up it goes away, until you get to a constant speed again. About to pull my hair out, any help please.

Be sure to always use premium fuel. Start simple. Check for trouble codes. Check your spark plug condition & gap. Check your spark plug wires. You may want to perform a fuel pressure test.

#### Handlebar Riser Issue

I have an '07 Night Train with 4-inch risers and drag bars. The bars don't wobble but stay canted left or right depending on the twist to the fork. The bushings were new, I changed to hard plastic. Still no good.

Try shortening the bushing sleeves a little (1/8, or 1/4"). Also, look for riser bolts with a shorter shoulder section.

#### Security Indicator Light Stays On

On my 05 Ultra Classic I took the fairing front cover off to repair antenna and when I reinstalled it checked everything, and it was fine. Then later that day the security indicator light was on when I rode it and tried to reset it. It took forever to get it to flash only once, and the light stayed on, and the tach and speedo do not work. Also, the turn signals are not working? Please help!!

Look for a blown fuse. Whether or not you have a blown fuse, we suggest you backtrack. You will not know anything without removing your outer fairing. Inspect your harness. Inspect your inner fairing supports. Broken fairing supports can cut your wiring harness and create dead shorts.

Fight for the compensation you need to cover vehicle repairs. medical bills, and other costs by hunting down the Law Tigers! If you experience a motorcycle accident, you should speak with an experienced attorney before accepting a settlement offer from the insurance company. A veteran lawyer can also help you file a claim for motorcycle accident injuries if negotiations break down.

What Are the Most Common Motorcycle Collision Injuries? Motorcycle accidents can cause significant injuries to people and their property. Some of the most common injuries that affect their quality of life include broken bones and traumatic brain injury (TBI). However, a spinal cord injury or loss of a limb would also severely disrupt a person's life. While most motorcycle accidents result in little more than a few minor scrapes and bruises, the crashes that cause grievous personal injuries often lead to legal battles. Motorcyclists have very little protection against accidents, so injuries to their persons and vehicles prove more significant than those of automobile drivers.

What Types of Claims Arise From Motorcycle Crash Injuries? If you experience a motorcycle accident, you may file multiple claims against at-fault drivers and insurance companies. Discover some of the most common claims that arise from motorcycle accident injuries below.

#### PERSONAL INJURY

Most personal injury claims seek repayment of medical expenses. Some of these medical costs may stem from physical injuries that required:

- Hospitalization
- Doctor's visits
- Surgeries
- Rehabilitation

In addition to the amounts paid for your medical care, you could receive compensation for your pain and suffering if you win your personal injury case. Keep in mind that insurance companies usually offer low settlement amounts for motorcycle crash injuries unless you retain a veteran attorney to represent you.

#### **EMOTIONAL DISTRESS**

Many people who experience motorcycle accidents suffer from emotional trauma. This trauma can result in fear of driving, anxiety when stopped at a red light, or panic attacks when faced with circumstances like those of their accidents, among other symptoms. A competent attorney can file an emotional distress claim on your behalf if you suffer from psychological issues connected to your motorcycle collision. They can also file if you received successful treatment from a psychiatrist, psychologist, or other mental health care professional.

#### PROPERTY DAMAGE

Even if you do not suffer a significant injury during your motorcycle crash, you may still file a claim for any property damage. Most motorcycle accident victims need to spend a lot of money to repair their bikes. Other costs associated with property damage may include towing, replacing personal items, or vehicle rentals.

#### What Type of Compensation Might I Receive?

To determine the type of compensation that you might receive for your injuries, discuss your case with an experienced attorney who deals with motorcycle accidents. You should ask about previous motorcycle injury claims that your attorney has settled or litigated on behalf of other clients. A motorcycle attorney will help you navigate the claims process, assess the strength of your case, and explore which types of outcomes might be available to you. Discover the main two types of compensation for motorcycle crash injuries below.

#### PERSONAL INJURY COMPENSATION

Compensation for your personal injury claim typically involves repayment of your medical expenses. You can also recover monetary damages for past pain and suffering, emotional distress, lost wages, and future medical care or pain and suffering. The forms of compensation that remain available to you depend on the unique circumstances of your accident and the injuries you suffered.

#### PROPERTY DAMAGE COMPENSATION

Property damage claims seek compensation for damage to your bike that resulted from the accident and rental expenses while your motorcycle sits in the mechanic's shop. These claims also include injuries to personal property, like your cell phone, clothing, helmet, or other accessories. You will likely want to add any towing costs to your property damage claim.

What Should I Do Before Filing a Claim for Motorcycle Injuries? Before you file a claim for motorcycle collision injuries, you should take a few steps to strengthen your case. Among the tasks you should carry out following a motorcycle crash, gathering evidence and calling an attorney with experience are

#### **GATHER EVIDENCE**

As soon as the accident occurs, you should start gathering evidence for insurance claims and litigation. Not only will this evidence help to build your case for any injuries that you suffered, but it will also protect you against claims made by the other parties. Some of the evidence you want to gather includes:

- Dashcam footage
- CCTV surveillance videos
- Photos of the scene (e.g., vehicles, helmets, skid marks,
- Witness statements and contact information
- Medical records, bills, and receipts
- Police report and dashcam footage from witnesses

#### RETAIN REPRESENTATION

Once you reach home, you should contact a personal injury lawyer who specializes in motorcycle accident cases, even in the middle of the night. You can always leave a message with your contact details to maintain your place in line for a callback. Until you speak with an attorney, you should not communicate with anyone regarding the accident. 啦






In 1914, Harley-Davidson was only 11 years old as a Company but had already proven the value of the motorcycle as a tool for working people. By this time, the United States Postal Service was utilizing over 4,800 Harley-Davidson motorcycles for rural delivery routes, making it one of nine departments of the Federal Government using Milwaukee iron.

But it was in 1915 that Harley-Davidson sold its first Package Trucks, or the first "delivery motorcycle." The first Harley-Davidson product designed specifically for utility use, the Package Truck started one of two platforms. The first was a sidecar chassis outfitted with a wooden trunk with a hinged top or vertical back door. This was the most common platform. The other style, which was less common and shorter-lived, was a "trike" format called the Forecar, which had two wheels in the front of the

vehicle holding the cargo container and the rear half of the vehicle being a conventional motorcycle. Typically, a Package Truck's motorcycle component had a low-compression engine and a transmission designed for sidecar use to account for the extra weight.

Package Trucks were often highly customized by the businesses using them. Among other unusual variations was a container shaped like a milk bottle for a Dayton, Ohio, dairy and the well-known open rack often associated with Coca-Cola delivery vehicles. Harley-Davidson built Package Trucks until the 1957 model year. It is unknown exactly how many were built. However, production of Harley-Davidson commercial and utility motorcycles would continue through 1973 with the Servicar.

Hollywood Dave: What if I'm in an accident and I don't have auto insurance?

**Rob the Shark:** You know David, It happens, obviously you should have insurance. If you don't have insurance and you are in a motorcycle accident and you want to present a claim, you are limited by law. You fall under what the law calls a proposition 213 and you cannot get paid for pain and suffering and emotional distress. What we call noneconomic damages. However, we will always help you. Call us. Whether you had insurance or not. We will help you. You can still recover economic damages. Such as damages to your motorcycle, your medical bills, your hospital bills... We are here to help you. We are riders. You are a rider, and we will do whatever we can to help. Give us a call.

Hollywood Dave: Rob, there are a lot of personal injury attorneys, what makes a motorcycle attorney any better?

Rob the Shark: You know when an accident occurs to a rider and I read the police report. I step into their shoes. I know exactly what they are going through. I get on their bike mentally and go through the accident. Lane splitting for example, if you don't ride a motorcycle how are you going to understand what is happening in that lane split. The instincts of the rider. Split second decisions. Only a rider can understand that. And that's where a motorcycle attorney that actually rides understands, rides every day, rides to the courthouse with his suit in the saddlebag, he will come out to you, to the hospital, to your home... that's what I do. I understand and that's the advantage that we have at Shark Law over other firms who quote on quote call themselves motorcycle attorneys.

Hollywood Dave: Hey Rob, as a motorcycle attorney, have you ever been in an accident?


