







## DEAR FRIENDS

I have long considered the work of Children's Friend to be a lifeline to those we serve. The work of our staff in support of the youngest and most vulnerable children in Rhode Island certainly meets the definition of a lifeline. Our services do save lives and do create better lives for those we serve.

The COVID-19 pandemic of the last year has enhanced and expanded my understanding of lifelines, our work, and our community.

Almost immediately as the impacts of the pandemic began to set in, families we serve experienced serious food insecurity. This literally meant they did not have food to feed their families. On a daily basis, in the midst of the chaos and unknowns, our staff and supporters jumped into action. For over six weeks the staff of Children's Friend delivered over 100 meals each day to kids and families in need.

As the pandemic made it unsafe for Children's Friend to provide services in-person with our kids and families, technology became a lifeline for how we connected with one another. Email, video chats, text, phone, and social media among other means allowed us to connect, communicate, and share information with each other. Thankfully, so much of our work was able to continue in a virtual way.

As our fee-for-service revenue and billings instantly disappeared and were drastically

decreased, our community became a lifeline to us. So many of our individual and corporate friends and partners stepped up to provide support for our response to our kids and families. On a larger scale, The Rhode Island Foundation and the United Way of Rhode Island harnessed their goodwill statewide to raise and distribute millions to agencies such as Children's Friend, to continue our response to the pandemic.

This past year has been full of challenges. It has also been full of lifelines. Lifelines that we provide to those in need, and lifelines that others provide to us in our times of need. I certainly have a new understanding of and appreciation for lifelines. Both providing lifelines when able, and receiving lifelines when needed, help to make our community stronger and better.

Thank you for being a lifeline to Children's Friend and to those we serve.

#### **IVANDA'S STORY**

Ivanda worked as a Certified Nursing Assistant (CNA) until an unfortunate tragedy struck not once but twice. A severe car accident prevented her from working in a job she truly loved. When her landlord sold the building, Ivanda lost her apartment. A single mom with two young children, she was desperate and had nowhere else to turn for help. Ivanda's children were enrolled in the Children's Friend Early Head Start and Head Start programs. As a parent, she was very involved in their education. She soon began to build great relationships with the Children's Friend teaching team. She was also very excited to welcome her Family Advocate, Paty, into her home for monthly visits. Besides providing educational development support, Paty also provided Ivanda with donations of food, clothing, diapers and help with mounting utility bills.

Ivanda began to build a trusting relationship with Paty. She disclosed details about the abuse she experienced as a child, a secret shared with no one except her Family Advocate. Paty immediately connected Ivanda with various resources to receive the necessary therapy to help her cope with her feelings of despair.

In addition to her childhood trauma, Ivanda sought counseling for an emotionally, psychologically, and verbally abusive relationship with the father of her children, a man she has known since the age of 18. She reached out to her Family Advocate, who was there for her and provided emotional support, guidance, and encouragement. "Ivanda is incredibly strong," Paty said, "and has endured much hardship in her life."

Ivanda finally had the courage and support to break away from this abusive relationship. Paty helped find a safe place to land, and she moved to a shelter in Middletown, RI. In the 44

early weeks of the pandemic, this was the only place to accept Ivanda and her children. She was thankful to have a place to stay even though it was a small, one-room apartment far from her community. Paty continued to support this family during these unprecedented times, especially the overwhelming stress and depression about certain situations in her life.

Paty recommended that the family be placed on a waiting list for McAuley Village, a nonprofit organization sponsored by the Sisters of Mercy and a partner of Children's Friend. Soon after, Ivanda shared the good

news that a three-bedroom apartment had become available. Although the rental contract was just for one year, it provided her with time to regroup, gain her emotional strength, and find a job. She'd also have time to work on being independent and self-sufficient.

Needless to say, this family has experienced some challenging times during the past few years. The COVID-19 pandemic has profoundly impacted the families we serve, making already difficult circumstances all the more complicated.

Through it all, Children's Friend has been a lifeline offering comfort and support in so many ways. In helping this family, Paty received a great sense of satisfaction in the knowledge that, in some small way, she is helping to ensure the safety and betterment of someone's life.

As she affirms, "This family is one of the biggest reasons why I love my job."

# WHEN FAMILIES GROW...



**Expectant mothers and families with newborns** received home visiting services to promote and strengthen positive parent-child relationships, promote positive growth and development in children, and build strengths of families and their protective factors.

#### **JOHN AND SARA'S STORY**

Panic, Relief, Joy – these three words come to mind in describing Sara's emotions when she and her husband, John, were notified that their application was approved. After a very long and frequently draining process, they could now breathe a sigh of relief that their dream of adopting a child had finally come true. In the spring of 2014, John and Sara learned about Children's Friend through a co-worker familiar with the agency's foster care and adoption services.

John and Sara soon began to participate in TIPS-MAPP training classes, encompassing ten weeks of threehour courses at Children's Friend. Then, in October of 2014, they started the home study process, which lasted four to six weeks and involved an extensive interview process covering finances, medical history, references, and an assessment to determine whether they are willing and able to raise a child. Sara and John were primarily interested in the permanency of adopting a child. As Sara states, "I don't know what I would do if they had to take the baby away from us."

Several months had passed, and in the summer of 2015, Sara received a telephone call from Children's Friend. She was informed that a woman wanted a family to adopt her unborn child. Of course, the couple indicated that they wanted to be considered. Unfortunately, they were not chosen. Three months later, another opportunity for adopting a child became available.

Again, the couple was informed that they were not chosen. Needless to say, Sara and John were very disappointed and anxiously waited for the next opportunity, which came about one year later. Disappointment set in once again as John and Sara experienced another unfortunate setback when the birth mother reconsidered her decision and decided against adoption.

In August of 2019, Sara had a conversation with her Children's Friend Case Worker, Melanie, who asked them if they would consider becoming foster parents. "From the very beginning, Mel was our rock and would check in with us even when nothing was happening," Sara said. "Since the very beginning, she has been there for us and got me over the hump to seriously consider foster care."

Approaching two years since this couple first became involved with the adoption process, they both agreed and said, "Yes, let's do it. We need to do something." On December 14, 2019, Sara received a telephone call informing her that a one-month-old boy needed a loving and caring foster home.

Sara and John were thrilled and couldn't wait to meet their new foster

son at the hospital. Then, three weeks to the day, Sara received a telephone call from Melanie at Children's Friend, who said, "There's a little girl that was born the day after Christmas. Do you want to be considered?" The answer was yes.


This opportunity seemed different. This time, the couple was asked follow-up questions that they determined to be a good indication that they were seriously considered. On January 8, 2020, they were notified that they were chosen to be the adoptive parents of a newborn baby girl – panic, relief, joy.

Nora Hope's adoption was finalized in court on July 16, 2020. John and Sara were now both foster parents and adoptive parents to two beautiful children who are just 22 days apart in age. The happy couple is currently working towards seeking permanency for their little boy and is thankful that the longest six years of their life are now behind them.

They credit Children's Friend and Melanie with providing the framework, training, and support that was so essential throughout this entire process. In describing this family, Melanie reflects, "They are such a wonderful family who waited a very long time and through it all, demonstrated positivity, grace, and dignity." She adds, "As the saying goes, 'All good things come to those who wait."

"Our home had an awful quiet sense to it," remembers Sara when she would come home from work every day. She would put the television on just so that there would be some type of noise in the house. Sara is now thankful for the sweet sounds of babbling voices emanating from the babies' cribs. She receives great joy in hearing the laughter and happiness in her husband's voice when playing with the children in another room.

Their once quiet home is rarely quiet anymore. Gratefully, now it is filled with precious moments of young children thriving in a loving and caring environment.







#### LYNNE'S STORY

Lynne's\* three-month-old son, Ben\*, was experiencing symptoms of the common cold. A first-time mother, she made an appointment with her son's pediatrician and was then provided with saline drops to help alleviate some of her son's nasal congestion. When her Children's Friend nurse, Maria, visited her home, Lynne expressed concern that Ben's symptoms had not subsided. Maria examined Ben and heard wheezing and respiratory retractions in his upper lungs.

Maria followed up with Lynne with a home visit and, through a demonstration, instructed her how to properly use the nebulizer to distribute the medication. She attended pediatric appointments with Mom, and provided referrals, and accompanied her on appointments for an allergist, asthma specialist, and an ENT physician.

She immediately telephoned his

pediatrician and was able to schedule

a doctor's appointment that same

afternoon. As a result, he received

immediate treatment. Lynne was

provided with a nebulizer to administer

the medication to her son at home as

needed.

Originally from the Dominican Republic, Lynne has lived in Rhode Island for the past four years. She first heard about Children's Friend through a referral from the Providence Community Health Center during the early stages of her pregnancy. In October of 2018, Maria began regular bi-weekly visits with Lynne to educate her about her pregnancy. Specifically, she discussed how her

baby will grow, some common danger signs that may occur during pregnancy, what to expect during labor and delivery, and how to take care of a newborn.

When Ben was born, Maria was there to help Lynne when she experienced difficulties with breastfeeding. She visited her home and was joined by another Children's Friend nurse, a Certified Lactation Consultant. Ben responded immediately after the consultant guided and supported Lynne in breastfeeding.

The Nurse Family Partnership is a maternal and child home visiting service for expectant first-time mothers and 1,118

their newborns. This program aims to improve pregnancy outcomes by helping women engage in good preventative health practices and improve child health and development by helping parents provide responsible and competent care. The program also improves the economic self-sufficiency of families by assisting parents in developing a vision for their own future, planning future pregnancies, continuing their education, and finding employment.

Through practical education and compassionate care, Maria can improve her client's health and her client's family health. As she affirms, "My job seeks to improve access to better the quality of their lives." In light of COVID-19 restrictions, Maria can still communicate with her clients through virtual telehealth visits, telephone conferences, and text messages. She adds, "The beauty of this program is that we orient and guide first-time mothers with the tools to empower them to be the main advocators for their own children."



## WHEN WRAP-**AROUND SERVICES** ARE NEEDED.

#### **LUCY'S STORY**

Sometimes it is easy to take much for granted in our lives. Good health, a steady income, an ample supply of food, and a roof over our heads are just a few of the things that come to mind. Now imagine being so poor that you could not afford a pair of shoes until after your 15th birthday.

In 2017, Lucy\* left Guatemala and traveled to the United States in search of a better life for herself and her two children. Growing up in Guatemala, school was never an option because her parents needed their daughter to work to make ends meet. In helping her family financially, Lucy wasn't privileged to receive an education. As a result, she is still to this day unable to read or write in English or Spanish. The only skill that Lucy possessed was her ability to sew.

Upon arriving in Rhode Island, Lucy learned about Children's Friend and how this organization helps to ensure the well-being and healthy development of vulnerable young children and their families. She immediately enrolled her ten-month-old son, Eric\*, within the Early Head Start Program at Children's Friend. Comforted that her son was now in a caring and nurturing environment for learning, she was committed and enjoyed the frequent Early Head Start

home visits with her Family Advocate. She looked upon these visits as a valuable opportunity to learn more about good parenting and child development.

The Family Advocate encouraged her to read to her son. However, Lucy was concerned about her inability to read. The Family Advocate reassured her that the most important thing was to expose her son to words by simply pointing to pictures. As Eric grew older, she began to set aside a portion of the day for "storytime," an activity that soon became "family time" when her older daughter gladly helped to read to her little brother.

When Eric was three years old, mom was so excited to witness her son's ability to speak the languages of Quiche Dialecto, Spanish, and English. Research has shown that being bilingual or multilingual can have practical benefits that positively affect cognitive abilities. This improvement in cognitive

ability may help a bilingual person to process information better.

Eric's growth and progress have been remarkable. But more striking has been Lucy's development as well. Children's Friend also supported her in attaining her own personal goals. She began to make and sell tamales from her kitchen to provide for her family and secure some income. She eventually applied for and received her work permit, received her driver's license, obtained her green card, and is now a full-time employee.

Children's Friend has always been there for this family to ensure that they received all the resources and benefits of the Special Supplemental Nutrition Program for Women, Infants, and Children (WIC). Once a teenager with no shoes and no education, Lucy is now a proud mother who provides the tools necessary to have the best life possible for her children.


Friend quickly shifted to remote services to best serve our children and families, as they were the ones who have been hit hardest during this crisis, with little to no safety net.

We saw our mission at its best – being innovative and quickly adapting to serve our children and families as best we could in the safest and most creative way possible. Our teachers mastered remote learning, organizing

fun activities, readers on Zoom, and planning Spirit Days for our kids. Our family visiting staff conducted virtual home visits and made curbside deliveries of food and diapers to ensure our families have the essentials. Our WIC, Women, Infants, and Children workers ensured that over 6,000 families had uninterrupted access to healthy food and nutrition supports. Our services never stopped and were an essential lifeline to those hardest hit by the pandemic.

Salvatore and Christine Cosimano have great memories of celebrating the holidays with their two daughters, Katie and Gina. They fondly remember the happy times seeing their young daughters so excited to open their presents. They recall the smiles, laughter, and joy that this most wonderful time of the year brings to their family. Sal and Chris hope that other families, who may be struggling to make ends meet, will also experience their own wonderful holiday memories.

Unfortunately, many of the families served by Children's Friend worry about putting food on the table and wonder how they will pay their monthly rent and utility bills. Sadly, for many of these families, there is insufficient money in the budget for holiday presents. The outbreak of the COVID-19 pandemic has hit these most vulnerable children and their families the hardest.

The Cosimano's first learned about Children's Friend ten years ago when their daughter, Katie, worked at the agency. Chris was heartbroken when she heard of a family with a three-year-old girl and an 18-month-old boy. It may have changed their volunteering, but not their commitment to our children and families. A socially distant drop-off schedule was made, and the couples' extraordinary generosity, along with the help of the outpouring of online donations and Amazon wish list donations from many generous donors, helped Children's Friend provide holiday gifts for over 1,200 families.

The couple feels assured that their yearly toy and clothing donation will go directly to families who are genuinely in need. When they first started, they stored their purchases in a small closet. Now their donations spill over to two rooms that were once their daughters' bedrooms. This past year, in addition to hundreds of clothes, toys, shoes, cosmetics, and bath sets, Sal and Chris generously donated enough warm coats for young children to fill 16 trash bags.

The old adage is true – "It is better to give than to receive." The act of helping others by donating to charity improves your emotional well-being. Giving provides happiness and fulfillment for the giver because they know their kindness will benefit those less fortunate, which can be inspirational.

Simply stated, we feel good when we help others.


Harriet Ware founded Children's Friend back in 1834. Today, Children's Friend is a nationally recognized, innovative



## OFFICE OF STRATEGIC MANAGEMENT

#### The Impact of Seamless Services for Families

Due to COVID-19, 2020 brought about some of the most sweeping changes in Children's Friend's 186-year history. Amid tragedy and grief, we also found opportunities for strategy and innovation as we continued to adapt to the ever-changing situations and circumstances. Children's Friend staff have always been a core support and lifeline for those they serve, and this role is more crucial than ever during the pandemic. Following the strategic "North Star" we set in 2018 to prioritize the most vulnerable kids, all while operating in this new pandemic context, we've learned many lessons about engaging families that have changed us dramatically.

In the "new normal" of hybrid in-person and virtual home visiting and learning, with many families experiencing more vulnerability than ever, we recognize that families need seamless supports. With 19 programs and specialists across early education, child welfare, and child development, we can significantly impact a family. But our ability to do so is influenced by how easily – seamlessly – our teams can work together to create a network of support for a family.

So we asked a question: How might we seamlessly connect families and pro-

viders across our programs to offer families the supports and services they need to maximize their child's growth and development?

To answer that question, we're undertaking several innovative initiatives, three of which we'll share here:

Launch an Innovation Lab: As a coordinated effort between our Philanthropy department, Programs, and Office of Strategy Management, the Innovation Lab will support our work to gather actionable feedback from staff and families that will guide program decisions, develop new approaches to supporting families, and help us improve through learning from our shared experiences.

Keep offering virtual services: Children's Friend plans to continue offering hybrid virtual and in-person services to families even after the pandemic because we've learned that in many cases, virtual options expand seamless access to our services and collaboration across providers.

Create a Centralized Intake process for all of our programs: We are using a staff and client-guided (Human-Centered) approach to design a new Centralized Intake department that connects families to the services they need while building connections across our programs.

Starting in 2021, the Innovation Lab and the Office of Strategy Management will work with a small team to design, test, and gather feedback from families and staff on different approaches to building seamless connections at intake. In an organization with 19 discrete programs, each with varied intake requirements and goals, this is no small task. With the experience of families and staff as a guide, we will create something that meets their needs first and plants the seeds for lasting, supportive relationships.






