Ethics Education & Academic Integrity

- **SBE Integrity Talk 2024:** SBE organized two sharing sessions titled '*Ethics & Compliance*' and '*Integrity in Action: Ethics and Compliance for Sustainable Success*' delivered by Dr. Hanna Ambaras Khan, Deputy Dean (Ethics, Sustainability and Governance). The sessions emphasized ethical awareness, compliance with institutional standards, and accountability from the beginning of students' academic journeys.



- **Cybersecurity Awareness Workshop (Series 2):** Conducted by Dr. Farahdilah Ghazali to strengthen cybersecurity practices and ethical digital behaviour. The programme highlighted cybersecurity as an ethical responsibility in protecting personal and organizational data.



- **Audit Buzz Programme:** Conducted by Associate Professor Dr. Mazlina Mustapha in collaboration with Form Five students from SMK Seksyen 1 Bandar Kinrara. The students are provided with insights into the ethical responsibilities of auditors and enhanced their awareness of fraud-related issues and ethical challenges in business practices.
