# Establishing Research Excellence: Launch of the Health Humanities and Arts Research Collaborative

The establishment of HHARC marks a milestone in developing humanities research infrastructure at CU Anschutz. This innovative collaborative hosts monthly sessions fostering interdisciplinary partnerships, provides mentorship for early-career researchers, and develops novel research methodologies. HHARC has successfully engaged faculty across health science disciplines, creating a vibrant community for exploring intersections between humanities, arts, and healthcare while advancing scholarly excellence.



#### Building Community Through Strategic Partnerships: Music, Medicine, and the Arts

The Arts & Humanities program built vital partnerships to expand arts and music integration across the University of Colorado and the Denver metro area. Highlights include **Dr. Richard Kogan**'s performance and lecture on Leonard Bernstein's creativity and mental health, featuring the **Denver Young Artist Orchestra** as an opening act. We were grateful to bring music and arts programming to Aurora STEM Middle School, Compositive Primary School, the Center for Interprofessional Practice and Education, and the Office of Access & Engagement's Community Circles. We also entered into partnerships with Urogynecology and Psychiatry on the Anschutz campus, CU Boulder's CU Presents, and CU Denver's College of Arts & Media and College of Architecture and Planning for programs launching in 2025!

# Advancing Health Equity Through the Arts: Three Major Gallery Exhibitions

The Art Gallery at the Fulginiti Pavilion launched three groundbreaking exhibitions exploring intersections of health and social justice. "Raw Material: Quilts by NedRa Bonds" examined issues of gender equity, racial justice, and healthcare through textile art. "7,000 Babies" celebrated **Dr. Justina Ford**'s legacy as Colorado's first licensed Black female physician. "Recovering Secrets: The Art of Jeffrey Kent" explored the story of **Henrietta Lacks** and HeLa cells while examining critical connections between addiction, science, and structural violence. These exhibitions fostered crucial dialogues about health equity while engaging diverse audiences across CU Anschutz.

# National Collaborative on Humanities & Ethics in Dentistry

In 2024, the CU Center for Bioethics and Humanities and the **School of Dental Medicine** brought together the **University of Texas Health**, the **University of Rochester**, and **Loyola University** to form the National Collaborative on Humanities and Ethics in Dentistry (NCHED). NCHED aims to create unique and valuable opportunities for reflection, learning, and teaching on ethical issues in dentistry and to stimulate progress nationwide in using arts and humanities to improve dental practice, research, policy, and education.



#### **Clinical Ethics Ambassador Program**



#### **Ethics Grand Rounds Program**

In 2024, our Ethics Grand Rounds program made significant strides by receiving Continuing Medical Education (CME) units, enhancing its educational value. We have also seen a staggering increase in enrollment and attendance, reflecting growing interest and engagement in the topics presented. We've had the privilege of hosting a diverse array of both local experts and nationally recognized presenters, offering unique perspectives on complex ethical issues. Our topics have been insightful, nuanced, and often underdiscussed in other forums, addressing critical gaps in healthcare ethics. The program has greatly expanded its reach, attracting a substantial national audience and fostering a deeper, more informed dialogue on ethical challenges in clinical practice. This year's success underscores the program's growing influence and impact.

#### **Pharmacy Ethics**

and Pharmaceutical Sciences for the Pharmacy Ethics Speaker Series. Created by faculty and students from the School of Pharmacy and the CU Center for Bioethics and Humanities, the series explores ethical issues in pharmacy aligned with both institutions' missions. It aims to foster a community focused on addressing complex challenges at the intersection of ethics, healthcare, pharmacy, and business—while attracting and retaining pharmacy students, faculty, and early career pharmacists. Notable events included "From Prohibition to Prescription: Ethical Considerations in Medical Cannabis Use" and "Walking the thin line: Compounding Ethics of Weight Loss Drugs."

# 25th Annual Pediatric Ethics Conference: Exploring the Ethical Frontiers of Precision Medicine

On April 26, 2024, **Children's Hospital Colorado** hosted its 25th Annual Pediatric Ethics Conference, bringing together over 125 healthcare professionals to explore ethical challenges in pediatric precision medicine. With the theme "Precise but not Perfect," the event addressed issues of access, equity, affordability, and regulation. As conference organizer and CBH Elected Core Faculty **Brian Jackson, MD**, reflected, "Precision medicine is transforming pediatric care at an incredible pace, but we must ensure that ethical considerations keep pace with scientific progress." The conference remains a vital forum for navigating the intersection of innovation and ethics in pediatric care.





#### **Doctor of Public Health**

#### **Core Curriculum Development**

At the **Colorado School of Public Health**, the Center leads two consecutive seminars in the Doctor of Public Health (DrPH) Program.

#### **Innovative Yearlong Course**

Integrated seminars on structural violence and public health

- Fall: History of public health
- Spring: Applied ethics tools and methods

#### **Critical Skills Development**

Students gain historical fluency and systematic ethical reasoning capabilities essential for advancing health justice

#### **Longitudinal Support**

Center faculty serve on dissertation committees, ensuring integration of key concepts throughout students' academic journey





#### **Med-Peds Residency Program**

Launched in 2019, the two-year curriculum provides residents with essential knowledge on structural racism in medicine and incorporates competency-based learning objectives. It has evolved to focus on the practical application of this knowledge through the concept of structural competency. Consistently highly rated by residents, the curriculum fosters open discussions and equips learners with actionable skills to address racism in clinical practice. Covering topics like health inequalities, structural violence, and social determinants of health, it addresses critical gaps in traditional medical education. The leadership of CBH Director of Education **Daniel Goldberg, JD, PhD** has been instrumental in advancing this important work, positioning our Program as a national leader in integrating equity-centered education into graduate medical training.

Promoting education, scholarship, and community engagement on the lessons of the Holocaust for health care and society.

#### Learning from the Past, Leading for the Future

What happens when healers become killers? The Holocaust shows us the devastating consequences when medical professionals abandon their ethics. Here at the Center for Bioethics and Humanities, we're turning this dark history into powerful lessons that help today's healthcare workers stand strong as protectors and advocates for all patients.

#### 2024 Programs

#### **Community Outreach**

"Unraveling the Past, Confronting the Present, and Charting an Ethical Future in Medicine: The History and Legacy of the Pernkopf Atlas" brought together **Dr. Sabine Hildebrandt** and **Dr. Howard Israel** to examine the controversial anatomical atlas created during the Nazi era.

### **Lancet Commission Teacher Training Program**

Launched in 2024, this pilot for a year-long fellowship on Medicine, Nazism, and the Holocaust, invited early-career health professionals on a transformative journey through the history of medicine's role in the Holocaust. Through immersive site visits, discussions with global experts, and pedagogical training, fellows gained powerful tools to bring ethical insight into today's clinics, classrooms, and communities.

#### **2024 Annual Grand Rounds Lecture**

Our 2024 Grand Rounds featured **Dr. Sabine Hildebrandt,** an internationally acclaimed expert on anatomy during the Third Reich. Her presentation "From Healing to Killing: The Role of Anatomists in the Holocaust" explored historical transgressions while offering powerful frameworks for ensuring that contemporary anatomy education honors the dignity of body donors.

#### **How Healers Became Killers Lecture**

**Dr. Matt Wynia**'s annual lecture was followed by a discussion titled "War Crimes, Social Influence & Justice: Lessons from the Holocaust for Today," featuring **Kathrin Janzen, MA, and Hans-Christian Jasch, JD, PhD.** 

To celebrate the 75th birthday of **program founder Dr. Bill Silvers**, we hosted a gathering that brought our community together in support of the Holocaust Genocide and Contemporary Bioethics program. Friends donated \$40,000 in his honor, which Bill matched, helping to raise an incredible \$80,000 to help ensure the lessons of the Holocaust remain integral to medical education today.

# Expanding Health Humanities and Ethics Education: Strategic Growth of Graduate Certificate Program

The Bioethics and Humanities in Health Graduate Certificate Program is undergoing significant expansion, establishing an innovative partnership with the **School of Dental Medicine** and securing approval for 11 new courses. This strategic redesign created accessible pathways for professionals in health fields to engage with humanities and ethics education, including new courses addressing research methods in health humanities, moral distress, and incarceration as a structural determinant of health.



# 14th Annual CCTSI Research Ethics Conference: Exploring the Ethical Challenges of Decentralized Clinical Trials

Decentralized clinical trials (DCTs) have soared in popularity, fueled by COVID-19 restrictions and the rise of telehealth in recent years.

While DCTs offer potential benefits such as increased access and convenience for research participants, the lack of a central study location or trained staff conducting visits makes maintaining oversight far more complex than traditional trials, posing unique ethical challenges.

#### **Selected Studies**

#### Health effects of high-concentration cannabis products

Faculty: Lisa Bero, PhD

The research team conducted a comprehensive review to assess the health impacts of high-THC cannabis products and support policy development.

#### Key findings:

- THC levels in cannabis have risen significantly, prompting public health concerns.
- States are exploring regulations to manage risks from high-concentration products.
- Research gaps include inconsistent exposure data, varied methodologies, and limited standardized findings.
- Current evidence is insufficient to inform robust policy decisions.
- We developed an interactive, public evidence map to support policymakers and researchers.

#### **Addressing Bias in Healthcare AI**

Faculty: Matthew DeCamp, MD, PhD

This work highlights how AI bias stems not only from data and algorithms but also from the broader health system context.

#### Key Insights:

- Bias in AI can affect patient care and arises from multiple sources.
- Equitable outcomes require ethical, context-aware deployment—not just technical accuracy.
- Shared responsibility across all stakeholders is essential.
- Continued research is needed to identify and protect at-risk patient populations.
- Our efforts position us as leaders in advancing responsible, equity-focused AI in health care.

## RESEARCH

#### **Evidence and Influence in Federal Rulemaking**

Faculty: Rachel Topazian, PhD

This study reveals which types of evidence and communication strategies most impact federal policy decisions, providing guidance for academic institutions aiming to inform rulemaking.

#### **Key Insights:**

- Surveyed 115 former EPA regulators on evidence use in decision-making.
- Most valued inputs: legal analysis, problem scope, tech assessments, and rule impact.
- Key gaps: racial equity (16%) and financial data (30%).
- Effective comment letters include strong data (94%) and technical recommendations (90%); repetition had little effect.
- Highlights a clear opportunity for academics to fill evidence gaps and shape policy through targeted, high-quality input.

This campus group of students interested in humanities and ethics in healthcare continues to grow. Representing all CU Anschutz schools and colleges, new members are always welcome!




# Colorado Collaborative for Health Ethics and Arts (CCHEA)


