



In this period of increased antisemitism, fear, exhaustion, and angst, The Beker Foundation has sought ways to support the well-being and resilience of the Greater Boston Jewish community. "Post-October 7, there were so many needs that were acute," said

Sheri Gurock, the foundation's Executive Director. "The whole community had just experienced this massive trauma and had no place to process it."

The Beker Foundation collaborated with JF&CS and other partners to introduce Circles of Connection, an innovative, scalable initiative that increases access to mental health support by leveraging trained peers who lead support circles in schools, synagogues, and other Jewish community settings. JF&CS, with its deep mental health expertise, provides facilitators with ongoing clinical supervision. Additional collaborators include CJP's Center for Combating Antisemitism, JCC Greater Boston, GPS Group Peer Support, and the Ruderman Family Foundation.

"Having JF&CS as a partner has plugged this program into a much broader web of **mental health support**," said Sheri. "I've been impressed by their **community-driven mindset** and mission and the real desire to make this happen."
