Hello Ka-MagCoop!

It is with a warm heart that we write this message about 2022. It was a year of milestones for all of us.

First, we have opened ourselves to welcome Pinoy seafarers and overseas workers from all over the country. With approval from the Cooperative Development Authority(CDA), we are now MagCoop Multipurpose Cooperative and as such we established initial partnerships with seafarer and Overseas Filipino Workers(OFWs) manning agencies in 2022.

Second, we established a new department, Membership and Marketing. The department is in charge of our membership expansion and strengthening our brand. In 2022, our membership has grown to over 40,000 members. We have established four (4) satellite offices in Cebu, Iloilo, Davao and Cavite to help with membership expansion and take care of our current members in their locations.

Third, we have fully embarked into strengthening our IT infrastructure and continued with our digitalization project.

Fourth, we have expanded the Microfinance Loans Assistance Program (MLAP) from Manila to Iloilo, Davao and Cavite. The goal is to support the micro business owners in the communities where we are present.

Finally, we have reached out to the community of Cooperatives in Metro Manila and co-hosted with One-Cooperative Federation, The Metro Manila Cooperative Congress of 2022 that was participated by over a thousand delegates from member-cooperatives.

In 2023, we are taking bolder steps to improve our services to you, our valued members.

We are building a 12-storey building at our property in Cortada St., Ermita, Manila. This will house a bigger and better Carepoint Clinic providing pre-employment medical examinations and healthg services to members. It will also house transient home facilities on its upper floors.

We are constructing The Cabin along A. Mabini St., Ermita, Manila, beside our offices at 1010 Building.

In Cavite, we have acquired a 1,000 sqm property at Brgy. San Agustin, in the city of Dasmarinas, with a two-storey building which will be the home of our satellite office in the area.

We are dreaming big for you, our valued members, and with your continued trust and patronage, the dream will be a reality soon.

I hope that MagCoop's 2022 milestones, and bold moves in 2023 will be your inspiration to invest and patronize in our products and services, and in our efforts to expand and to grow.

Let us continue to be united in our efforts to support a profitable and sustainable MagCoop.

2022 Sequential General Assembly

The 2022 Sequential General Assembly was held last June 6, 8, and 10, 2022 via video conferencing and physical attendance.

During the three-day sequential GA, several Coop updates were announced such as Cooperative Development Authority's approval on the amendments to its Articles of Cooperation and By-Laws. This milestone opens MagCoop membership to all Filipino seabased and landbased overseas workers, their families, employees of maritime, overseas recruitment organizations and the communities where our members are present.

The Coop's performance was also tackled by Operations Manager Rommel Villasfer and reported the results of the 2021 Audited Financial Statements and the amount of Interest on Share Capital and Patronage Refund to be distributed this year. He also presented the 2022 Development and Annual Plans and Budget, which were approved afterwards by the General Assembly.

Also discussed during the GA was the digitalization project that aims to expand the Coop in terms of membership and services. MagCoop contracted two service providers, Oradian and Bankingly, in order to provide core banking system and mobile banking. Once this project is set in place, members can access their accounts at their fingertips.

The general membership also held its election and voted for five members of the board and three members of the audit committee during the assembly.

The last leg of the Sequential GA happened in June 10 and was conducted in Times Plaza Building in Ermita, Manila. This was the first limited face-to-face gathering in two years and was attended by 228 members.







New Board of Directors and Committee Members



Following the recently held elections during the 2022 Sequential General Assembly, we announced the newly elected board of directors and audit committee members.

The general membership voted for Alexander Querol, Noriela Leonidas, Capt. Joselito Navales, Syntyche De Jesus, and Joy Hernaez as members of the board. While Agnes Domingo, Arlyn Macua, and Ermelinda Diolola remained as the members of the audit committee.

The Sequential General Assembly was conducted last June 6, 8 and 10, 2022 via face-to-face gathering and online platforms.

During the organizational board meeting held last June 17, the board elected Alexander E. Querol as Chairperson and Arnold B. Javier as Vice-Chairperson.



Partnership with Manning Agencies

We have formed strategic partnerships with leading maritime companies, Zeaborn Marine Services (Philippines) and Bright Maritime Corporation. Through the signing of Memorandums of Understanding (MOUs), we have committed to providing exceptional products and services to employees and crew members.



The first partnership, established with Zeaborn Marine Services (Philippines) on September 13, 2022, marked a significant milestone. Shortly after, MagCoop also collaborated with Bright Maritime Corporation in October 2022. By conducting informative sessions before these partnerships, we ensured a better understanding of their products and services, resulting in enhanced offerings for manning agencies, employees, and crew members.

These collaborations represent significant milestones in enhancing employee benefits and services within the maritime sector and reinforce MagCoop's commitment to fostering the well-being and success of employees and crew members.

Empowering Barangay 666 Through Sponsorship of Diverse Programs and Projects

In our unwavering commitment to community development, we launched a series of impactful programs and projects to uplift Barangay 666. We launched several important programs and projects to uplift the residents in areas like education, technology, and nourishment.

One of the notable projects sponsored by us was the renovation of the Barangay 666 Day Care Center. In collaboration with Adamson University, this joint endeavor took place in October 2022. The renovation of the day care center created a more conducive and child-friendly environment for the young learners, ensuring they have a safe and comfortable space for their early education.

In addition to the renovation project, we demonstrated our commitment to education by donating a laptop and a printer to Barangay 666 in May 2022. This generous contribution provided the community with essential tools for learning and information access.

Those charged with governance are responsible for overseeing the Cooperative's financial reporting process.








PROFITABILITY (in millions)



GROSS LOAN RELEASES (in millions)






SAVINGS (in millions)





MEMBERS' EQUITY (in millions)




PATRONAGE REFUND (in millions)

CarePoint Clinic's 2022 Milestones

Our clinic and healthcare facilities achieved remarkable milestones in serving the healthcare needs of the community and the maritime industry.

Throughout the year of 2022 a total of 8,247 patients received exceptional care at CarePoint, seeking services such as pre-employment medical examinations (PEME), annual physical exams (APE), and consultations.

In the face of the ongoing COVID-19 pandemic, CarePoint played a crucial role in ensuring the safety and well-being of individuals. CarePoint performed a total of 38,546 tests. This included 28,457 polymerase chain reaction (PCR) tests, 9,572 antigen tests, and 517 antibody tests. This comprehensive testing approach allowed us to meet the needs of crew members set to go onboard ships and employees as well, ensuring a safe working environment for all.

The dedication and expertise of our medical professionals, combined with state-of-the-art diagnostic facilities, enabled us to deliver accurate and timely results. CarePoint remains committed to providing comprehensive healthcare services, maintaining the highest standards of quality and patient care.

As we reflect on the achievements of 2022, we extend our heartfelt gratitude to our patients for entrusting their healthcare needs to us.
