Most Orthodox and Catholic Monastic Orders wait until a newly baptized person has matured, served in the church for a few years, and even then include the family in the decision process to become a Nun or a Monk. Not the DKC! They immediately push newly baptized persons to be tonsured as a Nun or Monk, then immediately begin to isolate the new member from their family and friends. By severing those connections, the new member is alone and cut-off from any hope or help when they suddenly realize they have made a terrible mistake!



All of this "Brain-Washing" techniques work together and compound each other. Once the new member is alone and cut-off from any hope or help, the DKC message is that the outside world is evil! And, the DKC has now "Saved" the new member from that evil and Geronta Dionysios is the only one that can "Save" them from now on! One can quickly see how important isolating the new member from their family & loved ones is to this DKC process.

Intolerance to questions

Once the new member is alone and cut-off from any outside opinions or questions, then any doubts about the DKC teachings or methods is violently suppressed by the senior DKC leadership at each DKC site. Any evidence of resistance to the DKC program, and especially any directive from Geronta Dionysios, is met with emotional torture or physical punishment, as well as accusations of "being in league with Satan and must be attacked like we would attack Satan"!

All DKC Victims have said that a main belief of the DKC is that Georgios "Dionysios" Kalambokas is God to them. Not a representative of God, but actually God. In one scene in the Norwegian documentary on what the DKC did to a small town in Norway, one of the current DKC "Nuns" there, Sister Iakovi, (Julie Greenleaf – American) states that the Elder Dionysios, "is like God himself to us. He is our mother and our father, guiding and disciplining us." When you enter one of the DKC churches and monasteries, there are very few pictures of Jesus, but there is one of Dionysios in almost every room.

All DKC Victims have also said that every day of every week of every month of every year the Abbess or Abbot at every DKC location around the world MUST email, text, or use Telegraph or WhatsApp to "Report" to Geronta Dionysios every infraction, mistake, or comment that every one of the Nuns and Monks made at that location. In one scene in the Norwegian DKC documentary, you will see Abbess Thavoria writing one of those end of day reports. In it, she is begging forgiveness because the dinner was "late" that day and that she is over-come with shame because she let Dionysios (God) down!

Again we see how these techniques are interconnected. All DKC members, even the senior Abbesses and Abbotts must "Confess" to the Elder on a regular basis. There are documented violations of the group or leader

One of the frequent "crimes" that many DKC Victims report is contradicting or questioning a statement from Geronta Dionysios. For example, a Nun or Monk is told "The Elder has noticed that you seem distracted the last few days." And, the member answers, I am very sorry he thinks that, I am not distracted by anything." That is when the Abbott or Abbess began shouting and striking the member saying "How dare you contradict the Elder!" "You are full of the evil of the world and are attacking our spiritual father who saved you!" "He will learn what you have just said and will bring his wrath on you!" This is an example of a thousand different variations of this "mind-game" that the DKC will continually subject their members to. The result is devastating. There have been reports of DKC Nuns and Monks attempting suicide at the DKC monastery.

ALL DKC Victims report living in fear of reprisals from the DKC once they escape. They receive threats of rapists coming to find them, threats to the Victim's family, and a number of senior members contacting them and saying its ok, all is forgiven if you just come back now. 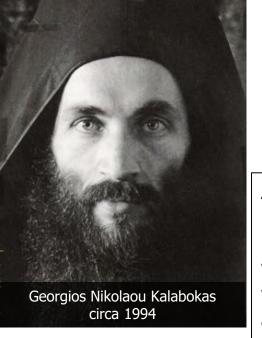
According to many DKC Victims, Here are some Warning Signs that the DKC is "Targeting" a family member or a community.

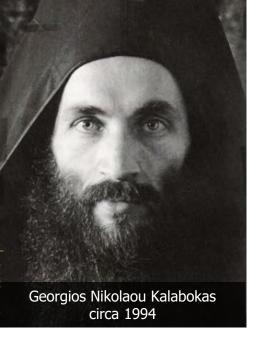

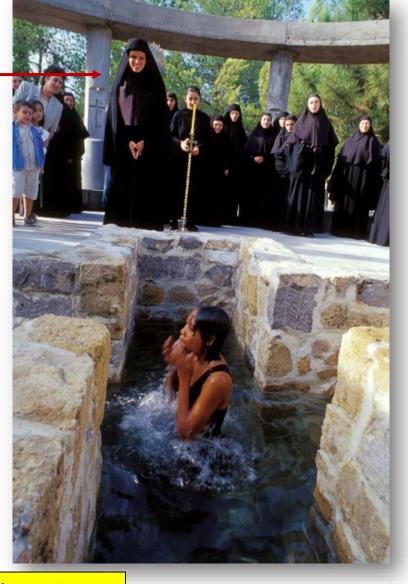

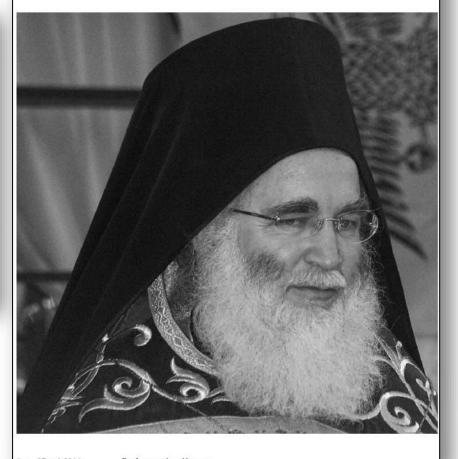


What are your thoughts on Archimandrite Dionysios Kalampokas?

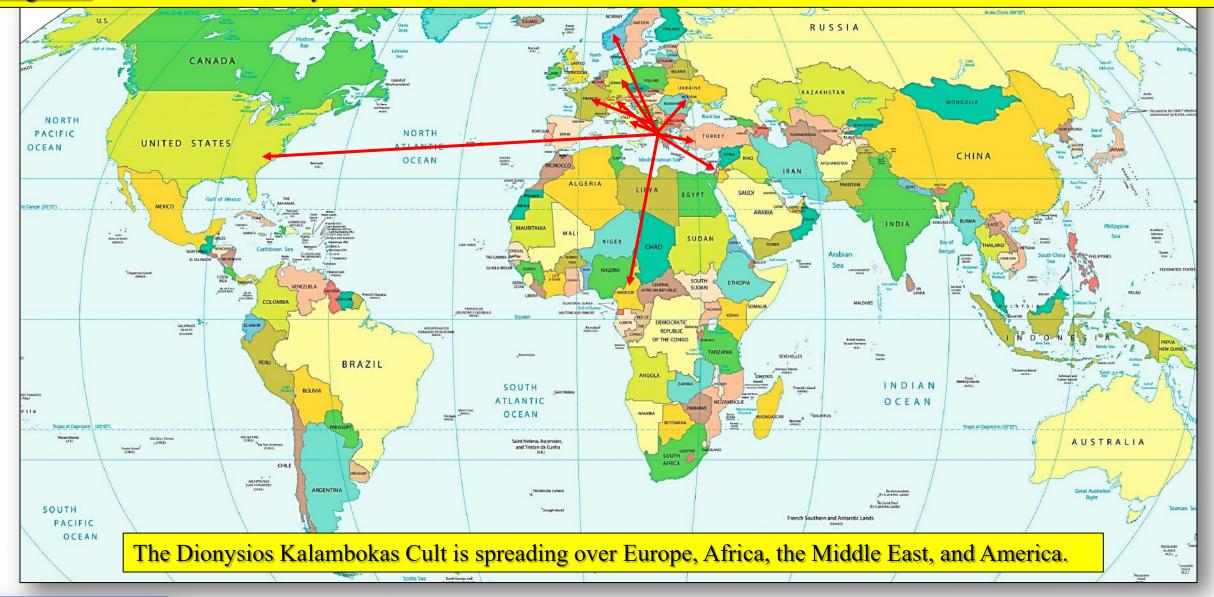


There were both men and women living at this monastery in Greece. There was not a lot of order...for example there were usually only one or two sisters in Church for the first services in the morning. Some monks and nuns stayed up all hours of the night talking and/or working. There was no silence. I never saw anyone having private prayer time. Most of the sisters were converts and tonsured very soon after becoming Orthodox without proper formation.

(As in my case as well) I know of a Mother and daughter who were there and they both left and returned to their country. One was a Great Schema nun. There was a 16 year old Jamaican girl and her mother living in the monastery. I was told that the mother had been prostituting the daughter in Athens when Dionysios found them and brought them to the monastery. They didn't attend services and never became Orthodox. The mother stayed in her room all the time and I never saw her. I know something happened with a monk in DC that was a scandal and caused them to switch jurisdictions. There was also a priest at the monastery in Greece who wasn't allowed to serve because of something that happened when they were at the monastery in Jerusalem.

Also Fr. Tom (who is now Bishop Melchizadech) was living at the monastery then but he has distanced himself from them.

I have met with and been informed about a number of individuals who have had dealings with these communities or members thereof resulting in too many unanswered questions about their recruiting methods and other activities, which have led me to this decision. I truly fear for the spiritual safety of anyone associating with these communities because of their activities and association with certain figures – non-residents of the USA.

I must be protective of the clergy and faithful placed under my spiritual care, those of all ages and at all stages of spiritual growth. Please communicate this prohibition to any members of your parish communities who have in the past had or may potentially have contact in the future with these communities. I do not believe that there is a necessity to make a public proclamation of this prohibition during liturgical services or otherwise. I do not want to create a "banned in Rome" syndrome, which very frequently led to increased sales of the banned object. I do believe that you know your individual flocks and those of your membership who might consider visiting monastic communities seeking to enhance their spiritual lives and growth, which is normally a good and positive step. You should, however, be prepared to offer them guidance about our very strong reservations and fears concerning these communities.

I assure you all of my prayers on a daily basis and I ask for yours for this unworthy soul, as well.

To Nun Taboria, Abbess of the Convent of King Olaf,

I greet you with a brotherly love in Christ and congratulate you on the Nativity and the beginning of the New Year; the present letter has been written by me with the blessing of the Catholicos-Patriarch of All Georgia:

In 2014 with the blessing of the Catholicos-Patriarch of All Georgia, a monastery and a convent were founded in Norway. Archimandrite Dionysius (Bordzikuli) was appointed Abbot of the monastery of the brotherhood, while you were appointed Abbess of the convent.

The rational motive for the Church of Georgia to found the aforementioned monasteries in Norway was to render guidance to the Georgian population living in this country; besides, because of the fact that the functioning of the Orthodox Church in this country had not been encouraged by the Greek Church, as you have told us, and neither were you willing to join the Ecumenical Patriarchate or any Orthodox Church, you asked our Church to found spiritual centers in your country.

The Church of Georgia received you under Her omophorion on one condition – that everything would be done and accomplished with the blessing of the Catholicos-Patriarch of All Georgia and the Hierarch assigned to your supervision by him(personally Las an auxiliary bishop, was assigned to fulfill this obligation). However, you have fully neglected this condition.

The baptism and tonsure of Ramzi, which were the most uncanonical and incorrect actions, is another subject for consideration (which later was the reason for the withdrawal of Archimandrite Dionysius (Bordzikuli) However, in this letter it will be suffice to dwell on the recent letters we received from the brotherhood of the monastery and point out the mistakes made in them:

1. In connection with the withdrawal of Archimandrite Dionysius (Bordzikuli), you wanted (for a certain period as you mentioned) to elect the abbot; and for this purpose, at first you chose Archimandrite Panteleimon, and

later Archimandrite Athanasius. You took action on this matter without having agreed upon it beforehand with me or the Catholicos-Patriarch, which is a complete disregard of the Canons of the Church

- 2. Apart from it, you chose both of the candidates for the post of the Abbot from the monasteries under the jurisdiction of another church. Persons serving in such circumstances do not have any right to simply serve in monasteries which are under the jurisdiction of another churchwithout our blessing, let alone fulfilling obligations of an Abbot. This is a very serious abrogation.
- 3. It is a very regrettable fact that the brotherhood of the Monastery of Saint Queen Sunniva and, as it appears, the sisterhood of the conventunder your supervision has been increased in number entirely uncanonically and this was also autocratically executed and based on the letter of Archimandrite Dionysius (Bordzikuli).
- I was only informed about it a month later, and you, not even having waited for the delivery of my letter, admitted other members into the monastery prior to my reply.
- 4. In the letter, dated by 11th August, you indicate that Archimandrite Panteleimon expected to be granted citizenship by the President of Georgia. This may be correct from the point of view of secular laws: however, the blessing and the recommendation on the citizenship of Georgia for any representative of the Orthodox Church, and more so for a clergyman who is in a close relationship with the Church of Georgia, should be received from the Patriarchate of Georgia or directly from the Catholicos-Patriarch for it is a simple rule of subordination, obligatory for everyone to observe. A similar mistake was made in the case of Mother Diodora, but it must not be repeated again.
- 5. In the second half of December of the current year, the secular persons and the clergy who arrived in Georgia did not beforehand take my blessing on the arrival, they did not even see me, neither did they contact me by phone to find out things about themselves although they knew very well that they had problems that required clarification, which is another proof of their incorrect acting without a blessing.
- 6. As we were informed by the brotherhood, two or three months ago some of their representatives were sent by them to the Ecumenical Patriarchate, with a suggestion that the monasteries of Norway be transferred into the jurisdiction of the Ecumenical Patriarchate. This also was done independently from us.
- 7. All this manifests by itself the fact that you yourself neglect the jurisdiction of the Church of Georgia and her Canons. Due to the fact that there has not taken place a formation of the Georgian parish in Norway, and the monasteries have not been officially registered as the property of the Church of Georgia, nor have we stablished the typikon for these monasteries and, apart from it, you have changed your attitude towards the



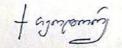
matter and seek a relationship with the Ecumenical Patriarchate, we deem this step (seeking a close relationship with the Ecumenical Patriarchate) most justifiable to be taken from your side.

The return of the monasteries of Norway into the bosom of the Ecumenical Patriarchate will let you and the Patriarchate of Georgia avoid numerous problems.

Mother Taboria, I am sending you the present letter in order to get acquainted with it and make it known to the brotherhood of the monastery, and take the proper decision.

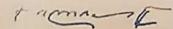

A little explanation

For three days now, information has been posted on the Internet about Mate Shengelia, a student of the second year of the Tbilisi Theological Seminary, and Giorgi Katamadze, a member of the Youth European Parliament, a student of the twelfth grade, who were caught in a big scheme by Archimandrite Dionysius (surname Kolumbokas) in Greece. Information is being spread through personal conversations that it seems that this happened entirely with the blessing of the Catholicos-Patriarch of Georgia, which is not true.

These two young men had previously visited the Patriarchate several times on different occasions. There was goodwill towards them, but the conversation on the mentioned topic never took place with anyone.

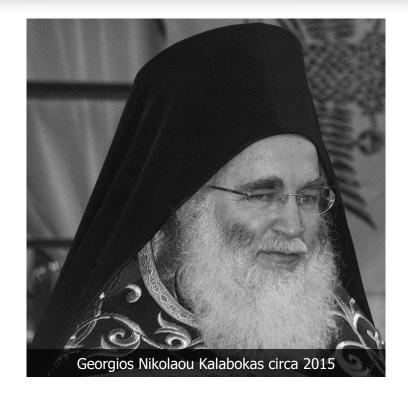

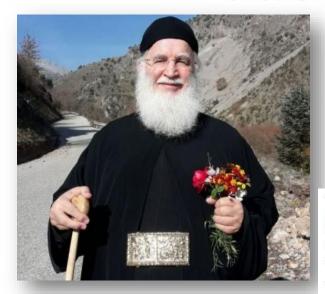

The Holy Synod of the Church of Greece deposed the former Archimandrite Dionysios Kalabokas

The Holy Synod of the Church of Greece recently imposed the ultimate penalty for ordination, that of removal from the rank of priesthood, to the hitherto Archimandrite Dionysios (real name George) Kalaboka (of the Holy Metropolis of Thessaliotides and Phanariophersalon), due to canonical offenses in which fell, restoring him to the order of Monks. The news became known through a circular of the Archbishop of Crete Mr. Eugenios (June 22, 2022) to the Monks and Nuns of the Archdiocese of Crete, which reads as follows:

The deposed priest was the spiritual father and founder of numerous monastic brotherhoods throughout the Orthodox world, two of which were in Zakynthos. The first was the male one in the Holy Monastery of Agios Georgios in Krimna and the second was the female one in the Holy Monastery of Speliotissa in Orthonion.

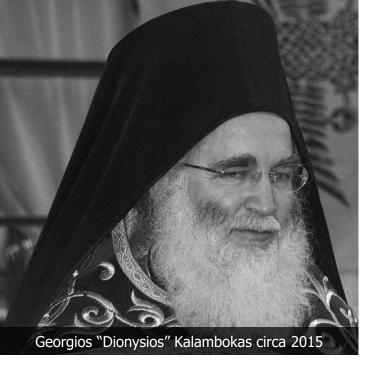
According to information from nyxthimeron.com, he himself, having contracted Covid-19 more than a year ago, was hospitalized for a long time in an intensive care unit in Greece and abroad. Today, he is in a rehabilitation center abroad, where his spiritual children take care of him, struggling to regain strength from the painful adventure of his health.

"When Elisabeth herself tells about life as she experienced it in the monastery in Greece, she refers to it as a mixture of hell and a wonderful community."

"Everything you do is reported on, she claims and says that she wrote to Elder Dionysios daily to tell them what she had done. Today, I had the wrong thoughts, I felt angry, jealous, or came too late, says Elisabeth. The Elder ended up knowing my innermost thoughts."

"When at the same time, as Elisabeth tells it, you do not receive information from the outside world, and you allegedly have no idea about the criticism that exists against the spiritual leader you can easily be controlled, she believes."

"The control is serious, it affects you so deeply, you are slowly but surely brainwashed, so that you are shielded from your own thoughts. I was not allowed to criticize Elder Dionysios. If I did, I was told that I had been listening to my demons. Then you stop criticizing. But luckily, I never stopped think these thoughts, thank goodness, Elisabeth says."

Nonne Diadora er forelagt kritikken, og svarer slik:

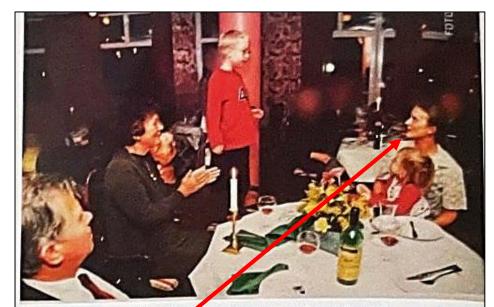

ut, mener Moestue, som roser Elisabeth for åpenheten. - Det er vanskelig utenfor å se hvordan det foregår og hvor

En kort periode bodde hun av praktiske årsaker hos en familie i Thessaloniki, fordi hun studerte teologi og skulle ha eksamen i den greske byen.

- Jeg fortalte dem at jeg ville forlate klosteret og ba dem om hjelp til å låne klær og skaffe meg en flybillett. Da sendte jeg en melding til mamma og pappa: «Jeg kommer hjem. Jeg lander på Arlanda i kveld, og da lander jeg som Elisabeth, ikke som Syster Benedicte»

Hun hadde notert en tekst som vertsfamilien skulle sende på SMS til klosteret så snart flyet hadde landet på Arlanda.

Så satt hun der, på flyplassen, i en kjole fått av vertsfamilien, med bare et pass i hånda og noen penger i en lommebok.

Den kvelden tikket det innen melding på klosterets mobiltelefon, signert Elisabeth Roest Kempemo: «Jeg har forlatt klosteret og vil ikke at dere skal kontakte meg mer.»

Det er gått 15 år siden Elisabeth kunne klemme moren og faren sin på Arlanda.

- Jeg kan ennå kjenne følelsen.

Hjemme i Sverige fikk hun psykologhjelp.

Klosteret i Thebes avviser dette.

«Klosteret i Thebes er ikke en sekt. Det tilhører kirken i Hellas, som er en kirke, ikke en sekt», skriver Diadora.

Gjennom kognitiv terapi, og deretter gjennom å ha lest seg opp om sekter og hvordan grupperinger kan fungere, har Elisabeth med åra klart å kvitte seg med skammen.

Hun håper at vi kan lære av hennes erfaringer.

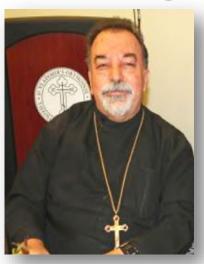

Notes/Narratives

On 07/14/16, Det. Skelley received a phone call from Det. Kelsey Ratcliffe, Carroll County Sheriff's Office concerning a sexual assault report that was made to the Carroll County Sheriff's Office. Det. Ratcliffe advised that the initial report was made to her agency; however it was determined that the incident location was in Frederick County, Maryland.

Det. Ratcliffe advised that she made arrangements for the victim to be interviewed by the Philadelphia Police Department Special Victims Unit, but has not received information that the interview has been conducted. Det. Ratcliffe advised Det. Skelley that the interview was arranged with P/O Tomekia Terry and provided her contact information.

Det. Ratcliffe further provided Det. Skelley with a copy of her initial report, which contained minimal information about a sex offense because an interview with the victim had not been conducted. The victim was identified as who resides in Philadelphia, Pennsylvania. She reported to Det. Ratcliffe that she was sexually assaulted by a priest at Sacred Monastery of St. Nina, 9002 Clemsonville Road in Union Bridge on 12/07/15. She identified the priest as Elias Bitar.

Det. Skelley will submit the initial report from Carroll County to I-leads.

On 07/15/16, Det. Skelley attempted to contact by telephone to obtain basic information relating to the sexual assault and arrange an interview with her. Det. Skelley was unable to make contact with the skelley was left for her to re-contact Det. Skelley.

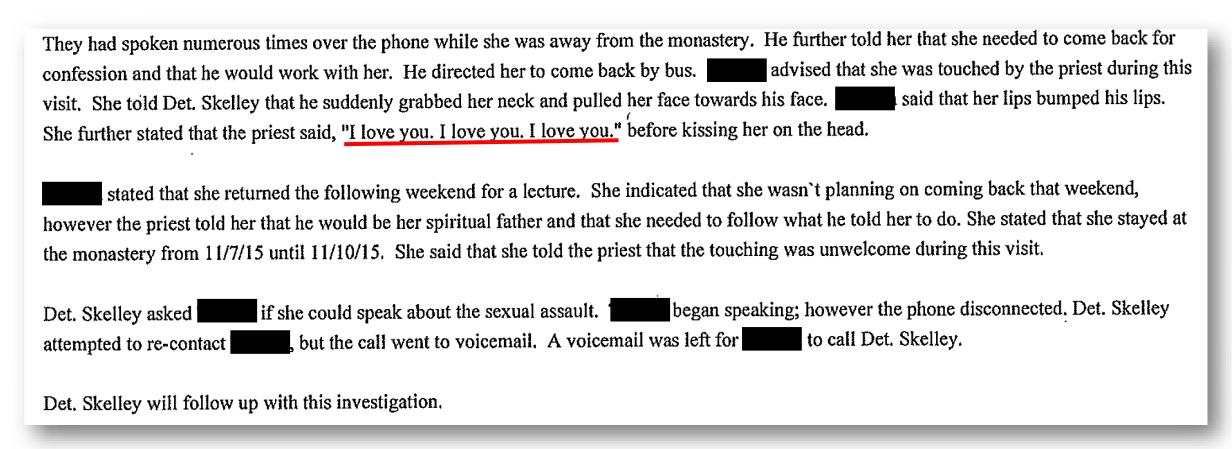

Skelley asked would try; however she would have to stop if she felt a panic attack coming on. During that phone call, Det. Skelley learned the following: was diagnosed with Post Traumatic Stress Disorder in March 2016. She sees a therapist weekly and has recently began seeing a second therapist after she began experiencing setbacks and flashbacks. She and her husband separated on 10/08/15 and she decided that she needed emotional and spiritual healing. A person familiar to her had been raving about the Sacred Monastery of St. Nina and had been going there. This to the Monastery on a Thursday, which believed was on 10/27/15. It was later learned that Thursday's friend/parishioner drove stayed at the Monastery until that Monday (11/02/15). She provided her phone number to the priest at his request. date was 10/29/15.

On 08/01/16, Det. Skelley received a phone call from Det. Edward Enriquez, Philadelphia Police Department. Det. Enriquez advised that he was given the task to interview at the request of the Carroll County Sheriff's Office. Det. Enriquez advised that he did finally make contact with on 06/27/16. He stated that he was concerned about her mental status based on the limited conversation he had with her. Det. Enriquez stated that was crying uncontrollably and no evidentiary information was learned during that conversation. He further stated that he spoke with a therapist by telephone. According to Det. Enriquez, the therapist requested that the interview take place in her office. Det. Enriquez advised that he could not do that and that it was against their agency policy.

Det. Enriquez has not received a return phone call from since 06/27/16. Det. Skelley has not received a response to voicemail left on 07/19/16 after the phone disconnected.

Based on the victim's lack of cooperation, Det. Skelley requests that this case be suspended.

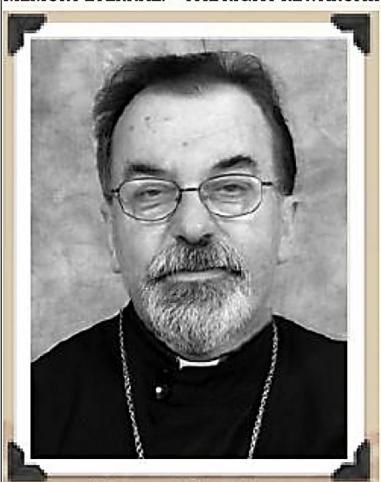

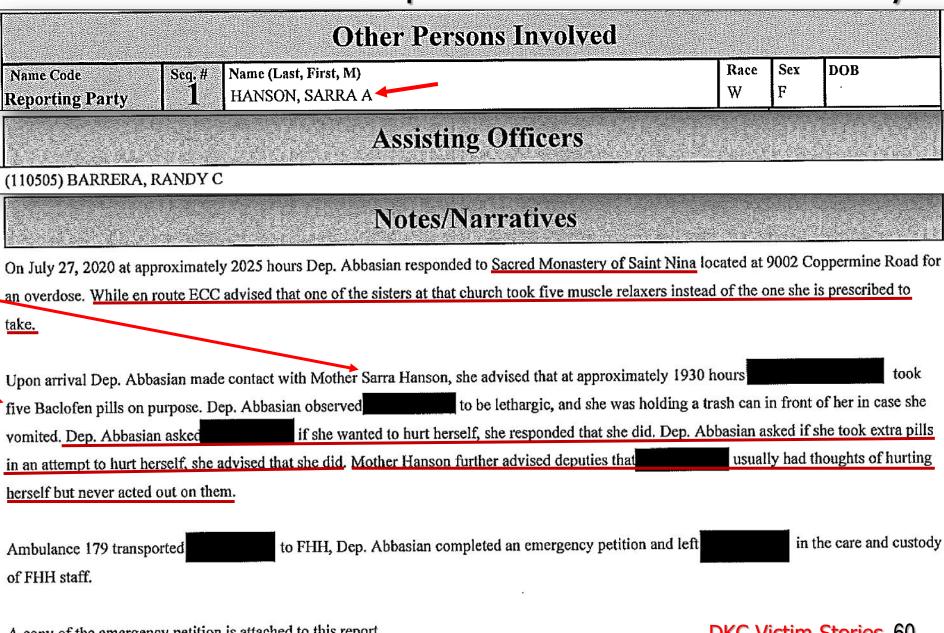

Case #2: Fr. Simeon Kharon - Part I. Background

And now we come to the second of three cases that the Synod has used against Metropolitan Jonah. When John Simeon Kharon was 13, his family emigrated from the Ukraine to the United States of America. They settled in San Francisco in 1989. Simeon traveled to Greece, met Elder Dionysios, and joined the Moni Petras Monastery in Karditsa, Greece. After three years at the Monastery, Fr. Simeon traveled to his home country of Ukraine, and then went to Russia.

According to the Special Investigative Committee (SIC) of the OCA:

In early December 2009, he meets with His Beatitude, Metropolitan Jonah in Moscow... Metropolitan Jonah invites Fr. Simeon to come to the United States. His Beatitude Metropolitan Jonah told us that he had thought that Fr. Simeon could be assigned to a parish, perhaps in New York or on the West Coast; a parish where there was a pastoral need for a Russian speaking priest.

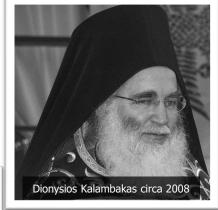
Bishop Jerome of Manhattan Participates In the Enthronement of the Newly-Elected Head of the Orthodox Church in America

From the Editors: On Sunday, December 28, 2008, with the blessing of His Eminence Metropolitan Hilarion, His Grace Bishop Jerome of Manhattan participated in the celebration of the enthronement of His Beatitude Metropolitan Jonah, the newly-elected Head of the Orthodox Church in America.



During the reception honoring Vladyka Jonah, Bishop Jerome read a congratulatory message from the First Hierarch of the Russian Orthodox Church Outside of Russia.





When Metropolitan Jonah was enthroned, dignitaries from around the world attended the ceremonies. Elder Dionysios from the Moni Petras Monastery attended the event. (Elder Dionysios is the spiritual father of five monasteries in Greece). Apparently there was discussion between Elder Dionysios and Metropolitan Jonah about the need for more monasteries on American soil.

According to eyewitness accounts of the enthronement, there was a group of monks and nuns with Elder Dionysios who had come from Greece for the event. The monks and nuns openly discussed the possibility of starting a monastery in the Washington, D.C. area.

One of the monks in attendance from Greece was Melchisedek Pleska (a former monk who had attended St. Tikhon's Seminary in America, then left for Greece and was reported to be in association with one of the monasteries of Elder Dionysios, who reappeared in America at Metropolitan Jonah's elevation, and then was suddenly elevated to the position of Bishop of the OCA.)

Another monk in attendance was Fr. Simeon Kharon.

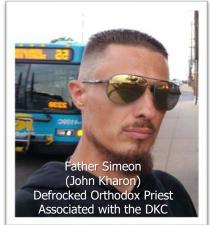
Abbot and Elder Archimandrite Dionysios was present at the enthronement of Metropolitan Jonah of OCA. Metropolitan asked him to send some monks and nuns from our monasteries in order to develop monastic life in USA. Fr. Simeon arrived in America in December 2009. He initially stayed at the Chancery. Several nuns (headed by Abbess Aemiliane) came from Elder Dionysios' monasteries, and settled in Washington, D.C. at the St. Nicholas Cathedral Rectory.

In March 2010, Metropolitan Jonah welcomed Fr. Simeon to live in the basement of the house next to St. Nicholas Cathedral in Washington, D.C., and he stayed there briefly. He then moved into an apartment and stayed there for three weeks.

According to the SIC Report:

Late on the evening of April 22, 2010, Fr. Simeon went to the apartment of J, who lived above [name withheld]. She allowed him to use her internet access code for the Wi-Fi connection. He claimed that he went to her apartment because his computer internet wasn't working. J told us that he came to her door with a bottle of "Everclear" (190 neutral grain alcohol) which he was drinking with orange juice. He asked her if she wanted to have a drink and asked for a cigarette. She did not allow him into her apartment but suggested they go out into the courtyard to smoke and to talk.





There was some conversation between them. At one point Fr. Simeon pulled out a knife to show J. He also spoke about smoking marijuana. He consistently "invaded" her space, and finally attempted to put his arm around J and kiss her. He claimed that he only put his arm on her to "say 'bravo' and pat her on the back." She pushed him away, ran to her apartment and locked the door. Fr. Simeon came back to her apartment and knocked on the door. J told him to stop or she'll call the police. Fr. Simeon replies "Maybe you f---ing should." She does call the police, Fr. Simeon returns to apartment.

The version of what took place next is based on J's testimony, on Fr. Simeon's account and on that of Police Officer Oladato. Fr. Simeon's account is confusing. When asked if he was drinking, he replied, "I may have had a shot of something." J's account was that he came to her door with a bottle of "Everclear."

Police Officer Oladato also stated that Fr. Simeon was "highly intoxicated." Fr. Simeon stated the nuns (that would include Abbess Ameliane and Sister Veronica (fellow monastics who had come from Greece and had started "Entrance of the Theotokos Monastery) had driven to the apartment with a delivery of food for him. At the same time, the police came to his door. They entered the apartment and began looking around, but Fr. Simeon rebuked them for "entering a holy place."

Loud, foul language was heard. "I'm a f---ing priest," Fr. Simeon told them. He took a swing and tried to hit a police officer. He was taken by the police and incarcerated.

The next day, he was released to Abbess Aemiliane.





Fr. Simeon confirmed that he had to make a court appearance on June 15, 2010. He appeared in court in full clerical garb and was accompanied by Abbess Ameliane and Sister Veronica. The nuns spoke to the Judge on Fr. Simeon's behalf, vouching for his good conduct. After the incident Fr. Simeon lived with the nuns at the St. Nicholas rectory for several weeks.

His Beatitude Metropolitan Jonah told the Committee that he learned about the incident around the middle of May. On May 19, 2010, he sent Fr. Simeon a letter. He "suspends" Fr. Simeon and encourages him to deal with his alcoholism.

At the end of June 2010, rumors started circulating that Fr. Simeon had raped one of the nuns. Then a rumor flew through the parish that Fr. Simeon had raped a woman back in January 2010 while Fr. Simeon was living at the Chancery.

Some accounts of the incident were inflated to surmise that 'some monk' had committed 'rape', perhaps even of the nuns. The report was conveyed to Fr. Simeon and to Abbess Ameliane. Their reaction, however, was excessive. Fr. Simeon responded with threats of bringing a lawsuit against those who spread these rumors. Abbess Ameliane's reaction was similar... Abbess Ameliane continues to stand by claims that Fr. Simeon 'never did anything to compromise his priesthood. "The nuns believed in the innocence of Fr. Simeon." Abbess Aemiliane wrote, on letterhead of the Holy Monastery of the Twelve Apostles [Red Church] of Karditsa, Greece (not OCA letterhead).

Most reverend Ignatius, Bishop of Demetrias,

I am writing to you t inform you that the police have filed charges against Theoktisti Emsley, nun at St John the Forerunner monastery in Anatoli for an attempt to bribe my lawyer. After obtainting the details of my lawyer under false pretences this morning, Theoktisti Emsley rang one hour later when I was with the lawyer in a bank and tried to influence him by offering a secret talk with Gerondissa Theodekti. She told him to suppress the charges, warned me off asking for the return of my money and from returning to Greece.

The lawyer immediately informed the police and lawyers chamber and the police filed charges againt Theoktisti Emsley.

Bribery of a lawyer under art 237 par 1 of the crimindal code in Greece carries 5 to 20 years in prison anda fine of 15,000 to 150,000 euros.

It is most regrettable that Your Excellency did not see fit to take control of the monastery before the sisters committed more crimes. In view of the seriousness of this crime and other crimes and Your Excellency s apparent inability or unwillingness to stop them, I have now publicised the charges on my blog, birdflu666. I was told by the President of the Lawyers Chamber that I am entitled to do so, and even put a copy of the charges up. I am an experienced science journalist and know about the laws of defamation.

It is time for the Orthodox Church to take the safety of its guests seriously, especially journalists investigating matters in the public interest and with a blog read around the worl. In St George, Karditsa, I was nearly raped by a priest lay name John Kharon and in St John the Forerunner, physically assaulted, nearly forcibly confined by Abbess Theodekti Vallianatou.

Since the Orthodox Church has completely failed to take action to protect me from further crimes even though you knew of the existing ones, I will explore the option of suing the church in the courts. If only a lawsuit and a fine will make you aware of your responsibilities before God and the law, then so be it. The Orthodox Church appears from my experience to be a criminal mafia and must face the law and public opinion..

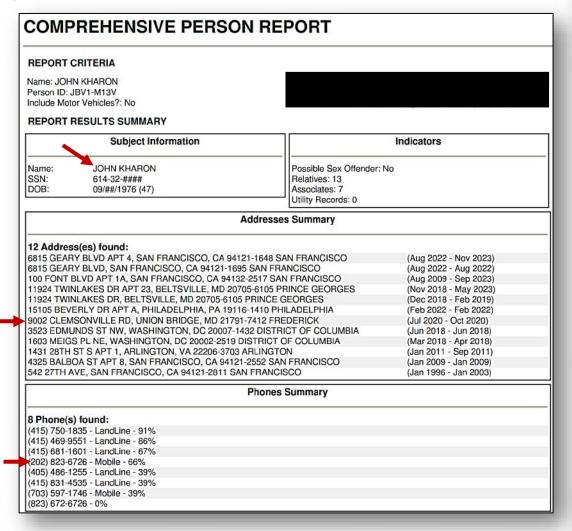

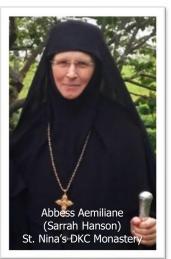

Statement from the Holy Synod Regarding the Resignation of Metropolitan Jonah

July 16, 2012

To the Clergy and Faithful of the Orthodox Church in America:

We have hesitated to release further details surrounding the resignation of Metropolitan Jonah as Primate of our Church, this in a desire to preserve his dignity and to prevent further harm to an innocent party. We did this knowing there would be appeals for additional information regarding our decision. We also harbored some hope that Metropolitan Jonah would show a willingness to accept responsibility for his actions and failures to act. However, things said and written by Metropolitan Jonah since his resignation have demonstrated that he is not accepting that responsibility.

Why did we ask Metropolitan Jonah to resign?

In slightly less than four years as our leader, Metropolitan Jonah has repeatedly refused to act with prudence, in concert with his fellow bishops, in accordance with the Holy Synod's Policies, Standards and Procedures on Sexual Misconduct (PSPs), and in compliance with advice of the Church's lawyers and professionals in expertise in dealing with cases of sexual misconduct.

The most disturbing and serious matter, indeed the final matter that caused us to ask the Metropolitan to resign or take a leave of absence and enter a treatment program, involves the Metropolitan's poor judgment in critical matters of Church governance, lack of adherence to the PSPs, and the risk of serious harm to at least one other person. While the names, dates and other details must be held in confidence to minimize the risk of further harm, we can say the following.

At some point after his enthronement as our Primate, Metropolitan Jonah unilaterally accepted into the OCA a priest known to him and to others to be actively and severely abusing alcohol, which more than once was coupled with episodes of violence and threats toward women. One of these episodes involved the brandishing of a knife, and the other the discharge of a firearm, the former resulting in the man's arrest. The man was also incarcerated for three days in yet another incident, shortly after he was accepted into the OCA by Metropolitan Jonah. While under Metropolitan Jonah's omophorion, this priest is alleged to have committed a rape against a woman in 2010.

Metropolitan Jonah was later told of this allegation in February 2012, yet he neither investigated, nor told his brother bishops, nor notified the Church's lawyers, nor reported the matter to the police, nor in any other way followed the mandatory, non-discretionary PSPs of the OCA. The alleged victim, however, did report the rape to the police. We know, too, that the alleged victim and a relative were encouraged by certain others not to mention the incident, and were told by them that their salvation depended on their silence. As recently as last week Metropolitan Jonah was regularly communicating with one of those who tried to discourage the PO Box 675 Syosset, New York 11791-0675

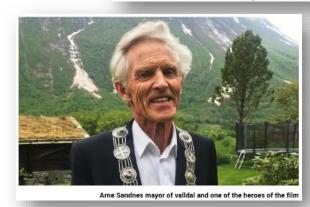

After 30 years of pursuing this effort, the Mayor is professionally embarrassed, naive, disillusioned, and weeps on camera.

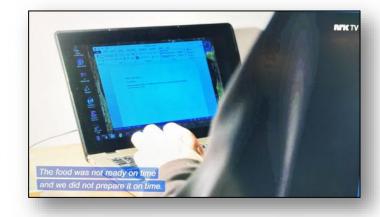




00:29:29 Abbess Tharovia recounts her conversion to become a Nun and obsession with Dionysios.

She also confessed to him that "dinner had been served late. The Sisters started it late. I went into the kitchen to "tidy them up", but it still was late when we had dinner. This never should have happened. I should not be making these kind of mistakes. Forgive me, It will never happen again."



00:39:18 Abbess Tharovia states that "The Geronta is the most important person at the Monastery. He is the main character and the driving-force of everything, even if we don't see him in front of us all the time."

Mayor Sandnes receives a document and a copy of a letter to Abbess Thavoria, St. Olav Monastery, and Geronta Dionysios stating that the Serbian Orthodox Patriarchate was expelling them from their jurisdiction and to immediately cease any claims of being associated with the Serbian Orthodox Patriarchate.

About the case

A notorious, religious Greek sect has come to Norway, and settled in the western municipalities of Selje and Norddal. They describe themselves as Orthodox, but the monasteries in Norway have been kicked out of their former patriarchate. As of today, no one in the Orthodox Church will acknowledge these.

This grouping is led by geronta/leader Dionysios, and has nothing to do with the Orthodox Church. They are referred to as a sect. To have the right to call itself an Orthodox monastery, the monastery must be connected to a patriarchate. The grouping was previously under the Georgian Patriarchate, but they have lost this connection, after a number of unforgivable and reprehensible conditions were uncovered. The letter of eviction from Georgia can be found on this page.

Far too young people are manipulated and baptized as monks/nuns, which is a direct violation both of Norwegian law and within the church. Shocking stories about various types of power are told from inside the monasteries.

We see it as our duty to inform about what is going on - right in our midst. We are a group of several people who want to put an end to this, and want their business to be documented, stopped and, if possible, prosecuted.

Most of the cases we write will be in English, because the case is of an international nature - and then it is extra important that our foreign visitors understand. If anything is unclear, contact us via the contact form. Non-serious inquiries will not be answered.
