Editor's Opinion



THE villages of Culcheth, Croft and Glazebury find themselves at a critical crossroads in 2026.

Long cherished as peaceful "outlying settlements" in Warrington, they are now grappling with an identity crisis fuelled by urban sprawl, political friction, and the relentless pressure of national infrastructure.

To many residents, the very character that makes these villages home is under siege.

The most visible battleground is the Green Belt. As of April 2026, controversy has peaked over a proposed Glazebury solar farm, which has seen staunch opposition.

While the planning officer recommends approval, locals warn of "unacceptable harm" to the openness of the countryside and potential land contamination.

This is not an isolated case; from self-build homes on Dam Lane to large-scale housing allocations in the Borough's Local Plan, there is a palpable fear that the villages are being "swamped" to meet distant housing targets, stretching doctors' surgeries and schools to their breaking point.

Infrastructure remains a "nightmare" for many.

The decline of the village centre is also a sore point. The loss of shops at the CPS Centre and its potential conversion into apartments has sparked protests, with residents lamenting the "slow death" of local

commerce and a lack of facilities for young people.

Compounding these physical issues is a breakdown in local governance. Recent months have seen the Parish Council described as a "toxic environment," marred by political infighting and calls for a Governance Review.

When the bodies meant to represent the villagers are mired in infighting, the community's voice in larger planning battles is weakened.

Culcheth, Glazebury and Croft are more than just dots on a developer's map; they are communities with deep roots.

To protect them, 2026 must be the year that local leadership resets its focus. The villages need proactive protection of their Green Belt, a revitalised centre that serves all ages and a unified front against unsuitable development.

Without this, the unique identity of these villages risks being lost to the encroaching tide of "incremental growth."

The forthcoming Culcheth Community Day taking place on Bank Holiday Monday, May 4th, on the village green is a great opportunity for everyone to get together for the good of the community.

The aim of Community Day is

to give various organisations an opportunity to showcase what they offer, while also raising much needed awareness and funds.

Let's hope our elected members can enter into the spirit of the occasion and put their differences aside and put on a united front for the benefit of the local community.

Times are tough enough without ongoing political infighting.

We need a stable community with those elected working together for the benefit of everyone.

I sense the vast majority of people have had enough now.

Finally congratulations to Croft Filters on their 40th anniversary!

Councillor opposes plans for self-build homes in the Green Belt

PROPOSALS for up to three self-build dwellings on Green Belt land are being studied by Warrington planning chiefs – together with objections from a borough councillor who claims the site is subject to serious flooding.

Cllr Matt Smith is opposing an application for permission in principle for the properties off Dam Lane, Croft.

He says the section of Dam Lane immediately adjacent to the application site is highly susceptible to flooding.

During periods of heavy rainfall, the Cockshot Brook overtops its banks in this location, rendering Dam Lane completely impassable and creating a significant safety and accessibility hazard.

The proposed development would exacerbate this existing and serious flood risk.

He also objects because of the loss of Green Belt land.

But consultants acting for the applicant say the proposals would redevelop the site in a way that

would not cause substantial harm to the openness of the Green Belt.

As such the development would not be inappropriate in the Green Belt.

The properties would contribute to the borough council's 5 year housing land supply and moreover, contribute to the council being able to meet demand for those listed on the council's self build register.

The development would also generate some economic benefits Croft village.

40 Years of Filtration at Croft Filters

WARRINGTON-based SME Croft Filters Ltd are marking 40 years in business, reflecting on four decades of growth, resilience and manufacturing of bespoke filtration solutions for diverse high-spec sectors; including food and drink, power generation, oil and gas, pharmaceuticals, and Formula One.

When brothers Mark and Neil Burns founded the company in 1986—originally established as Croft Engineering Services—they could not have predicted that their filtration business would still be thriving in 2026. Influenced by the town's strong wire-manufacturing heritage, Croft began by supplying products made from metal wire mesh.

Whilst still at school in 1988, Darren Travis joined the team as a part-time Saturday worker—a move that would prove pivotal. Through his unwavering commitment, he rose steadily through the business, eventually becoming a partner, then director.

The Foundation of Success

While the founders were ambitious, establishing the business required vital external support. Neil brought extensive experience in wire mesh, whilst Mark had previously spent nine years as a Jet Engine Fitter in the Royal Air Force.

Through Mark's military service, the Royal British Legion provided an interest-free loan of £2,500—equivalent to approximately £7,500 today—to support former service personnel in establishing their own businesses. In addition, Croft received a £1,000 grant (around £3,000 in today's terms) from The Prince's Trust now known as The King's Trust Enterprise Programme, which supports young entrepreneurs and aims to improve employment prospects. Introduced in 1983, the Nationwide Enterprise Allowance Scheme provided £40 a week—approximately £120.99 today—to the unemployed with entrepreneurial ambitions. In addition to these grants and loans, Croft received an inheritance of £3,500; this support proved vital for the directors during a period of financial constraint, enabling them to purchase essential manufacturing equipment, such as a lathe that is still used to manufacture filters today. Without this initial backing, Croft believe they might not be here today.

Innovation

Mark, Neil and Darren proved early on that innovation would be the key to the company's success. Over the years, this would take many forms; one key pioneering step was in 1997 when they secured the website domain name www.filters.co.uk at a time when the internet was only just

starting to take off.

Throughout the years, Croft have invested heavily in machinery, processes, and equipment despite their SME status, in order to deliver cutting-edge filtration solutions. One milestone demonstrating this was 12 years ago when they purchased their very first metal 3D printing machine, paving the way for enhanced filtration design and development.

From the early days of retailing mesh components in 1986 to pioneering metal 3D printing in filtration Croft's journey has mirrored the evolution of British manufacturing itself.

Leading by Example

After 38 years, founder and director Neil Burns retired from the company, leaving an ethos centred on the importance of supplying quality products and investing in the future.

Neil's profound knowledge of wire mesh and his innovative thinking paved the way for Croft's achievements over the years. His pursuit of excellence resulted in groundbreaking product innovations, advanced filtration processes and pioneering methodologies. Through collaborative research projects with academia and industry partners, Neil significantly contributed to global filtration knowledge.

A Legacy of Loyalty

Croft have a dedicated team of staff which is evident in the fact that many remain with the company for a significant portion of their careers. The firm currently have a workforce of 16 who collectively represent over 220 years of service. In the 40 years since they were founded Croft have provided over 650 years of employment with members of the team working for as long as 23 years right up until their retirement.

Investing in the future

Croft also maintain a strong focus on the future through their apprenticeship and student programmes. For over 20 years, they have supported successful apprentices in roles ranging from metal fabrication to accounts. Furthermore, by collaborating with universities and colleges across the UK and abroad, they have welcomed more than 200 students, providing them with essential hands-on industry skills.



A Blast from the Past

As Croft celebrate their 40th anniversary, they are reminiscing about the stories that still make them laugh today. One that comes to mind for many is the day an employee brought a Second World War bomb into the workshop with the intention to saw it in half and see what was inside. Used for many years as a doorstop, the device was actually live. Fortunately, a member of staff discouraged him before he proceeded to saw into it. The bomb disposal team was called, and a controlled explosion was carried out in a field across from Croft.

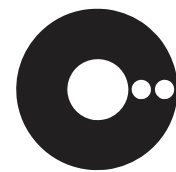

- Start applying summer lawn foods now - remember to water them in well
- Help the environment by composting as much of your garden waste as possible

Parish Meeting cancelled by independents

TWO Independent councillors cancelled what they had described as a “unique Parish Meeting” to discuss the current governance and leadership of Culcheth and Glazebury Parish Council.

Calling it an “unprecedented move” at the time, Cllrs Neil Johnson and Bernie Kingston said it would provide an opportunity for the community to make a stand, after claiming they have been blocked from even speaking at meetings.

But after Culcheth Life went to press last month they issued a public statement cancelling the meeting.

Public Statement From Cllrs Johnson & Kingston re the Cancellation of the Parish Meeting

“We are formally cancelling the Parish Meeting that we convened earlier this year in our capacity as Parish Councillors.

The request for this meeting was made by Cllr Johnson at the February Parish Council meeting and was followed up, the next day, in writing by Cllr Kingston on 11 February to ensure that arrangements could begin promptly. Under the Local Government Act 1972, Schedule 12, Part III, residents have a statutory right to a Parish Meeting, and the Parish Council has a duty to ensure that such a meeting is arranged “at a time and place suitable for the inhabitants of the parish.” The legislation is clear: Parish Meetings must be accessible, timely, and free from obstruction.

Despite this, the Parish Council Chair delayed and failed to take the basic organisational steps required in a timely manner. By 24 April 2026

(the proposed date of the Parish Meeting), almost 10 weeks will have passed since the request was first made in the February PC meeting.

The date proposed is a Friday night, a timing that is neither reasonable nor consistent with the democratic purpose of a Parish Meeting. A Friday evening meeting predictably limits attendance for residents. It cannot credibly be described as “suitable for the inhabitants of the parish” as the law requires.

Compounding this, on 19 February 2026, the Parish Council published a Q&A statement on its website that presented a partial and misleading account of the Parish Meeting process. Rather than offering neutral information, the document framed the meeting in a way that discouraged participation and cast doubt on its legitimacy. This is not the role of a Parish Council, which should support—not influence—the statutory rights of residents to assemble and speak.

In addition, the potential presence of security personnel at the meeting raised serious concerns about the atmosphere residents would face on arrival.

Parish Meetings are intended to be open, welcoming, and community-led. The possibility of security being stationed at the door risks creating an intimidating

environment for those wishing to attend, particularly for residents who may already feel hesitant about speaking publicly.

These issues cannot be separated from the wider conduct that has characterised recent Parish Council meetings. If the behaviour displayed by the Chair and several Councillors in recent months were to set the tone for the Parish Meeting, residents could reasonably expect further examples of the hostile and discouraging environment that your Independent Councillors have endured. This has included dismissive comments, personal remarks, and behaviour that has made constructive participation extremely difficult. No Parish Meeting should take place under conditions that risk replicating such an atmosphere or deterring residents from speaking freely.

The Parish Council have also attempted to apply unfair and disproportionate costs to the organisation of the meeting and more importantly, a Parish Poll that may follow.

Parish Meetings are a statutory right of the electorate, not a discretionary event. To discredit the convening of a Parish Meeting on the basis of potential costs undermines the process of residents seeking to exercise their rights and contradicts both the spirit and the letter of the legislation.

Alongside these concerns, residents have now completed a petition for a Community Governance Review (CGR). This will

trigger a formal process conducted by Warrington Borough Council, which is transparent, open, and independently managed. A CGR provides a structured and impartial route for examining governance arrangements, ensuring that residents’ voices are heard without the barriers, delays, or pressures that have characterised the handling of this Parish Meeting.

Taken together—the delay organising the Meeting, (almost 10 weeks will have passed), the publication of a biased Q&A by the Parish Council, the attempt to undermine the process based on costs, the likelihood of reduced resident capacity due to external attendees, the potential presence of security, and the wider pattern of conduct at recent council meetings—the process has been neither democratic nor transparent. It has not met the statutory requirement to support open participation by the parish electorate.

Given these circumstances, we cannot endorse a meeting arranged in a manner that restricts attendance, misinforms residents, and undermines the democratic intent of the law. We therefore withdraw our original convening request and will not proceed under the conditions imposed.

We remain committed to open, accountable local governance and to ensuring that residents have fair, accessible, and lawful opportunities to participate in parish affairs.

Council checking criteria for Parish Council Governance Review

WARRINGTON Borough Council has confirmed it has received a petition for a Governance Review at Culcheth & Glazebury Parish Council, and is now studying the petition to see if it has met the necessary criteria.

More than 650 local residents have signed up to a formal request for the Borough Council to undertake a Community Governance Review in the Parish, after local Independent Councillors Bernie Kingston and Neil Johnson assisted with the collection of signatures.

Cllr Johnson travelled to Warrington Borough Council's offices in Times Square to submit the signatures and the formal request in person.

He says it will afford local people the chance to "decide their own futures" and aims to put an end to "the culture of secrecy" surrounding the Parish Council.

Cllr Neil Johnson said: "I am pleased to report that the requisite number of signatures has been collected to begin the process of a Community Governance Review in Culcheth and Glazebury.

"This is something that residents have been calling for for some time.

"A Community Governance Review is a legal process where the Borough Council can review how people are represented. As well as the Parish Council, reviews can also consider electoral arrangements, such as the number of councillors and individual warding arrangements in parishes.

"The process should be transparent, open, and independently managed. A Community Governance Review provides a structured and impartial route for examining governance arrangements, ensuring that residents' voices are heard without the barriers, delays, or pressures that have characterised the current management of the Parish Council.

"A full consultation will follow, and residents will have the opportunity to make proposals

for how the governance of our local area might change. Options available include the dissolution of the Parish Council in its current form, in the event that enough people feel strongly enough".

Cllr Johnson added: "Kick-starting a Community Governance Review is a landmark moment. More than 600 residents have signed the petition to commence the process, which is now in the hands of the Borough Council solicitor. I will be urging the Council not to delay, but to act quickly to get this consultation fully underway.

"As your independent voice, I am committed to ensuring that democracy is put back into the hands of the people. I want to see an end to the culture of secrecy, the lack of transparency, and the constant safeguarding of vested interests that characterise our Parish and Borough Council. I will be on hand to discuss and assist all residents with the submissions they make to this Review.

"This is our chance to decide our own futures. Let's make the best of it!"

A Warrington Borough Council spokesperson said: "We have received a petition for community governance review for Culcheth and Glazebury Parish Council and are currently checking that all the criteria is met. Once agreed, we have to draw up terms of reference and publish them. The Terms of Reference is a prompt to local consideration, initial discussions and the exchange of ideas in a review, which will in turn assist the council to prepare draft proposals. We have one year to complete the review. As part of this, a full consultation takes place, involving parishes, ward members, local stakeholders and residents. Given

that there is a Boundary Review taking place it is likely that any review will be deferred until that is complete in accordance with Boundary Commission guidance.

"A Community Governance Review can be triggered by a petition presented to the Council. For a petition to be valid, certain conditions need to be met. For areas with more than 2,500 local electors, the petition must be signed by at least 7.5% of them.

"A review deals with matters including naming, mergers, alteration, abolition, and electoral arrangements. This is to make sure

that local governance is effective and convenient, and that it reflects the identities and interests of local communities. A review generally deals with structural issues and does not deal with dissatisfaction with the operational decisions of a Parish Council and its members, which are more appropriately dealt with through the electoral process and engagement with the Parish Council and its auditors."

Culcheth & Glazebury Parish Council was also given the opportunity to respond to the call for a Governance Review, but as yet none has been forthcoming.



Solar Farm plan approved despite opposition

CONTROVERSIAL plans for a solar farm on Green Belt land at Glazebury have been approved despite more than 40 objections.

Planning officers at Warrington recommended the scheme be approved when was considered at a meeting of the borough council's development management committee.

The scheme involves two agricultural fields at Duckinfield Farm, Hurst Lane, Glazebury.

The scheme would require the laying of an underground cable to Culcheth, crossing Jibcroft Brook and a number of fields before joining Fowley Common Lane and the A574 Warrington Road and then following Culcheth Hall Drive, Lodge Drive and Ellesmere Road to where it will link with an existing substation.

Access to the site would be via Hurst Lane, which also provides access to Hurst Hall Farm, a small residential development, Glazebury CE Primary School and Glazebury Cricket Club.

Larger construction vehicles would be able to access the site via a level crossing on the nearby railway line, however.

Cheshire Archaeology Planning Advisory Service has warned about the possible impact on the Tudor origins of the adjacent Hurst Hall Farm.

The solar farm would consist of rows of solar panels, either fixed in place or tracking the movement of the sun. It would have an operational life of 40 years, after which it would be returned to agriculture. During its life, it would still be available for grazing sheep.

A public footpath crosses the site which would be subject to management measures to ensure the safety of users.

Landscaping would be carried out, including planting, to screen the solar farm from public viewpoints. Existing trees would be retained and enhanced. Minimal waste would be produced by the development and there would be unlikely to be any significant noise impact.

But Planning officers said the proposal is considered to use "Grey Belt" land and would not be inappropriate development in the Green Belt.

The loss of agricultural land and landscape harm are considered to be outweighed by the environmental

benefits of renewable energy and the impacts of the development on the local highway network including public rights of way are acceptable subject to conditions.

There would also be no unacceptable harm to residential amenity.

Attracting wildlife into your garden

AN enlightening presentation on attracting wildlife into your garden was given by George Pilkington at the monthly meeting of Croft WI.

George has had a passion for wildlife since his childhood and after serving 20 years in the police force he left to study for an MSc in Countryside Management (Cert. Ed). He now designs wormeries, bumble bee and solitary bee nest boxes as well as teaching children and special needs adults about looking after wildlife in our gardens.

George focused his talk on feeding wild birds as this is a subject currently in the news. This April the Royal Society for the Protection of Birds (RSPB) issued new guidance on the use of bird feeders during the summer months 'Feed Seasonally Feed Safely'. The guidance is to pause filling bird feeders with seeds or peanuts from May 1 to October 31.

Small amounts of mealworms, fat balls or suet can still be put out for the birds but there should be plenty of insects, seeds and fruit available for birds to find in the garden at this time of year.

From November 1 to April 30, seeds or peanuts can be used in bird feeders. The best seeds to use are black sunflower seeds, sunflower hearts, nyjer seeds and crushed peanuts as these are mineral and oil rich. (Mixed seed may contain a lot of wheat which has a lower nutritional value).

George explained that these measures are designed to stop the spread of Trichomonosis, a highly contagious disease caused by a protozoan parasite. It is causing a massive population decline in garden birds such as Greenfinches and Chaffinches. The birds appear fluffed up, lethargic and have difficulty swallowing food due to throat lesions - leading to death by starvation. The disease can be spread by pigeons but also via contaminated food or water at feeders.

Water for birds should be changed every day and George recommended using a plastic paint roller tray as a birdbath as it has a sloping surface and can easily be washed and dried. Bird feeders should be cleaned weekly and left to dry before refilling. He also suggested moving feeders around the garden so that mess

doesn't build up in one place. Last summer the RSPB stopped selling bird tables and hanging tables because the parasite can survive in any mess that accumulates on the tables.

Anne Lamming gave the vote of thanks to George for such an informative and topical presentation.
