Abbeville Spring Festival's main weekend begins Thursday evening

The main weekend of the Abbeville Spring Festival is coming up, providing the finale to an event which is celebrating its 40th anniversary.

Through the years, the festival has had a tried and true formula of music, food, and crafts, and this year is no different.

The evening of Thursday, May 12, will provide a welcome to the fun, with food vendors and amusement rides on duty from 5 p.m. to 10:30 p.m.

Jackson Station will take the main stage at 6 p.m. and at 8:30 p.m. Rhythm Muscle will play until 10:30 p.m.

The festivities will continue on Friday, May 13. Arts vendors will be on hand from 1 p.m. to 9 p.m., and a garden club flower show will be held from 4:30 p.m. to 6:30 p.m.

Food vendors and amusement rides will be present from 5 p.m. to 10:30 p.m., and the entertainment will continue.

On the main stage, ELO-VEation will be performing beginning at 5 p.m., Dance Dynasty at 7:15 p.m. and Flashback the Party Band at

8:30 p.m.
On the acoustic stage, Pope and Bert will perform beginning at 6 p.m., and Tracie and

Byron at 7:30 p.m. Saturday, May 14, will provide the festival's conclusion, with a Kidzone on Washington Street from 9 a.m., to noon, and a car show on North Main with the same

Saturday will be the last day for the flower show, whose hours will be 10 a.m. to 4 p.m. Arts vendors will be on hand from 10 a.m. to 9 p.m. and food vendors and amusement rides will be on hand from 11 a.m. to 10:30 p.m.

Two Brews will host a doughnut eating contest at 10 a.m., and the entertainment will be going full blast.

The Westwood Elementary School chorus will take the main stage beginning at 12:30 p.m.

The Phoenix Academy of Arts will take the main stage at 2 p.m., followed by the First Ladies of Honkeytonk beginning at 4 p.m., the Trevor Hewitt Band at 6:30 p.m. and Jim Quick and Coastline will close the festival with a performance starting at 8:30 p.m.

About the music

City of Abbeville special events coordinator Emily Bledsoe and community development director Austin Walker provided information on the musicians scheduled to perform.

Voters to go to polls for referendum

Voters in the Abbeville County School District will go to the polls on Tuesday, May 17 for a referendum in which District voters will be asked to fund improvements at the District's two high schools and at the Abbeville Career Center.

The referendum will consist of two questions:

Question 1 is as follows: "Shall the Board of Trustees of Abbeville County School District be empowered to issue, at one time or from time to time, general obligation bonds of the School District, in a principal amount of not exceeding \$43,800,000, the proceeds of which will be used for the following:

"Dixie High School: --"Constructing, equipping,

and furnishing a new academic wing.

--"Constructing, equipping and furnishing a new kitchen and dining room; and

--"Appropriate demolition

"Abbeville Career Center --"Construction, equipping and furnishing additions, improvements and repairs?

"Question 2 is as follows: "If and only if Question 1 above is approved, shall the Board of Trustees of Abbeville County School District, South Carolina be empowered to issue, at one time or from time to time, general obligation bonds of the School District, in a principal amount of not exceeding \$11,900,000, the proceeds of which shall be used for the following:

"Dixie High School:
--"Constructing, equipping

and furnishing new locker rooms and gymnasium

-- Constructing, equipping and furnishing new track"

Abbeville High School
-- "Constructing, equipping and furnishing new locker

rooms and gymnasium
-- "Constructing, equipping
and furnishing new track?"

Abbeville County School District Superintendent Dr. Mason Gary spoke at a community meeting in Calhoun Falls on Tuesday, May 3, to help educate the public about the referendum.

At press time, he was scheduled to speak on the same topic at Dixie High School on Thursday, May 5. He is also scheduled to speak tonight at Grace United Methodist Church in Abbeville on May 11 at 6 p.m.

Council seeking more transit funding

Abbeville County Council met Monday night and agreed to apply for an SCDOT grant of up to \$150,000 to continue to operate a public transit system here in Abbeville County.

Following an executive session, Council came back into open session and Councilman Jason Bonds made a motion to authorize the County Director to apply for the SCDOT/ OPT public transportation contract, utilizing South Carolina state mass transit funds, and to designate the McCormick County senior center and McCormick area transit as the public transportation provider for Abbeville County, accord-

ing to Clerk to Council Lynn

Sopolosky.

This was seconded by Councilman John Calhoun, and it passed unanimously, Sopolosky said Tuesday.

Earlier in the meeting, UCMAC executive director Bill Boone and Becky Powell Moon executive director of McCormick Area Transit had spoken about the Abbeville Public Transit Systems future.

Moon noted that the current funding source under which the Abbeville County transit system has been operating will expire in December.

She asked that County Council apply for new funding from SCDOT to keep the system going

the system going.

They were accompanied by Keith Scott, who is originally from Abbeville and

who is retired from working

with the City of Anderson. Scott is the son of the late Sandy Scott, who achieved fame as an AHS band director.

The County could be matching up to \$150,000 over the three year period of the grant, said Abbeville County Director David Garner Tuesday.

Abbeville County, Green-wood County, and McCormick County have applied for the Barrett Lawrimore Award, which honors regional cooperation among local governments in South Carolina, Garner said.

They did this in recognition of their collaboration in bringing public transit to the three counties.

The award winner will be announced this summer at the Association of Counties conference.

Morgan promotes community health

Amanda Morgan had a question for Abbeville Rotarians that she was speaking to recently.

What is most representative of determining how long you will live?

Is it your body mass index, or your genetic makeup, or your zip code?

If you answered "zip code," then you were right on target.

And that is in large part the reason Amanda is in public health today. It was, in her words, "why I dedicated my life to community health."

Specifically, she works with Abbeville Area Medical Center, where she is the Director of Community Health, Wellness and Outreach, and she is serving at a particularly challenging time today.

"We are dealing with the aftermath of COVID," she told Rotarians.

The pandemic has left aftereffects that linger in a particularly painful way.

One of them is food insecurity. Abbeville Area Medical Center has begun distributing food, on various designated dates, and the great majority of recipients appear to be senior citizens.

About 2,700 boxes of food have been distributed since March.

And during the pandemic itself, the hospital launched a COVID testing program--something that AAMC was not specifically mandated to do, but did so as a public service, with the medical personnel testing people in addition to their regular jobs.

Morgan, who writes grants to provide for various programs, said the hospital is renovating a building on the AAMC campus to be a

community resource center to promote things such as digital literacy.

Then there is the Best Chance Network, which provides cancer screenings for women who might not otherwise be able to afford them--a Network which AAMC is helping to coordinate.

The hospital is also helping to bring the Dolly Parton Imagination Library to the Abbeville area--a project promoting literacy among young people.

There is also a program to help people with chronic diseases such as diabetes and hypertension, to ensure that patients make healthy choices to keep those diseases in check.

"I'm about helping people help themselves," she told Rotarians.

School board has budget workshop

The Abbeville County school board had a budget workshop last night in preparation for the budget for the 2022-23 fiscal year.

The District receives much of its revenue from the state, and how much revenue it will get for the coming fiscal year is dependent on the state budget for 22-23, according to the finance director, Abbeville County School District finance director Roni Scott said recently.

That state budget is still being determined, with the House and Senate at press time having different versions, according to Scott.

State Rep. Craig Gagnon said Tuesday that he expects for the House and Senate to ultimately form a conference committee to work out the difference.

The conference committee version has to be voted on by both Chambers, and the Governor will have it, and will have a certain amount of time to veto any portion he does not like.

The legislature, Gagnon expects, will have to come back into session to review the vetoes, and this will probably be in June before the fiscal year starts in July.

First reading on the School District budget is slated for the school board meeting in May, and second reading, along with a public hearing, is scheduled for June.

It appears that the state will give the District one million dollars more than it gave the District last year.

The state had an excess of over two billion dollars, and they allocated \$200 million to school districts

throughout South Carolina. The budget for the coming fiscal year for the School District is slated to be approximately \$28 million.

The extra money from the state will potentially be used for salary increases for District employees, she said.

County budget for 22-23 moves forward

A proposed Abbeville County budget for the coming fiscal year took a step forward Monday night, thanks to action by Abbeville County Council.

County Council had a public hearing and passed second reading on a budget ordinance for 2022-23. Abstaining were Council members Jason Bonds and Drew Simpson.

"I'm not against it," Bonds said Tuesday concerning the budget. "I just want to have time to read it thoroughly."

The proposed budget will include a tax increase of just short of three mills, said Abbeville County Director David Garner Tuesday.

The 22-23 fiscal year begins on July 1 of this year.

Expressing concerns during the public hearing on the budget Monday night was Mack Beaty of Abbeville, who talked about issues ranging from the need for the county to purchase new software for certain things to the impact of various fees.

Certain pieces of software relating to tax assessment and finances do not communicate with each other, so that the data from one is not seamlessly shared, Abbeville County Director David Garner said Tuesday. Ann Davis, president of the Greater Abbeville Humane Society also spoke during the public hearing, expressing concerns about the Abbeville County animal shelter. Among those concerns was that of record keeping for the animals.

She also called on the county to pay the animal shelter employees more.

Council had a public hearing and passed third reading on a fee in lieu of taxes agreement for what had been called Project FOAM. It is now revealed as a company called Aerofoam, which is based in Dubai.

The company manufactures closed-cell thermal insulation material for condensation control in air conditioning, refrigeration, and chilled water installations, according to the company Website.

The material is also suitable for reducing thermal losses in heating and plumbing systems, according to the Website.

It could bring \$11.3 million in capital investment and as many as 50 jobs to the county, and it would be housed in the county's spec building, which would be "upfitted" to accommodate the new industry. The spec building is located at Lakelands Commerce Center on the outskirts of Abbeville. More details about the industry are expected in coming weeks.

During the public comment period for the ordinance, Mark Warner, economic development specialist for Abbeville County, praised the project as a good one.

Council passed resolution authorizing the County Director to enter into a contractual relationship with Palmetto Posting, Inc., of Spartanburg, South Carolina, for the posting of delinquent tax notices.

Council passed a resolution authorizing the County Director to enter into a purchase agreement with Atlantic Emergency Solutions for the purchase of one ambulance not to exceed \$265,180.

Council approved a proclamation recognizing National EMS Week and to honor the men and women who serve Abbeville County.

Council went into executive session to discussion personnel and contractual matters.

Before the Abbeville County Council meeting Monday night, there was a meeting of the County Transportation Committee, which allocates funds for various transportation projects, using money allocated from a state fuel

The members of the Abbeville County Council and the County Transportation Committee are the same.

The SCDOT requested \$422,245 for necessary improvements to Marion Street, Horne Drive, and Ferguson Road, and the CTC agreed.

Abbeville County Roads and Bridges Department requested \$250,000 for road materials such as gravel, crusher-run, pipe, and other material for maintenance and rehabilitation projects throughout the county, and the CTC agreed.

Abbeville County Public Works Department requested \$180,000 for construction of road access to the Diamond Hill and McIlwain fire department stations, and the CTC agreed.

AAMC tackling 'chronic care'

Center has launched a chronic care management program, according to AAMC's Amanda Morgan.

Chronic care management refers to any care provided by medical professionals to patients who have chronic diseases and conditions, she said.

A disease or condition is chronic when it lasts a year or more, requires ongoing medical attention or limits the activities of daily life.

Examples include diabetes, hypertension, obesity and cancer.

Abbeville County has a population of 25,000, and based on statistics, slightly more than 6,000 have multiple chronic diseases.

The goal of the AAMC program is to help patients achieve a better quality of life through the management of their conditions, according to Morgan.

are outside of face-to-face patient visits," she said. "One of the most important aspects of chronic care is documentation and an extensive electronic health record.

"Many patients who have chronic conditions see multiple care providers; a detailed electronic record is essential to facilitate optimum care."

In the AAMC health care system, as many as 2,000 patients may be chronically ill, she indicated.

Abbeville Area Medical Center is involved in other endeavors as well:

--AAMC is in the process of establishing the Dolly Parton Imagination Library in the Abbeville County area, Morgan told Abbeville Rotarians Thursday.

Dolly Parton's Imagination Library is a nationwide book gifting program that mails

"Chronic care manage- free, high quality books to ment provides services that children from birth to age five, no matter their family's income, according to the program's website.

Morgan is hoping to get the program off the ground no later than June 1.

The program was launched in 1995.

--Since March, 2022, food distributions have provided for the giving away of 2,794 food boxes, equal to \$98,310 worth of food and 41,910 pounds of food.

"We've had five (food distributions) so far," Morgan said Friday.

-- The mobile COVID testing outreach team tested 8,062 individuals between June 1, and Dec. 31, 2020, and 4,477 people between Jan. 1 and Dec. 31, 2021, and 1,432 people between Jan. 1 and March 31, 2022, for a total of 13,971 people

CF mayor injured in attack Wednesday

Calhoun Falls Mayor Terrico Holland was injured in an attack, according to an Abbeville County Sheriff's Office news release.

Deputies were dispatched Wednesday to a residence in the Burton Drive area of Calhoun Falls, outside the town limits, in reference to an assault.

Upon their arrival, it was determined that Holland had been assaulted.

"He did sustain injuries from the assault, after he was hit several times with a metal chair," according to the press release.

Subsequent to the investigation, the suspect was identified as 25-year-old Jonah Trayvon Wilson of Calhoun Falls.

On Thursday afternoon, an arrest warrant was obtained on Wilson for assault and battery, second degree.

Wilson was located and arrested, and as of press time, bond information was unavailable.

What's at stake

Superintendent Dr. Mason Gary explains goals of May 17 referendum

By Henry E. Green "The timing couldn't be worse."

Abbeville County School District Superintendent Dr. Mason Gary admitted, with those words, that the referendum coming up on May 17 is set against a backdrop of galloping inflation--the worst in 40 years--and people struggling to make ends meet.

However, the Superintendent will tell you that the people of Abbeville County can invest now or they can invest later, but they will have to take action at some point in the future to bring District facilities up to standard.

"2022 dollars are as cheap as we're going to have," he

Dr. Gary noted that after he arrived in the School District two years ago, he embarked upon a capital improvement plan, with an eye toward cataloging the improvements that needed to be made to District facilities.

"I went into every building (of the District's schools)," he said.

With his fact-finding tour under his belt, the Superintendent took action.

"We created a phased capital improvement plan," he

said. "We have completed over 25 projects."

All the projects in phases one and two but one have been completed.

The third phase includes improvements to be funded by the referendum.

The District is going to find out how the public feels. "The voters are going to tell us," he said.

The centerpiece of the referendum would be the construction of new academic wings at the two high schools--Dixie and Abbeville.

Each of the new buildings would be two-story. Both campuses, he explained, are "landlocked," and there is not much room to expand--hence the plan for two-story academic wings.

He dispelled a rumor that the District actually is planning to have consolidation through the back door, moving Dixie facilities to the AHS campus.

"Consolidation is not what I'm trying to do," he said.

The bottom line is that so many Dixie and AHS students are housed in buildings that date from the 1950s.

Eighth grade students at Dixie, for example, are housed in facilities dating

from 1952--facilities where the classrooms are relatively small, in comparison to today's standards.

The goal is to put these students, and those at Abbeville, in classrooms that meet 2022 standards.

The building at Dixie would be big enough to accommodate the seventh grade, which currently is divided among Cherokee Trail and Diamond Hill elementary schools in the attendance area serving Dixie.

Dr. Gary recommends moving the seventh grade to Dixie.

In addition to the new academic wings at Abbeville and Dixie, a "yes" vote would fund improvements at the Abbeville County Career Center. Currently, a visitor has to walk by classrooms at the Career Center in order to get to the main office, and this, according to the Superintendent, could create security concerns.

The funding would reconfigure the entrance to eliminate this concern, and would provide more classroom and lab space as well.

Finally, a "yes" vote on the referendum would fund constructing, equipping and furnishing a new kitchen and dining room at each

high school, creating more space, so that more students could enjoy lunch at one time.

All of the above would be covered in Question 1 of the referendum--in which District voters would give the school board the power

to issue up to \$43,800,000 in general obligation bonds to make these projects a reality.

There is also a Question 2, and, slightly paraphrased, it reads as follows:







Grand opening held for Refinery

There was on Wednesday a grand opening for the Refinery, a housing development complex at the corner of Washington and Chestnut in the city of Abbeville.

The ribbon cutting provided a climax to a slate of activities that also included tours of the complex and remarks by those who had helped make the Refinery a reality.

Tonya Haddock, managing partner of Cadence Development, LLC, provided a welcome, and there were also remarks from Mayor Trey Edwards of Abbeville, former mayor Delano Freeman and Anna LaGrone, executive director from the

Greater Abbeville Chamber of Commerce.

Also speaking were Taylor Davis, CEO of NHE, Inc., Kevin White, Managing Direct of Real Estate with NHT Communities, and Seaver Rickert of the Key Bank Community Development Lending Team.

"It seems somewhat surreal that this day is actually here," Haddock told the audience.

The Refinery represents the first major housing development in Abbeville in a number of years, Edwards indicated.

The property on which the Refinery is located had not seen major development in a number of years. "But

Selfishness

Matthew 20:20 "Then the mother of Zebedee's sons came to Him with her sons, kneeling down and asking something from Him. (21) And He said to her, "What do you wish?" She said to Him, "Grant that these two sons of mine may sit, one on Your right hand and the other on the left, in Your kingdom."

Church growth consultant, Win Arn, interviewed thousands of Christians in America several years ago and asked them what they thought the church existed for. Eighty-eight percent said, "The church exists to serve my needs and the needs of my family." In other words, 88% are selfish in the fact that they think the church exists for them and not for the sake of reaching lost people for Christ. In essence that is the attitude of the mother of James and John-she, along with her sons, believed that they were more important than anyone else in the kingdom of God. I would like to share three thoughts on this passage.

First of all, this is a brash request. You have to admire the boldness of the mother's request. I believe the Bible encourages bold prayers but this prayer was brash in the respect that it was arrogant. In essence they believed they deserved this position. They felt that they were more spiritual than the other ten disciples. It is obvious that they felt that they had done more to merit those positions than anyone else. How arrogant! But when you think about it, that request is no more arrogant than some of our requests. How often we pray for God's blessings as if we deserve them more than anyone else. God's blessings are just that—blessings not something we have earned or deserve.

Secondly, this is a brutal request. Brutal in the respect that it must have hurt Jesus when they asked it. This question came right on the heels of Jesus relating to His disciples that He was going to be betrayed to the chief priests and scribes and condemned to death. He had just finished telling them that He was going to be scourged and crucified and resurrected on the third day. This must have hurt Him to realize that they were not thinking about Him—only themselves. At this time Jesus had been with His disciples three years and they still had not gotten the point of His Messiahship.

No doubt this was a brutal blow to Him. But, don't we often fail to grasp the point of our discipleship? Discipleship is not about us, it is not about what Jesus can do for us but what we can do for Him and His kingdom.

Third, this gave Jesus an opportunity to bare His soul to them. Jesus asked them if they were willing to drink the cup that He was about to drink and be baptized with the baptism He was about to be baptized with. They glibly answered, "We are able." Then Jesus told them that indeed they would, but those positions were not His to give. Jesus was breaking the news to them that they indeed would suffer for Him.

Suffering and prominence go hand in hand in the kingdom of God. Those who receive the crown must first endure the cross. There is no glory without suffering.

We must realize that if we want to achieve prominence in the kingdom, we must first be willing to endure pain.



The Indoctrination System


On July 7th, 1986, an employee of Boeing discovered by accident a document in an IBM copier he had purchased for scrap parts. The document is entitled "Silent Weapons for Quiet Wars: An Operations and Research Technical Manual TM-SW7905.1." The document details the blueprint and plan for enslavement of the people of the United States and the world by the world's ruling class through the manipulation and control of industry, pop culture, energy, education, and political systems. It documents that a third world war has been underway since a 1954 meeting of the Elite, the first Bilderberg meeting. big club, which would include the vast majority of society, including respected members of society like most medical "Silent Weapons doctors. for Quiet Wars" has been authenticated by technical writers within military intelligence. It can easily be found online in pdf form, or as a video presentation on Youtube or Brighteon.com.

Charlotte Iserbyt was a lifelong educator who died on 2/8/22. She was a genuine American hero because she was unafraid to tackle hard truths and not back down from



a corrupt system. Iserbyt was the Senior Policy Advisor in the Office of Educational Research and Improvement in the US Department of Education during Ronald Reagan's first term. It was here that Iserbyt learned what the US education system is really all about and meticulously documented her research and findings in her book entitled "The Deliberate Dumbing Down of America," published in 1999. Iserbyt was fired from her position in 1982 for leaking to the press some of the matters she later shared in her book. She stated in 2012 that what she learned about the intent of the education system was the greatest horror she had ever encountered. She stated in this 2012 presentation that: "The US Department of Education is a marxist factory designed to destroy any semblance of good values, academics, and to make sure our children march blindly into a socialist, communist world government. That's the goal of the US Department of Education." She wrote a letter to President Reagan at the time stating that the Department of Education should be abolished and public education should return to its original status, run at the local level, with no influence from federal or international interests.

In the aforementioned book, Iserbyt details that the real purposes of American education are the following: 1) to use the schools to change America from a free, individual nation, to a socialist, global state subservient to the United Nations Charter, and not the US Constitution. 2) to brainwash children to reject individualism in favor of collectivism, 3) to reject high academic standards in favor of egalitarianism, 4) to reject truth and absolutes in favor of "tolerance," and 5) to reject American values in favor of internationalist values.

Through education, the brainwashing and indoctrination of the masses is to accept a new global feudalism. Tolerance today means the acceptance of perversions like transgenderism, and Satanism is the normalization of perversion.

John Taylor Gatto was the

New York City teacher of the year in 1989, 1990, and 1991. He was also the New York State teacher of the year in 1991. An accomplished educator was Gatto who also was one of the harshest critics of the education system at large. Gatto has many different presentations online on this subject. Gatto stated that between 1967 and 1974 teacher training all over the United States was covertly revamped through the coordinated efforts of a small number of private foundations, think tanks, global corporations and universities working through the US Department of Education. One of those foundations was, once again, the Rockefeller Foundation. In a document entitled "Designing Education for the Future," State education agencies would act as on-site federal enforcers ensuring compliance of local schools with Washington DC directives. These Washington DC directives were summarized in the last paragraph. Gatto stated that: "Government schooling made people dumber, not brighter; made families weaker; ruined formal religion with its hard sell exclusion of God; set the class structure in stone by dividing children into classes and setting them against one another; and has been midwife to an alarming concentration of wealth and power in the hands of a fraction of the national community." The wealth and power in the hands of the few he refers to are those setting the agenda, and compiling blueprints such as "Silent Weapons for Quiet Wars."

Indeed, the fundamental tenet of "science" is evolution, taught as unquestionable fact in schools from the earliest age. If this is true, then the Bible is not true. The creation account in Genesis and the evolution doctrine taught in schools cannot both be true. One is true and the other is false. The education system is really about indoctrination into believing in, and serving the false system at large in some capacity. It trains people what to think rather than teaching them how to think. The Floodgates are Opening

As we close in on the last official day to get legislation passed and to the Governor, the State House has been flooded with (as usual) a slew of bills. Many of these bills are versions of House bills that the House passed months ago that the Senate refused to take up. Now the Senate is sending their versions to the House for us to consider in a rush. It's a strange way to legislate, in my opinion. Nonetheless, the flood

The past couple of weeks we saw some very substantial bills receive debate and passage in the House. I supported the following:

H. 5183, the "Transparency and Integrity in Education Act". This bill prohibits K-12 teachers, administrators and others from teaching or disseminating information that one ethnic group is inherently superior to another or are somehow "guilty" of the crimes or atrocities committed by members of their ethnic or racial background. These are the essence of the abominable "woke" tenet known as Critical Race Theory.

H. 3105, the "South Carolina Religious Freedom Act." This legislation deems religious services in houses of worship as essential services during declared states of emergency.

H. 5182, the "South Carolina Opioid Recovery Act." It establishes the South Carolina Opioid Recovery Fund, the Discretionary Sub-fund to participate in receiving funds from the national opioid litigation settlement proceeds.

H. 3126, legislation countering COVID-19 vaccine mandates, and enrolled the bill for ratification. The General Assembly believes that a federal vaccine mandate is unconstitutional and shall not be enforced by this state unless, after legal challenge, courts of this state or of the United States of America hold the federal vaccine mandate to be enforceable.

S. 11, legislation addressing paid parental leave for state employees, and enrolled the bill for ratification. The legislation makes provisions for paid parental leave for state employees due to the birth, adoption, or foster care of a child.

H. 3524, providing for the extension of a pipeline company exemption, and enrolled the bill for ratification. The legislation revises a provision granting pipeline companies the rights, powers, and privileges conferred upon telegraph and telephone companies.

ago, the Sena sent the election reform bill (H. 4919) back to the House with an amendment that made changes to the appointment of The State **Election Commission members** that was totally unacceptable. The House re-committed the Bill to the House Judiciary Committee. Since then several bills that have come to the House for approval have been amended with the House version of the Election Bill and returned to the Senate in an attempt to get them to approve it. It's a necessary parliamentary maneuver to get this much needed reform passed without shenanigans

This past week, I voted in the affirmative for the following bills:
H. 4568, Chemically Induced Abortion Reversal Medical Information, and it was sent to the Senate. If enacted, this proposed legislation would require

a medical disclosure of specific effectiveness information to anyone seeking a mifepristone or misoprostol induced abortion, including, but not limited to a Plan B or a "morning after pill," with a few stated exceptions.

The House amended and returned to the Senate S. 108, a bill relating to duties of the State Geological Survey Unitin the Department of Natural Resources. The bill allows the unit to conduct topographic mapping using light detection and ranging (LiDAR) data collections by December 31, 2022, and at least every seven years thereafter. The House then added the language from the election reform bill.

The House amended Senate amendments to H. 4408, a joint resolution authorizing expenditure of American Rescue Plan Act funds, and returned the legislation to the Senate.

legislation to the Senate. The House returned S. 233 to the Senate with amendments (a LOT of them). The legislation provides for a real property tax exemption extension by providing that a qualified surviving spouse may qualify for an exemption if the qualified surviving spouse owns the house. The legislation also revises eligibility criteria to allow for an exemption when the county assessor certifies to the Department of Revenue that the house is located on heirs' property and the person is the owner-occupied resident of the house. The amendment includes provisions providing for tax value adjustment for property damaged by flooding, hurricane, or wind events (previously approved by the House in H. 4243). Another amendment establishes a property tax exemption for all farm buildings and agricultural structures owned by a producer in this state used to house livestock, poultry, crops, farm equipment, or farm supplies. The legislation revises provisions relating to special license plates for military medals to ensure that veterans receive the exemptions from fees to which they are entitled. Another amendment addresses the inclusion of mixed-use property under the rural telephone service property tax exemption (previously approved by the House in H. 5144). Another amendment revises a tax exemption for the property of telephone companies and rural telephone cooperatives operating in this state that is used in providing rural telephone service. Another amendment includes tax incentives for apprenticeship programs employing veterans and individuals who have been incarcerated for nonviolent offenses (previously approved by the House in H. 3348) and also a newly-hired veteran of the U.S. Armed Forces who was honorably discharged or released from such service due to a service connected disability. The legislation includes provisions expanding eligibility

The House amended and returned to the Senate S. 1117, a bill that adds cotton to the definition of the state's agricultural commodities list to provide self-assessment insurance against unforeseen issues. It sets an assessment at fifty cents per bale of cotton when delivered to a gin. It increases the Guaranty Fund from four million dollars to twenty-five million dollars. The bill also creates the SC Agricultural Commodities Advisory Commission to assist

the Grain and Cotton Producers Guaranty Fund.

The House insisted upon its amendments to S. 506, regarding home-based food production, whereupon, the chair appointed Representatives Matthews, Jones, and McGarry to the Committee of Conference. The Senate appointed Senators Climer, Fanning and Kimbrell.

The House received message that Senate concurred with amendments to S. 227, the Massage Therapy Practice Act and enrolled it for ratification.

The House amended, gave third reading and enrolled for ratification S. 1179, a bill dealing with social workers providing behavioral telehealth.

The House amended and gave second reading approval to S. 460. The bill revises numerous provisions to consolidate and simply the statutory authority of the State Fire Marshal. The legislation's revisions are not to supersede or impair the authority granted to the State Board of Pyrotechnic Safety relating to the manufacture, sale and storage of fireworks. An amendment includes provisions (previously approved by the House in H. 3252) providing for enhancements to the Volunteer Strategic Assistance and Fire Equipment (V-SAFF) Program.

The House amended and returned to the Senate S. 613, a bill that updates the requirements for delegating certain nursing tasks to unlicensed assistive personnel (UAP) and makes it clear that a physician assistant may delegate these tasks to a UAP. Among many things, the bill defines a category of unlicensed medical staff-the Certified Medical Assistant (CMA). The bill also outlines that the unlicensed assistive personnel must not administer medications except as provided by law. The bill provides that medical assistants employed at the time of the passage of this act may continue to work but must become certified within two vears of the act's effective date to continue to work in the role of a CMA. The limitation on specific tasks that may be delegated to a CMA applies when the delegation is done by a PA or an APRN.

The House amended and gave second reading to S. 968, a bill that establishes the "Veterans Service Organization Burial Honor Guard Support Fund." The fund helps to offset the costs paid by South Carolina chapters of congressionally chartered veterans service organizations that provide well-equipped and properly trained honor guard burial details at the funerals of qualifying South Carolina veterans.

A bill that I voted against was S. 628, a bill that enacts the allows a pharmacist to dispense a self-administered hormonal contraceptive or administer an injectable hormonal contraceptive in accordance with a standing prescription drug order by a prescriber to a patient who is eighteen years of age or older or someone under eighteenyear-old who has evidence of a pervious contraceptive prescription. I felt that this procedure may create a problem if the individual seeking these medications is not examined by a physician regularly to make sure there are no conditions that may render this medication a danger. It passed

The House gave third reading and enrolled S. 222 for ratification. This bill allows fictive kin to be eligible to be foster parents under the Kinship Foster Care Program. The bill outlines that

"fictive kin" means an individual who is not related by birth, adoption, or marriage to a child but who has an emotionally significant relationship with the child or the child's family.

The House amended, gave third reading and returned to the Senate S. 1103, a bill providing for the distribution of child identification kits. These inkless, in-home fingerprint and DNA identification kits are to be distributed throughout the district or school on request to the parent or legal custodian of any kindergarten, elementary, middle, or high school student. This enables a parent or legal custodian to submit the kit to federal, state, tribal, or local law enforcement to help locate and return a missing or trafficked child. Unless expressly appropriated by the General Assembly, the Department shall not expend funds to procure kits.

In some good news, the Senate passed H. 4608 (which I was a co-sponsor) the "Save Women's Sports Act". This prohibits biological males from competing against women in women's sports. It will now go to the Governor for his approval and become law.

There are many more bills coming before the official Sine Die deadline. Stay tuned!

The House amended, gave third reading and returned to the Senate S. 946, a bill establishing at least thirty minutes of unencumbered time on each regular school day to all fulltime teachers teaching in a grade between kindergarten and fifth grade. The bill also provides that the policy also directs a principal of any elementary, middle, or high school to provide at least thirty minutes of unencumbered time on each regular school day to any teacher who is responsible for instructing a student who is removed from the general education setting for more than twenty percent of the day. The House added an amendment regarding exceptions and establishing

The House approved S. 812, which revises various provisions governing the practice of certified public accountants, and enrolled the bill for ratification. The membership of the South Carolina Board of Accountance is revised to provide for the inclusion of one resident licensed certified public accountant from tion makes revisions that align the state's practice act with national CPA organization rules and regulations as a means of ensuring that South Carolina is not placed at a competitive

disadvantage.

The House approved S. 637 and enrolled the bill for ratification. The legislation revises the application of mortgage lending provisions to retailers of manufactured and modular homes in order to bring state law into compliance with the latest updates that Congress has approved to the federal Dodd-Frank Act.

The House approved S. 635 and enrolled the bill for ratification. The legislation makes revisions to the South Carolina Research Authority that include: adding the President of South Carolina State University, or his designee, to the SCRA Board of

Trustees and affording university presidents greater flexibility in allowing designees to serve on the board; authorizing the Research Authority to invest in corporate bonds; and, increasing the amount of time that a startup company is allowed to remain in an innovation center.

The House made appointments to a conference committee to address its differences with the Senate on H. 3729, a bill addressing charges for storing towed vehicles.

The House amended Senate amendments to H. 5075, a bill revising the South Carolina housing tax credits that supplement federal tax incentives for the development of affordable housing, and returned the legislation to the Senate.

The House returned Joint Resolution S. 1106, a proposed state constitutional amendment for increasing state financial reserve funds that are used to cope with revenue shortfalls, to the Senate with amendments. The proposed amendment provides for the state's General Reserve Fund, currently set at five percent of General Fund revenue of the latest completed fiscal vear, to be increased each year by half of one percent until it equals seven percent of General Fund revenue of the latest completed fiscal year. The proposed amendment increases the state's Capital Reserve Fund from two percent of General Fund revenue of the latest completed fiscal year to three percent of such revenues. Should the General Assembly pass the joint resolution, these proposals for amending the South Carolina Constitution would be placed before the state's voters as ballot questions at the next general

The House amended, approved, and sent the Senate H. 5252, the "Economic Encouragement Act." This joint resolution provides an expedited process for approving competitive electric power pricing for potential economic development prospects that the Department of Commerce can offer to encourage these businesses and industries to invest in South Carolina and bring jobs to the state. The legislation authorizes the Public Service Commission to consider quantifiable net benefits to utility customers due to economic development in deciding whether to approve the competitive rates proposed by an electric utility. These economic development rates must be above the marginal cost of energy production. The provisions expire on July 1, 2026.

The House returned S. 533. a joint resolution prohibiting the payment of subminimum wages to individuals with **shilities** to the amendments. The resolution provides that employers, community rehabilitation programs. and hospital patient care workers at regional centers shall not use a provision of the Fair Labor Standards Act of 1938 to pay disabled employees a subminimum wage. No individual with a disability may be paid less than the federal minimum wage. The Department of Disabilities and Special Needs is required to submit an annual report to the General Assembly concerning the payment of a subminimum wage in South Carolina. The legislation establishes a South Carolina Task Force on Eliminating the Subminimum Wage charged with identifying and developing protections for disabled subminimum wage employees to maintain competitive employment while phasing out the use of the subminimum wage by August 1, 2024. The legislation includes the "Employment First Initiative Act" (previously approved by the House in H. 3244) which relates to policies at state agencies and South Carolina's political subdivisions encouraging competitive integrated employment for individuals with disabilities.

The House returned S. 908,

a bill disallowing the driving of certain modified vehicles including the modifications commonly referred to as the "Carolina Squat" or the "California Lean," to the Senate with amendments. The legislation makes it unlawful to drive a passenger motor vehicle, including a pickup truck, on the highways of this state that has been altered so that the height of the front fender is raised or lowered four or more inches above or below the height of the rear fender. Penalties are established for violations. The legislation includes provisions (previously approved by the House in H. 3600) governing utility terrain vehicles including conditions and requirements that allow for a UTV to be operated on roads. The legislation includes provisions (previously approved by the House in H. 4534) that restructure penalties and make other changes to provisions targeting catalytic converter theft.

The House returned **S. 1178** to the Senate with amendments. The bill allows **online sales of self-service storage facility property**, rather than on-premises sales exclusively, in instances when no one has purchased the property at the required public sale. All sales must be conducted by auctioneers who are licensed in South Carolina.

The House returned S. 158, a bill allowing an exemption from continuing education requirements for experienced real estate professionals and financial advisors, to the Senate with amendments. The legislation allows a licensed real estate broker or salesperson who has twenty-five years or more of experience in South Carolina and is at least sixty-five years old to apply for an exemption from continuing education requirements. A financial advisor subject to securities registration is also eligible for this experience-based full continuing education waiver.

The House amended and gave second reading approval to **S.** 17, the "Permit Extension Joint Resolution of 2022." This joint resolution provides for the extension of various valid permits issued for construction, reconstruction, and other development of land for a period beginning December 1, 2016, and ending December 31, 2023.

The House approved **S. 934**, which revises the membership of the **South Carolina Building Codes Council**, and enrolled the bill for ratification. The legislation requires each member of the council to be a South Carolina resident and provides that the member who is an architect licensed in South Carolina must be selected from a list of qualified candidates submitted to the Governor by the South Carolina Chapter of the American Institute of Architects.




