



Important Background Fredrick was arrested in 2013 by the FBI and charged with Conspiracy to Commit Wire Fraud and Making a Materially False Statement to the Securities and Exchange Commission. He subsequently pleaded guilty to these charges in 2014 and was sentenced to 63 months in Federal Prison, 3 years of supervised release and ordered to pay restitution.
